School Boards caught between community and courts

Texas school board members are caught in a difficult situation. When we took office, we swore to uphold the laws of this state and nation. In many Texas communities, however, citizens disagree with a recent court ruling that eliminates prayer at football games and are encouraging local school boards to ignore the court's direction.

Las February the Fifth Circuit Court of Appeals ruled in Doe v Santa Fe Indep. Sch. Dist. that school districts cannot allow student-led, student-initiated prayer over the loudspeaker at football games because it violates the Establishment Clause of the United States Constitution. The Fifth Circuit Court has jurisdiction over Texas, Louisiana and Mississippi; therefore, the decision is binding on Texas school districts.

Although the court's decision has

been appealed to the United States Supreme Court, school districts are responsible for complying with the Fifth Circuit Court's ruling unless the Supreme Court reverses the lower court's decision. Failure to comply with the court's ruling could result in liability to the district and to the board members, thereby diverting education resources (time, energy and dollars) away from school children.

Texas school boards have shown their support for student-initiated, student-sponsored prayer and moments of silence at school events by approving resolutions to this effect in the annual Texas Association of School Boards (TASB) Delegate Assembly every year since 1993. An identical resolution will be considered in the 1999 Delegate Assembly on October 9.

Additionally, the TASB Legal

Assistance Fund (LAF) filed a brief to the Fifth Circuit in support of the Santa Fe ISD Motion for Rehearing-which was denied-and the LAF Board voted to fund an amicus curiae ("friend of the court") brief to the U.S. Supreme court in support of student prayer at football games, if the court agrees to hear this case.

The bottom line is this: Texas school boards and their association (TASB) must uphold the laws of this country. However, we are committed to finding a way to change the current law concerning prayer at school events.

If you believe that student-initiated, student-sponsored prayer and moments of silence should be permitted at school events, please contact your state and national elected officials.

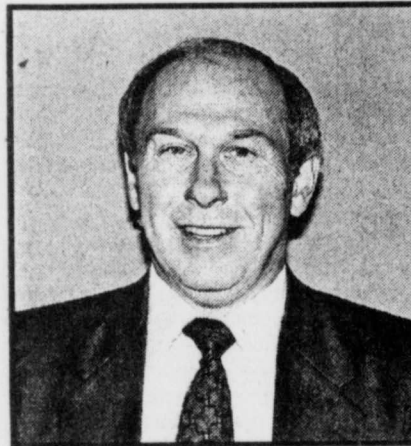

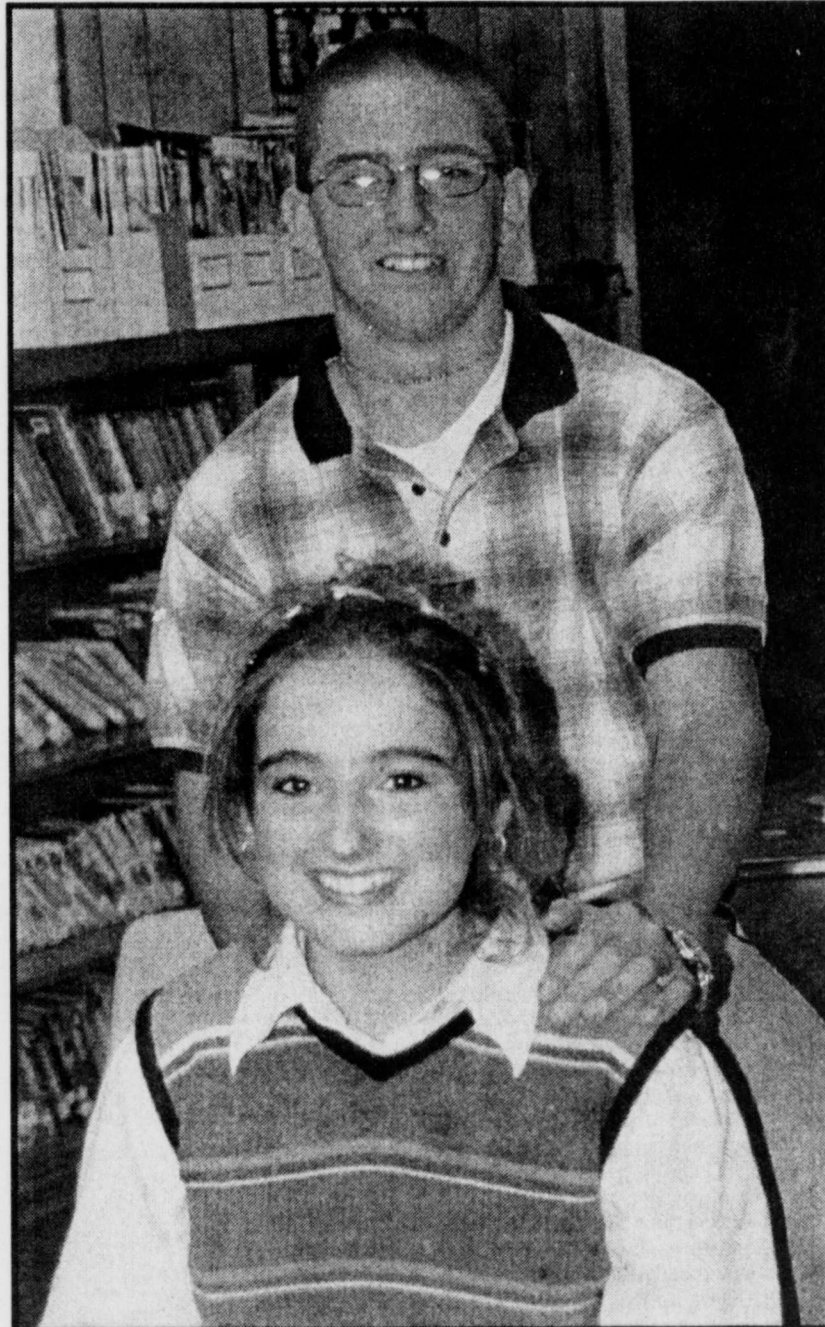

McCrury Homecoming set

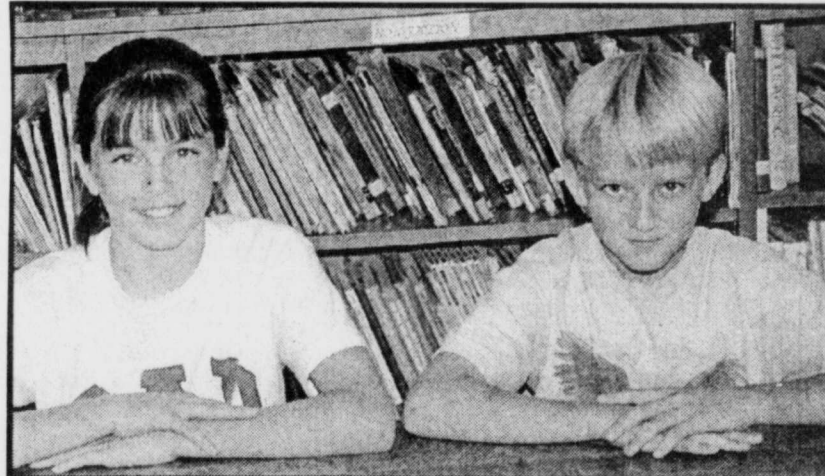
The date has been set for the McCrury Community Homecoming. It will be on Sunday, October 10, 1999 at the pavillion near the cemetery on FM 196.

Best Brownies

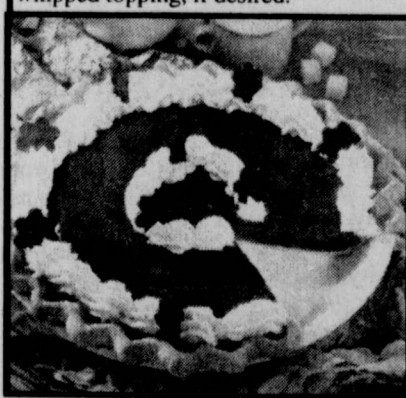
1 stick butter or margarine-melted
1 cup sugar
1 teaspoon vanilla
2 eggs
1/2 cup all-purpose flour
1/3 cup Hershey's cocoa
1/4 teaspoon baking powder
1/4 teaspoon salt
1/2 cup chopped nuts
Heat oven to 350 degrees. Grease 9-inch square baking pan. In medium bowl, stir together butter, sugar and vanilla. Add eggs; with spoon, beat well. Stir together flour, cocoa, baking powder and salt. Add to egg mixture; beat until well blended. Stir in nuts. Spread batter into prepared pan. Bake 20-25 minutes or until brownies begin to pull away from sides of pan. Cool completely in pan on wire rack. Frost with Creamy Brownie Frosting.

Creamy Brownie Frosting

3 tablespoons butter or margarine-softened
3 tablespoons Hershey's cocoa
1 tablespoon light corn syrup or honey
1/2 teaspoon vanilla
1 cup powdered sugar
1 tablespoon milk
In small mixer bowl, beat butter, cocoa, corn syrup and vanilla until blended. Add sugar and milk; beat until smooth and of spreading consistency. Add additional milk, 1/2 teaspoon at a time if needed.

Hot Fudge Pudding Cake

1-1/4 cups granulated sugar-divided
1 cup all-purpose flour
7 tablespoons Hershey's cocoa-divided
2 teaspoons baking powder
1/4 teaspoon salt
1/2 cup milk
1/3 cup butter or margarine-melted
1-1/2 teaspoons vanilla
1/2 cup packed light brown sugar
1-1/4 cup hot water
whipped topping-optional
Heat oven to 350 degrees. In large bowl, stir together 3/4 cup sugar, flour, 3 tablespoons cocoa, baking powder and salt. Stir in milk, butter and vanilla; beat until smooth. Pour batter into 8 or 9-inch square baking pan. Stir together remaining 1/2 cup sugar, brown sugar and remaining 4 tablespoons cocoa; sprinkle mixture evenly over batter. Pour water over top. Do not stir. Bake 35-40 minutes or until center is almost set. Cool 15 minutes; spoon into dessert dishes. Spoon sauce from bottom of pan over top of cake. Serve warm with whipped topping, if desired.



Hershey's Cocoa Cream Pie

Hershey's Cocoa Cream Pie

1/2 cup Hershey's cocoa
1/3 cup cornstarch
1/4 teaspoon salt
3 cups milk
3 tablespoons butter or margarine
1-1/2 teaspoons vanilla extract
1 baked 9-inch pie shell or graham cracker crust
sweetened whip cream
In medium saucepan, stir together cocoa, sugar, cornstarch and salt. Gradually add milk, stirring until smooth. Cook over medium heat, stirring constantly, until mixture comes to a boil; boil 1 minute. Remove from heat; stir in butter and vanilla. Pour into prepared crust. Press plastic wrap directly onto surface. Cool to room temperature. Refrigerate 6-8 hours. Serve with sweetened whipped cream.

Cocoa Kiss Cookies

1 cup butter or margarine-softened
2/3 cup sugar
1 teaspoon vanilla
1-2/3 cups all-purpose flour
1/4 cup Hershey's cocoa
1 cup finely chopped pecans
1 bag Hershey's Kisses
powdered sugar
In large bowl, beat butter, sugar and vanilla until creamy. Stir together flour and cocoa; gradually add the butter mixture, beating until blended. Add pecans; beat until well blended. Refrigerate dough about 1 hour or until firm enough to handle. Heat oven to 375 degrees. Remove wrappers from chocolate pieces. Mold scant tablespoon dough around each chocolate piece, covering completely. Shape into balls. Place on ungreased cookie sheet. Bake 10-12 minutes or until set. Cool slightly, about 1 minute; remove from cookie sheet to wire rack. Cool completely, about 1 minute; remove from cookie sheet to wire rack. Cool completely. Roll in powdered sugar and roll again just before serving if desired.

Deep Dark Chocolate Cake

2 cups sugar
1-3/4 cups all-purpose flour
3/4 cup Hershey's cocoa or Hershey's European style cocoa
1-1/2 teaspoons baking powder
1-1/2 teaspoons baking soda
1 teaspoon salt
2 eggs
1 cup milk
1/2 cup vegetable oil
2 teaspoons vanilla
1 cup boiling water
Heat oven to 350 degrees. Grease and flour two 9-inch round baking pans. In large mixer bowls stir together sugar, flour, cocoa, baking powder, baking soda and salt. Add eggs, milk, oil and vanilla; beat on medium speed for 2 minutes. Stir in water. (Batter will be thin) Pour batter evenly into prepared pans. Bake 30-35 minutes or until toothpick inserted into center comes out clean. Cool ten minutes and remove from pans to wire rack. Cool completely. Frost with Buttercream Frosting.

One Bowl Buttercream Frosting

6 tablespoons butter
2-2/3 cups powdered sugar
1/2 cup Hershey's cocoa
1/3 cup milk
1 teaspoon vanilla
In small mixer bowl, beat butter until creamy. Add powdered sugar and cocoa alternately to milk, beating well after each addition until smooth and of spreading consistency. Blend in vanilla. Add additional milk, 1 teaspoon at a time if needed.

Double-Decker Fudge

1 cup peanut butter chips
1 cup Hershey's semi-sweet chocolate chips or mini-chips
2-1/4 cups sugar
1 jar marshmallow creme-7 ounces
3/4 cup evaporated milk
1/4 cup butter or margarine
1 teaspoon vanilla
Line 8-inch square pan with foil, extending over edges of pan. In medium bowl, place peanut butter chips. In second bowl, place chocolate chips. In heavy 3-quart saucepan, combine sugar, marshmallow creme, evaporated milk and butter. Cook, over medium heat, stirring constantly, until mixture comes to a boil boil 5 minutes, stirring constantly. Remove from heat; stir in vanilla. Immediately stir in half of the hot mixture into peanut butter chips until chips are completely melted; quickly spread into prepared pan. Stir remaining hot mixture into chocolate chips until chips are completely melted. Quickly spread over top of peanut butter layer. Cool to room temperature; refrigerate until firm. Use foil to lift fudge out of pan. Peel off foil. Cut into pieces. Store in tightly covered container at room temperature.

For Peanut Butter Fudge: Omit chocolate chips and place 1-2/3 cups peanut butter chips in large bowl. Cook fudge mixture as directed above. Add to chips stir until all chips are completely melted. Pour into prepared pan.

For Chocolate Fudge: Omit peanut butter chips and place 2 cups of Hershey's semi-sweet chocolate chips or mini-chips in large bowl. Cook fudge according to directions above. Pour into prepared pan.

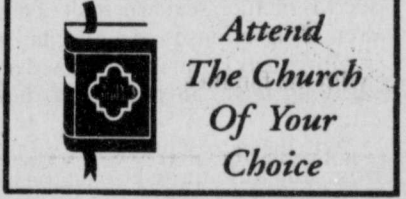

The first thing a con artist often does is persuade consumers that Year 2000 computer problems will create havoc on our economy. They may describe frightening scenarios of banks shutting down, leaving account owners empty handed and unable to recover funds from their accounts or investments in IRAs and Certificates of Deposit.

Con artists may also warn about problems affecting other sources of income such as government assistance or investments in the stock market. Fearing the elimination of social security, Medicare, or their hard earned retirement dollars.

Common schemes con artist use to swindle money:

- * Convincing consumers that the dire predictions regarding loss of financial security due to Year 2000 problems are true.
- * Persuading consumers to invest in "special" or "secret" products, companies, or accounts that will generate tremendous profits.
- * Advising individuals to withdraw their money out of banks, credit unions, or other financial institutions and turn it over to them for "safekeeping"

Tips and warning signs to guard against fraud

- * NEVER give out account information or credit card numbers to someone unless you're certain they are trustworthy. Thieves can appear very sincere and friendly. And they can be very persuasive. All they need is your account number to empty all the money out of your account.
- * Don't enter into a deal if you're being pressured to act immediately.
- * Be wary of people posing as bank officials, police officers, or other government agents who ask you to assist them in an investigation or audit of your financial institution. You may be asked to withdraw cash or give out your account information. No legitimate official would ask a consumer to participate in this type of investigation.

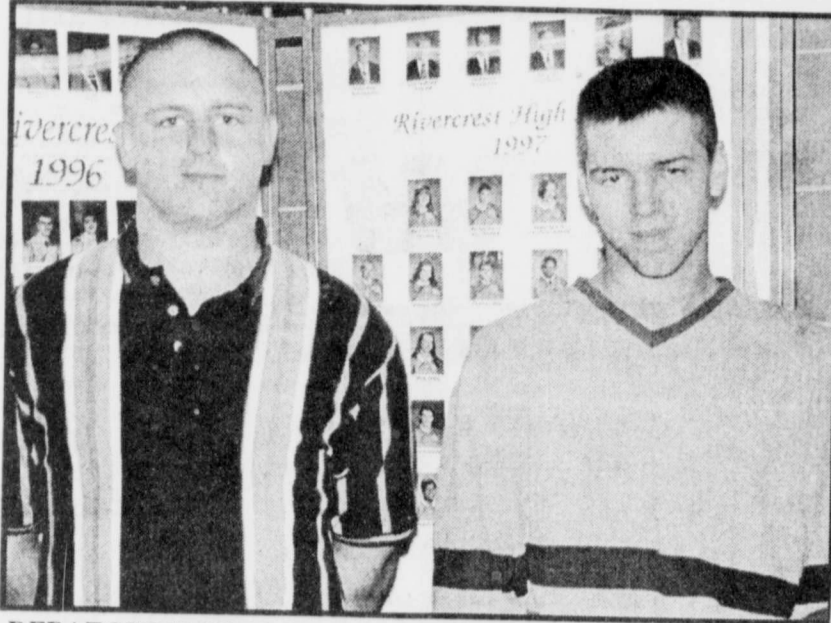

Rebels fall to Clarksville Tigers

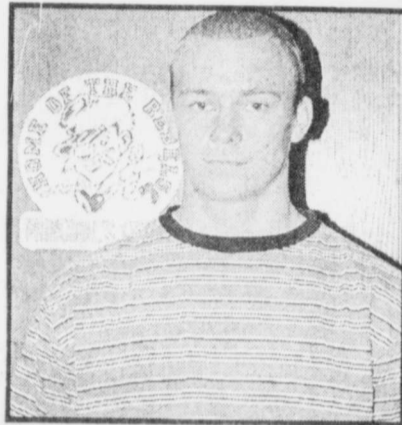

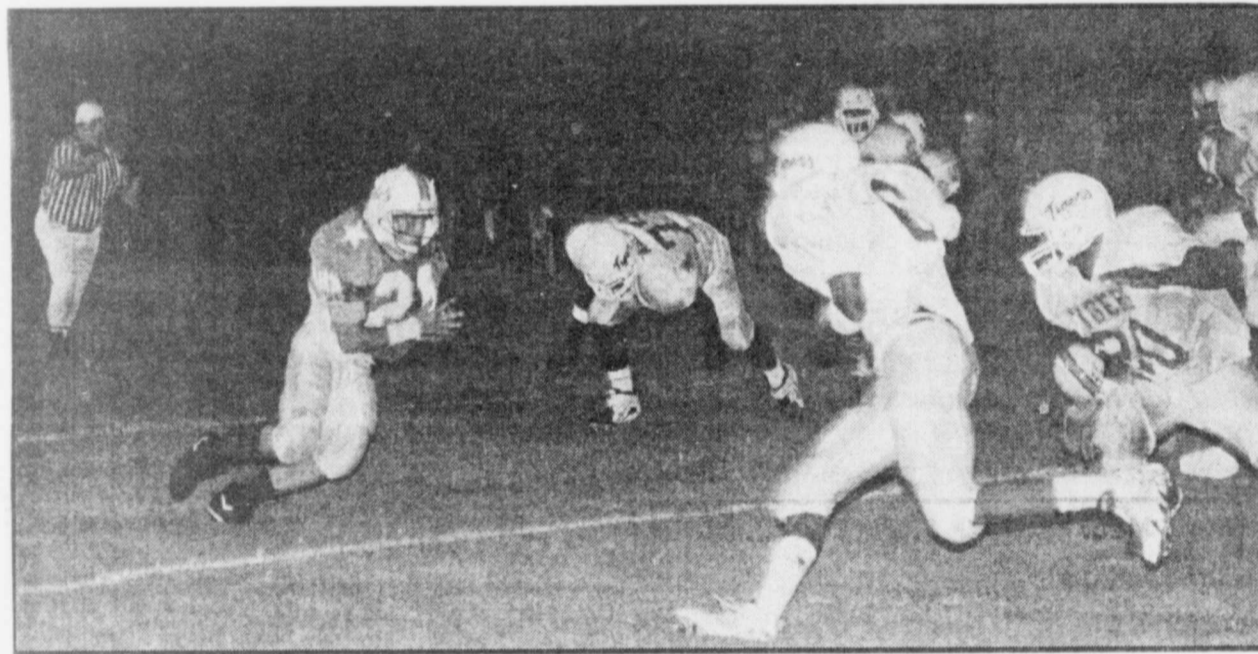

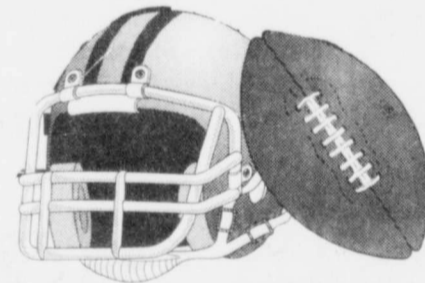

Bogata couple loses horses

On Monday, October 4, in 102nd Judicial District Court held at the Red River County Courthouse in Clarksville, TX, the Honorable John F. Miller, Jr. heard a hearing pertaining to Section 821 of the Health and Safety of Animals Code.

The hearing pertained to cruelty to animal charges against Chris and Wendy Albritton of Bogata, TX.

The original complaint charged that the couple had housed five head of animals (three horses and two mules) in their backyard in a residential area of Bogata, and had not provided the animals with adequate food, water and shelter over an extended period of time.

In a previous ruling by Justice of the Peace J.R. Lewis, the animals had been seized and placed in custody until such a time a hearing could be held to determine if the animals should be returned to the couple, or if they should be sold at auction.

The couple had been charged that the animals had been chained to trees for extended periods of time without food and water, through the winter and summer months, thus not providing adequate nutrition and care to keep the horses in good condition.

The hearing began with testimony from witnesses called by Red River County Attorney Jack Herrington. Bogata Chief of Police, Charles Clegg was the first witness called. He gave documentation of the events that had involved his office, beginning in August of 1998. Clegg stated that he had investigated the charge made against the Albritton couple after receiving numerous complaints from citizens regarding the alleged mistreatment of the animals. He had continued his investigation from that time forward and had done everything possible to make his investigation thorough and conclusive. Stating that he was "no expert on horses" Clegg had contacted equine professionals and experts in the field to verify or nullify the charges against the couple. When the Lamar County

Humane Association was called to intervene in the situation, Clegg had accompanied representatives of the Humane Association to the residents where the animals were being kept, when hay was donated to the couple for the animals' upkeep.

Clarksville Veterinarian Hardy Stewardson was called to testify as to the condition of the animals at the time of seizure and to give his opinion of the treatment the Albritton's had been charged with while caring for the animals. Dr. Stewardson, who was in equine practice exclusively for a period of nine years, had on more than one occasion within the past several months, observed the animals and was able to give testimony that their condition was deteriorating, not improving. Dr. Stewardson stated that he had checked the horses for their ages, done blood work for Equine Infectious Anemia, given the animals a routine worming and basically fed and watered the animals properly since they had been in his care. From Dr. Stewardson's facility, the animals were moved to pasture where they were stabled at the time of the hearing.

Georgia Fergin, representative of the Lamar County Humane Association, who had been involved in the case since August of 1998, gave testimony as to the participation of the Association since their involvement. Mrs. Fergin stated that the Albritton's had at first, said they would work with the Association to improve the condition of the animals, but later decided not to.

The Association had secured hay for the animals on two occasions and had offered further assistance with the upkeep of the animals, but dismissed themselves from the case when they were told by the Albritton's to leave their property.

Attorney for the Albritton's, George Preston, countered with testimony from Wallace E. Kraft, DVM, of Paris, who had visually observed the animals some six weeks follow-

ing their seizure. Since the time of the seizure, the animals had been turned out to pasture and been fed adequate amounts of grain. Kraft stated that the animals were "thin, but not emaciated".

When County Attorney Herrington questioned Dr. Kraft if chaining animals to trees without feed and water for extended periods of time, as the Albritton's had been charged with doing, was the correct and humane way to care for animals, Kraft commented, "a year's a long time."

In concluding the hearing, Preston called both Chris and Wendy Albritton to testify. Both stated that they had fed the animals well, that the horses were in good condition and there was no basis for the charges against them. They further refuted the statements made by Dr. Stewardson regarding the age of the animals, as well as the state of their condition when Dr. Stewardson had been called to inspect the animals. The Albritton's both refuted the statements made by Mrs. Fergin.

The Albritton's both stated that since the time the animals had been removed from their property, had moved from Bogata and had secured a place to keep the animals, which was "7 or 11 acres, I'm not sure" according to Wendy Albritton.

When asked by Herrington why all the witnesses had contradicted the Albritton's claim that they had properly cared for the animals, both Chris and Wendy Albritton stated "I don't know."

As Judge Miller concluded the hearing, he conveyed to the court that his ruling was based on experienced testimony from equine experts. Upon conclusion of this statement to the court, Judge Miller ruled that the horses not be returned to the Albritton's and be sold at public auction.

Cruelty to animals charges are presently pending against the Albritton's by the Red River County Attorney's office.

I have worked with the food distribution for several years, and this is the first time I have heard of any complaint.

I am writing in response to a letter written by Ann Clark to your newspaper. The letter referred to the monthly commodities distribution in Bogata. For the past three years the East Texas Food Bank has provided approximately 500,000 pounds of quality, nutritious food products to the citizens of Bogata who are in need. This program is designed to serve in emergency, short-term situations only. The East Texas Food Bank is based in Tyler and 80% of the money needed to deliver food to Bogata is from Smith County and 100% of the food comes from outside Red River County. The Food Bank has provided the food and staff to administer the program. The number of citizens seeking aid has doubled since we began and therefore the expenses have doubled. The First Baptist Church has generously allowed us to use their parking lot and fellowship hall each month, but we found it necessary to rely more and more on volunteers from your community to administer the program on-site. I regret that Food Bank staff was not present when Ms. Clark sought help and I apologize for the

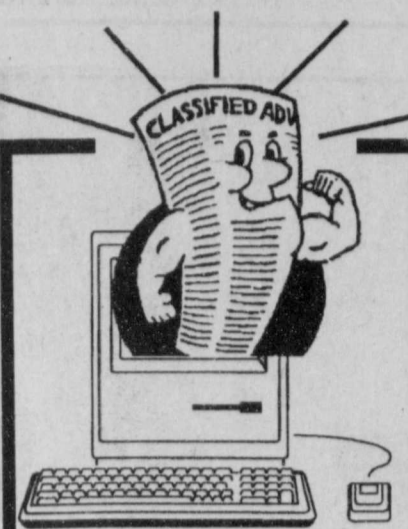

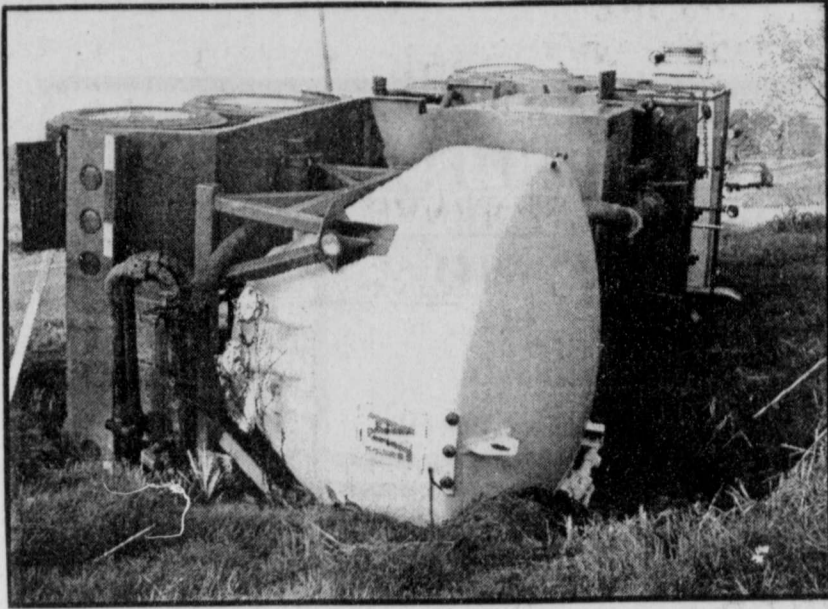
