# Deport council proposes strict animal control laws in response to petition

is under consideration by the Deport City Council. The ordinance sets limits to the number of dogs and/or cats a resident may own, as well as requiring each animal to have a valid certificate of vaccination.

The ordinance defines "animal" as any mammal or marsupial, domestic or wild, other than humans, which may be affected by rabies.

The ordinance also regulates the keeping of rabbits and poultry.

The ordinance proclaims it unlawful for an animal or animals to run at large (not on a leash) and the animals are subject to impoundment by a city official for a period of at least 72 hours. At the expiration of the 72 hours, if the animal has not been claimed by it's owner it will be considered abandoned by it's owner and the animal will be disposed of (put to death) by a qualified shelter at the city's expense. According to councilman Francies, the cost per animal is estimated to be around \$20 per animal.

If the animal is claimed by it's owner before the 72 hours have expired the owner will incur all ex-

A strict Animal Control Ordinance penses for vaccination of the animal or animals.

> Section 11 of the proposed ordinance states that any one owner or family harboring more that three (3) dogs or (3) cats over six months of age shall be declared a nuisance. The only exceptions are for veterinary clinics or kennels located within the city limits.

> The proposed ordinance is published completely in the public notice section of the Deport Times this week.

Any resident of the city of Deport is invited to read the ordinance in publication, and will be available for review at the Deport City Hall during regular business hours.

Anyone with opinions for, or against the proposed ordinance is invited to attend the next city council meeting Monday, May 8th at 6:45 p.m. at Deport City Hall to voice their opinions

Residents can also call City Hall at 652-3875 to voice their opinions.

The truth is that one section of the ordinance will limit the number of pets (cats or dogs) any one person or family may own.

I believe that this ordinance as it is currently written is unfair to cat and dog owners who are responsible, keep their animals vaccinated and well cared for. Section 11 of the ordinance states that no owner or family can lawfully harbor more than 3 cats and 3 dogs over six months of age. Exceptions are veterinarians offices or a person with a kennel license.

Why would citizens of Deport allow an ordinance to be voted into law that discriminates against those who love, protect and truly care for pets?

Yes, a petition was signed by 100 people saying that animals needed to be vaccinated and better controlled, as there are many stray

only three, nor should it.

Only dogs and cat owners are singled out to be told they may only love and cherish three dogs and three cats or their animals will be considered a nuisance. If a neighbor complains that someone is 'over their limit" the animals are subject to impoundment.

Please, let's not pass section 11 of this ordinance as it is currently proposed.

I am NOT against an animal ordinance, just the limitation of the number of dogs and cats a **RESPONSIBLE** pet owner can have.

The council will discuss and vote on this ordinance at the next city council meeting May 8th at 6:45 p.m. Let city hall know how you feel. They will listen, but you must speak up.

# Duane Allen recalls first two songs he ever performed

Oak Ridge Boys looking forward to concerts this weekend

Ridge Boys, and most people know that lead singer Duane Allen is a native of this area. But, in a phone interview Tuesday, Duane confessed to a story that "I don't believe I've er told the press before"

When asked if he could remember the very first song he ever sang for the public he laughed and said "Clearly"

Duane received such a big round applause that he says "I really thought I was cool"

Two weeks later his older brother, Fred, and his cousin, Loy took Duane to the community of Minter to a gospel singing. He was given the opportunity to sing once again.

'Well, I had had my big premier two weeks before. My brother and cousin had taught me a little song called 'Show Me The Way To Go Home' and I stood right up and sang it. It was pretty quiet after I finished up with the verses about 'I had a little drink about an hour ago and it went right to my head' but I was only four and they were pretty forgiving. Fred

Everyone has heard of the Oak and Loy kinda got into trouble for teaching me that song, though" he laughs.

From that beginning was launched a career in music that has spanned generations and continents.

The Oak Ridge Boys, consisting of duane, William Goldman, Richard Sterban and Joe Bonsall went from their firmly rooted gospel beginnings to country music that has netted them hits such as "Your The One " "Heart of Mine" "Bobbie Sue" and Elvira".

They have toured Europe, Soviet Union, West German, Canada and of course the entire United States.


Their gospel roots stand the Oaks in good stead when it comes to helping others, too.

CITY OF DEPORT **ORDINANCE NO. 0001** 

An ordinance regulating the keeping of dogs and cats in the City of Deport; providing for definitions; requiring the vaccination of all dogs and cats kept in the City; providing for the impounding of certain dogs and cats found running at large; providing for the redemption of dogs and cats not so redeemed by the owner; providing for the impoundment and the quarantining of animals; providing for animal care and restraint; providing for reports of human and animal exposure to rabies; providing for submission of specimens for laboratory; providing for an effective date of May 8, 2000; providing for a penalty of not more than \$1,000.00 for violations of this ordinance, and not more than \$100.00 for any person or persons who assist in the violation of any provisions of this ordinance; providing for repeal, and providing for a severance

Be it ordained by the City Council of the City of Deport: Article I. In General

Section 1. Definitions: As used in this ordi-

nance, the following terms mean: Animal: Any mammal, or marsupial, domestic or wild, other than man, which may be affected by rabies Animal Control Officer: That person or agent responsible for the care, seizure, cus-

tody, disposal and impoundment of dogs, cats, rabbits and poultry. Animal Shelter: A licensed facility, public

or private, used to confine and impound dogs, cats, rabbits and poultry seized, lost, abandoned or given over by owners. Animal Wound: Animal bite or scratch that has inflicted a break or abrasion to the skin of a humar

Cat: Any member of the animal species felis

Dog: Any member of the animal species canis familiars

Harboring: The act of keeping or caring for an animal including, but not limited to, the providing of food, shelter or medical attention for the animal

Livestock: Includes any cows, horses, mules, jacks, jennets, goats, sheep, swine or any other livestock. Owner: Any person having right to property in an animal; who has an animal in his care

or custody; or who knowingly permits an animal to remain on or about any premises occupied by him. Poultry: All domesticated fowl and all game birds, which are kept in captivity.

Running at large: Dog, cat or fowl not under the control of the owner or agent. Section 2. Livestock Not To Run At Large:

It shall be declared a nuisance for any person to allow and permit any cows, horses, nules, jacks, jennets, goats, sheep, swine or any other livestock of any character to run at large upon the streets, alleys, public highways, public parks, public lands, or upon any vacant lot or lots within the City. Section 3. Disposal of Dead Animal

The carcass of any animal dead of disease or any other cause shall be removed and/or not known, the owner of the premises where such animal is found, at his own expense within twenty-four (24) hours after such death. Failure to comply with this section shall be declared a nuisance. Section 4. Keeping of Livestock Restricted. It shall be declared a nuisance for any person or persons within the City Limits to keep or pen any cattle, horses, mules, jacks, jennets, goats, sheep, or any other livestock in an enclosure less than two (2) acres in area and within one hundred (100) feet of any building or structure used for sleeping, dining, living and/or business, except such a building or structure belonging to the owner of such livestock; provided however that the keeping of horses and cattle in such an enclosure is restricted to no more than one (1) such animal per one-half acre of land contained within said enclosure, with the exception of temporary keeping of up to one (1) animal per one-fourth (1/4) acre up to ninety (90) days maximum

(4) Date vaccinated; (5) Rabies tag number; (6) Veterinarian's signature or signature stamp and license number

(d) Any dog or cat found in the City without a current vaccination tag will be declared a nuisance and shall be impounded as provided herein Section 7. Unlawful To Allow Dogs Or Cats To

Run At Large; Impoundment. It shall be declared a nuisance for the owner

of any dog or cat to permit or allow such dog or cat to run at large upon any public street, highway, alley, court, square, park, sidewalk, other public ground or public property or any unfenced land within the corporate limits of the City.

Section 8. Female Dogs/Cats in Estrus (heat) To Be Kept Under Control.

It shall be declared a nuisance for the owner or person in control of any unspayed female dog or cat, while such dog or cats is in estrus (heat), to allow the same to be upon, in or about any public house, public place, street, or alley in the City

Section 9. Dangerous Dogs. Subchapter D to Chapter 822 of the Health

and Safety Code, Vernon's Annotated State Statutes, as hereinafter amended, styled Dangerous Dogs, including the requirements for registration, restraint, liability insurance, penalties, and all other requirements set out therein, shall apply to all dogs located within the City Limits of the City of Deport, Texas. Section 10. Noises.

It shall be declared a nuisance for any person to harbor or keep on his premises, or any pre mises under his control, any animal which shall cause the peace and quiet of the neighborhood or the occupants of the adjoining premises to be disturbed, at anytime or the day or night.

Section 11. Number of Dogs and Cats Limited The harboring and maintaining of more than three (3) dogs and/or three (3) cats over six (6) months of age by one owner or family shall be declared a nuisance. This subsection shall not apply to veterinary clinics.

Section 12. Harboring. The harboring or maintaining of any dogs or cats in any enclosure unless said enclosure is kept clean and sanitary and free of offensive

odors shall be declared a nuisance. Section 13. Killing Animals. The members of the Deport City Hall or duly authorized agent are authorized to kill any animal of any kind when it is necessary for the protection of any person or property.

Section 14. Enforcement Officers. (a) Those persons designated by the City shall enforce the civil and criminal provisions of this chapter. It shall be a violation of this capture to interfere with an officer in the perfor-

mance of such officer's duties (D) Animai control officer. The mayor an Councilmen shall appoint an animal officer and such other assistants as may be required. The animal control officer and assistants shall be under the supervision and control of the Mayor and Councilmen. It shall be the duty of the animal control officer and assistants to take up and impound all animals running at large, to keep and properly care for all animals impounded, to dispose of animals that have not ned or sold as hereir issue citations or warnings to violators, and to perform such other duties as may be directed by the Mayor and Councilmen under the terms of this chapter

pounded for a period of at least seventy-two (72) hours. At the expiration of said period, it shall be presumed that the owner of said dog or cat has no further title or ownership of the same, and that said dog or cat has become an abandoned animal which may be disposed of by the shelter, as herein provided. The dog or cat may be delivered to any person who will pay the adoption fee and any charges for vaccination shots, if the dog or cat does not have a current and valid vaccination, as provided in Section 21. If neither the owner nor some other person claims the dog or cat, the dog or cat shall be destroyed. Any dog or cat, which appears to be ill, suffering from rabies, mange or any other infectious disease, shall be destroyed.

(b) A record shall be kept of the disposition made of the impounded dogs or cats. Section 20. Procedure When a Person Is Wounded by An Animal

(a) When a dog or cat, which has bitten a human, has been identified, the owner or custodian will be required to place the animal in quarantine. Unvaccinated animals should not be vaccinated against rabies during the observation period. The ten (10) day observation period will begin on the day of the bite incident. The animal must be placed in a TDH-approved facility specified by the local rabies control. However, the owner of the animal may request permission from the local rabies control for home quarantine if the following criteria can be

(1) Secure facilities must be available at the home of the animal's owner, and must be approved by the local health authority.

(2) The animal is currently vaccinated against

(3) The local rabies control or a licensed veterinarian must observe the animal at least on the first and last days of the quarantine period. If the animal becomes ill during the observation period, the local rabies control must be notified by the person having possession of the animal. At the end of the observation period, the release from quarantine must be accomplished in writ-

(4) The animal was not a stray at the time of the bite

(b) A dog or cat which has bitten a human and has been designated by the local rabies control as unclaimed may be humanely killed in such a manner that the brain is not mutilated. The brain shall be submitted to a TDH-certified laboratory for rabies diagnosis

(c) If the biting animal is a high-risk animal, it shall be humanely killed and the brain submitted for rabies testing.

(d) If the biting animal is a low risk animal, neither quarantine nor rahies test will be required unless the local rabies control has cause to believe the biting animal is rabid, in which case it should be humanely killed and tested for rables

(e) The local rabies control may require an animal, which has inflicted multiple bite. wounds, punctures or lacerations to the face, head or neck or a person to be humanely killed and the brain tested for rabies.

(f) If the biting animal is not included in (a). (b), (c), (d) or (e) of this section, the biting animal will be humanely killed and the brain tested for rabies or the local rabies control may fined for a thirty (30) day observation period as an alternate method to killing and testing, otherwise conforming to the requirements delineated in (a). (g) Any animal required to be guarantined under this section which cannot be maintained in a secure quarantine shall be humanely killed and the brain tested for rabies. Section 21. Disposition of Domestic Animals Exposed to Rabies. (a) Unvaccinated animals which have been bitten or directly exposed by physical contact with a rabid animal or its fresh tissues shall be: (1) Humanely killed: or (2) If sufficient justification for preserving the animal exists, the exposed animal shall be immediately vaccinated against rabies, placed in strict isolation for ninety (90) days and given booster vaccinations during the third and eight weeks of isolation. If the animal is under three months of age at the time of the second vaccination, an additional booster shall be given when the animal reaches three (3) months of

(e) It is a defense to prosecution under Subsection (a) (5) of this section that the animal was discovered on the person's property in the act of or immediately after injuring or killing the person's goats, sheep, cattle, horses, swine or poultry and that the person killed or injured the animal at the time of this discovery

Article IV. Penalty. Section 26.

Any person who violates or fails to comply with any provision or provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not less than Ten Dollars (\$10.00), nor more than One Thousand Dollars (\$1,000.00); and any person who said aid, abet or assist in the violat any provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine of not less than One Dollar (\$1.00), nor more than One Hundred Dollars (\$100.00). Section 27. Conflicting Ordinances Repealed.

That all ordinances, orders of resolutions heretofore passed and adopted by the City Council of the City of Deport, Texas, are hereby repealed to the extend that said ordinances, orders or resolutions, or parts thereof, are in conflict herewith.

Section 28. Severance Clause.

The provisions of this ordinance are hereby declared to be severable, and if any section, subsections, clause, phrase or provision of the ordinance is for any reason held unconstitutional or void by a court of competent jurisdiction, such holding shall not affect any valid provision of this or any other ordinance of the City of Deport, Texas. Section 29. Contracts





Section 5. Regulations Relating To Keep-

ing Of Rabbits and Poultry. The following regulations shall govern the keeping of rabbits, poultry and certain birds in the City:

(a) It shall be the duty of any person owning or having within their management or control, any rabbits, chickens, turkeys, geese or other poultry, to keep same in an enclosure upon their own premises at all times. Enclosure shall mean a house or building, or in case of a fence or structure or pen, it must have secure sides, top and a secure bottom. The structure or pen shall provide protection from the weather

(b) No rabbits, chickens, turkeys, geese or other poultry shall be kept in any enclosure within the City, any part of which enclosure is within one hundred (100) feet of any occupied building or dwelling within the City other than the building or dwelling occupied by the owner of the animals.

(c) This section is not to be construed to prevent owners from keeping pet animals inside their residence.

(d) It shall be the duty of every person raising or harboring any rabbit or poultry to keep the enclosure required therefore in a sanitary condition, so that the same shall not at any time become foul or offensive to adjacent neighbors or to the public (e) Failure to comply with this section

shall be deemed a nuisance. Section 6. Vaccination Against Rabies.

(a) Required. It shall be the duty of the owner or keeper of each and every dog or cat kept in the City to have such dog or cat vaccinated against rabies by a practicing veterinarian by the time the animal is three (3) months of age and within every subsequent twelve (12) month period.

(b) Vaccination and tags. A licensed veterinarian shall do all vaccinations of dogs and cats for rabies. Upon vaccinations, the veterinarian shall give to the owner a suitable tag to be placed on a collar around the dog's or cat's neck, and on such tag there shall be stamped that the dog or cat has been vaccinated for rabies, the date of vaccination, the clinic number, and the name and serial identification number.

(c) Certificate. The veterinarian shall issue to the owner of each dog and cat a rabies vaccination certificate. The certificate shall include the following information: (1) Owner's name, address and telephone

 (2) Animal identification. Species, sex, age, size, predominant breed and colors;
(3) Vaccine used, producer, expiration ate and serial number;

Section 15. Duties of Animal Control Officer. The Animal Control Officer or his agent's duties are:

(a) Enter upon private premises to investigate complaints or irresponsibility or inhumane animal care.

(b) Enter upon private premises to apprehend a stray dog or cat, a vicious dog or cat, or a wild creature suspected of being infected with ra-

(c) Apprehend and impound any dog, cat, rabbit or poultry in violation of any provision of this chapter with the City.

(d) Report in writing once each month to the M and Councilmen the total number of dogs and cats impounded, redeemed, adopted or disposed

(e) Watch for, investigate and enforce the provisions of this ordinance

(f) Shall not be responsible for the apprehension or disposal of animals (except for dogs, and cats, rabbits or poultry), rodents, reptiles or insects.

Article 11. Animal Shelter

Section 16. Animal Shelter Established Super-

There shall be provided and/or designated a suitable place for the impounding of all dogs, cats, rabbits or poultry picked up under the provisions of this ordinance, and such animal shelter shall be supervised by the Animal Shelter Manager. When authorized by the City Council, the Mayor or his designee may contract with one or more veterinary clinics or one or more private individuals in Clarksville to keep the impound dogs, cats, rabbits or poultry in lieu of the City. The City shall establish policies and procedu

Section 17. Impoundment of Dogs and Cats In Violation Of Ordinance; Treatment and Care of

mpounded Dogs and Cats. (a) It shall be the duty of the Animal Manager or his agents to impound all dogs, cats, rabbits or poultry, the owners or which, have or are violating the terms and provisions of this ordinance

(b) All dogs, cats, rabbits or poultry picked up and impounded in accordance with and under the terms and provisions of this ordinance shall be dealt with in a humane manner and disposed of in accordance with the terms and provisions of the applicable section of this ordinance. Section 18. Redemption by Owner.

The owner of any impounded dog, cat, rabbit or poultry may redeem such dog, cat, rabbit or poultry at a reasonable time prior to sale or destruction by paying the fees required by the Animal Shelter, and by having on their person and producing a vaccination certificate showing the dog or cat to have been vaccinated within a twelve month period. In the event the dog or cat was not properly vaccinated prior to redemption, the owner shall pay to the operator of the animal shelter an amount equal to the cost of vaccination of said animal, and shall receive from the operator of the animal shelter a receipt certifying that the vaccination fee has been paid. However, any dog or cat suffering from rabies or suspected of having rabies or any dog or cat suspected of having bitten someone shall be kept under observation until such dog or cat has been inspected by a licensed veterinarian and such disease or condition diagnosed by such veterinarian, in accordance with Section

Section 19. Disposition of Unclaimed Impound Dogs or Cats; Record.

(a) Any dog, cat, rabbit or poultry placed in the animal shelter in accordance with the provi-sions of this article shall be kept and so im-

(b) Currently vaccinated animals which have been bitten or otherwise significantly exposed to a rabid animal shall be:

(1) Humanely killed: or

(2) If sufficient justification for preserving the animal exists, the exposed vaccinated animal shall be given a booster rabies vaccination immediately and placed in strict isolation for forty-five (45) days.

(c) These provisions apply only to domestic animals for which an approved rabies vaccine is available

Section 22. Liability of Owners of Impour Animals

The payment of pound fees shall not exempt the owner, or person in control of any animals impound from prosecution under the provisions of this ordinance.

Section 23. Authority of Individuals to Impound.

If any dog, cat, rabbit or poultry shall be found running at large upon the premises of any person other than the owner's, the owner of occupant of such premises shall have the right to confine such a dog, cat, rabbit or poultry. Until he can notify the Animal Control Officer to come and impound the same. Provided, however, that the same shall be done within a onable time. When so notified, it shall be the duty of the Animal Control Officer to cause such dog, cat, rabbit or poultry to be impounded at once

Section 24. Disclaimed Animals

If, for any reason, the owner of harborer of a dog, cat, rabbit or poultry chooses to disclaim ownership of same of same or voluntarily delivers the dog, cat, rabbit or poultry to the animal shelter, this action shall be constituted as a formal acknowledgment of consignment of same to the animal shelter. The owner or harborers shall pay a consignment fee to the animal

Article 111. Cruelty to Animals

Section 25. Certain Actions Unlawful (a) It shall be unlawful for any person to tentionally or knowingly:

(1) Torture or seriously overwork an animal; (2) Fail unreasonably to provide necessary food, care or shelter for an animal in his cus-

tody; (3) Abandon unreasonable an animal in his istod

(4) Transport or confine an animal in a cruel

(5) Kill, injure or administer poison to an imal belonging to another without legal authority or the owner's effective consent:

(6) Cause one animal to fight with another; (7) Use a live animal as a lure in dog race aining or in dog coursing on a racetrack. (b) It is a defense to prosecution under this

ORDINANCE #00-06 AN ORDINANCE AMENDING

ORDINANCE #98-09 TO REDEFINE A JUNKED VEHICLE IN SECTION 1.A. AS STATED IN THE TEXAS TRANS-PORTATION CODE.

WHEREAS, the "Junked Vehicle" Ordinance #98-09 contains a definition of a junked vehicle which is not in compliance with the Texas Transportation Code; and NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY

OF BOGATA:

That Section 1.A. of "Junked Vehicle" Ordinance #98-09 be changed to read as follows and as defined in Subchapter E. Section 683.071 of the Texas Transportation Code

"Junked Vehicle" means a vehicle that is self-propelled and;

(1) does not have lawfully attached to it (a) an unexpired license plate; or

(b) a valid motor vehicle inspection cerificate:

(2) is wrecked, dismantled or partially dismantled, or discarded; or (3) is inoperable and has remained inoper-

able for more than:

(A) 72 consecutive hours, if the vehicle is on public property; or

(B) 30 consecutive days, if the vehicle is on

private property. (Added by L 1995, chap. 165(1); chgd. by L.1999, chap. 746(1), eff. 9-1-99) APPROVED, PASSED AND ADOPTED

There will be lots of prizes and lots of fun. The Easter Bunny will be on hand and everyone is invited to come and bring a friend.






