Rivercrest Begins Second Half District

The Rivercrest Rebelettes picked off the second half of district 20-AA play last week on the right foot by defeating the Redwater Cardinals at Rivercrest Tuesday night. The Rebels ended their first half of district play later Tuesday night in second place by edging Redwater in a close contest.

The Rebelettes took a commanding lead over the lady Cardinals at the outset of the game and led 49-12 at half-time. The Reb fems increased the lead to post a 77-23 victory. Veronica Howerton lead scoring for Rivercrest with 24 points and sophomore post Kim Wilkins added ten. Jean Ann Norman, Jackie Via, and Rhonda Branch each contributed nine points.

The Rebels got off to a slow start and were down by four points at the end of the first quarter. They came back in the second quarter and held a one point lead at half time. The Rebs held on to their slim lead through the third period before pulling away in the final eight minutes to post a 59-52 win.

Junior center David Rozell led scoring with 15 points. Bradley Moore added 12 and Stan Wood and David Wisinger each had ten. The victory gave the Rebs a district record of 5-1 and ended the first half of district play one game behind New Diana. Senior Veronica Howerton led scoring for Rivercrest

with 26 points. Jean Norman added 15 and Jackie Via had eight. The victory brought the Rebelettes season record to 20-2 and the district record to 7-0. The Rebels had a hard time of things as the high-ranked Lions jumped out to an early lead that they never relinquished. The Rebs, playing without forward Stan Wood, were down 34-20 by

half-time. Although the Rebelettes matched the Lions point for point, they could not close the gap and gave the Lions a hard fought 63-48 victory. Bradley Moore led scoring for the Rebs with 17 points. David Rozell had 13 and John Hines added ten more. The loss dropped the Rebs season record to 17-7.

A report for the year ending November 30, 1981, the second year of operations, was given. The year was successful in that the ambulance service was able to continue to furnish a good ambulance service to the county, however, financially it was not a good year in that expenses had exceeded revenues in excess of \$17,000. While revenue had increased slightly, for the 1980-81 year, expenses had increased substantially. The need for additional members is becoming more imperative all the time in order to stay even with the constantly increasing cost of operations.

Subscription Rates For Newspaper Up

In order to cover mailing costs, subscriptions to the Deport Times, Bogata News, Talco Times and Blossom Times will be raised. The U.S. Postal Service has initiated a 35 percent postal rate increase for mailing, and in order to cover mailing costs, subscriptions will now be \$7.50 for any subscription within Lamar, Red River or Titus counties, and \$9.50 for any subscription outside of the county.

Subscriptions only cover the cost of mailing a paper, and the new increase in postal rates has made it imperative for the papers to go to the new rates immediately.

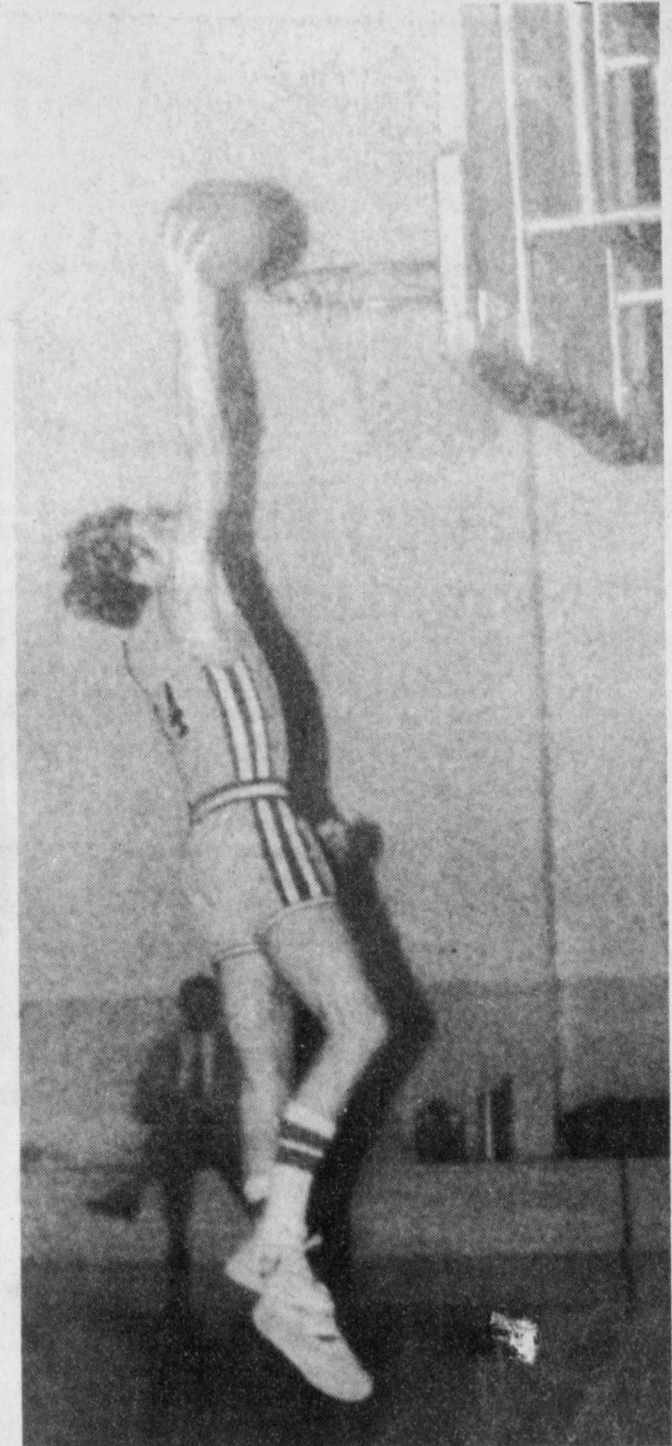

The girls are tied with a 5-2 standing with Detroit for the North Zone championship.

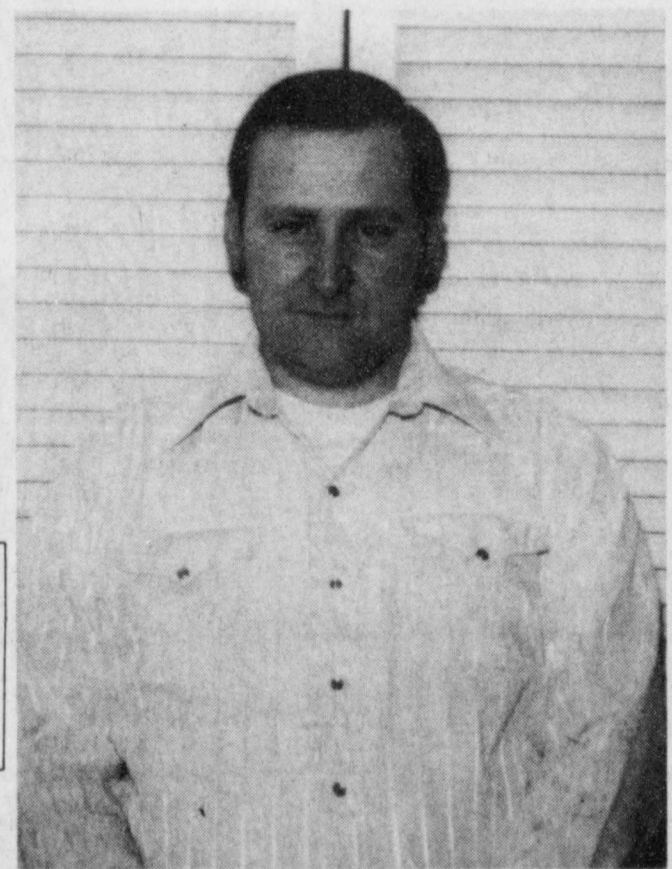

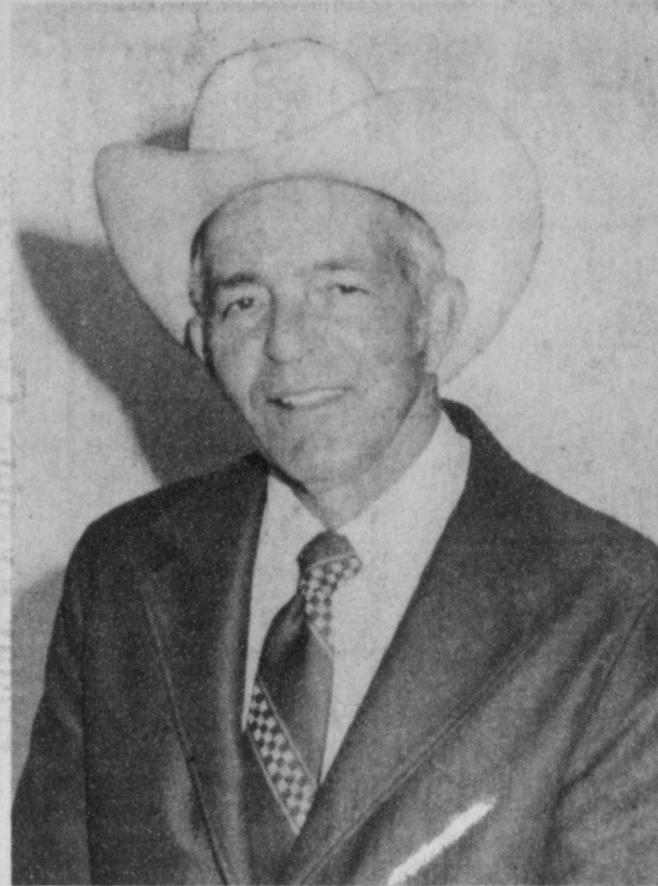
Whitman, 54, is a native of Red River County and attended the Clarksville schools. He is a veteran of six years service with the U.S. Navy in World War II and the Korean War.

General Telephone Propose Rate Increase

A General Telephone Co. proposed rate increase, filed Jan. 29, 1982 with the Public Utilities Commission in Austin, would mean 20% higher telephone bills in Talco and 35% higher bills in Mt. Vernon for basic service.

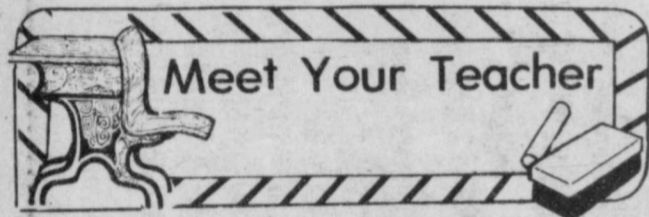
In Mt. Vernon, where there exists extended area service, the local business one-party rate would increase from \$18.30 to \$25.05, which includes a charge of \$3.05 for the ability to dial the Glade Branch (588) numbers. The figure represents a 36.88% increase. A local one-party residence would increase 35.97%, from \$6.95 to \$9.45, including a charge of \$1.35 for extended area service.

In Talco, the rates would increase local residence one-party lines from \$6.95 a month to \$8.30, a 19.42% increase of \$1.35; and would increase local business one-party lines from \$18.30 to \$22.00, a 20.21% increase of \$3.70 a month.

In addition, the company proposes to receive \$30 million from increased intrastate long-distance revenues. Other new revenues would include approximately \$18 million from terminal equipment such as telephones and business systems, and \$5 million from miscellaneous services.

Several other services, for which the company has not been charging, will also be charged to the customer, including service on equipment which the customer could take to a service center and a directory assistance charge. Each customer would receive three free calls a month to take care of new numbers. There would be a charge for each call to directory assistance after the three-call allowance.

None of the rates will go into effect until approved by the Public Utilities Commission.

Lum received his bachelor of science degree from East Texas State University and hopes to get his master of science in May.

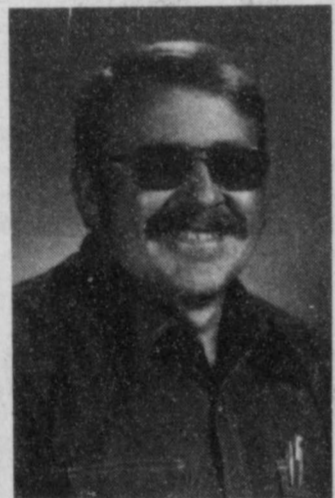
