

Crime Rate Shows Drop For First '84 Half

A 3.7 percent drop in the Texas crime rate was recorded for the first half of this year compared to the same period in 1983, according to statistics compiled by the Department of Public Safety.

Col. Jim Adams, DPS director said the actual number of major crimes reported during the period also declined.

The DPS director said four of the seven major crime categories

registered decreases.

Murders were down 8.2 percent, robbery cases dropped almost 10 percent, and aggravated assaults declined by almost four percent. Burglaries were down 5.1 percent.

The number of rapes rose 11.6 percent, theft cases were up 1.4 percent and motor vehicle thefts increased by 2.7 percent.

Arrests for the period totaled 439,061, a decrease of 4.3 percent compared to 1983. Drug arrests were

up 16.6 percent, totaling 27,888. There were 66,969 DWI arrests in the first half of this year, a decline of seven percent.

Two Texas law enforcement officers were killed in the line of duty by criminal action, while one died as

a result of a job-related accident. A total of 1,751 officers were assaulted while on duty.

DWI arrests for the first half of 1984 totaled 66,959 compared to 71,972 in the first half of 1983.

Rebels Down Cooper Bulldogs

The Rivercrest Rebels traveled to Cooper last Friday night to deal the Cooper Bulldogs a loss, 7-0. The superb defensive play on the part of the Rebs kept the game interesting. It became a scramble to see who would come up with the next fumble...there were eleven in all.

The Bulldogs won the toss and marched down the field to the Rebel 20 yardline. An attempted field goal with 6:51 left in the first period was unsuccessful.

The Rebs first possession was a little shaky as the first fumble of the evening occurred on the first play. An alert Rivercrest squad recovered the ball and advanced to the 39 yard line. A 41 yard punt by Kyle Roland gave Cooper the ball on their own 20.

James Anderson and Kyle Roland put the defensive pressure on the Bulldog offense and on the fourth play of the series caused a Cooper fumble which was recovered by Rebel Charles Lewis. The Rebs took over with 1:46 remaining in the opening period.

Rebel quarterback Bobby Thomas came out passing with a completion to James Anderson for ten yards. Two plays later the Rebs turned the ball over to the Bulldogs. But on Cooper's first try, they handed it right back. James Anderson recovered the fumble on the 41 yard marker with :23 seconds remaining in the first period.

The second quarter was speckled with fumbles and penalties on both sides. There were good defensive plays by Paul Yeatman, Bobby Thomas, Kyle Roland, Bobby Williamson, Charles Lewis and Chris Anderson. The final Bulldog drive of the half was stopped by David Mauldin, Chris Alford and Bobby Thomas. The halftime score was 0-0.

Rebel quarterback Bobby Thomas came out passing with a completion to James Anderson for ten yards. Two plays later, the Rebs turned the ball over to the Bulldogs. But on Cooper's first try, they handed it right back. James Anderson recovered the fumble on the 41 yard line with :23 seconds remaining in the first period.

Charles Roberts carried on the first series of downs by the Rebels in the second half. A holding penalty on Rivercrest forced the punt.

Defensive action by Charles Lewis, James Anderson, Shane Wright and Rusty Screws held the Bulldogs down and the Rebels took over on their own 34.

The Cooper defense was ready for Charlie Roberts, however, and the Rebs had to boot it away. Cooper

started their drive from their 30 yardline.

The Bulldog offense trekked down the field to the Rebel 30 when defensive pressure applied by Shane Wright, Chris Alford, Bobby Williamson, J.D. Wright, James Anderson, Chris Anderson, Paul Yeatman and Kyle Roland caused the Bulldogs to turn the ball over. Jody Thornton came up with the recovery for Rivercrest. The Rebs failed to capitalize on the possession.

Rivercrest came alive following an interception by Bobby Thomas. The penalties came down on the Rebs for 10 yards. A punt by Kyle Roland deflected off a Cooper Bulldog and was immediately confiscated by Rebel Charles Lewis.

The running prowess of Charlie Roberts combined with a 37 yard Thomas pass to Kyle Roland advanced the Rebel squad to the two yard marker. Rivercrest got a little over anxious and a heartbreaking fumble gave control to the Bulldogs.

Cooper however couldn't put the drive together and punted to Rivercrest.

The Rebs were still fired up following the 37 yard reception by Roland in the previous series. It only took one play as Bobby Thomas, with a good front line blocking, let fly with a 34 yard pas to yet again, Kyle Roland, waiting in the endzone. The Rebs led 6-0 with 4:22 left in the contest. The Rebels set up for the extra point and John Easley obliged by booting it between the uprights. Rivercrest held the lead 7-0.

Cooper was frustrated by a fumble on their next possession. Rebel Sammy Wilkerson fell on the ball and Rivercrest began to run time off the clock.

The Bulldogs got one more chance at it but yet another fumble squelched their hopes. The Rivercrest Rebels were on top.

Rivercrest head coach Terry Giddens said "Overall we cut out mistakes that we made against Prairiland. Toward the end of the game, it started to show up. Cooper was quicker and a little bit heavier than we were, but we got our fundamentals down and it paid off in the fourth quarter."

Rivercrest rushed for 76 yards and completed four of seven passes for 85 yards. They received six first downs, lost three fumbles and recovered eight, and were penalized 35 yards. The Rebs punted eight times for 270 yards.

Cooper rushed for 252 yards and completed two of eight passes for 30 yards. They made twelve first downs, lost five and recovered two fumbles, and were penalized 45 yards. The Bulldogs punted three times for 90 yards.

The Rebels will host Mt. Vernon Friday night at Johtown.

Lone Star Revival Set

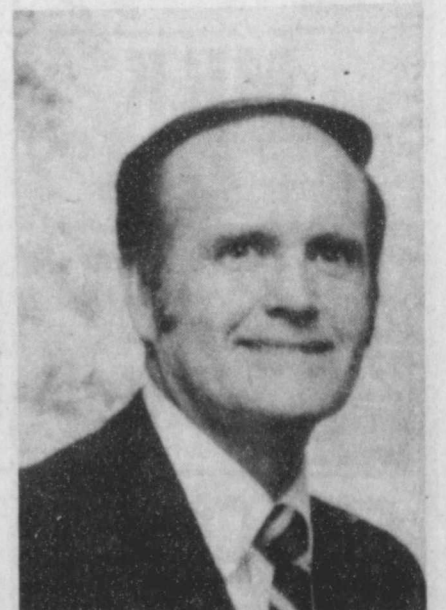
Revival services will be held at the Lone Star church on September 23-28 with Rev. David Coker bringing the messages.

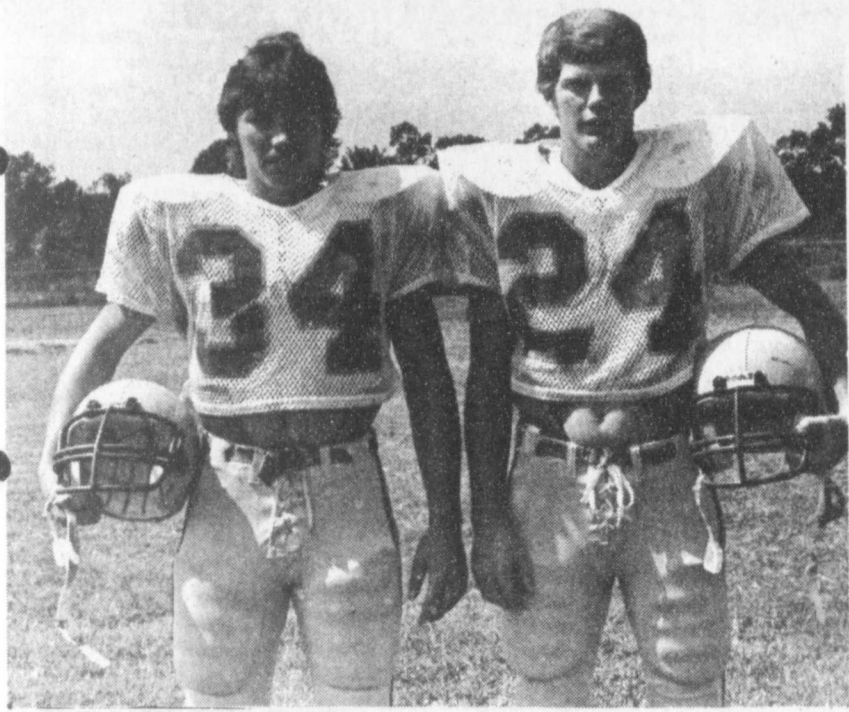

"Pastor Appreciation" Month At Bogata Assembly Of God

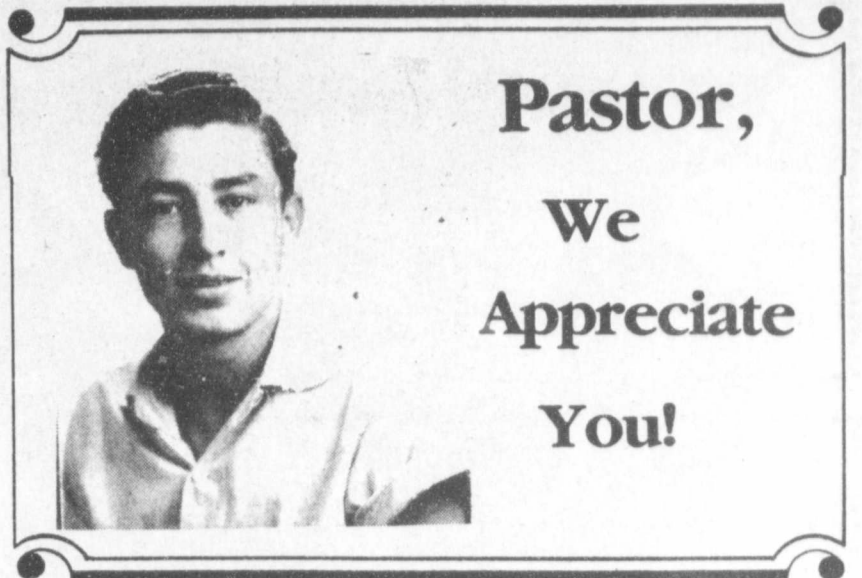
At Bogata First Assembly Church, September has been set aside as "Pastor Appreciation Month". The month also marks the second year for the Escalante family to be in Bogata.

PUBLIC NOTICE

BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 6, 1984

PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 29 proposes a constitutional amendment that provides to state-chartered banks the same rights and privileges that are or may be granted to national banks of the United States domiciled in this state. For example, if national banks become authorized to maintain branch offices, this amendment would extend the same privilege to state banks.

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 19 proposes a constitutional amendment that restructures the Permanent University Fund to provide: (1) for the expansion of the institutions eligible to participate in the bonding capacity of the fund to include the components of The University of Texas and Texas A&M University systems that have been added to those two systems of higher education since the Permanent University Fund was last restructured by constitutional amendment; (2) for the expansion of the purposes for which bond proceeds can be expended from new construction to include major repair and rehabilitation projects and the acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials; (3) for an increase in the bonding capacity from 20% (3/4 for The University of Texas System and 1/4 for the Texas A&M University System) to 30% (20% for The University of Texas System and 10% for Texas A&M University System) of the value of the assets (exclusive of real estate) in the Permanent University Fund in order to provide sufficient bond proceeds to care for the addition of 10 new institutions to those authorized to participate in the Permanent University Fund bonding program and to care for the expanded purposes for which the bond proceeds can be spent; and (4) for the dedication of the dividends, interest, and other income from the Permanent University Fund remaining after payment of principal and interest due on bonds and notes issued, to the provision of support and maintenance (over and above normal legislative appropriations) for Texas A&M University in Brazos County, Prairie View A&M University, and The University of Texas at Austin.

agencies and institutions of higher education which are not included in The University of Texas or Texas A&M University Systems and, therefore, not eligible to participate in the Permanent University Fund bonding program. The amount of this appropriation could be adjusted every five years by a 2/3 vote of the Legislature, but could not be adjusted in such a way as to affect outstanding bonding indebtedness. Each institution of higher education that is eligible to participate (i.e., those institutions of higher education outside The University of Texas and Texas A&M University Systems) would be authorized to expend directly its share (such share to be determined pursuant to an equitable formula) of the \$100 million appropriation for the purposes of acquiring land, constructing and equipping buildings or other permanent improvements, major repair and rehabilitation of other permanent buildings or improvements, and acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials. Additionally, each institution would be authorized to issue bonds backed by a pledge of up to 50% of its share of the \$100 million annual appropriation for the purpose of land acquisition, new construction, and major repair and rehabilitation projects.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to create from general revenue a special higher education assistance fund for construction and related activities, to restructure the Permanent University Fund, and to increase the number of institutions eligible to benefit from the Permanent University Fund."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 65 proposes a constitutional amendment which authorizes the legislature to provide for the payment of assistance to the surviving dependent parents, brothers, and sisters of officers, employees and agents of the state or its political subdivisions, including members of organized volunteer fire departments and members of organized police reserve or auxiliary units authorized to make arrests, who die in the course of performing hazardous official duties. Payments to surviving spouses and dependent children of

such officers, employees, and agents are already authorized by the Constitution.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for payment of assistance to the surviving dependent parents, brothers, and sisters of certain public servants killed while on duty."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 20 proposes a constitutional amendment which abolishes the office of county treasurer in Bexar and Collin counties if a majority of the voters in each of those counties vote in favor of abolishing the office of county treasurer in a local election to be held on the issue. All the powers, duties, and functions of the office of county treasurer in each of these counties would be transferred to the county clerk.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to abolish the office of county treasurer in Bexar and Collin counties."

PROPOSITION NO. 5 ON THE BALLOT

Senate Joint Resolution 22 proposes a constitutional amendment which provides a new method of filling a vacancy in the office of Lieutenant Governor. The amendment requires the President pro tempore of the Senate to call together the committee of the whole Senate within 30 days after a vacancy occurs in the office of Lieutenant Governor. The committee would be required to elect one of its members to perform the duties of the Lieutenant Governor until the next general election. This individual would continue his duties as Senator at the same time that he performs the Lieutenant Governor's duties. If the Senator who is elected ceases to be a Senator before the next general election, another Senator must be elected according to the above procedure to perform the Lieutenant Governor's duties. The President pro tempore would be required to perform the Lieutenant Governor's duties pending the election of one of its members by the committee of the whole Senate.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the state senate to fill a vacancy in the office of lieutenant governor."

PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that permits the use of public funds and credit for payment of premiums on non-assessable life, health, or accident insurance policies and annuity contracts issued by a mutual insurance company authorized to do business in this state. The constitutional prohibition against a grant of public money to an individual, association, or corporation or against becoming a stockholder in a corporation, association, or company has limited life and health group policies of political subdivisions to non-mutual insurance companies. The amendment would permit mutual insurance companies to bid for those policies.

The proposed constitutional amendment will appear on the ballot as follows: The constitutional amendment to permit use of public funds and credit for payment of premiums on certain insurance contracts of mutual insurance companies authorized to do business in Texas."

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 4 proposes a constitutional amendment to change the membership of the State Commission on Judicial Conduct to include one Judge of a Municipal Court and one Judge of a County Court at Law, who shall be selected at large and appointed by the Supreme Court with the advice and consent of the Senate.

The amendment also provides additional grounds for removal from office of judges or justices of Texas courts, and provides additional disciplinary actions that could be taken in lieu of removal or censure. The amendment would extend the Commission's disciplinary authority to masters, magistrates, and retired or former judges who hear cases by designation. The amendment creates a tribunal to review recommendations of the State Commission on Judicial Conduct for removal or retirement of a judge or justice. The review tribunal would be composed of seven (7) Justices or Judges of the Courts of Appeals selected by lot by the Chief Justice of the Supreme Court. The amendment also provides for appeal of the review tribunal's decision to the Supreme Court of Texas and grants an accused judge the right to discovery of evidence.

The proposition will appear on the ballot as follows: The constitutional amendment relating to the membership of the State Commission on Judicial Conduct and the authority and procedure to discipline active judges, certain retired and former judges, and certain masters and magistrates of the courts."

PROPOSITION NO. 8 ON THE BALLOT

House Joint Resolution 22 proposes a constitutional amendment which increases the per diem of members of the Legislature. The amount of per diem allowed during a calendar year would be equal to the maximum amount set in federal income tax statutes as of January 1 of that same year as a deduction for ordinary and necessary business expenses incurred by a state legislator. Current per diem is \$30; the maximum deduction is now \$75.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide a per diem for members of the legislature equal to the maximum daily amount allowed by federal law as a deduction for ordinary and necessary business expenses incurred by a state legislator."

BUDDY'S WORKSHOP
Easy Way to Paint And Use Stairway

What do you do if the stairway that needs painting must remain open to traffic around the clock?
You plan to do it as a two-day job. Paint every other step on the first day. This allows use of the unpainted steps while the new paint is drying. You can do the unpainted steps on the next day. Identify the "dry" steps by taping a piece of white paper to each of them before painting the others.

When washing painted walls in the kitchen or bathroom, is it best to start at the top or bottom of the wall?
Most people start the washing job at the top, on the theory that everything will come clean as they work their way downward. This is sometimes not true. Kitchen or bathroom walls are likely to contain grease spots. If you start at the top, the grease will run down the wall and can stain the dry surface below. Start washing at the bottom, removing everything as you go. Anything that does run down the wall will be easier to remove from a wet surface and is less likely to leave a stain.

Pouring liquid from a large can into a small opening without a funnel can be difficult. But you can make a funnel from heavy aluminum foil or a cone-shaped paper cup. Use two thicknesses of foil and mold it in the shape of a funnel or simply snip off the bottom of the paper cup. Pour with care, whichever you use, to avoid unnecessary spilling through overflow.
