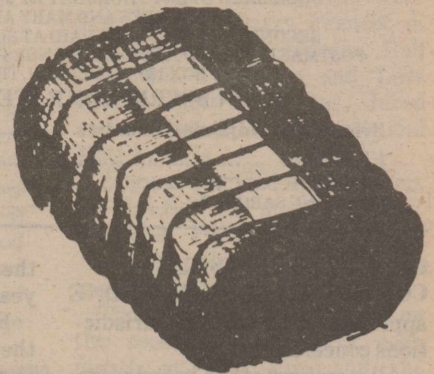

Wreck Kills One, Injures Two

A Bedford woman was killed and her two daughters were injured in a one-car rollover about 2:00 p.m. Friday about 10 miles west of Silverton on Texas 86.

Mrs. Dorothy Petty Carmichael, 41, driver of the car, was pronounced dead at the scene by Silverton Justice of the Peace James R. Edwards, who ruled the death an accident.

Mrs. Carmichael died from massive head injuries, according to the Department of Public Safety officers who investigated the accident.

Her daughters were in serious condition at Northwest Texas Hospital in Amarillo.

Priscilla Carmichael, 11, sustained back and leg injuries. She was transported to Swisher Memorial Hospital in Tulia for first aid by the Tulia ambulance with Tulia and Silverton ambulance attendants, and was transferred to the Amarillo Emergency Receiving Center. She is said to be in stable condition this week, and doing fairly well.

Her sister, Laura Carmichael, 16, had cuts, scrapes and a back injury. She was treated at the scene by Dr. James Chua Tuan of Silverton before being transported to the Amarillo Emergency Receiving Center by the Silver-

ton Volunteer Ambulance Service. She, too, is considered in stable condition this week. Doctors have been allowing her to regain some strength before doing surgery on her.

The DPS said all three were apparently thrown from their 1979 Plymouth two-door automobile which overturned three times.

According to the DPS, the car was westbound on Texas 86 about 1 1/2 miles into Swisher County near the Calvin Shelton farm when it went off the right side of the road. The driver overcorrected, causing the vehicle to veer to the left, run off the pavement and overturn, the DPS said.

Mrs. Carmichael's body was brought to Schooler-Gordon Funeral Home in Silverton, and from there was transferred to Bedford for services.

She received her worst cuts on her right leg, had a broken left leg, head and internal injuries.

County Appraisal District To Waive Fourth Quarter Payments From Taxing Jurisdictions

The board of directors of the Briscoe County Tax Appraisal District met in regular session July 14, and voted to waive the fourth quarter payments by the taxing jurisdictions.

A discussion was carried on concerning the district's surplus funds, which have resulted mainly from expenses being less than were anticipated for 1983. Members felt that the money would

be beneficial to the jurisdictions.

The taxing jurisdictions and payments involved are Briscoe County, \$7,561.20; Silverton ISD, \$9,254.08; City of Silverton, \$775.97; Mackenzie Water Authority, \$775.97; City of Quitaque, \$382.78. appraisal office to the jurisdictions concerned.
All members of the board were present, including Chairman L. B. Garvin, jr., Ray Teeple, Stanley Fogerson, Don Burson and Joe Mercer. In addition, the chief appraiser, Mrs. Carlye Hill, was present.

A financial report was given by Mrs. Hill prior to the discussion of surplus funds in the appraisal district account.

The 1982 collections through the month of June were reported by Mrs. Hill as Briscoe County, 95.1%; Silvertown ISD, 94.6%; City of Silvertown, 84.6%; Mackenzie Municipal Water Authority, 90.0%.

Mrs. Hill reported that all delinquent accounts had been turned over to Perdue, Brandon, Blair & Fielder, delinquent tax attorneys for the appraisal district. Delinquent taxpayers will be receiving letters from the attorneys in the next few days. The 1983 delinquent tax rolls are somewhat more than last year. Motion carried to accept the collections and delinquent tax report as favorable considering

the economic conditions this year.

Following was a discussion of the Budget Hearing held June 23 at which no representatives from the jurisdictions were present. Motion carried to adopt the 1984 proposed budget.

Mrs. Hill reported that the 1983 Board of Review, consisting of Murry Wayne Morrison, John Francis and Clifton Stodghill held its organizational meeting July 5. Officers elected were Clifton Stodghill, chairman, and John Francis, secretary. Members set the date for the Taxpayer Protest Hearings on July 28 from 9:00 a.m. until 2:00 p.m. The ARB approved the proposed ag and market values. Schedules used by the tax office for personal and residential property were examined and approved.

Following examination of the current bills, the motion to pay all bills carried.



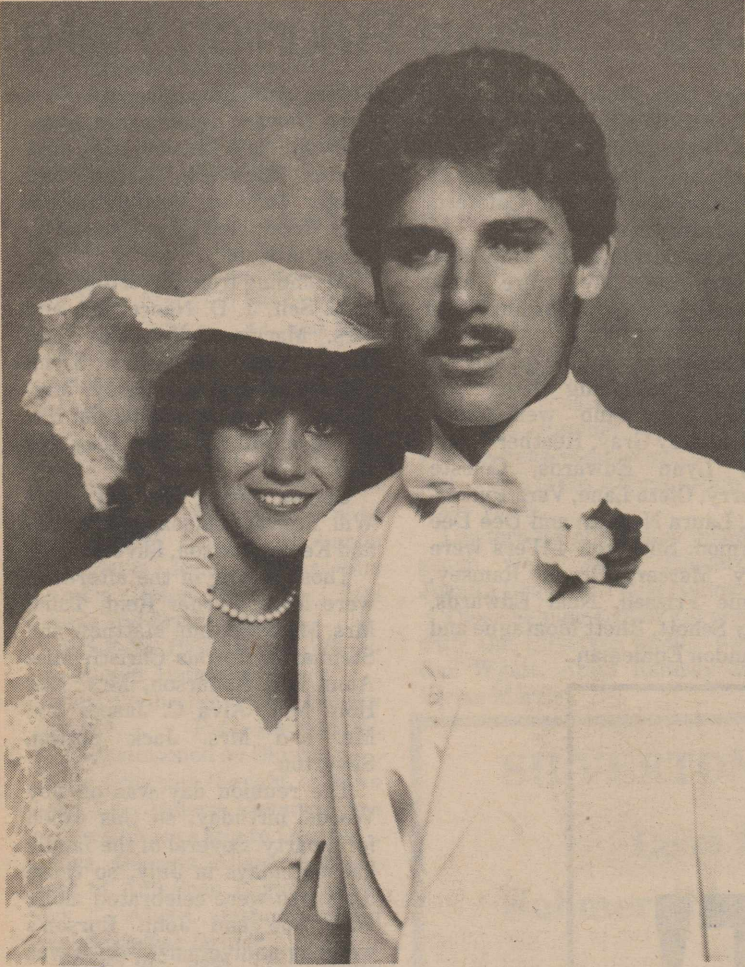

The vows were exchanged before an altar decorated with tiered candelabra accented with greenery.

The bride is the daughter of Mr. and Mrs. Ted Kingery of Silverton, and the parents of the bridegroom are Mr. and Mrs. Dick Roehr, also of Silverton.

Escorted to the altar and given in marriage by her father, the bride wore a gown of white organza, the victorian bodice of which was accented with a high collar of Chantilly lace, a Schiffli embroidered yoke sprinkled with pearls, and a ruffle of Chantilly lace which encircled the yoke. The skirt of the gown extended into a chapel-length train and was sprinkled with lace motifs and embellished with rows of Chantilly ruffles. To complete her ensemble, the bride wore a derby hat accented with lace and fluff maline.



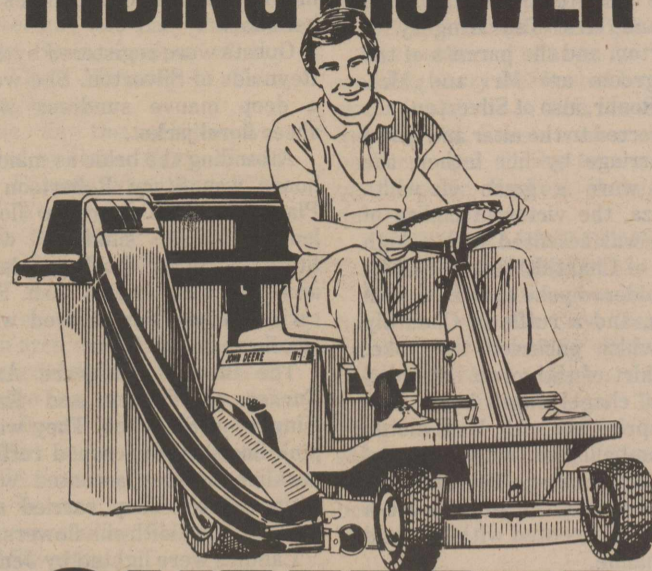

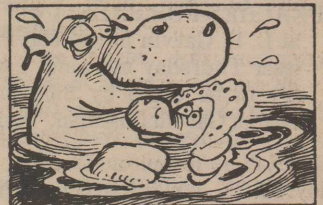
