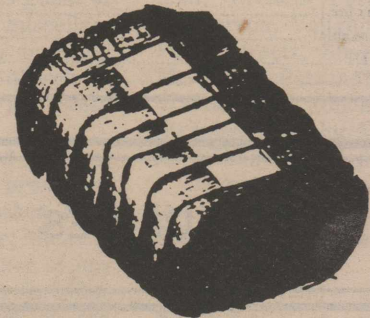

## Owls Are Bi-District Champions! Plans Being Made For Christmas Jubilee

Six-man football district 1-A won two bi-district trophies last Friday night, and one of them has permanent residence in the trophy case in Silverton High School. The other belongs to Three Way, who defeated Guthrie 40-14 while the Owls were destroying Higgins 40-36.

Friday night proved to be one of the most outstanding highlights in SHS football history, as the Owls did what they had to do to redeem an early-season 54-16 loss at Higgins. That early game was played on a very wet and muddy field, and without the services of Sloan Grabbe (who was ill) who adds a lot of punch to the line on both offense and defense.

In their first state playoff appearance since 1947, the Owls jumped out to a 40-6 halftime lead over a heavily-favored Coyote squad, then hung on for the win that sends them against defending state champion Jayton at 7:30 p.m. Friday at Ralls. The Owls had a winning season in 1970 when they were co-district champions with Clarendon; how-

ever, by virtue of Clarendon's victory over the Owls that year, the Bronchos represented the district. The Owls also had a winning season in 1980, but didn't win district.

"Man, that was a sweet one," said Coach Jack Shely following Friday night's trophy presentation. He smiled as he thought about the 40-36 upset victory over Higgins. "That'll teach 'em to ignore us," he laughed.

"We were able to get into our game plan and stay there," the coach said. "Boy, it was wild, though. We've done that all year. We'd get a big lead at halftime and then we'd have to hang on for the win." Shely had his team well prepared. After spending a weekend with Higgins game videos, Shely was able to pick up some tell-tale indicators as to what play the Coyotes were planning to run. "I called the interception and both screens," Shely said in the warmth of his

office.

The Owls won the toss and elected to receive the ball to open the game here Friday night. Todd Reagan picked up a couple of yards on first down, Russell Simpson added a couple yards more on second down, and on third down Simpson went 54 yards to score on a pass from Cal Brannon. Sloan Grabbe kicked the PAT, and with 8:41 remaining to be played in the first quarter, the Owls held an 8-0 lead which they never relinquished.

Higgins started their first possession on their own 35, and

**P-TA Recycling Effort To End November 30**

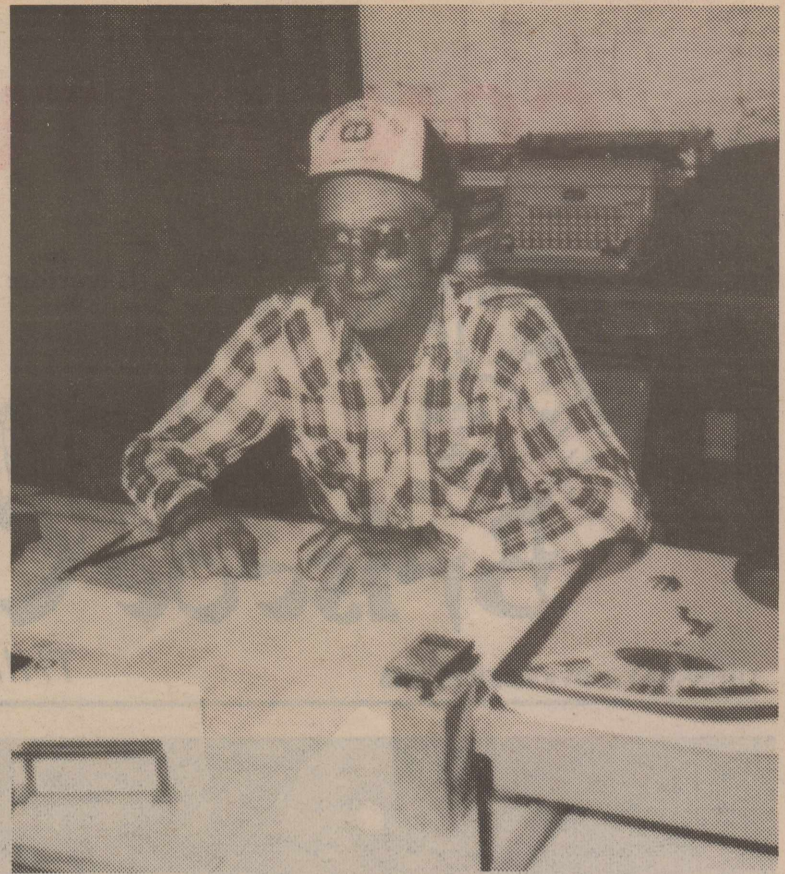

**November 12, 1970**—Owlettes, Queen Bees to play game for charity . . . Louise Croft installed as Worthy Advisor of Silverton Rainbow Assembly . . . Junior High football win dedicated to Mrs. Erma Joy Luhman . . . Silverton Owls in tie with Clarendon for district title . . . In a non-conference contest Sunday afternoon, Dean Burson sustained a broken kneecap. Surgery was performed Wednesday at Plainview. Mrs. Burson is expected to be back in the game in a few days . . . Roger Cantwell honored on birthday . . . From the school news: One day Mrs. Herring got the notion that she should have a pair of alligator shoes. All she could think of was how a pair of alligator shoes would look on her feet. After school every day she would go home and say, "Oh, John, I sure would like for you to get me a pair of alligator shoes." Day, night and any other time she got a chance, Mrs. Herring would ask for a pair of alligator shoes. One day as he was driving along in his country Cadillac (that pickup truck) he saw an alligator walking across the road. He thought, "Now is the time!" He jumped out of the truck and chased the alligator across the field and down the pasture till he caught it. After a considerable battle, he finally defeated the alligator. He turned it over on its back, started in awe and said, "What do you know about that. Not one shoe on this alligator!" . . .

Mr. and Mrs. Jaye Turner are parents of a daughter . . . Shower honors little Donna Eulane Wallace . . .

**November 18, 1950**—WSCS meets with Mrs. Bailey Hill . . . Bale no. 40 turned out on new machinery at the Farmers Gin Wednesday . . . Pastors of the local churches were Rev. Grady Adcock, Methodist; R. L. Bailey, Church of Christ; G. A. Elrod, Baptist . . . Junis Mercer was elected FFA Sweetheart . . . Gay Merrell wrote an article about nicknames in which she said back in the days "when Dick Turner was a sophomore he was a heroic football player and his actions on the field won him the name of 'Fightin' Dick.' Junis Mercer has been going around school com-

plaining because she was so fat everyone is calling her 'Barrell House Bessie.' It doesn't exactly fit, but that is the way of a nickname. Billy Wayne Garvin is better known to the students of SHS as 'WAD.' My guess is that he threw too many paper wads when he was younger. When anyone hails Darrell McWilliams around school they usually call him 'Gunner' or 'Beetle Ears.' Guess how he got the last one! Who in the world is Kenneth Stephens? No one knows but they all know who 'Red' Stephens is because of that flaming top-knot. Ray Savage has a cute nickname—"Lobo." He doesn't want to tell us how that one was

acquired. Everyone calls Eudean Baird 'Sally.' She got this name when she was a mere bratt. And of course Dorothy Heckman is never known as anything but 'Dottie.' I guess everyone knows who 'Pug' is . . .

The only attendants were Mr. Shorty Bingham, Mr. and Mrs. Charlie Oates, jr. and Mrs. Curtis Bingham . . . Mr. and Mrs. Obra Watson, Mr. and Mrs. Sid Richards and Mr. J. S. Watson spent Sunday in Amarillo with Mr. and Mrs. Oneal Watson . . . Jim Bomar who has been ill for sometime has had a relapse of influenza and is very ill . . . Mrs. Henry Heckman and Dorothy Cross were Plainview visitors Sunday . . .

**November 12, 1936**—Lockney falls before Silverton ball luggers . . . Silverton Owls win over

Quitaque Panthers Armistice Day, 7-0 . . . A Quitaque boy was injured when he smashed into a car that was parked too close to the football field . . . On fourth down, Vinson Smith came through with a touchdown through the center of the line. Date Martin ran the left end for the extra point. Fullback Smith received a bad cut below the eye but did not leave the game in the fourth quarter. It ended with not a single penalty for roughing being assessed during the entire game . . . Miss Wilma Sechrist and Mr. Delphine Hunt were

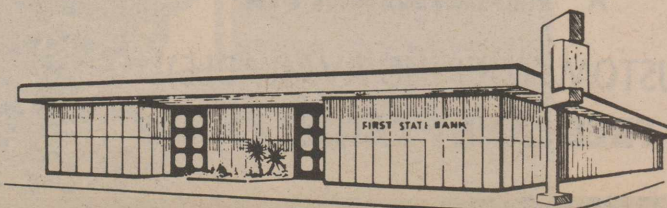

after running a couple of plays fumbled. This was recovered by Reagan on the Higgins 36 with 7:42 still showing on the first quarter clock.

Reagan ran for a first down on the Higgins 11, and after an incomplete pass, Simpson carried the remaining yards for another Silverton score. Grabbe kicked the PAT, and with 7:28 still remaining in the first quarter, the Owls led 16-0.

Higgins came back to pass for a first down on their own 34, the tackle made by Simpson, and added another first down to the Silverton 20, this stop made by freshman Neal Edwards. Then the Coyotes scored with 6:02

remaining in the first period. They missed their conversion attempt, and the score stood at 16-6.

On Higgins' next possession, a fumble was recovered by Simpson. This time the Owls made a first down on the Coyote six before Brannon passed to Grabbe for another score. Grabbe kicked the PAT, and the scoreboard reflected a 24-6 advantage for the Owls with 1:24 still to be played in the first quarter.

The Coyotes gambled on fourth down on their next possession, but the ball went over to the Owls as the first quarter ended thanks to the defense of Brannon. A pass to Reagan gave Silverton a first down on the Higgins 27, and Simpson picked up another first down on the 10. Reagan carried an apparent touchdown with 8:33 remaining in the first half, but this was nullified by an official call. The Owls fumbled and recovered their own fumble at the 12, and Grabbe's field goal attempt at 7:27 of the second quarter was blocked.

Higgins came passing back, and after one incompleton, Simpson intercepted a Coyote pass and ran for another score for the Owls with 7:11 still showing on the game clock. Grabbe kicked the PAT, and the Owls led 32-6.

Higgins' next possession saw

the ball go back to the Owls on downs. Simpson ran for about six yards, and a pass from Brannon to Corey Robertson picked up a first down on the Higgins 35. Reagan ran the rest of the way for a touchdown with 4:25 still remaining on the second quarter clock. Grabbe kicked, and the Owls held a 40-6 lead. Higgins' next possession was ended by a fumble, the recovery made for the Owls by Neal Edwards.

The Owls were unable to move the ball on this possession, and

punted the ball away just before the first half ended.

Silverton opened the second half by kicking the ball out of the end zone for a touchback. Higgins passed complete on first down and went for it on fourth needing a yard and made a first down. Higgins fumbled and Robertson recovered for the Owls on the next play with 8:33 remaining in the third period. Simpson picked up a first down on the 26, and on fourth down, a bad snap from center prevented Grabbe from getting off a kick with 7:04 remaining in the third quarter.

Higgins came back with a first down on the Silverton 10 and scored with 4:24 remaining in the third. Their PAT try was good, and the score was narrowed to 40-14.

The Owls took Higgins kick out to near midfield, and passed to Grabbe for a first down. Another pass was completed to Simpson, but a penalty moved the Owls way back. On fourth down, needing 14, the Owls punted.

Higgins picked up a first down as the fourth quarter began, but on the next play, Robertson intercepted a Coyote pass with 9:10 still to be played in the game. The Owls weren't able to move the ball, and punted on fourth down.

Higgins came back with a first down before going two yards for another score with 6:05 remaining in the game. Their PAT was good, and the score had been narrowed to 40-22.

The Coyote defense was tough on Silverton's possession, and the Owls punted with 5:00 minutes remaining in the game.

Higgins came back to score at 3:06 on a pass play that covered 20 yards. They made good on their PAT kick, and narrowed the score to 40-30. And they weren't through yet.

On Silverton's possession, Higgins intercepted a pass and ran for a 28-yard touchdown with 1:41 remaining in the game. Brannon blocked the PAT kick for the Owls, and the score stood at 40-36.

The hungry Coyotes played good defense and the Owls were forced to punt with 39 seconds remaining. This time, the Owl

defense was very stingy, and forced the Coyotes to return the ball after a pass incompleton on fourth down with eight seconds remaining in the game.

Simpson rushed the ball 26 times for 123 yards and Reagan went 11 for 77. Brannon hit on six of eight passes for a gain of 152 yards and two touchdowns. Reagan caught two passes for 80 yards and one touchdown, Grabbe caught two for 38 yards and one score, Robertson caught one for 20 yards and Simpson caught one for 16 yards. Reagan was credited with 24 tackles, Brannon got 17 and Simpson got 14.

As soon as time expired on the clock, Silverton fans poured onto the field to congratulate their football heroes who were shaking hands with their vanquished opponents. Team members and fans alike were jubilant as the bi-district trophy presentation was made.

Following the making of team pictures and other merry-making, Coach Shely said, "I still think it'll be awful hard for them (Jayton) to prepare for us. They're a darn good team, but they better be ready for us." Jayton demolished Sierra Blanca 50-0 in their bi-district encounter Friday night.

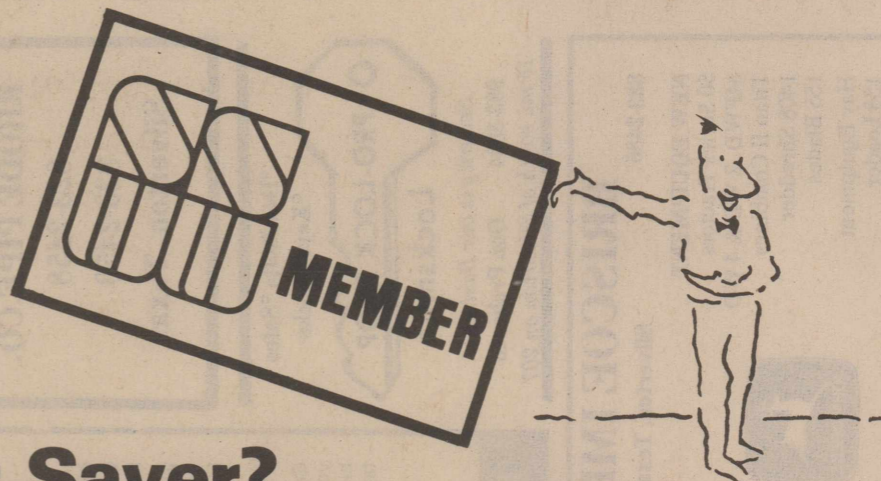

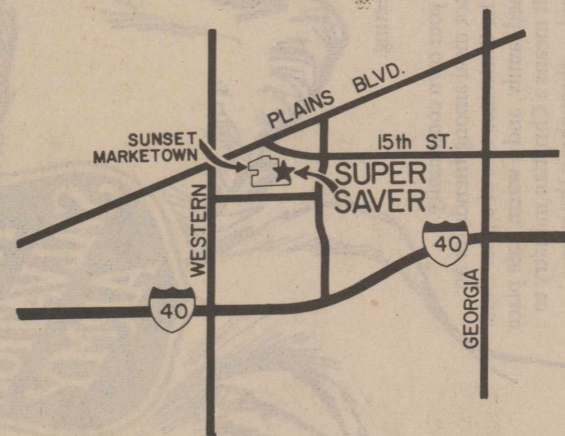

## State Agency To Conduct Public Hearing

The Texas Department of Human Services, the state agency which provides assistance to needy families and children and aged and disabled persons, will conduct a hearing in Amarillo to obtain public comment regarding program directions, budget priorities, and expenditure of federal block grant funds including Title XX and Low-income Home Energy Assistance.

The hearing is scheduled for 1:00 to 4:00 p.m. December 2, 1985. It will be held in the Continental Room, First National Bank, 8th & Taylor. Facilities are accessible to disabled persons and interpreters will be available for deaf or Spanish-speaking persons.

Conducting the hearing will be members of the department's advisory committees and staff of the agency. Comments from individuals, representatives of interest groups, and recipients or providers of agency services will be recorded for consideration by department executives in establishing a program and funding plan for 1987 through 1989.

Almost one out of every nine Texans use one or more department services. During Fiscal Year 1985, the agency provided services for 1.7 million people or about 10.6% of the population. Services include financial assistance, health care, day care, family planning, employment services, nursing home care, community care, licensing of child-care facilities, and protective services.

## Motorist Can Become A Statistic At Thanksgiving Holiday

Major V. J. Cawthon, Regional Commander of the Texas Department of Public Safety, said, "With Thanksgiving approaching many families are thinking about the traditional family reunion with turkey dinner and all the trimmings, but for many, this occasion will end in tragedy because of a traffic accident."

Statistics indicate at least 50% of these accidents will be attributable to the drunk driver. One or two beers may not make a person drunk, but consuming any amount of alcohol will increase that person's odds of having an accident. Add a little speed with these drinks and the results are tragic.

"Almost 98% of all people killed in traffic accidents were not wearing seat belts. Approximately 25% of the deaths and 80% of all injuries could have been prevented if people would just use their seat belts," Major Cawthon stated.

Major Cawthon concluded by saying, "If the motoring public

would use seat belts, child restraints, reduce their speed and not drink and drive, this would go a long way toward keeping this Thanksgiving a pleasant one."

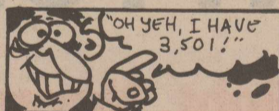
