KC News begins 34th year of publication with big changes


If readers will look at the Volume number at the left hand top of the front page, you will notice *The Knox County News* is beginning its 34th year of publication with this week's issue.

It was Thursday, October 21, 1971, that the first issue of the News was published, beginning another hometown newspaper out of necessity after The Knox County Herald, 66-year-old publication, was closed on October 13, 1971.

A town meeting was called on October 14, 1971, by then Chamber of Commerce manager Doris Crownover and with the pledged support of Knox City merchants, churches and individuals, this 'new baby of Knox County' was established that afternoon, making us 'the oldest established newspaper in Knox County'.

My mother, Billye Angle, who had worked for the previous owner and my father, the late Buddy Angle, 'backed their ears' and took the plunge into the newspaper business, never looking back.

With the help of longtime Stamford American publisher, the late Roy Craig and his wife Dorothy, the two helped, coached, guided, critiqued and molded my mom and dad's efforts of this publication into what I consider the finest there is. Many other area weekly newspapers have come and gone during the last 33 years and we are thankful to have lasted this long and proud every time someone tells us they think we 'are one of the best' !! Things have changed so much in our small community while we have been publishing the NEWS. Through the years, there have been three grocery stores, three dry good stores, two hardware stores, two lumber yards, three restaurants, three cotton gins, two el-

evators, a Dairy Queen, a local cable office, a local WTU office, a local Lone Star Gas office, even the school's 'Little Store' that I noticed was being torn down when I went to take a picture.

But as we all know - things change - lives change - and time marches on.

The News will be undergoing a huge change effective this Friday. Dave will no longer be working here at the News. His medical condition since the accident he was in last year has forced an earlier than expected 'retirement' on him as he can no longer continue with the workload he has had through the years. All of our married lives friends have marveled at the fact that we have been together 24/7 - something that will be a big change for us. We have been married for 23 years and have worked together here at the paper for 22 of those years. He will still drop in from time to time and help us with picture processing until I get the hang of it.


Greyhounds claim decisive 48-14 victory in 'Battle of Highway 222'

The Knox City Greyhounds proved without any doubt that they are still headed for the post season playoffs when they demolished the Munday Moguls, 48-14 at Greyhound Stadium last Friday night. Both teams entered the fierce Knox County rivalry with district records of 0-1 and a lot to prove.

With Munday receiving, Knox City began the 'Battle of Highway 222' with Jeffery Rodriquez kicking the ball down to the Munday 38 yard line.

On Munday's first drive, the first and 10 play was a pass by Bufkin that was called back on an offensive pass interference penalty. The second down play saw another penalty, this time a facemask call against Knox City. On third down, Bufkin threw a pass that was intercepted by Knox City.

The Greyhound's first drive began on the 36 yard line with Greyhound fullback Cody Wainscott gaining 7 yards up the middle. On second down, Riley Spells ran for a KC first down with a 5 yard run. On first and 10, Wainscott picked up another 8 yards running through the middle of Munday's defensive line. On second down, quarterback Andy Shaver kept the ball and picked up a first down with an 11 yard run. Riley Spells thrilled the home crowd with an 11 yard run on first down for Knox City's first touchdown of the night. The score moved to 7-0 when Jeffery Rodriquez kicked in the extra point score.

The Munday kick return was taken by Gulley back to the Munday 48 yard line before Greyhound Jeremy Saxton made the stop. On first and 10, Gulley was hit in the backfield for a one yard loss. On second and 9, a penalty against Munday for holding moved the ball back for a Munday second down with 22 yards to go. The next Mogul play saw a pass by Bufkin to Gulley, the ball was in and out of his hands as he was hit by Greyhound defender Cody Wainscott. An offsides penalty against Knox City gave the Moguls an additional 5 yards. J.J. Collier then ran the ball for no gain. A pass from Bufkin to Gulley resulted in a yellow flag against Munday for delay of game. The next pass from Bufkin to Gulley was overthrown. On fourth down, Grey punted the ball to Knox City. Riley Spells had the home fans on their feet when he took the ball from the 6 yard line out to the 46 yard line.

On Knox City's second series, Riley Spells began the action with a 38 yard following a big block by Derrick Magana. With the ball on the 20 yard line, Cody Wainscott took the ball to the 13 yard line. Quarterback Andy Shaver then tried a pass to Magana, but the ball was deflected at the line of scrimmage. On the next play, fullback Cody Wainscott took a handoff from Shaver, running the ball right through the Munday defense for 13 yards and across on the home side of the scoreboard. Jeffrey Rodriquez kicked in the extra point to put Knox City ahead 14-0 with 3:44 left in the first quarter.

Munday's next possession started off with Bufkin handing off to Gulley, who ran to the 45 yard line while picking up a Mogul first down. A penalty against Knox City for offsides was declined. On first and 10 from their own 40, Bufkin pitched the ball to Gulley, only to have another yellow flag thrown for motion against Munday. On first and 15 from their own 30, Gulley ran for a 1 yard gain. On second and 14, a Bufkin pass to Gulley brought another yellow flag as a pass interference penalty was called on Greyhound defender Quentin Spells. After 15 yards was marked

Thursday, November 11, the 2004 Knox County Veterans Day program will be held at the Veterans Memorial in Benjamin.

A Veterans Day exhibit will be from 9 a.m. to 2 p.m. in the Knox County Courthouse. Photographs and news clippings about veterans of any time period are being sought for the display. A German flag from World War II is needed to show along with a Japanese and an American flag. A Purple Heart medal display is planned and names of any Purple Heart Veterans with a Knox County connection are sought along with wartime or overseas service items. The exhibits will be set up Wednesday afternoon, November 10, after 1:00 p. m. If anyone wants to help orbring items for display, call Clara Brown at 940-474-3288 or the KCHC office at the Benjamin Courthouse 940-459-2229. Posters and essays of the top six entries from area elementary students in the Veterans Day contest will be part of the display.

At 10:30 a.m. on November 11, members of the Munday band will entertain the gathering program audience with a half hour of appropriate musical selections.

At 11:00 a.m. the program will begin with Charles Baker as emcee. Following an invocation and a presentation of the colors, the County Judge will welcome the audience. Next will be the Pledge of Allegiance and the two young speakers reading their Veterans Day essays.

The family of R. Otis Burnett, the Gold Star family, will be recognized and will place a memorial wreath at the arch which is engraved with the names of Knox County veterans who died in battle. Following the playing of "Taps", the program will end with the singing of "The Star Spangled Banner."

Immediately after the program, a beans and grilled hamburger meal will be served at the Benjamin Ex-Students Memorial Center. All profits from the meal will go into the Veterans Fund of the Knox County Historical Commission. Tickets will be \$6.00 a plate. The Veterans Fund is used to help pay for upkeep of the Knox County Veterans Memorial, addition of names, support other veteran related projects, and the growing collection of albums about Knox County Veterans. 
A Dallas club with about 14 or 15 people will be coming here and will be competing among themselves.





Local women enjoy bus tour




Tax Assessor-Collector candidate Bud Hogan issues formal statement to Knox County voters





off, Bufkin handed off to Gulley for a 5 yard gain on first and 10. On second and 5, Gulley again tried to run the ball but was stopped at the 42 yard line for a 3 yard loss. On third and 7, the Munday handoff went to J.J. Collier who lost 5 yards when he was hit behind the line of scrimmage by Greyhound defender Tomas Myers for a 5 yard loss. On fourth and 12, Grey punted the ball out of bounds on the 29 yard line.

Knox City took over their third possession of the game from the 29 yard line. On first and 10, Quentin Spells thrilled the spectators as he took the ball 46 yards to the Munday 25 yard line. On first and 10, a pass from Shaver to Derrick Magana went incomplete. The first quarter ended on the next

With Riley picking up the first down, Cody Wainscott picked up three yards on 1st and 10 from the Munday 8 yard line. On second down, Quentin Spells ran and fumbled the ball, but the Greyhounds were able to recover. On third down, Cody Wainscott scored his second touchdown of the night on a run up the middle. Jefferey Rodriquez missed the extra point kick, but a penalty against Munday for running into the kicker gave Knox City another opportunity for the extra point. With 10:06 left in the first half, Rodriquez kicked the ball through the uprights to put Knox City ahead 21-0.

Knox City kicked to Monday, the ball bounced around before Munday downed it on their 30 yard line. On their first and 10 play, Gulley ran the ball to the 35 yard line. On second and 5, Bufkin pitched the ball back to Gulley, who picked up 3 yards before being brought down by Greyhound linebacker Tomas Myers, On third and 2, Gulley is hit by the Riley Spells for no gain. Facing another fourth down punt, Grey got off a high kick to Quentin Spells, who ran the ball out to the 40 yard line. A penalty back on the 32 yard line against Knox City moved the ball back to the 21 yard line.

On first and 10 with a 21-0 lead, Shaver passed to Magana who ran to the 40, but Knox City had the play brought back with another penalty for holding. A second penalty on the same play was declined and the original holding penalty moved the ball back to the Knox City 11 yard line. On first and 20, the handoff went to Riley Spells who ran 18 yards up the middle, but fumbled the ball. Wainscott recovered the fumble. On their next play, Shaver passed to Ty Chisum for Knox City's ninth first down, this time on the 34 yard line. On first and 10, Shaver threw an incomplete pass to Wainscott. On third and 11, Shaver handed off to Wainscott for a two yard run as the third quarter ended. 




