

## Greyhounds tune out Pied Pipers, 22-12

### District 9A race still hot

The Knox City Greyhounds gave their fans a few anxious moments at Hamlin last Friday night as the Pied Pipers played a tough game in front of their own home crowd.

Riley Spells had another outstanding game for Knox City, scoring two touchdowns and picking up 202 yards while rushing with the ball 20 times on a wet and soggy Hamlin field. Quentin Spells also picked up 102 yards, adding to the Greyhounds total of 332 yards on the ground.

Knox City was the first to put points on the scoreboard with a 28 yard touchdown run by Spells and an extra point kick by Jeffrey Rodriguez. The game stayed just one touchdown apart until Knox City scored again in the third quarter after a 43 yard run by Spells. The kick after by Rodriguez failed.

Knox City scored again in the fourth quarter with a 47 yard run by Spells, but Hamlin also scored two touchdowns in the fourth quarter.

Quarterback Andy Shaver at-

tempted 4 passes with 1 completion to Derrick Magana for 3 yards. Shaver was also intercepted once by Hamlin. Penalties were just about even for both teams as Knox City picked up 69 penalty yards on 9 yellow flags, while Hamlin

had 67 penalty yards on 9 calls.

Knox City will host Rotan this week when the Yellowhammers travel to Greyhound Stadium on Friday night. Kickoff for this important District game is set for 7:30 p.m.



## Good voter turnout expected for next Tuesday's election

*Early voting ends Friday, Tuesday polls open from 7:00 a.m. to 7:00 p.m.*

Tuesday, November 2, is just around the corner and is one of the most important days that we have coming up for a long time, an especially long time if the candidate of your choice does not win.

Interest in the General Election is intense to say the least, and is evidenced by the turnout so far in early voting.

According to County Clerk Ronnie Verhalen as of Tuesday morning, 102 votes had been cast in person, while 37 of the 57 requested ballots by mail had been returned.

*Early voting continues through Friday in the Clerk's office in Benjamin from 8:00 a.m. to 5:00 p.m.*

Polls will be open Tuesday from 7:00 a.m. until 7:00 p.m. to elect a President and Vice President, Members of Congress, Members of the Legislature, and state, district, county and precinct officers.

Voters in Knox City will cast their ballots at either Precinct #7S in the Knox County Aging Center on East Main or Precinct #7N at the Knox City Community Center on South East Third and Avenue B.

Other polling places include Precinct #1 - Benjamin Memorial Building, Precinct #2 - Truscott Community Center, Precinct #3 - Gilliland Baptist Church, Precinct #4 - Vera Community Building, Precinct #5 - Goree Community Building, Precinct #6N - Munday City Hall, Precinct #6S - Munday Community Building, and Precinct #8 - Gillespie Baptist Church.

## Important information for November 2 election day

The Poll Judges and Clerks understand that this process may frustrate voters; however, it has been implemented to achieve more accurate and efficient results in the democratic process.

Readers are urged to get out and vote on November 2 and be a part of the democratic process. Every vote does count! And remember to bring your voter registration card or some other identification to the poll.



## Texas Department of Transportation urges Halloween safety on highways

Halloween should be a time for fun, not tragedy, and this month the Texas Department of Transportation (TxDOT) is reminding everyone to not let Halloween turn into a nightmare by planning ahead and designating a sober driver before attending any Halloween festivities that involve alcohol.

With Halloween falling on a weekend this year, there is a potential for an increase in impaired driving deaths during a holiday that already has a high rate of alcohol-related fatal crashes.

In fact, according to the National Highway Traffic Safety Administration, two-thirds (66.6%) of all highway fatalities across the nation at Halloween in 2003 were alcohol-related.

That's why TxDOT is making a special effort this year to remind everyone to plan ahead and designate a sober driver before all Halloween festivities that involve alcohol.

Please follow these simple reminders for a safer Halloween weekend:

- Plan ahead and designate a sober driver BEFORE you go out partying.

- Don't even think about getting behind the wheel of your vehicle if you've been out drinking;

- Take the keys and never let a friend leave your sight if you think they are about to drive while impaired;

- If impaired, call a taxi - use mass transit -- or get a sober friend or family member to come and get



you;

- Or just stay where you are and sleep it off until you are sober.

And, if you are hosting a Halloween party this year, make sure all of your guests leave with a sober driver.

Impaired driving is one of America's deadliest crimes. Nationally, more than 17,000 people died in alcohol-related highway crashes during 2003. Every 30 minutes, nearly 50 times a day, someone in America dies in an alcohol related crash. Millions more are injured. This means you, your friends and your family are regularly at risk.

But the nightmare of drinking and driving impaired does not end

with the tragic death, disfigurement, disability and injury caused by impaired drivers. Real nightmares can also come from the dozens of other serious consequences that face those who choose to drive impaired.

The consequences if arrested while driving impaired are serious and real and often include jail time, the suspension or loss of a driver's license, higher insurance rates, the embarrassment and humiliation of telling friends, family and employers, plus dozens of unanticipated expenses for attorney fees, fines and court costs, car towing and repairs, time away from work, and many others costs.

It's simply not worth the risk.

Incidents reported include: Open Door - 7, Assist EMS - 2, Loud Music - 2, Assist other agencies - 9, Motorist Assist - 4, Funeral Escort - 1, Civil Standby - 3, Bee Call - 1, 911 Hang-up - 3, Gas Drive-off - 3, Alarm Call - 3, Welfare Concern - 4, Abandoned Vehicle - 3, LZ - 1, Suspicious Vehicle - 3, Rattlesnake Call - 1, Lost Cell Phone - 1. During September 2004, this department received several calls from the following agencies - Central (911) - 67, Sheriff's Office - 28, City Hall - 31. During the month of September, this department has continued with the painting of the

stripes in the downtown area. Also Officer Aaron Lewis graduated from the academy and also passed the state test and now is a full time peace officer, "a job well done".

More violations of weedy lots and abandoned vehicles, violators have been cited, citizens need to check around their house and make sure they are in compliance.

### Proclamation for Breast Cancer Awareness Month

An estimated 13,700 Texas women will be diagnosed with breast cancer in 2004, and about 2,600 women will die of the disease. Nationally, breast cancer is the most common form of cancer in women.

Research shows that breast cancer mortality could be reduced by at least 30 percent if women followed recommended breast cancer screening guidelines.

All women have the chance of developing breast cancer. Women 50 or older are the most likely to develop breast cancer. African American women are the most likely to die of breast cancer than any other group of women. Getting a mammogram and breast exam only once is not enough. The American Cancer Society recommends that women get a mammogram and clinical breast examination every year beginning at age 40.

A woman has the greatest chance of successful treatment if breast cancer is found at an early stage. Early detection practices are part of a good breast health routine. A good breast health routine includes a yearly mammogram, clinical breast examination and monthly self-examination.

Further, Medicare helps pay the cost of a yearly mammogram for women age 40 or older with Medicare Part B.

In recognition of the important lifesaving early detection practices available for breast cancer, I, Charles Lankford, Mayor of Knox City, do hereby proclaim October 2004 as *Breast Cancer Awareness Month*. I urge all Knox City women to become aware that they are at risk and to discuss a screening program with their health care providers, I urge all other Knox City citizens to encourage a woman they love to do so.




