This historic photography session is sponsored by the Red River Valley Museum in Vernon.

Students will be given an orientation and slide show at 8:00 AM at the museum before going on location to historic Doan's Crossing for the photo shoot.

Participants will enjoy a lunch catered from a real chuck wagon. Students will photograph in the field the area around the historic adobe and then go on location to photograph longhorn cattle and return at the museum at 5 pm for a book signing by Wyman, who has two new books titled, "6666: Portrait of a Texas Ranch" and "Windmill Tales". Wyman earned a Bachelor of Science Degree in Wildlife Management from Texas Tech University in 1974. His interest in photography and photojournalism developed and expanded while involved in research at Texas Tech.

His editorial endeavors were first published in 1979 with photos appearing in National Wildlife and Texas Parks and Wildlife magazines. His work has since appeared on over 250 magazine covers including more than 50 national and international covers.

His magazine assignments have included locations such as Mexico, Montana, Canada, Alaska, and the entire state of Texas. He was the official photographer for the historic event in the capture of the last remaining herd of southern plains bison in existence by the personnel of Texas Parks and Wildlife Department.

Mr. Meinzer was voted "Outstanding Alumnus" in 1987 by the department of Range and Wildlife Management of Texas Tech University for contributing to the field of range and wildlife management through writhing and photography.

He was the recipient of the "Distinguished Alumnus" award in 1995 from the School of Agricultural Science Natural Resources at Texas Tech University.

Texas Governor George W. Bush and the 75<sup>th</sup> Legislature of Texas designated Wyman the 1997 State Photographer of Texas. He is a contributing editor to the Texas Wildlife Association Magazine and has been the Keynote speaker for numerous civic and educational organizations. He conducts photography workshops across the state and teaches photography for Texas Tech University in Lubbock.

## Sign-up period for 2005 EQIP funding to end March 18

TEMPLE — The USDA-NRCS in Texas announced that farmers and ranchers wishing to be considered for 2005 funding in the Environmental Quality In-centives Program (EQIP) should make sure they sign up by the close of business Friday, March 18. EQIP was reauthorized in the 2002 Farm Bill to provide a voluntary conservation program for farmers and ranchers that promotes agricultural production and environmental quality as compatible national goals.

EQIP offers financial and technical help to assist eligible participants install or implement structural and/or management practices on eligible agricultural land. In 2005 Texas will receive approximately \$64 million in EQIP financial assistance funds and approximately \$5.5 million in Ground and Surface Water EQIP funds.

"The funds will help farmers and ranchers improve the natural resources on private working lands in Texas," said Dr. Larry Butler, Texas NRCS State Conservationist. "They will be used to solve locally identified resource problems in each county and will also fund special statewide concerns recommended by the Texas State Technical Committee such as water quantity, water and air quality, wildlife habitat, and treatment of invasive species. This program offers cost share and incentives payments to producers applying approved conservation measures."

Butler explained, "Using national and state EQIP priorities, counties working through a Local Work Group chaired by the local Soil and Water Conservation District recommended local resource concerns to be addressed, eligible practices, and cost-share rates and/or incentive payments. This group also recommended cost-share rates for beginning farmers. In 2005, producers who meet the criteria as a Limited Resource Farmer or Rancher can receive 90 percent cost share for eligible practices. The group also recommended an application ranking process to prioritize applications for funding. We have reviewed and concurred in all of their recommendations."

Beginning immediately after March 18, all applications will be ranked and those selected for funding will be approved. A conservation planner will develop a contract and conservation plan for each contract that is approved. Producers who have been awarded contracts can then begin implementing the approved conservation practices this year.

#### An Agenda for a Better America

As great a nation as America is, there are always areas we need to address to manage changes in our economy and society. To that end, I recently joined my Senate colleagues to announce a "top ten" legislative agenda for the 109<sup>th</sup> Congress to set clear goals for the next two years to try to make our country a better place.

First, we are going to beef up our national security and support our military families. I am committed to expanding our resources to respond to bioterrorism and to acquire better technology to help the Department of Homeland Security detect, prevent, and apprehend terrorists.

The families of those soldiers making the ultimate sacrifice for freedom deserve our eternal gratitude. So we will work to increase the military death benefit to \$100,000.

Our top domestic priority is to preserve and strengthen Social Security for future retirees. According to the 2004 Report of the Social Security Board of Trustees, beginning in 2018, the program's benefit payments will exceed the amount of payroll taxes being collected. The time to act is now, because every year we delay makes the cure that much more painful. I support President Bush's plan to offer younger Americans voluntary, personal accounts and we will consider other proposals to ensure this venerable program is there for generations to come.

Also high on our list is legislation to make our tax code fairer, more efficient, and much simpler. Over the past decade the length of the federal tax code has increased by 48 percent, requiring the average American to spend 23 percent more time filing the forms. We must do better. Adopting a less complex tax system will achieve greater, tax fairness and be a significant boon to our economy.

Promoting strong families is another priority. When we passed family tax relief in 2001, including a greater child tax credit and relief from the marriage penalty, we

did so under the constraints of a 10-year limit. Those tax cuts were among the most effective ever passed and generated significant economic growth. Working families really saw the difference in their disposable income. So we want to make this permanent. People need to know that in 2011, they're not going to have to pay \$1,500 more, on average, because the marriage penalty is back. As a Texan, I will also work to keep the sales tax deductible from federal income taxes.

No list of legislative goals would be complete without a comprehensive energy bill. To boost our national and economic security, we must increase domestic energy production as well as our energy efficiency. A good start would be to enhance incentives for alternative energy such as wind, solar, and clean-burning coal.

We also want to sustain the job creation momentum we started with passage of tax relief in each of the past four years. Congress should make these tax cuts permanent to reduce the tax burden on individuals and small businesses and free up investment to create new employment opportunities for all Americans.

Our fellow countrymen also need to be fully prepared to compete in the 21<sup>st</sup> Century. Learning is a life-long process. From pre-school Head Start programs to improvements in primary and secondary education, we want to encourage accountability and results. Addressing the cost of higher education and providing incentives for Americans to enter the teaching profession are key aspects of our agenda as well.

An additional item on our list is to rein in out-ofcontrol class action lawsuits, which prop up costs for consumers and harm the economy. This legislation would establish federal jurisdiction where the amount in controversy exceeds \$5 million and any member of the plaintiff class is a citizen of a different state than the defendant.

We must address problems in our health care system. This includes measures to make vaccines more readily accessible, improve public health preparedness, and increase the availability of affordable health care coverage through association health plans and expanded health savings accounts.

We want to promote families and protect children. The Child Custody Protection Act would strengthen state parental notification laws by making it a federal offense to transport a minor across state lines to circumvent these statutes.

We have a lot to do in the 109th Congress. Together, we can get the job done, which is why my number one priority is always listening to my Texas constituents and representing their views in Washington.

#### **LEARNING BY HAND**

There are some things you can only learn by hand. Imagine reading a book with instructions on how to milk a cow, i.e.,

- 2) Grasp the teat
- 3) Squeeze and pull

The same instructions (with slight alterations) could apply to picking an orange, lancing a boil, cracking a safe or trying to open one of those titanium formed plastic wraps that a new tool or toy comes in.

The cow-milking instructions skip the part about a scoop of grain, loose head catch, cow kicks, letdown, flies, switches with cockleburs, flying manure and the carbs in strawberryflavored tit dip!

I think of the knowledge required when I send my son to the next ridge to check for cows on the other side. Although I've spent hours on end explaining things to him, words alone can't give him a feel for his horse, a sense of where to cross an arroyo, an ability to spot a cow amidst its mesquite camouflage, a caution of "snaky" places, and the increasing confidence that takes him further from me every day.

He continues to increase his cowboy savvy with every ride, every gather and every branding. Every morning when he feeds the horses, the dogs, and the birds, he adds sediment to his sea of knowledge. Knowledge accrued by hand.

There are subjects that can be taught in a classroom like history, pharmacology, social studies or political science, that a student might grasp without 'lifting a finger,' so to speak. But as soon as you drift into chemistry, computer science or agronomy you are forced to participate more than cerebrally to learn the subject. Thus chemistry lab, soil judging, and mouse training.

Is it possible to be a piano teacher and not be able to play the piano? Theoretically, maybe. But most useful skills require a hands-on approach. Children progress from learning how to shovel with a spoon, to whistling, to making that obnoxious sound by placing their hand under their armpit and pumping.

So, while there may be millions of books written on how to improve your golf game, train your horse or flatten your abs, unless you put that knowledge into practice you will never truly learn how. And practice you must; here, let me get my hand inside my shirt and show you.



#### **Rolling Plains Ramblings**

#### **By Morton Scott**

Knox County was among one of the last Texas areas explored and settled by others than Native Americans.

Texas was settled from the Gulf Coast northward and from Louisiana westward.

This pattern continued until limited by dangerous attacks from Indian tribes that ranged across what came to be called Comancheria.

Comancheria was the southern Great Plains, where nomadic plains Indians followed the buffalo. Of these, the Comanches were among the largest tribes.

The Comanches were among the best nomadic horsemen and warriors in history. Comancheria, therefore, is a fitting name for the land the Comanches dominated.

Comancheria was the area spreading from the Rolling Plains to the Llano Estacado, the Staked Plains, of western Texas and eastern New Mexico.

Indians frequently raided isolated ranches and farms. cows and even people from the homesteads. The isolated rider

Indians, too, were defending their through southern New Mexico, the homes.)

The nearest Marshall or Texas Ranger might be days away. Frontier settlers were a rugged people - but often short-lived. Many chose not to risk the dangers. Many tried - but then moved back to civilization.

The only real solution was the United States Army. Washington finally responded to the pleas of frontier families.

In 1849, Capt. Randolph B. Marcy headed an expedition to explore the Canadian River through the Indian Territory, the Texas Panhandle, New Mexico and then continue on through Arizona to California.

His expedition had three responsibilities: (1) to escort 1,500 Forty-Niners to the California gold fields; (2) to conduct a scientific evaluation of the resources of the Canadian River and its environs and (3) to evaluate the Canadian as a possible route for a transcontinental railroad.

When Marcy and his soldiers arrived in Santa Fe, they found Warrior bands would steal horses, his orders changed. He was to turn the '49ers over to other escorts and then to return to Fort Smith might never return home. {The by establishing a military road

Texas frontier and Indian Territory to Fort Smith, Arkansas.

This became known as The Texas Road and later was the first cattle trail north and the Butterfield Stage Coach route.

In 1851 he commanded Gen. William G. Belknap's<sup>qv</sup> escort on a tour to select sites for forts on the Texas frontier.

Sites selected would later include Forts Richardson, Chadbourne, Concho, Bliss, and, of course, Belknap and Griffin and Camp Cooper.

In 1854, Marcy was assigned to pick a Texas site for the first reservations for Comanche and other plains Indians. He chose sites in Young and Throckmorton Counties.

The hope was that establishing a reservation would end Indian raiding, thereby making settlement safe. However, that's another story for another day - probably next week





Participants will enter transactions, learn to categorize transactions by type of income and expense, split and memorize transactions, and to develop meaningful reports. Tips for use will be discussed throughout the course.



## IRS Tax Tip 2005 #2 Taxpayer Rights A Priority For IRS

The law requires the IRS to protect taxpayer rights, and in its dayto-day operations, the IRS and its employees make taxpayer rights a top priority. This includes explaining those rights to taxpayers, keeping taxpayer information private and confidential and being professional and courteous.

Besides what is expected of IRS employees, taxpayers have many other rights. They have the right to have someone represent them before the IRS and to accompany them to any meeting with IRS employees. When there is a disagreement, they have the right to request that the independent IRS Appeals office review the case. Taxpayers who still disagree can put their case before the court system.

Taxpayers who have been unsuccessful in resolving issues with the IRS through normal channels have the right to contact the Taxpayer Advocate by calling, toll free, 1-877-777-4778. The Taxpayer Advocate can offer special help if an IRS action is causing the taxpayer significant hardship.

To let taxpayers know about their rights, the IRS produces Publication 1, Your Rights as a Taxpayer. The Spanish-language version is Publication 1SP. These publications, which highlight taxpayer rights and related IRS programs, are available on the IRS Web site at www.irs.gov or by calling 1-800-TAX-FORM (1-800-829-3676). Information on the Taxpayer Advocate Service is also available on the Web site.

## Give the Valentine gift that keeps on growing

TYLER – For Valentine's Day, nothing says, "I'll love you forever," like red roses.

But even under the best of conditions, that expensive rose bouquet will wilt after a few days, said Keith Hansen, horticulturist with Texas Cooperative Extension.

So how about giving your significant other a gift that will last for years?

"It's easy with a rose garden, or even one well-placed rose bush in a sunny spot in your yard," said Hansen, Extension agent in Smith County.

There are no secrets to enticing a properly selected rose bush into producing beautiful flowers year after year, Hansen said. You do need to provide the plant a few essentials and have basic gardening skills.

"First, the best roses are grown in full sun," he said. "Lanky bushes grown in partial or full shade have few blooms and are much more prone to get serious foliage diseases. Give your plants at least five or six hours of direct sun, preferably early morning sun."

Also, Hansen noted that roses don't do well in poorly drained soils that stay waterlogged after every rain.

"The best rose soils drain quickly, yet remain moist. If you have a heavy clay soil, build a raised bed to provide better drainage," Hansen said. "And whether you have clay or sandy soil, incorporate plenty of organic matter like peat n.oss, decomposed bark, compost, or rotted manure. Correct planting is important as well. Most modern roses, including hybrid teas, floribundas and grandifloras, are "graffed."

"Grafted" means that the aboveground plant and the rootstock are from different varieties. There are many reasons for grafting rose bushes, including adding vigor to a beautiful though weak variety. Not all roses are grafted.

"Antique, shrub and miniature

varieties, selecting the right rose can seem like a daunting task for the beginning "rosarian," said Dr. Brent Pemberton, horticulturist with the Texas Agricultural Experiment Station.

There are, for example, at least 15 categories of roses, from China to old European, a host of colors, several bloom periods, and large shrubs, tree-like roses, miniatures and everything in between

Extension, working with the Texas Agricultural Experiment Station, has simplified the selection process with Earthkind roses.

The Earthkind designation has been given to 11 rose varieties that have been scientifically proved to be adapted to Texas conditions. The Earthkind varieties are more tolerant of diseases, meaning less dependence on chemical treatments and thereby "kinder" to the environment, Pemberton said.

The Earthkind varieties are Pinkie, Knock Out, Carefree Beauty, The Fairy, Sea Foam, Else Poulsen, Belinda's Dream, Mutabilis, Perle d'Or, Caldwell Pink and Marie Daly.

Roses can be selected by characteristics and designation on the Internet at <u>http://horticulture.tamu.edu:</u> 7998/rose/search.html.

Commercial dealers who stock Earthkind varieties can be found at http://aggiehorticulture.tamu.edu/ earthkindrose/links.html.

Texas Superstar rose varieties can also be identified at the site. Superstar roses have been selected for adaptability to the state's conditions too.

Giving flowers as a way of sending non-verbal messages dates back to Europe in the 1700s, Pemberton said Entire volumes were dedicated to the message meant by sending particular flowers.

"For example, a yellow rose meant jealousyl daisies meant loyal love and innocence, and bluebells, humility," he said.
