



Practitioners, like Dr. Finley, provide a preceptorship site that will allow these students to gain knowledge of the many great benefits of rural health care. 
Guests begin to look around the room as he begins to describe the attributes of the recipient before he or she is named.

AUSTIN — A plan to put a string of 200 video surveillance cameras along the 1,200mile border Texas shares with Mexico appears to be moving forward.

On behalf of the Governor's Division of Emergency Management, the Texas Department of Public Safety is soliciting bids from contractors who can install and maintain the cameras and do related work.

The state is calling the proposed line of cameras a "virtual

State Lets Bids On Border Cameras neighborhood watch." That's

because via the Internet, citizens are eventually supposed to be able to monitor the cameras and report suspicious activity.

Meanwhile, through lawsuits, the federal government is pressuring about 50 private landholders to allow their land to be surveyed as possible border fence sites.

But the federal government dropped its suit to acquire fenceable borderland under the control of the University of Texas-Brownsville and Texas Southmost College. The two sides say they will explore nonfence methods to secure the

SBOE to accept Hispanic input

The State Board of Education met March 27 and voted unanimously to accept more input before final adoption of new English reading standards that

will be used for the next 10

The board is scheduled to vote on final adoption of proposed changes to the Texas Assessment of Knowledge and Skills test that students must pass to advance in elementary, middle and high school.

A week before the meeting, board member Mary Helen Berlanga of Corpus Christi and state Rep. Abel Herrero, D-Robstown, said more needs to be done to help students because thousands have struggled with the current reading curriculum.

Berlanga and Herrero asked that the board accept expert input on the learning styles of Hispanic children.

Forty-seven percent of the total number of children enrolled in public school in Texas are Hispanic, Berlanga pointed out.

> Most eighth graders pass reading

Ninety-two percent of Texas' eighth-grade students passed the reading portion of the Texas Assessment of Knowledge and Skills test, the Texas Education Agency reported.

This is the first year that students must pass the eighthgrade reading test in order to be promoted, the agency said.

Auto insurance minimums go up

State law requires people who drive in Texas to be financially responsible for the accidents they cause.

Before April 1, the minimum amount of liability insurance required was \$20,000 for each person injured in an accident, up to a total of \$40,000 for everyone injured in an accident, and \$15,000 for property damage per accident.

And beginning April 1, the minimum amount of liability insurance Texas drivers are required to carry for bodily injury/property damage will be \$25,000/\$50,000/\$25,000.



MOTHERING INSTINCT

For years, New Mexico State University managed a ranch on the Jornada, running Santa Gertrudis' cattle. One of the vivid lessons I learned was the intense protectiveness of the Braymerblood mama cows.

If you stepped into the high-fenced corrals with the mothers and their youngin's, you were asking for trouble. They were big, dark red, rangey and high-horned. When one turned her head and locked you in her gaze, you knew how it felt to look down the barrel of a cannon and see Darth Vader peekin'

In genteel terms, in the cow business that behavior is called 'good mothering instinct.' That's like describing my teenage son's socks as "making a bold statement." The instinct is characteristic in the females of most species, with notable exceptions in the seahorse, the penguin and certain celebrities.

A strong mothering instinct insures the propagation of the species. Couple that with the male instinct to pollinate frequently and it's no wonder there are so many jackrabbits and rich child support lawyers.

But, back to Braymer cows. My Canadian friend Don has raised rodeo bucking bulls for many years. He selects his breeding cows and sires from practicingproven good buckers. Cow

#19-L was a black brockleface Braymer with the face of a gargoyle. Don weaned her calf last fall and put him in a corral to precondition half a mile away. Gargolita (19-L) went apoplectic! She could not see her baby - he was gone! She ran the fence line in the pasture in a bawling frenzy.

Other, more mature cows tried explain why this was done, how weaning was a natural process and when she could expect the soreness in her udder to abate. All to no avail!

TxDOT Observes National Work Zone Awareness Week

AUSTIN - For many motorists, the first word that comes to mind when a highway construction work zone is ahead is "delav," when the word that should come to mind is "caution." Work zones can be hazardous places for motorists as well as construction crews working to improve Texas highways.

In observance of the ninth annual National Work Zone Awareness Week, April 7-11, 2008, the Texas Department of Transportation (TxDOT) is joining the Federal Highway Administration (FHWA) and numerous other state DOT's and national transportation associations to urge motorists to take extra care when traveling in and around work zones.

TxDOT maintains more than 79,000 miles of highway with more than 1,000 construction or maintenance projects underway at any given time. With so much construction work underway, it is all too common for motorists to encounter work zones.

Over 1,000 motorists are killed and 40,000 are injured in work zone-related crashes across the nation each year. In Texas, approximately 150 people are killed annually in highway construction and maintenance zones.

More than four out of every five work-zone fatalities are motorists traveling through the work zones. Speeding and inattention are the most cited causes of work zone crashes, and one in three work zone crashes is a rear-end collision.

"We want motorists to be aware of the safety issues that work zones pose to construction workers and the traveling public," said Carlos Lopez, director of the TxDOT Traffic Operations

Division. "Our goal, as always, is to reduce the number of fatalities that occur in work zones and to remind motorists to do their part to help save lives."

Lopez said everyone should take responsibility for work zone safety, from engineers and planners to drivers and pedestrians. The key to reducing work zone fatalities is as easy as following some simple rules:

· Observe and comply with work zone warning signs. Speed limits may be reduced, traffic lanes may be altered or reduced in number, and people may be working on or near the road-

· Slow Down. Speeding is one of the major causes of work

zone crashes.

- · Don't Tailgate. Keep a safe distance between you and the car ahead of you.
- Keep a safe distance from construction workers and their equipment.
- · Obey flaggers. They are the experts in what is best for safely moving traffic through the work
- · Stay alert and minimize distractions. Dedicate your full attention to the roadway. Avoid eating, changing radio stations, or talking on cell phones.
- Keep up with the traffic flow. Motorists can help maintain traffic flow and posted speeds by obeying speed limit and warning signs and merging as

directed.

- Plan and schedule enough time to drive safely. Check the radio, TV and Websites for traffic information.
- · Be patient and stay calm. Remember that work zones aren't there to personally inconvenience you. Highway crews are working to improve the road so that your future drive will be

USDA Seeks Public Coment On Changes To **CRP Managed Haying And Grazing**

COLLEGE STATION - The U.S. Department of Agriculture today announced that it will hold public meetings in Texas on April 8-9, 2008 on proposed changes to managed haying and grazing on Conservation Reserve Program (CRP) land.

USDA's Farm Service Agency (FSA) will hold a meeting on April 8, 2008 at 9:00 a.m. at the Regency Inn Suites Hotel in Abilene.

The second meeting will be on April 9, 2008 held at the Fifth Season Inn in Amarillo beginning at 1:00 p.m.

FSA is proposing rule changes to the frequency that managed haying and grazing is allowed on land that is enrolled in CRP. Public comments will be accepted at the meeting and the public may also comment on changes to primary nesting season dates, during which managed having and grazing are not permitted.

FSA will consider public comments when it prepares state-specific environmental assessments that will evaluate the

effects of the proposed changes. The environmental assessments will aid USDA decision-makers and the public with an analysis of the benefits and potential impacts of the proposed changes to managed having and grazing on CRP land.

Public comments can be submitted both electronically and by regular mail. They must be received by the close of business on May 9, 2008. 





The Greyhounds came up short in the 0-13 loss to the Tigers.


According to Coach Ball, "The Hounds showed promise throughout the game." M.J. Abila pitched the season opener with 7 strickouts.




Bandy Moeller reachs to tag the Tiger out at third base
