The U.S. Postal Service considering closing about 3,700 post offices over the next year because of falling revenues. In the list of the proposed Post offices to close: Benjamin, Goree, Guthrie, O'Brien, Weinert, Rochester and several others.

budget deficit this year, closing post offices is one of several proposals the Postal Service has put forth recently to cut costs. Last week for example, Postmaster General Pat Donahoe announced plans to stop mail delivery on Saturdays, a move he says could save \$3 billion proposed post office closures, annually.

"We are losing revenue as we speak," Donahoe said. "We do not want taxpayer money. We want to be selfsufficient. So like any other business, you have to make

choices"

Post offices in every announced today that it is state except Delaware are up for closure and will be reviewed according to how much money they bring in, how many hours of work are performed there each day and how close they are to other post offices.

Dean Granholm, the vice Facing an \$8.3 billion president for delivery and post office operations, said the first wave of closings would begin this fall. He estimated that about 3,000 postmasters, 500 station managers and between 500 and 1,000 postal clerks could lose their jobs.



The caravan of around 300 merchants, accompanied by military companies, of the Brazos.

The northwest direction of the expedition took them through many of our surrounding counties, including King, Foard, Cottle and Motley, making this an important and interesting historical topic.

Mark Sunday, August 7, left June 21, from Brushy ty, about 15 miles north of Austin. They came through Wise and Montague Counties, then northwest into Clay and Wichita Counties. They were at the Wichita River near the future site of Wichita Falls, by August 4th. The Wichita River's muddy, reddish waters were mistaken for the Red River. Following the Wichita River they crossed Archer and Baylor Counties entering today's Knox County where they crossed over "the Narrows", the ridge that divides the water flowing to the South Wichita The 1841 expedition from those of the Salt Fork

Cattle Trails Wheat and Stocker Conference to be held

LAWTON, Okla. – The annual Cattle Trails Wheat and Stocker Conference will be held August 5 at the Comanche County Fairgrounds Coliseum, 920 South Sheridan Road, in Lawton, Oklahoma.

This conference is a joint effort between Texas AgriLife Extension Service and the Oklahoma Cooperative Extension Service. The meeting is alternated between a Texas and Oklahoma location each year.

Conference planners expect to provide wheat producers and/or stocker cattle operators the most up-to-date information on topics that influence wheat and stocker cattle profits, said Stan Bevers, professor and AgriLife Extension economist in Vernon, Texas.

The conference will begin at 8a.m. with registration and end at 4 p.m. Registration is \$20 per person which includes educational material, a copy of the Cattle Trails Stocker Conference Proceedings, a noon meal and refreshments. Additional information can be obtained at http://agrisk.tamu.edu.

Producers can register by contacitn an AgriLife Extension county agent, Oklahoma Cooperative Extension county educator, or by contacting either Karen Thompson with the AgriLife Extension district office at 940-552-9941, ext. 217, kethompson@ag.tamu.edu, or the Oklahoma Cooperative Extension district office at 580-255-0546.

"We hope the conference will assist producers in driving their operation to profits," Bevers said. "Producers in this area are facing major issues from varying fronts. Most obvious is the ongoing drought and its impact on production and commodity prices."

Providing information on marketing wheat and cattle during these times will be ever, an overview of the entire marketing environment; Dr. Derrell Peel, Oklahoma Cooperative Extension livestock marketing economist, Still water, Oklahoma the cattle market; and Dr. Mark Welch, AgriLife Extension grain marketing economist in college Station, developing a wheat marketing plan and an update regarding the grains market.

A second front is the current environment in Washington, D.C. regarding the federal budget and its potential impact on the 2012 Farm Bill, Bevers said.

Dr. Joe Outlaw, professor and AgriLife Extension economist in College Station, will provide an update of ongoing discussions regarding possible reductions of agricultural producer's support and safety nets.

Outlaw is also co-director of the Agricultural and Food Policy Center at Texas A&M University and regularly provides legislators with analyses of possible change. Most recently, Outlaw provided testimony to the Senate Agriculture committee regarding the state of the national agriculture economy.

The afternoon session will begin with a panel consisting of four area producers who have experience these multifronted issues and how their operation has changed over the past five years to address these issues. Producers will include Steve Marten, Holliday, Texas; Terry McAlister, Electra, Texas; Dennis White, Ninnekah, Oklahoma, and Jimmy Kinder, Walters, Oklahoma.

The conference will conclude with Dr. Jeff Edwards, Oklahoma Cooperative Extension associate professor and small grains specialist, Still-water, Oklahoma and Dr. Todd Baughman, AgriLife Extesion professor and agronomist in Vernon, Texas, discussing the challenges and successes of dual purpose wheat and varietal updates.

In addition, industry spon-

sors will have their products on display during the event. There will be opportunities during the conference to visit with these respective representatives to discuss their products and how they might fit into your operation, Bevers



The Next Republic of California?

"The last thing I want to do is create a state that's a carbon copy of what we have now," says Republican Riverside County Supervisor Jeff Stone about his recent plan to fix the state of California.

His plan: split the state into two.

If he has his way, the new state would be called South California and would be America's 51st state.

"The latest proposal takes most of Southern California with the exception of Los Angeles and dips into the Central Valley," says former California U.S. House of Representatives' Member Richard Pombo, former Chairman on the House Committee on Natural Resources. "This would create a more conservative state"

A more conservative state is exactly what Stone and many Californians are looking for. Thirteen counties would break away from the state including: Riverside, Fresno, Imperial, Inyo, Kern, Kings, Madera, Mariposa, Mono, Orange, San Bernardino, San Diego and Tulare. The Los Angeles Times reports, "Combined, those counties are home to about 13 million people. Republicans

account for the majority of registered voters in all of those counties except San Diego, San Bernardino and Imperial."

"California may be at the point where something like this desperately needs to happen," Pombo says. "People are talking about this right now because of the state of the government; people are looking for something, a change."

Republican Riverside County Supervisor Jeff Stone's plan isolates much of the coastal area in California. This is the area most conservatives consider to be the reason why the state faces such economic turmoil due to its liberal penchant for high taxes and overbearing regulations. Because of this, Pombo says some people wish the plan for the secession would include more of the state. "If the proposal took in more of the Central Valley, people might take to it more. No one wants to be with the coastal areas."

California faces an 11.8 percent unemployment rate. For perspective, in a three-year time span, California has lost 1.15 million jobs. A big factor of the high unemployment in the state is the high taxes businesses must pay. The fact that businesses, large and small, are leaving the state to find more business-friendly environments is only part of the reason why Stone has proposed

this break up of California.

"Our taxes are too high, our schools don't educate our children well enough, unions and other special interests have more clout in the Legislature than the general public," Stone said in a statement, reported by the Los Angeles Times. "It has to change."

Whether or not Stone's plan is the kind of change California needs or is looking for, the state doesn't seem too amenable to deviate from the status quo.

"We went through the 2010 election and Republican seats were picked up everywhere except California," Pombo says. "The state with the most problems voted for more of the same."

Ironically, on a national level our nation seems to be experiencing the same kind of divide between red and blue states. There is a saying that trends start in California, and the irreconcilable differences cited by Supervisor Stone are seeming played out on a national stage every day in Washington, D.C.

While Stone and others have determined that the marriage in California cannot be saved, many observers in Washington hope that this California trend doesn't spread.

The Chamber of Commerce did a great job on this year's festival. Leslie Moore, Emily Nelson and Mark Tucker (just to mention a


few) deserve a big "Thank You" for a great weekend.





Attention Cattlemen: Changes Announced for Adult Cattle being Sold at Texas Markets

AUSTIN - Effective August 1, 2011 the Texas Animal Health Commission (TAHC) will no longer require brucellosis testing of adult cattle for change of ownership. TAHC will also cease to pay the \$2 per head supplement to markets for the testing. Approximately half of the markets have indicated however, that they intend to continue testing all or some of the adult cattle sold through their markets. For markets wishing to test, they will still be able to receive all the supplies currently being provided at no charge, including the brucellosis card test kits. TAHC inspectors will also be able to run the supplemental testing as usual if a card positive animal is disclosed. TAHC officials strongly encourage voluntary testing of Texas cattle to remain vigilant in keeping Texas Brucellosis

It is imperative to remember that Brucellosis was found in two cattle herds in Texas earlier this year. Approximately 25 card positive (usually false positive) animals per month are detected throughout Texas markets. The secondary test run by TAHC inspectors at markets will usually clear those consignments for sale unrestricted, and only require the card positive animal to be held

"Even though TAHC is undergoing drastic budget reductions, the agency will continue to provide a market inspector wherever cattle are sold to support all of the cattle programs underway," Dr. Dee Ellis, State Veterinarian, said.


A separate issue regarding the identifica-

tion of cattle is also under discussion. Historically all Texas cattle leaving a market have had a USDA eartag in place because they were brucellosis tested there. The official identification of cattle (usually with a metal eartag) is not completely linked to brucellosis testing however. TAHC and USDA rules require official identification on all cattle tested, but they also require the market to record existing official Id's on any adult cattle presented for sale, all dairy cattle prior to movement, any bulls involved with the Trichomoniasis program (including virgins) and Mexican origin event cattle.

It is anticipated that the TAHC will consider a rule proposal in September that may require permanent official identification of adult cattle sold at Texas markets. It is further anticipated that USDA will release in the near future a rule for comment that will eventually require cattle moving interstate to have permanent official identification.

"I am asking all markets for voluntary compliance to continue eartagging adult cattle (or reading existing tags) sold through their markets for the next few months, while the rule making process is in progress," Dr. Ellis stated. Local TAHC regional offices and inspectors will work with individual markets on possible exceptions for extremely weak or old cattle presented for sale in the meantime.

USDA Announces Last Call for Producers to File AGI Forms with the IRS-

Failure to do so Will Result in Interruption of Program Payments

KNOX CITY.TX - July 22, 2011 - Knox County USDA Farm Service Agency (FSA) Executive Director, John Rector, reminds producers that they must submit an Adjusted Gross Income (AGI) verification consent form (CCC-927 or CCC-928) to the IRS as soon as possible in order to maintain eligibility for 2009 and 2010 program benefits.

The consent form authorizes IRS to verify for FSA whether a payment recipient's AGI meets the eligibility requirements for FSA programs. The form became a requirement for payment eligibility beginning with the 2009 crop year, however many program participants have not yet submitted this form for 2009 and 2010 program benefits.

"Producers who fail to file these forms before Sept. 2011 will receive a notice from the National Office stating that the producer is ineligible for 2009 and/or 2010 payments," said Rector. "The producer will be responsible for fully refunding all payments received under programs subject to AGI limitations," he said.

IRS requires written consent from all individuals or legal entities before verification of the average AGI can be provided to USDA. Individuals must submit form CCC-927and legal entities must submit form CCC-928. Without these forms on file, eligible producers will not receive USDA program payments.

Rector further clarifies that these consent forms are required for payments received from the Natural Resources Conservation Service (NRCS) as well as those received through FSA. Completed forms must be returned to the IRS.

with the \$100,000 or so it takes to run a post office, many of them are not even breaking even, Granholm

"We made heroic efforts to take costs out of the system while still providing service," Donahoe said. "[But] the volume continues to drop off, especially profitable volume, like first class mail, and believe me that's what drives this whole thing."

Already the United States postal service has taken action. They have commenced in consolidating mail processing operations, adjusted carrier routes nationwide, consolidated area and district offices, reduced staffing levels at national headquarters and in the area and district offices and sold unused and underused facilities

Freezing executive salaries

The Postal Service has more retail locations --32,000 -- than any other private business in the United States -- more than every Walmart store, Starbucks and McDonald's combined.

In reviewing its retail facilities, the USPS looks at current office needs, proximity of other postal

locations, proximity to budgets. Granholm said alternate access options, the structural condition of the office, lease terms if property is leased, real estate market if property is owned, and retail revenue transactions. Other factors in the review process to be considered are customer access, impact on customer and community postal needs, impact on employees, cost savings, environmental impact and the long-term needs of the Postal Service.

Because many of the proposed closings are in rural areas where there is not another post office nearby, the Postal Service plans to partner with community businesses to create what it calls village post offices -- which will sell stamps and ship packages -- within grocery stores, gas stations, libraries and town halls.

Village post offices will not provide the full range of services, though. Most will not offer custom shipping options, only flat-rate shipping, and few will provide passport services. But because Postal Service staff would not run them, USPS would save substantially on labor costs, which accounts for the largest portion of most post office USPS expects to open about 2,500 village post offices within a year.

In order to oppose the closing of a local office, the process is as follows: A written proposal will be posted for 60 days for comments and will then be sent to the District Manager for approval. The District Manager will determine if proposal is warranted. If warranted, the proposal will be sent to the Vice President of Delivery and Post Office Operations for final decision. That Vice President will make the final decision based on all of the information collected during the study. If warranted, final determination will be posted for 30 days, at which time customers can appeal the decision to the Postal Regulatory Commission. If there are no appeals, the consolidation could occur as early as 60 days after the last date of the posting of the final determination







A child up to 8 years old, unless tailor than 4 feet 9 inches, must ride in a child safety seat.


REAR-FACING SEATS possible, up to the weight or height limit of the seat. At a minimum, keep roar-facing until age 1 and 20 lbs.



FORWARD-FACING SEATS From a minimum of age 1 and 20 lbs until the child reaches the upper weight or height limit of the seat.



BOOSTER SEATS 8, or up to 4 feet 9 inches.



SAFETY BELTS

From 8+ years old or latter than 4 feet 9 inches
