# **Festival** set to begin Friday

With apologies to pop singer Pink, the Knox City Chamber of Commerce is about to say what everyone in Knox County has been waiting to hear ... let's get this party started.

The 23rd Annual Knox City Watermelon Festival is scheduled to begin its run this Friday. The event will continue throughout the weekend.

The action will get under way Friday evening with the annual parade.

"Everybody please make plans to attend this year's Watermelon Festival Parade this Friday to kick off the festivities," said parade chairman Michelle Stanfield.

All float entries need to be in front of the Knox City City Park at 5:30 p.m. to begin sign-ups. Knox City head coach Charles Steele reminded all high school athletes to be at the park by 5:30 p.m. so they could participate in the event.

Stanfield said individuals that did not wish to participate in the parade should grab a spot anywhere along the parade route downtown and cheer. The parade will begin winding its way through the town at 6 p.m.

Lt. Capt. James Doolittle once said, "There is nothing stronger than the heart of a volunteer."

The Knox County Hospital District Auxiliary, The Pink Ladies, have again donated \$15,000 for the refurbishment of an ambulance.

Funds are raised through the resale of donated clothing and small household items. The organization is staffed by volunteers who contribute many hours each year to raise funds for the purchase of equipment for the Knox County Hospital District.

KCHB president Clint Jones said the hospital district is lucky to have the Pink Ladies' help.

"Every dollar raised by this remarkable organization ultimately touches the lives of our citizens," Jones said. "We are very fortunate to have volunteers who so tirelessly support us".

Stationed in Munday, the ambulance was placed in service on June 28.

As part of the upgrade, the patient compartment of the old ambulance was refurbished and remounted onto a new chassis.

"Over the last 12 months the Pink Ladies have donated over \$45,000 toward equipment purchases," said KCHD administrator Stephen Kuehler.

"I commend them for 32 years of dedication and commitment to rural health. Many of our purchases would be impossible without their assistance."

Funding provided by the Pink Ladies was partnered with a grant from the Texas Department of State Health Services to make the remount possible.

# **Voters reminded to** go to polls on July 31

It's time to go to the polls ... will vote at Knox City Aging again.

Knox County residents are urged to remember to vote in the Joint Run-off of the Primary Election on Tuesday, July 31. Residents must vote in the same Primary Party that they voted in the May primary election. However, if you did not vote in May you can cast a ballot in the party of your choice in the run-off. Please bring your Voter Registration Card.

Both the Republicans and Democrats are voting at the same polling places. The precincts have been combined into the four county commissioners' areas. Precinct 101 Center. Precincts 201 and 202 vote at the Benjamin Memorial Building. Precincts 301 and 302 vote at Munday City Hall. Precinct 401 votes at Munday Community Center.

Both parties are voting for U.S. Senator. The Republicans are also voting for Railroad Commissioners and Texas Supreme Court Justice. The winners of the races will be on the General Ballot in May.

Your vote will make an impact on the final results because so few tend to vote in a run-off.

Early voting at the Courthouse in Benjamin ends Friday, July 27.



# **Texas AgriLife Extension: grasshopper** problems in region likely to get worse If you've got grasshopper wild host plants - weeds and after they reach the adult stage, Irrigated cotton looked better.

problems now, you're probably going to continue to have them until this fall, said a Texas AgriLife Extension Service entomologist.

Grasshoppers are long-lived; they're with us most of the summer, and growers are still battling them, said Dr. Allen Knutson, AgriLife Extension entomologist, Dallas.

Some producers have already had to re-treat two or three times to protect crops, Knutson said.

And because grasshoppers thrive in hot weather, the problems they pose to crops will likely get worse before they get better, he said.

"As we get into the hot, dry summer, more and more of their wild grasses — dry up, and that forces them into our crops, especially irrigated fields," he said.

High grasshopper populations are tied to drought for a number of reasons, according to Knutson. The first grasshopper hatch was earlier than normal because spring warmed up sooner than normal. And because many areas had a dry winter, a fungus, Entomophthora grylli, that usually causes high grasshopper mortality was not as prevalent in many areas.

He noted that if producers in a particular area didn't have an early grasshopper population boom, they're unlikely to see one later in the summer. Though grasshoppers live two months or they are homebodies, rarely travelling more than a few miles from where they were hatched.

AgriLife Extension district reporters compiled the following summary for the Rolling Plains region. "The region remained extremely hot and dry. Without rain soon, it was predicted this year's dryland cotton crop will fail. The only cotton left in the region was under irrigation. Dryland cotton was only about 6 inches tall, with some plants already starting to bloom.

but without rain soon, much of it will likely fail too. Peanut producers reported an averagelooking crop with little disease pressure. Producers worried irrigation wells may fail early. They were pumped hard last year, and there hasn't been enough rain this year to replenish the water table. Rural communities were also beginning to have water-well problems. Ranchers weren't any better off as pastures were playing out fast with no grazing left for cattle. Some were providing supplemental feed on a daily basis, while others continued to ship cattle to sale barns or out of state.

### **Area farmers** eligible for FSA disaster loans

Several area counties have been declared eligible for Farm Service Agency (FSA) disaster emergency loans on July 12, 2012. Generally, that means that farmers who have lost at least 30 percent of their production caused by drought Jan. 1, 2012 are eligible for FSA loans. Proceeds from crop insurance are taken into consideration when determining eligibility.

FSA Farm Loan Manager Kelley R. Boone, is urging farmers who are interested in receiving an emergency loan to submit their applications into FSA as soon as possible. Kelley R. Boone said, "We hope farmers will get their applications in early rather than waiting until near the deadline, which is March 12, 2013 The longer they wait, the more chance there is for long delays

determine the resource concerns and needs of the area and how to best address those needs. The NRCS and their local conservation partner, the Wichita-Brazos SWCD, provide agriculture producers with professional consultation and financial assistance through Farm Bill conservation programs to apply conservation practices on their land that address soil erosion and health, water quality and quantity issues, as well as wildlife habitat.

The Local Working Group includes community agricultural producers, owners/operators of nonindustrial private forest land, professionals representing agricultural and natural resource interests, and individuals representing a variety of disciplines in the soil, water, wetland, plant, forestry, and wildlife sciences who are familiar with agricultural and natural resource issues.
