## **Council votes to move to Stage 2 of drought plan**

The Knox City City Council turned up the alarm level a notch at its recent meeting in regard to the ongoing drought conditions. At the urging of the North Central Texas Municipal Water Board, the council voted to elevate the drought status to Stage 2.

The elevation of the drought stage, local residents will face stricter water usage guidelines, including the limitation of watering landscaped areas (lawns) with hose-end sprinklers or automatic irrigation systems only two times per week. No watering is allowed from 11 a.m. to 6 p.m.

Stage 2 is the conservation of water. The and all restaurants will be required to measure, city officials hope, will reduce the overall daily water consumption by approximately 15 percent.

In addition to limited water of lawns, residents are prohibited from washing any car, motorbike, boat, trailer, airplane or vehicle except between the hours of 7 a.m. and 9 a.m. and 6 p.m. and 8 p.m. on designated watering days, nor are residents allowed to fill, refill or add to any indoor swimming pools, wading pools or Jacuzzi-type pools except on designated watering days.

Also, the operation of any ornamental fountain or pond for aesthetic or scenic purposes is not allowed, except

> According to NCTMWA representative David Kuehler, the Miller Reservoir has been strained recently due to high temperatures and water consumption. Kuehler said that it is hard to project a definite time on water levels frame because so much depends on the weather.

> According to Kuehler, during the first six months of 2011, 4,500 acre feet of water left the lake via evaporation and use, and during the first six months of 2012, 2,072 acre feet of water left the lake via evaporation and use. The sale of water during both points were about

However, he noted that during the week of June 24-July 1 of this year, the lake lost 234 acre feet, and during the week of July 23-30, it lost an additional 103 acre feet of water. As of midnight on July 29, the Texas Water Development Board indicated the lake has 7,481 acre feet of water remaining.

When asked about evaporation, Kuehler said that there is an average of about an 80 percent evaporation rate from the lake, meaning that of every 1,000 gallons of water that leaves the lake, 800 gallons are lost due to evaporation. To further illustrate this, in June of 2011, 747 acre feet of water was sold. In June of 2012, 692 acre feet of water

was sold, so sale of water has remained about the same.

Kuehler said records show that the level of water in Miller Creek has gone down every week from October 1, 2010 and during all of 2011.

In this year through July 30, there have been two weeks where the water level stayed the same and two weeks where it increased marginally. The rest of the time, the water level decreased.

Even though there has been some rain recently, there was no increase in water in the lake. The water did, however, fill up some tanks and ran in some creeks, but little, if any, made it to the lake.

## **Tax-free** weekend set for Aug. 17-19

In 2012, Texas shoppers get a break from state and local sales taxes on Aug. 17-19 — the state's annual tax holiday. Lay-away plans can be used again this year to take advantage of the sales tax holiday. As in previous years, the law exempts most clothing, footwear, school supplies and backpacks priced under \$100 from sales and use taxes, which could save shoppers about \$8 on every



\$100 they spend.

Retailers will not be required to collect state and local sales or use tax on most footwear and clothing that are sold for less than \$100 during the holiday. The exemption applies to each eligible item that sells for less than \$100, regardless of how many items are sold on the same invoice to a customer. For example, if a customer purchases two shirts for \$80 each, then both items qualify for the exemption, even though the customer's total purchase price (\$160) exceeds \$99.99.

The exemption does not apply to the first \$99.99 of an otherwise eligible item that sells for more than \$99.99. For example, if a customer purchases a pair of pants that costs \$110, then sales tax is due on the entire \$110.

The exemption also does not apply to sales of special clothing or footwear that the manufacturer primarily designed for athletic activity or protective use and that is not normally worn except when used for the athletic activity or protective use for which the manufacturer designed the article.

Yuck!




I wasn't really worried about what they could see in the scan. I like to see people laugh.

- A magic marker.


Two quarters and nine pennies.
