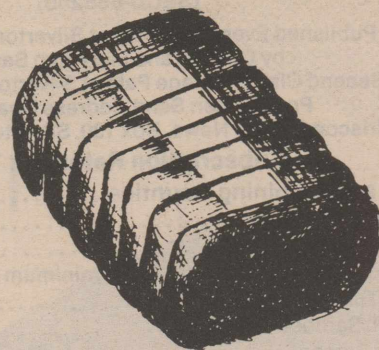
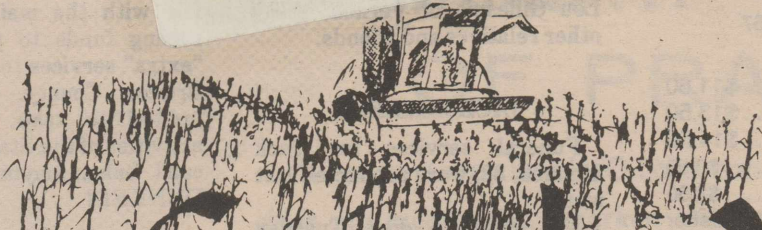

Beginning June 1, representatives from the Texas Agricultural Statistics Service will begin contacting farmers and ranchers across the state to help set the 1990 planted acreage estimates and midyear livestock inventories.

State Statistician Dennis Findley emphasized that information from these surveys will help

producers adjust their production and marketing plans for 1990. "Good marketing requires good information and advanced planning. Information from these surveys will provide Texas producers with solid facts and figures they can use when making their marketing plans.

"There are many uncertainties facing agriculture," Findley added, "and accurate, reliable figures will give producers a chance to make sound production and marketing decisions during the coming year."

Results of the confidential interviews, conducted by telephone or in person by field enumerators, will be published later this summer. The 1990 planted acreage report will be released June 28 and the U. S. cattle inventory will be released July 27.

To reduce survey costs, Findley is urging farmers and ranchers to return the mailed questionnaires as soon as possible. Individual reports will be combined with other reports to state estimates.

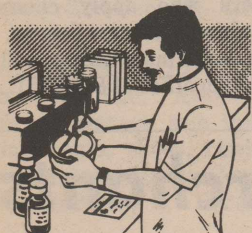

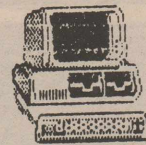

June 4, 1970—Rain, hail destroy crops southwest of Silverton . . . Silverton's protest was upheld, and the National Baseball Congress ordered a rematch, stating that the game should start at the point of the protest and that the batter and pitcher be the same as at the time of protest. At the time of protest the score was tied at 7-7. No runs were scored by either team in the eighth inning, but Silverton put the game on ice in the ninth inning by pushing across five. Bill Satterfield hur-

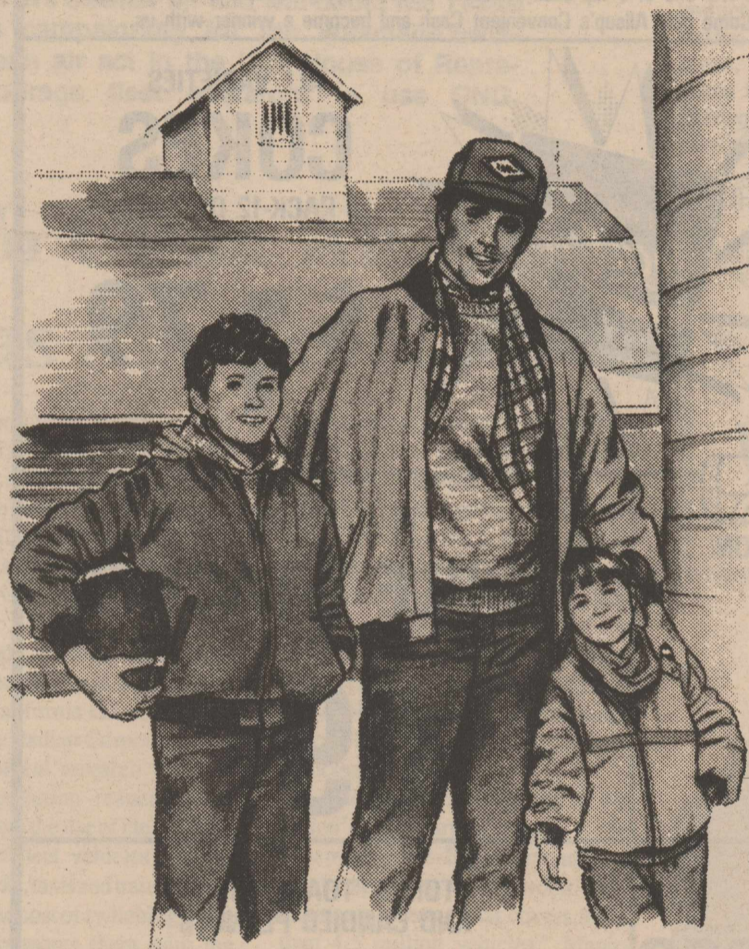

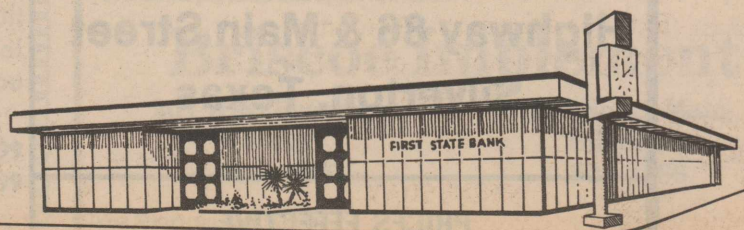

**PROTECT YOUR CHILD
 IN THE CAR**

If you think child car restraints are confining, what about a body cast—or a coffin?

Observation surveys in 34 rural Texas counties show that three out of four rural children ride unrestrained or incorrectly restrained. My personal observations have noted mothers holding infants on their laps while driving, children standing up in pickup and car seats and between car seats, and children left unrestrained in automobiles with the motor running at the post office or grocery store.

Parents, your infant or child cannot buckle up himself. YOU are the only one who can protect him. Grandparents and child care people, too, need to take responsibility for buckling up the children in their care.

Have you ever stopped to think that your child could become a human missile if you had to make a sudden stop or if someone ran into you? It is not humanly possible to restrain a child with your arms. If they are riding in your lap, they could be crushed between you and the steering wheel or dash.

The Texas Highway Department has determined that rural Texans are not buckling up their children in child safety seats or seat belts and have asked the Texas Agricultural Extension Service to use their extensive educational network to manage the Rural Child Passenger Safety Education Project. In the first year of the project in 34 rural Texas counties, 72.8 percent of the 4,891 observations showed children either rode unrestrained or incorrectly restrained. The survey found that parents driving pickup trucks were significantly less likely to restrain their children.

I realize that the cost of correct child car safety seats can be prohibitive to many families. Some communities have a child safety seat loan program. If you have an approved child car safety seat you no longer use and would loan it to some other family, call me at 823-2131. It might be that one of the clubs in each community would like to take this on as a community service project.

There are probably many seats out there being stored in garages, closets, or attics that could be loaned to another family for a short period of time or to a grandparent who has a little one coming to visit. I will be glad to coordinate such a project or assist a club in organizing a loan program if there is interest and cooperation from the communities.

Let's protect our future generation by helping encourage young families to buckle up their children and by providing them a loaner car seat if they are unable to purchase one.

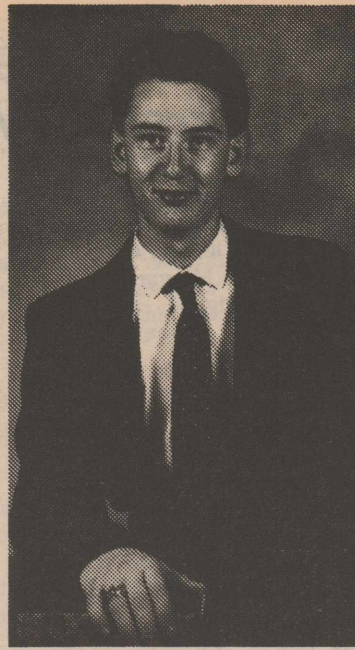

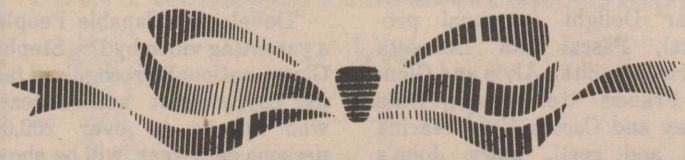

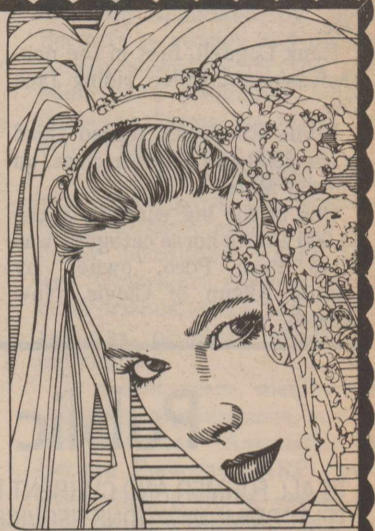

Each of the high-pointers took home trophies from the National Cutting Horse Association-sanctioned event. The results reflect their cumulative efforts during three days of competition in South Plains Fairgrounds Livestock Pavilion.

Dick Cogdell, first in the open division, riding Double Dixie Doc.

Rank Cogdell, first in the non-professional division, riding Jack Cee.

Eddie Rhoderick placed third in the \$500 novice rider class, on Thirsty Mate.

One of the big winners in the \$3,000 novice horse category was Tivio Poco Poco, owned by Lonnie Allsup of Clovis, New Mexico.

May Weather is Cooler, Drier Than Normal

The weather across the Texas South Plains during the month of May 1990 turned out to be both cooler and drier than the long-term averages.

Temperatures averaged 0.8 degree below normal and ranged from 1.4 degrees above normal at Post to 2.1 degrees below normal at Paducah.

Maximum temperatures averaged 0.1 degree below normal and ranged from 2.6 degrees above normal at Post to 1.4 degrees below normal at Floydada. The highest temperature reported during the month was 105 at Paducah on the 26th. Silverton's maximum temperatures averaged 79.9 degrees, which was 2.70 degrees below the South Plains average.

Minimum temperatures averaged 1.5 degrees below normal and ranged from 0.8 degree above normal at Lubbock to 4.2 degrees below normal at Tulia. The lowest temperature reported during the month was 33 at Dimmitt, Muleshoe and Tulia on the morning of the 5th. Silver-

ton's minimum temperatures averaged 48.8 degrees, which was 2.80 degrees below the South Plains average of 51.6 degrees.

Precipitation averaged just an inch which was 1.64 inches below normal and ranged from 0.15 inch above normal at Spur to 2.79 inches below normal at Snyder. While most of the month was dry, the precipitation occurred during the first two to three days of the month and again during the last two to three days. One positive aspect of the dryness was that soil temperatures warmed rapidly during the first of the month and when coupled with above normal rainfall for the previous four months of the year. Farmers were able to plant area crops somewhat earlier than in the past few years.

Silverton received 1.82 inches of precipitation, which is .82 of an inch above the South Plains average and 1.29 inches below the 45-year history for Briscoe County.

Spring Cooler, Drier Than Normal on Texas South Plains

Spring across the Texas South Plains in 1990 turned out to be both cooler and drier than normal.

Temperatures averaged 0.5 degree below normal and ranged from 0.1 degree above normal at Post to 1.7 degrees below normal at Plainview.

Maximum temperatures averaged 1.7 degrees below normal and ranged from 0.3 degree below normal at Levelland to 3.3 degrees below normal at Plainview. The highest temperature recorded during the season was 105 at Paducah on May 26. Silverton's average maximum temperature was 70.4 degrees, which was 2.50 degrees below the South Plains average of 72.9 degrees.

Minimum temperatures averaged 0.7 degree above normal and ranged from 1.9 degrees above normal at Floydada to 0.4 degree below normal at Littlefield. The lowest temperature recorded during the season was 19 at Muleshoe on March 17 and Tulia on March 25. Silverton's average minimum temperature was 41.8 degrees, which was 2.40 degrees less than the South Plains average.

Precipitation averaged 0.32 inch below normal and ranged from 2.71 inches above normal at Jayton to 1.88 inches below normal at Friona. Both March and April averaged above normal precipitation but May was over an inch and one-half below normal, so the entire season turned out to be below normal because of that dry May. Silverton received 5.77 inches of moisture during the spring months, which was 1.47 inches above the South Plains average and .24 of an inch above the 45-year history for Briscoe County.

Emergency Haying, Grazing Approved

Briscoe County has been approved for emergency haying and grazing of 1990 designated ACR (acreage conservation reserve) and CU for Payment (conserving use acres) through December 31, 1990.

Producers who are interested in haying and/or grazing their ACR and CU for Pay during the five-month non-grazing period must come by the ASCS office prior to haying or grazing and sign a request form, according to Earlyne Hutsell, CED, Briscoe County ASCS.

They also are required to certify that the designated ACR or CU acreage has not been irrigated in 1990 and will not be irrigated until after the five-month non-grazing period. Your ASCS office can furnish the details on this program.

Cactus Cove Fishing Report

Another certified lake record walleye was caught at Lake Mackenzie on Sunday, June 3, by Lewis Cannon of Tulia. The five-pound two-ounce fish was caught on crank bait in the main part of the lake across from the beach area.

May 31, a 1 1/4-lb. sand bass was caught on minnows in Tule Creek by Susan Jensen of Tulia.

A three-pound three-ounce largemouth bass was caught by Bill Noble of Tulia on the north side of the main part of the lake. He was working a Rat-L-Trap when he caught the big fish.

There will be a bass fishing competition held by the Golden Spread Bassmasters Club at Lake Mackenzie on Sunday, June 24.

Water temperature at a four-foot depth is now 75° and the water depth at the dam is 108 feet.

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

Claim Forms And Additional Information

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m.-4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

Mauro Pushes Natural Gas

Amendment To Clean Air Act Can Help Texas Air, Economy

AUSTIN—An amendment to the national Clean Air Act encouraging the use of compressed natural gas in fleet vehicles would save millions of dollars and significantly reduce toxic emissions in Houston and other cities with major pollution problems, according to Texas Land Commissioner Garry Mauro. It would also boost the Texas economy, he said.

"I'm happy to announce we have a thorough scientific study that proves what I've been saying now for more than two years," Mauro said. "Compressed natural gas can cut air pollution by more than 250 million tons a year and save \$250 million at the same time in the year 2000."

"What does that mean for Texas?" Mauro asked. "In Houston, for instance, a non-compliance city I'm especially interested in, converting fleets to CNG would cut pollution by more than 17,000 tons a year at a savings of \$17 million."

Mauro cited a comprehensive environmental and economic study by Radian Corporation that shows that converting fleet vehicles in the nation's most polluted cities to run on compressed natural gas (CNG) will not only improve air quality but also save tens of millions of dollars.

The increased demand for natural gas will also help the Texas Economy, Mauro said, since this state has the largest reserve of natural gas. It can also increase income to the Permanent School Fund, which is managed by Mauro, since its' income is primarily from energy leases on state land.

"The upcoming vote on the Waxman-Lewis-Bryant amendment to H.R. 3030 will be one of the key environmental votes of the current Congress," says Ken Kramer, Director of the Lone Star Chapter of the Sierra Club.

"In Texas, the health care cost of vehicle generated air pollution ranges from \$3 billion to nearly \$6 billion a

year," according to Becky Herron, Public Affairs Manager for the American Lung Association. "Without new controls, the auto pollution problem will only worsen in the '90's due to increased population — more people driving more cars, more miles."

The study, commissioned by the Texas General Land Office and Southern California Gas Company, was done by Radian Corporation, an Austin technical research firm. It examines pollution reductions attained through the use of clean-burning CNG in fleet vehicles such as delivery trucks, taxis and transit buses, calculates the cost of switching to the fuel, and compares them with the reductions and costs that would be realized under House Energy and Commerce Committee and Senate revisions to the Clean Air Act.

"For those of you like me who have trouble grasping what more than 17,000 tons of polluting gases look like, imagine putting them all in a leakproof cylinder. It would take a cylinder more than twelve times bigger than the Astrodome to hold them."

"Houston has more than 800 buses running regular routes. That means they put enough particulates into the air to fill more than 6,000 one-liter soda bottles a day. CNG-fueled buses would reduce that pile of soot by some 85 percent. In addition, if all Houston fleets comply by purchasing new, dedicated vehicles, the net savings to Houston fleet operators will be more than \$17 million per year. How can you argue with a plan that cleans up the air and saves money," Mauro said.

Legislation similar to that proposed by U.S. Reps Henry Waxman and Jerry Lewis of California and John Bryant of Dallas is already in place in Texas. Mauro conceived and actively worked to pass those laws in 1989. He emphasized that other states are now following suit,

with similar legislation being considered in the state legislatures of Oklahoma and Louisiana.

The Texas legislation requires most state vehicles, school buses in the larger districts, and all mass transit fleets to begin converting to clean alternative fuels such as natural gas in 1991. Studies show that fleet operators save 40-50 percent in fuel costs and about 50 percent in maintenance costs when they burn CNG in their vehicles.

The Radian study looks at the nation's nine dirtiest cities. "The Waxman-Lewis-Bryant amendment would apply to the 40 worst non-attainment areas. That covers more than 4.5 million vehicles," Mauro said. "They will consume more than 1 trillion cubic feet of natural gas a year. And that means more than 50,000 new jobs for American workers."



High Plains cotton producers at sign-up time indicated the intent to plant 3.149 million acres to cotton in 1990, up 378,000 and 13.64 percent from 2.771 million planted in 1989.

Those are figures compiled for its 25-member counties by Plains Cotton Growers, Inc., Lubbock, from USDA's Agricultural Stabilization and Conservation Service (ASCS) preliminary report on 1990 program enrollment. Although admittedly skeptical of anything labeled "preliminary," PCG believes the numbers indicate that earlier projections of 3.2 to 3.3 million acres may prove a little high.

Whatever the size of the increase, it stems largely from a reduction in the acreage conservation reserve (ACR) requirement, from 25 percent of base acres in 1989 to this year's 12.5 percent. An unfettered calculation of the reduced ACR produces a 16.67 percent increase, to

3.233 million acres. But there are other forces affecting planted acreage, PCG points out.

One major factor is a reduction of almost 44,000 acres in the effective base on enrolled farms from 1989 to 1990. At the 87.5 percent permitted planting rate, that alone could mean over 38,000 less planted acres. Also, there are producers who can't plant their full permitted acreage because of conservation compliance plans that mandate high residue crops on more than the 12.5 percent required ACR.

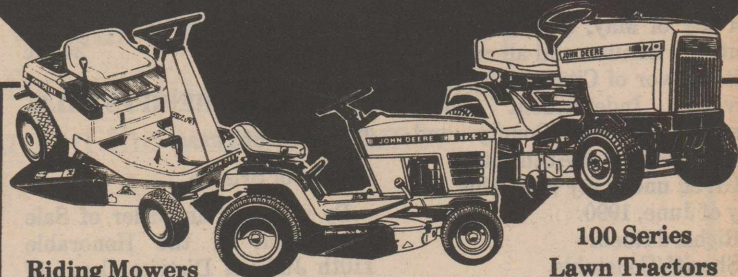
The acreage-depressing effect of conservation compliance requirements, crop rotation needs and other elements when the ACR is low was clearly demonstrated in 1988 and 1989. In 1989, with an ACR of 25 percent, High Plains producers planted 96.9 percent of permitted acreage on enrolled farms. In 1988 the ACR dropped to 12.5 percent, and farmers planted only 94.5 percent of the permitted maximum.

Interesting "but by no means conclusive," PCG says, is the past record of the ASCS intended plantings report as an indicator of ultimate planted acreage.
