Merchants Plan Stampede Bucks Give-Away June 30

Silverton merchants met in the Pioneer Room at First State Bank Monday night to discuss the Stampede Bucks give-away planned for Saturday, June 30. Each one present took a list of merchants to contact in regard to participation in the program.

It was decided that Stampede Bucks would be given away in hourly drawings on June 30, and that there would be grand-prize drawings for children and adults. The amounts of these prizes will be determined by the amount of participation received, but it is hoped that the children's grand prize will be \$50.00 and the adult's grand prize will be \$500.00, each paid in Stampede Bucks which will be redeemable for merchandise at any of the participating businesses. The Stampede Bucks will be issued in small denomination so they can be spent at as many local businesses as the winner

Silverton Stampede Bucks will NOT be exchanged for cash, and no cash will be given in change when the Bucks are exchanged for merchandise. The participating merchants who receive the Bucks will be able to get cash for

them at First State Bank.

The Bucks must be redeemed by July 31, 1990. After July 31, 1990, they will be void.

Owners of the participating businesses, their families and employees will be eligible to win.

Each person may register one time only for these drawings. Hourly prize winners will not be eligible for another hourly prize, but will be eligible to win the grand prize.

The person whose name is drawn for Stampede Bucks must be present on the courthouse square at the time of the drawing to win.

For the drawings for Stampede Bucks, a child will be considered to be those boys and girls age 12 and under. A separate container will be provided from which the children's names will be drawn.

An adult will be considered to be anyone 13 years of age or older, and a container will be provided for the adult drawings.

Each person registering for either drawing will be required to sign a roster, and no one will be permitted to sign up more than once. Registration for the drawings wilk be conducted on the courthouse square on Saturday, June 30, only. The Stampede begins at 10:00 a.m. and the first drawings for Stampede Bucks will be at 11:00 a.m.



Veteruns Given First Chance to Bid on **Forfeited State Land**

Detailed information on 283 tracts of forfeited state land included in an August high bid sale is now available through the Texas Veterans Land Board

Located in 110 Texas counties, these tracts are being offered exclusively to eligible Texas veterans and can be purchased

with no down payment.

The VLB will finance the entire loan amount of all winning bids. There is no limit on the amount loaned or on the number of tracts that an individual can bid on. However, eligible Texas veterans are limited to one land purchase in the sale.

"I want to encourage all eligible Texas veterans who have been looking for quality land to take advantage of this sale," said Jack Giberson, executive secretary of the VLB. "Since these tracts have never been offered for sale by the Board, this sale gives Texas veterans an excellent opportunity to buy good land with 100 percent financing."


Giberson noted that these tracts of land are being offered exclusively to Texas veterans because the VLB has always given Texas veterans the first chance to buy forfeited tracts. If any of the tracts do not sell in the August sale, they will be offered for sale to the general public through real estate agents.

Eligible Texas veterans will receive an 8.75 percent interest rate with a 30-year assumable fixed-rate loan. A \$25 non-refundable bid fee for each bid submitted is required.

The sale will be by sealed bid only, with the minimum bid set by the Texas Veterans Land Board. All bids must be received by August 21 at 1:00 p.m. Any and all bids received after that time will be rejected. Bidders need not be present at the bid

opening.





The Texas Department of Agriculture is warning grain producers who are in the midst of harvest to be leery of "turn row" buyers who offer to buy their crops straight from the field, Texas Agriculture Commissioner Jim Hightower said.

"Some Texas producers don't have trucks to haul their wheat or grain sorghum to the elevator. That makes them prime targets for turn row buyers who literally offer to pull a truck up onto the turning row on the perimeters of the field, load the grain, and haul it away," Hightower said. "At first glance, such a service may seem like a dream come true, but in too many cases—often after it's too late—it becomes clear that such a business arrangement was a costly nightmare.

"Producers who have loaded a year's work on the trailer truck sometimes never see a red cent. Other producers eventually get a copy of a scale ticket showing the weight of the grain, but since there are never scales available in the fields, there's no guarantee they got credit for the entire

Social Security In Briscoe County

If you work in social security covered employment, and almost everyone does, you should keep your records up to date. This means reporting circumstances that could affect your eligibility for, or the amount of, social security payments. Among the changes that should be reported is a change in name.

Newly-married women may continue to use their maiden names at their places of employment. If you intend to use your married name, however, you should report the change to social security and apply for a new social security card. Your new card, showing your old number but with your new name, will usually be issued within two weeks after we receive the information we need. This same advice applies if you're divorced.

You can use your original or a certified copy of your marriage certificate that shows both your old and new names for social security purposes. If you are foreign born, you also will need evidence of United States citizenship or lawful alien status, Social Security makes no charge for a name to be changed in its records. Some firms advertise that they will provide this service for a fee; however, Social Security offers this service—as it does all other services—free of charge.

The process can be started simply by calling Social Security's toll-free telephone number, 1-800-2345-SSA (1-800-234-5772). The best times to call are 7:00 - 9:00 a.m. and 5:00 - 7:00 p.m. weekdays. Social Security treats each call confidentially. We also want to ensure that you receive courteous and accurate service. This is why we have a second social security representative listen to some telephone calls.

load. Sometimes a portion of the load gets dumped prior to the weighing.

"Certainly not every trucking firm that offers this service is unscrupulous, but there are enough of them out there that it's worth reminding producers that the best way to protect their investment is to avoid sales of this nature," Hightower said.

TDA's Grain Warehouse Assistant Director Bob Tarrant offers these tips to Texas producers:

*Sell only to a licensed grain elevator. Many elevators have trucks available to haul the grain to their place of business. Others can provide names of reputable firms.

*Always get an official scale ticket for grain sold to a grain elevator.

*Keep official scale tickets in a safe place since they are evidence of ownership.

*Upon completion of harvest, always request a grain warehouse receipt. Receipts are negotiable documents of title and can be used as collateral.

*Report anyone suspected of attempting to make "turn row" purchases to the Texas Department of Agriculture.

Any licensed grain elevator should have a TDA license clearly displayed in the place of business. If the license is not displayed, a call to TDA's grain warehouse program before the sale can alleviate any questions.

Grain elevators are required to be licensed and bonded by TDA to cover the grain stored in case the warehouse goes bankrupt. The state has about 685 licensed grain warehouses.

Vietnam Veterans To Benefit From V.A. Ruling

According to Billye Kesler, County Service Officer for Briscoe County, Secretary of Veterans Affairs Edward J. Derwinski, following personal consultation with President Bush, recently ruled that Vietnam veterans stricken with a rare form of cancer are entitled to disability payments based on their service in Vietnam.

The VA Secretary acted following the release of study results by the U.S. Centers for Disease Control that showed an increased risk of the disease among veterans who served in Vietnam. The CDC reported that the risk of non-Hodgkin's lymphona is 50 percent greater among Vietnam veterans than among veterans who served elsewhere, although it did not point to Agent Orange or any other factor as causing the elevated risk. Agent Orange was sprayed from 1965 to 1970 in Vietnam to destroy enemy crops and ground cover.

Derwinski said his decision was not based solely on scientific conclusions or the lack of them. "I am exercising my authority...

to make a determination that in my judgment there is enough information to give Vietnam veterans the benefit of the doubt regarding non-Hodgkin's lymphoma and its connection to service in Vietnam."

Using a new "significant statistical association" standard, the Veterans Advisory Committee on Environmental Hazards last fall reviewed 31 studies and their relationship to non-Hodgkin's lymphoma and reported that while no association could be definitely made, it could not rule out the possibility."

VA officials announced they would immediately begin to identify and re-open claims filed by veterans who served in Southeast Asia and who alleged that their development of non-Hodgkin's lymphoma resulted from Agent Orange exposure. VA years ago established a policy that makes it unnecessary for veterans to prove actual exposure as long as their service records validated in-country Vietnam service.

Derwinski said VA will extend as much latitude as possible to award retroactive benefits and in assisting widows and children of veterans who died as a result of non-Hodgkin's lymphoma. He reiterated that since 1981 VA has been providing free, priority health-care services to Vietnam veterans who believed their health was affected by Agent Orange exposure. VA also has conducted a program offering free comprehensive physical examinations to veterans. More than 230,000 have taken advantage of the program and a registry containing their addresses will be used to make follow-up contact concerning

Derwinski's ruling.

On May 16, the advisory committee is scheduled to review studies dealing with herbicide exposure and another group of cancers including soft-tissue sarcoma, and porphyria cutanea tarda, a non-fatal liver ailment.

SIX FLAGS NUMBERS ARE UP AS SUMMER SEASON BEGINS

Six Flags Over Texas has begun its summer season with attendance figures up substantially despite record spring rains in the Dallas-Fort Worth area.

Park president Bob Bennett said more than 600,000 persons visited the Arlington theme park during the spring season which began in mid-March.

"Our business was up more than 16 percent over last year," Bennett said, "and the trend has continued since we began daily operation on Memorial Day."

Bennett attributed the spring success to introduction of the massive Texas Giant wooden roller coaster and the celebration of Bugs Bunny's 50th birthday.

"We expected the Giant to be a popular ride, but the public reaction has surprised even us," Bennett commented. Members of the American Coaster Enthusiasts tell us the ride has a very good chance of being rated the top wooden coaster in the country. Who could ask for more?"

The huge ride drew national attention when a park in Pennsylvania filed suite challenging Six Flags' claim that it was the tallest wooden roller coaster in the world.

One parent, who was taken to court because the 13-year-old daughter (in the parents' absence) had smeared eggs all over the outside and inside of a neighbor's car, felt that it was just a kid's prank and should not be considered a crime for which the parents were responsible.

Many parents today feel as this parent did—that they are not responsible for their children's actions. Some say they can't make their children attend school. What then is the responsibility of a parent? Is it only to provide food, clothing and shel-

Just-Picked Corn at Peak of Flavor

The sweetest fresh corn goes straight from the garden into a pot of boiling water. Corn contains the most sugar the moment it's picked. The longer it's held before cooking the more the sugar will turn to starch. If you're like most people, however, you probably aren't lucky enough to have a row of corn growing in the back yard. In that case, shopping at your local farmers market is likely to yield the freshest supplies in town.

Corn sold at farmers markets is harvested the morning you buy it, or, at the latest, the night before, said Paula De la Fuenta, Texas Department of Agriculture farmers market coordinator. Supplies in most markets will be plentiful from now through July.

This is the eighth season TDA has assisted farmers markets in a program that has grown to 90 markets in 75 towns and cities across the state. Approximately 3,700 farmers sell produce, plants and other products at the markets, which are expected to gross \$34.5 million this year.

When shopping for corn, look for ears with fresh, green husks and moist silk that has no signs of decay. Ears cool to the touch are likely to be sweeter than those that feel warm. Kernels should be plump and tender-looking. If they appear overly large and coarse, they will be tough and

Everyone's favorite way to eat sweet corn is on the cob. Tender ears do not require lengthly cooking. Right before you're ready to eat, strip the ears of husks and silk. Drop one ear at a time gently into unsalted boiling water. Salt toughens corn. Boil rapidly for three to five minutes. Or slip the ears into boiling water, cover the kettle and remove it from the heat. Let the corn stand five minutes before

Roasted ears take more time but, to some, are worth waiting for. To roast ears on the grill,

pull the husks down, but don't remove them. Do remove the silk. Then put the husks back in place, twisting them at the top to protect the kernels. Soak the ears about 20 minutes. Then put them over hot coals and cook 20-25 minutes. Turn the ears every now and then for even cooking. An easier way to prepare ears for roasting is to strip husks and silk, rub the ears with butter, salt and pepper, wrap them in foil and roast.

Raw and cooked corn can be cut from the cob easily with a sharp knife. Hold the ear pointed end down at a slight angle. Slice downward into a bowl or shallow pan. The following recipes call for fresh kernels. Try them once you've had your fill of corn on the

SAUTEED CORN AND OKRA

8 bacon slices 2 C. sliced okra

2C. fresh corn kernels Salt and pepper to taste

Cook bacon in large skillet until crisp. Drain bacon, crumble and set aside. Pour all but three tablespoons drippings from skillet. Saute okra in drippings, stirring frequently for five minutes. Add corn to skillet; cook until tender. Stir in crumbled bacon and season with salt and pepper. Makes six servings.

FRESH CORN APPETIZER DIP

1 (3 oz.) pkg. softened cream cheese

3 T. sour cream

1 T. lemon juice

2 T. chopped pimiento 2 T. chopped green onion

1 sm. mashed garlic clove

2 tsp. crushed oregano 1½ C. cooked corn kernels

In small bowl blend cream cheese, sour cream, lemon juice, pimiento, green onion, garlic and oregano. Add corn; stir to blend. Cover and refrigerate at least two hours. Serve with fresh vegetables, crackers or chips. Makes approximately two cups.

The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m.-4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

The 10-year conservation reserve program since 1986 has idled 1.84 million highly erodible acres, 20.2 percent, of the 9.1 million cropland acres in the 25 High Plains counties represented by Plains Cotton Growers, Inc., Lubbock.

Those figures from USDA's Soil Conservation Service (SCS) were evaluated recently by PCG alone with CRP reductions in program crop bases supplied by the Agricultural Stabilization Conservation Service (ASCS). Farmers who signed land into the reserve program have agreed to devote the idled acreage to conservation uses such as permanent grasses for a period of 10 years. In return USDA pays a share of the cost of establishing grasses or other cover crops and will pay yearly rental of up to \$40 per acre.

CRP crop base reductions reported by ASCS total only about 1.5 million acres. Although land bid into the program had to be used for program crop production from 1981 to 1985, SCS figures reflect total cropland area while ASCS numbers represent only crop base acres

TDA Warns of Fraudulent Sales Of Pesticides

Agriculture Commissioner Jim Hightower has warned that some unregistered and illegal pesticides again are being marketed in Texas.

"We put an end to a similar scam a year ago when we traced the illegal products to a boiler room operation in Florida," Hightower said. "But the temptation for these operators is apparently too great with the high costs of farming. These out-of-state telephone solicitors are once again trying to undercut sales from legitimate licensed dealers.

The CRP has reduced base cotton acreage in PCG territory by 774,720 acres, 16.7 percent of the area's 4.64 million acre total base. The remaining 724,634 acres of base reductions cover corn, grain sorghum, wheat, barley and oats. Bases are not lost, however. They will be restored to individual farms at the conclusion of their respective CRP contracts, beginning in

Most High Plains cotton acreage in the CRP is found on whole-farm CRP entries, PCG notes, citing ASCS figures showing less than 122,000 CRP acres on farms participating in the 1990 farm program.

With certain exceptions, the farm law limits acreage accepted into the CRP in any county to 25 percent of the county's total cropland. Eleven PCG counties have reached or slightly exceeded the limit, including Bailey, Briscoe, Cochran, Deaf Smith, Dickens, Gaines, Martin, Motley, Swisher, Terry and Yoakum counties.

Nationwide about 34 million acres have gone the CRP route though the nine sign-up periods from 1986 through 1989, and USDA has no plans to accept additional acreage unless the program is extended in the pending 1990 farm bill.

In Briscoe County, there are 171,079 total acres of cropland and 46,395 acres of cropland in the CRP. Total cotton base acres is 67,332 and the base cotton acres in the CRP is 16,280.

"Every year about this time, Texas farmers and ranchers get phone calls from salespeople offering pesticides that are supposedly just like commonly used products, but at reduced prices.

"After comparing the costs, however, the farmer discovers that he or she has paid an exorbitant price for the product -particularly when the product turns out to be almost useless,' Hightower said.

Hightower said most of the products are improperly labeled and do not provide the type of pest control promised by the salespeople.

In the latest series of incidents, Texas farmers have received calls from Capital Farm Supply, of Coral Springs, Florida. The sales representative, calling himself J. J. Johnson, offered a product called "Corral," claiming it to be a cure-all herbicide that is safe for all uses from fence rows to field crops.

The product is not registered with TDA or the U.S. Environmental Protection Agency.

All pesticides sold in Texas must be registered with TDA and EPA. Both agencies have strict labeling requirements.

Sale or use of this product is illegal.

Most of the complaints received by TDA so far this year have been in the Panhandle, Hightow-

In 1989, TDA ended a similar sales scheme after a four-month investigation that included help from the Florida Department of Agriculture, United Parcel Service, the U.S. Department of Agriculture and EPA.

"The easiest way to beat this scam is to buy only from established, well-known businesses,' Hightower said. "Texas producers should immediately be suspicious of any telephone sales of pesticides."

Persons with questions or information about possibly illegal sales of pesticides should contact their nearest TDA district office.

Have A Carefree Fourth Of July Picnic

Ah, a checked tablecloth, some cold chicken, a French cheese, a crisp pear, a cold bottle of . . . Now wait a minute. That sounds like a pique-nique not a picnic and certainly not a Fourth of July picnic. A Fourth of July picnic means burgers, watermelons, peaches, potato salad, barbecue, beans, fried chicken, ribs, chips, dips, salsa, carrot sticks, pickles, onions, chow-chowwhen; you get the drift. It means food, the real thing, and, afterwards, fireworks, the biggest fun night of the whole summer.

But be careful . . . Yes, even on the Fourth of July there's something to worry about. That something is food poisoning. Food poisoning is more common when the weather is hot, and unless it rains all day, it's bound to be hot on July 4 in Texas. Here are a few cool suggestions from Texas Department of Agriculture home economist Carol Guthrie to make your holiday healthy as well as a lot of fun.

1. Plan ahead. The night before the picnic pack non-perishables plates, napkins, utensils, tortilla chips. Take enough plates and utensils to ensure that any used for raw meat or poultry will not be reused. Salmonella spreads easily from raw to cooked food. Set out a jug of water, soap and paper towels to wash hands and clean up spills.

2. Include "problem-free" foods in the menu. Summer is the time for peaches, home-grown tomatoes, watermelons, cantaloupes and other fresh produce. Check out the local farmers market for the freshest fruits and vegetables. Until you cut into a melon, you don't have to worry about it

3. Make sure you have a well-insulated cooler. The day of

the picnic, pack it with items that must stay cold-drinks and such perishables as potato salad, hamburger patties, cooked meat, deviled eggs and the like. You'll need plenty of ice. Pre-chilled beverage bottles also will help keep food cold. Wrap food containers tightly, and put raw perishables into plastic bags. Make sure the cooler lid closes tightly. At the picnic site keep the cooler in the shade.

4. If you're grilling meat or poultry, be sure to cook it thoroughly to destroy any organisms that might cause illness.

5. Don't let cooked food sit around too long. Bacteria grow between 40 and 140 degrees F. When foods are left out for more than two hours at these temperatures, bacteria grow rapidly. Milk products, eggs and seafood should remain on ice until you're ready to use them.

Surprise. The U.S. Department of Agriculture says that, contrary to what most people think, mayonnaise does not increase the risk of food poisoning. Most commercial mayonnaises and salad dressings contain lemon juice or other acid flavoring, which slows bacterial growth. Salt in mayonnaise also retards bacterial growth. A little mayonnaise in food, therefore, actually decreases chances for food poisoning slightly, says USDA. That's no excuse, however, to leave dishes containing mayonnaise out in the heat. The best rule of thumb-keep them on ice.

If some new dishes will add sparkle to Fourth of July fireworks, try these recipes for Potato-Vegetable Salad (two dishes in one), and Texas Peach-Lime Ice Cream. After the food has been served, sit back under a

tree and enjoy. POTATO-VEGETABLE SALAD

1 lb. cooked potatoes, cut into chunks 1/2 C. white wine vinegar

1/4 C. olive oil

Salt and pepper to taste C. yellow squash, cut into chunks

2 C. zucchini, cut into chunks 1 C. sliced mushrooms

1/2 C. cooked green peas 3 chopped green onions 1 shredded carrot

2 chopped green bell peppers

16 cherry tomato halves
Place hot potatoes in large bowl. Combine vinegar, oil, salt and pepper in screw-top jar; shake well. Pour over potatoes and toss lightly. Cover and refrigerate. Steam yellow squash and zucchini 10 minutes or until just crisp-tender; chill. Just before serving, combine potato mixture and squash with remaining vegetables. Toss lightly. Makes 6-8 servings.

TEXAS PEACH-LIME ICE CREAM

4 C. partially crushed peaches Juice from 6 limes (about 3/4

1 T. grated lime peel 1 T. lemon juice

1 tsp. grated lemon peel 2 tsp. peach extract (optional)

21/2 C. sugar

1/2 scant tsp. salt 4 eggs

1 qt. half and half 1 pt. whipping cream

2 T. vanilla extract In medium bowl combine peaches, lime juice, lime peel, lemon

juice, lemon peel and peach extract. Set aside. Combine sugar and salt; add eggs and beat until frothy. Add half and half. Cook over medium heat, stirring constantly until mixture begins to thicken. Cool. Add whipping cream and vanilla to custard; mix well. With a rubber spatula add peaches to custard. Pour mixture into freezer container. Freeze according to manufacturer's directions. Makes 1 gallon. Note: 4 cups of home-frozen peaches may be used instead of fresh. If 1 cup sugar was used to prepare peaches, use only 11/2 cups in

"The flag is a symbol of our country, a symbol of our freedom and people should not be allowed to burn it," the Congressman


"I support and will fight in Congress for a constitutional amendment that makes it illegal to burn the American flag as an act of vandalism," Sarpalius said on Flag Day.


