## Weather Was Hot And Dry During June

It was just plain hot across the Texas South Plains during the month of June 1990. It also was dry with several weather stations reporting only a trace or nothing at all. Numerous temperature records were set including the alltime highest temperature ever recorded at Lubbock. High recorded at Lubbock. High
temperatures over 100 degrees

were frequent and averaged 13 days across the area while ranging from 20 days at Seminole to only seven at Spur. There were 10 days in June 1990 when the temperature was 100 degrees or higher in Silverton.
Temperatures averaged 5.8 degrees above normal across the area and ranged from 7.7 degrees above normal at Lockettville to 1.9 degree above normal at Spur. The average temperature at Lubbock of 84.4 was the all-time highest average temperature for June and was second to the alltime highest average temperature for any month topped only by 85.4 in July 1966. New records for highest average temperatures were set at fourteen of the reporting stations

average minimum temperature was 65.4 degrees, lower than the 66.3 South Plains average.

Precipitation was quite varied across the area and ranged from nothing to some reports over five inches. When compared to the long-term averages, June area long-term averages, June area
rainfall was 1.88 inches below rainfall was 1.88 inches below
normal and ranged from 2.54 inches above normal at Jayton to 3.43 inches below normal at Olton.
Silverton's precipitation for the month totalled 1.60 inches, which was .60 above the South Plains average, but was 2.18 inches below the 45 -year history for Briscoe County.

## Rep to be Here

 Tuesday, July 24State Comptroller Bob Bullock said Thursday that a representative from his agency will be in Silverton on Tuesday, July 24, to answer questions about Texas taxes and assist taxpayers with paperwork and problems.
"I don't want to see state taxes turn into a burden for folks who can't get to a field office. Our visits are a service we're happy to provide to Texas taxpayers," Bullock said.

## Briscoe County

How bank accounts affect Supplemental Security Income (SSI) eligibility is an area that consistently confuses people who are receiving or applying for SSI. This column should help clear up some of that confusion.
To be eligible for SSI, a person must have resources of less than $\$ 2,000$ ( $\$ 3,000$ for a couple). Bank accounts are usually considered resources; therefore,
they count toward this limit.
What's so confusing about that, you wonder. Well, Social Security considers a bank account yours if considers a bank account yours if
your name is on it as owner or coyour name is oner and there are no legal restrictions that keep you from taking money out and using it for your own benefit. This is true even if you don't use the account or don't consider the account yours. That means it's important that bank accounts are precisely titled to reflect ownership and access.
Let's suppose Mary Jones applies for SSI. Her daughter,Jane, has a $\$ 3,000$ savings account. Jane listed Mary as a joint owner, primarily so Mary would have access to the money in case something happened to Jane. Although Mary doesn't consider the Mary doesn't consider the account to be hers, Social found ineligible for SSI because she is over the $\$ 2,000$ resource limit. Of course, if Jane's account is titled to restrict Mary's access, the account would not be considered Mary's and would not affect Mary's eligibility
Proper titling also is critical when community, civic, or social groups collect money for a special reason such as to help pay a SSI recipient's medical expenses. Although the donors gave money to the person, they also placed restrictions on its use, and the account must be titled to show the restrictions. As long as the account title shows the money account title shows the money cannot be used for food, clothing
or shelter, the account is not considered a resource.
