




There will be a style show, and Emily Lemley will be the guest speaker on "Teen Sexuality."



All requested forms required for payment eligibility must be filed with the ASCS office before program payments can be received. Pay limit "person" determinations for 1991 are based on conditions that exist on May 1.

FARM PROGRAM CHANGES

It has been determined that, for 1991 only, the idle rows or rows in a skip-row pattern are now eligible for CU for Pay acres. Windstrips and terraces that

"Together we must work for the good of all to utilize, conserve and properly manage those resources in our care." Participation in Soil and Water Stewardship Week activities offers an opportunity to reflect on the nation's natural resource problems and consider actions to resolve them or reduce their

have been established for conservation as required in conservation plans with SCS and are at least 160 inches wide are now eligible for ACR and CU for Pay for 1991.

The State ASC Committee has exempted Texas from the 50% cover crop requirement on ACR. Producers are required to control weeds, insects and rodents, as well as wind and water erosion on ACR and CU for Pay.

ELIGIBILITY

Land designed as ACR and CU for Pay must be cropland with a history of being planted to a row crop or small grains, or designated as ACR or CU for Pay, in one of the last five years.

HAYING AND GRAZING
ACR and CU for Pay acres may be
grazed or hayed during the sevenmonth non-growing season (November

1 through May 31). The five-month non-haying and non-grazing period is June 1 through October 31.

CERTIFICATION

May 15 is the final day to certify wheat, oats, barley, etc., including ACR and CU acres with a small grain cover. This also is the final date to certify to zero acreage planted if the farm has a base for that commodity. Measurement service for small grains is available and must be requested by May 15.

If you have wheat or other small grains on ACR or CU that will be left standing and not substantially destroyed by May 15, you must file a request to leave the small grains standing and pay a \$10 fee to stay in compliance. If this request is filed, this acreage may never be haved or grazed between June 1 and October 31.


