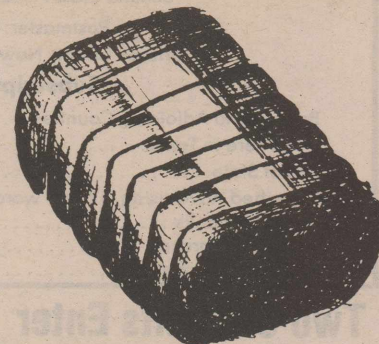
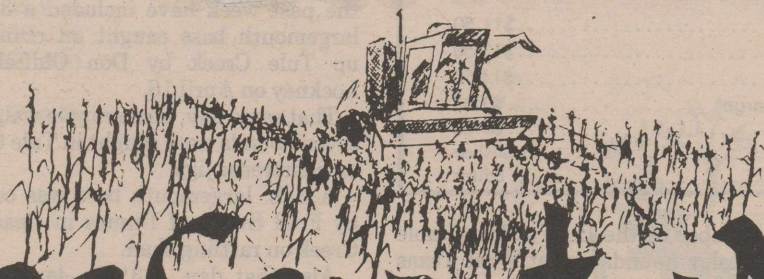
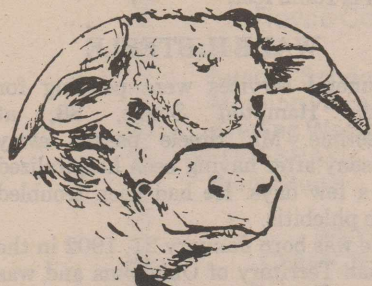

### Cactus Cove Fishing Report

Big fish weighed in at the Cactus Cove Marina on Lake Mackenzie during the past week have included a 3 1/4-lb. largemouth bass caught on crankbait up Tule Creek by Don Oldfield of Lockney on April 16.

That same day, nine crappie weighing seven pounds were caught in Tule Creek on chartreuse jigs.

A 3-lb. largemouth bass was caught by Fred Sweet of Dumas in Deadman Creek on rattling shad.

Also that day, a 3 1/4-lb. largemouth bass was caught on chartreuse spinnerbait in Tule Creek by Larry Don Bice of Tulia.

Bryan Breedlove and Wayne Henderson brought in a 3 1/2-lb. largemouth bass, a 2 1/2-lb. sandbass and a 4-lb. 1 1/2-oz. sandbass caught in the main part of the lake on April 16. They were using roadrunner jigs that were white with red heads.

On April 20, a 5-lb. 7-oz. largemouth bass was caught on a chartreuse spinner near the mouth of Tule Creek by Randy Race of Lockney.

Kevin Smith and Randy Newman of Lubbock caught 13 1/2 pounds of largemouth bass on chartreuse

spinnerbait Saturday.

Water temperature at a four-foot depth is 60°, and water depth at the dam is 100.2 feet.

## Plans Continuing For Annual PTA Little Wrangler Rodeo, Fun Night

Plans are continuing for the PTA Little Wrangler Rodeo and Fun Night. Entry forms will be handed out to students at school Tuesday, May 7. Registration will be in the school cafeteria Monday, May 13, from 3:00 until 4:00 p.m. You also may return entry forms to Beverly Minyard before that day.

This year's rodeo will be held Friday, May 17, at 7:00 p.m. in Wood Memorial Arena. PTA will be cooking hamburgers on the grill for your enjoyment and convenience before and during the rodeo. Other concessions also will be available, so plan to join PTA for supper and an evening of fun.

Events will include the goat race, in which contestants will run to a goat, retrieve a ribbon, and race back to the finish line.

Other events include the stickhorse race for ages 4-7. Bring your own stickhorse, to avoid skittish horse problems, and race to the finish line.

The wagon race for 4-8 year olds is a three-member team event which includes a pusher, a puller and a rider who race to the finish line. If you have a wagon, please bring it.

Goat dressing is an all-girl event which includes 9-12 year olds. This also is a three-member team event, in which the girls dress a goat with clothes provided, put it in a wagon and pull it to the finish line.

Junior and senior goat milking is always a popular event. The juniors are kindergarten through eight-year olds. This two-member team includes one child to hold the goat while the other milks it, and runs to the finish line with the can, the bottom of which is covered with milk.

For 9-12 year olds, the scoop race will be a fun event. This two-member team will include a team member pulling the other in a scoop to the finish line.

Barrel rolling will be a race with your barrel to the finish line for 9-12 year olds. The two-member teams will

compete.

Kindergarten through eight year olds can compete in the greased pig race for a ribbon.

The cowchip relay for 9-12 year old boys includes two members of a team shoveling up a cowchip, racing down the arena, passing to your partner and racing back to the finish line without dropping or touching the cowchip.

The boot scramble will be held again this year for 4-8 year olds. Don't wear your new boots; you may never see them again!

The horse events will be the same as previously held. Barrel race will include juniors (K-8 years) and seniors (9-12 years). The flag race includes the same age groups.

The one event held for adults is the cowchip throwing contest. This is a free

event and pre-entrance is not required. There is always stiff competition in this event, so get your throwing arm ready.

PTA is hoping to have a fun-filled night planned for your enjoyment.

Since this is the only money-making project for all expenses incurred during the year in conducting PTA projects, everyone's participation and attendance is greatly appreciated.

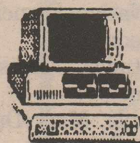

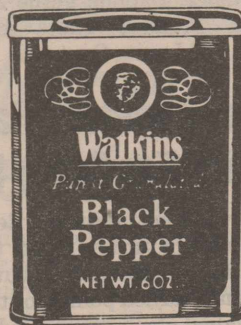

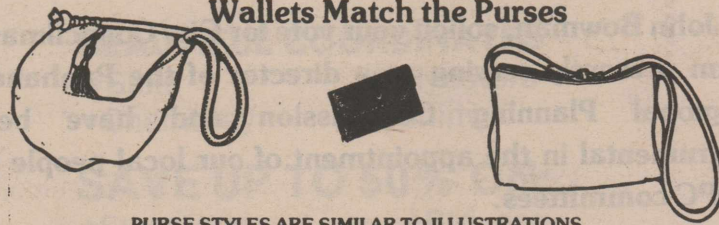

## Taxpayers Ask IRS

These are typical of questions asked by taxpayers and are presented as a public service of this publication and the IRS.

**Q.** What qualifies a person to be claimed as a dependent on my tax return?

**A.** Five tests are used to determine dependency in order to claim an exemption on your tax return. They are: member of household or relationship test, citizenship test,

joint return test, gross income test and support test. Each of these rules has its own criteria. If you have a question as to whether or not to claim a dependent, consult the instructions in your tax package.

**Q.** Even though my dependent did not live with me the entire year, does he or she still qualify as a dependent on my tax return?

**A.** Yes, if he or she meets all of the tests mentioned above, he or she may still qualify as a dependent.

**Q.** How much is each exemption for a dependent worth?

**A.** For tax year 1990, each exemption, including yourself, is \$2,050.

**Q.** What do I do if I need more time to file?

**A.** You must apply for an extension of time to file using Form 4868, *Ap-*

*plication for Automatic Extension of Time To File U.S. Individual Income Tax Return.* You must file Form 4868 by the regular due date of your return, and you must enclose payment of any tax you estimate you will owe. You will then be allowed four more months to file your return. You cannot file Form 1040EZ if you get an exten-

## Mid-Year Crop and Livestock Reports Due

With land preparations and spring planting getting underway across the state, Texas producers are gearing up for another year, and one of the most important production inputs a producer can use in determining production and marketing plans is the mid-year crop and livestock reports released by the Texas Agricultural Statistics Service.

Beginning June 1, representatives from the Texas office will begin contacting farmers and ranchers across the state to help set the 1991 planted acreage estimates and mid-year livestock inventories.

"Information from these surveys will provide Texas producers with solid facts and figures they can use when making their plans for the coming year," state statistician Dennis Findley reported.

"The surveys will be very important this year because they will be the first accurate measure of the impact of participation in the 1990 government farm bill," he added.

Individual reports will be combined with other reports to set state estimates. Results of the confidential interviews, conducted by telephone or in person by field enumerators, will be published later this summer. The 1991 acreage estimates will be released June 27, while the mid-year cattle inventory will be released July 29.

"These surveys are important production tools, and good, overall participation will give producers an accurate view of where Texas agriculture stands.

"Following several years of near drought-like conditions in the central and southern portions of the state and severe flooding in East Texas last spring, some producers need all the help and information they can get," Findley noted.

## Social Security In Briscoe County

Disabled May Work While Getting SSI

There are special provisions in the Social Security law designed to encourage blind and disabled Supplemental Security Income (SSI) recipients to try to work. These provisions allow recipients to attempt work without fear of losing all their SSI checks or Medicaid coverage. Also, recipients whose SSI checks were stopped because their earnings made their income too high to continue getting SSI may be able to get checks again if they find they are no longer able to work.

Recognizing that a disabled recipient's return to work may not follow a steady progression, the law allows the recipient to use SSI as a steppingstone to employment. Recipients may continue to get some money from SSI while testing their ability to work. The amount received depends on the amount of earnings—as earnings increase, the SSI payment decreases and may eventually stop. A recipient who finds his or her work attempt is unsuccessful, however, may have payments started again—often without filing a new SSI application.

In addition, many blind and disabled recipients can keep their Medicaid coverage even when their checks stop because their earnings are too high. To keep Medicaid coverage, a recipient must continue to be blind or disabled, meet all other non-earnings SSI eligibility requirements, depend on Medicaid coverage to continue working, and be unable to purchase similar medical care.

Blind or disabled recipients who work also are encouraged to develop a "plan for achieving self-support." Such a plan allows them to set aside income and/or resources to reach their work goal. And since the income set aside won't reduce their SSI check, people with a plan often get a higher SSI check than people without a plan. Expenses associated with reaching a work goal can include education, vocational training, purchasing work-related equipment, or saving to start a business.

## Money Talk

Over the past few years, much has been written and said in the news about "junk bonds." Many people may wonder, just what is a junk bond?

In order to define what they are, it is important to understand what a bond is. Bonds are debt instruments issued by corporations or governmental entities to raise capital for expansion or improvement projects. The bond holder (buyer) is paid from revenue of the issuing entity. Bonds are rated by bond grading agencies according to their probability of default. "AAA" is the highest, meaning the risk of non-payment when the bond is due is very low. A "D" rating is the lowest grade, which indicates a borrower has defaulted on repayment at some time. The better a corporation's, state's, or municipality's bond rating is, the lower the rate of interest required for loans.

The term "junk bond" essentially refers to high-yielding bonds that are rated below an agency's investment bond grades. Junk bonds have low ratings because of their risky and speculative nature. A good rule of thumb is that higher yields mean higher risks. Before you consider investing in junk bonds, you should talk to a licensed stockbroker or financial counselor.

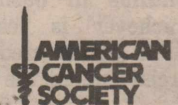

# Energas Company Requests Increase of Rates, Charges

Energas Company has notified the 66 incorporated communities on its West Texas Distribution System that the company intends to implement an increase of approximately six percent in its overall revenues effective May 24, 1991. The company also has proposed to increase its service charges.

The annual increase to an average residential customer using 96 Mcf of natural gas per year would be approximately \$27.72, or seven percent.

About 211,000 customers are affected in an area extending from Pampa, Hereford and Lubbock to Midland and Odessa. Such customers include all sales customers who are not on irrigation or special industrial contracts with the company. This rate request will not affect customers in the communities of Amarillo, Dalhart, Channing, Fritch, Sanford or Ozona. It does affect customers in Silvertown and Quitaque.

By law, Energas is entitled to recover its cost of service through its rates and charges to customers. Those costs include cost of gas purchased for distribution, operation and maintenance expenses, depreciation expenses, taxes and a reasonable rate of return on rate base.

The overall rate of return being requested by Energas in the current filing is 12.13 percent.

The last rate adjustment was filed by Energas for the West Texas Distribution System was in 1984 and the subsequent increase of approximately 17 cents per Mcf was effective November 1, 1984.

While Energas has been able to hold cost increases to a level well below general inflation rates since the last rate request, the increased investment in plant additions made since 1984 and operating cost increases have created the need for additional revenue.

Eugene A. Ehler, president of Energas Company, noted that the company has been successful in its efforts at cost containment. "The company has worked diligently to contain its operating and maintenance expenses to a level that is well below the rate of inflation for the period. These efforts are largely responsible for the

company's ability to operate nearly seven years without requesting a rate increase."

Governing bodies of the 66 communities in the West Texas System will be provided with additional information from Energas as support for the company's rate increase request.

In its application to the cities to increase its rates, Energas has proposed an effective date of May 24, 1991. However, the cities have the authority to suspend the operation of the rates filed for a period not to exceed 90 days beyond this date in order to provide more time to study the filing.

"We feel the rate request is necessary and that the company has demonstrated a commitment to hold costs down," said Ehler. "Energas is prepared to meet with representatives of the 66 communities at the earliest convenient time to discuss the filing."

"Through the years, Energas company has worked very closely with the cities and towns it has served and with their representatives. The cities and the company have been able to resolve any differences in rate matters. We are proud of the Energas record of reliable gas supply, dependable and prompt service, and our record as a utility business that has been able to maintain customer rates among the lowest in the state," he said.

Energas Company, a division of Atmos Energy Corporation of Dallas, provides natural gas service to over 310,000 customers in West Texas.

# Emergency Farm Loan Applications Being Taken

Applications for emergency farm loans for losses caused by drought and excessive heat are being accepted at the Farmers Home Administration (FmHA) office located in Floydada, FmHA County Supervisor Becky Rainer said today.

Briscoe County is one of eight counties in Texas recently named by Secretary of Agriculture Clayton Yetter as eligible for loans to cover part of actual production losses resulting from the drought and excessive heat.

Mrs. Rainer said farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business or \$500,000, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest is 4.5 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FmHA emergency loan," Mrs. Rainer


said. Farmers participating in the PIK or Federal Crop Insurance program will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until December 9, 1991 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly run over into the new farming season," Mrs. Rainer said.

FmHA is a credit agency of the U. S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U. S. citizens and to farming partnerships, corporations or cooperatives in which U. S. citizens hold a majority interest.

The FmHA office in Floydada is open from 8:00 a.m. to 5:00 p.m. Monday through Friday.
