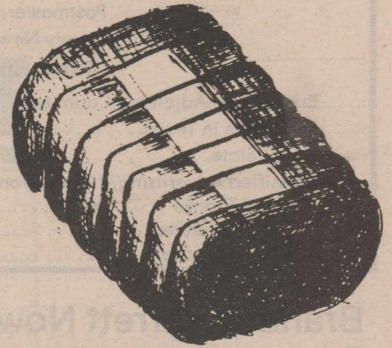

Gasoline Reunion, Marker Dedication Planned Sunday

Sunday, August 4, residents and former residents of the Gasoline community will meet at the Quitaque Community Center for their homecoming and later that day will dedicate an appropriate historical

medallion.

Registration for the homecoming will begin at 9:30 a.m. at the center, and the noon meal will be catered by Roye Pigg of Quitaque. There will be a short business meeting following the meal.

Many former residents already are preparing to be present and looking forward to a big day of reminiscing.

At 4:00 p.m. a Texas Historical Medallion will be dedicated at the site of the old Gasoline Cotton Gin, located two miles east of Quitaque on Highway 86 and three miles south on Farm-to-Market Road 599.

Three progressive men, M. E. Tomson, L. A. McCracken and J. H. Clack, had a dream of building a cotton gin to take care of the rapidly-increasing cotton acreage that was producing bumper crops. The nearest gin was in Turkey, ten miles away.

In 1906 the dream became a reality when they purchased a gasoline engine from a Dallas firm. In April of 1907 the gin was ready and the 1906 cotton crop that had been piled in the fields was ginned. Fuel for the gasoline engine was freighted by wagon and team fifty miles or more from Estelline and Memphis. The people spoke of hauling their cotton to the gasoline gin. Eventually, they dropped "gin" and just said they were going to Gasoline. That was the name adopted by the community and was officially designated to the post office there.

This was the first gin in Briscoe County.

Glenda McCracken Francis, granddaughter of the late L. A. McCracken, will dedicate the historical marker, and her son, Barry Francis, a great-grandson, will unveil the new medallion.

Everyone is invited and urged to attend this dedication ceremony.

Brandon Jarrett Now Recovering from Burns

Brandon Jarrett, a former Silverton resident and graduate of Silverton High School, who has lived in Albuquerque, New Mexico since his marriage, was severely burned on the job as a painter July 6. He was a patient in the trauma burn unit of University Hospital in Albuquerque until a few days ago.

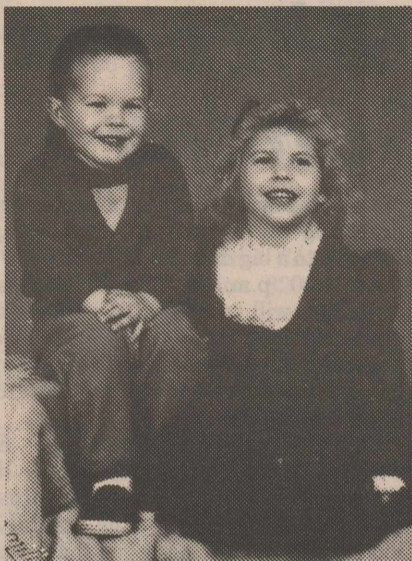
Jarrett is a self-employed painter who does work for building contractors, and he was spraying laquer in a home. He had worked there on Friday, and had all the pilot lights turned off. When he returned there to work on Saturday morning, someone had returned and relighted the pilots. Not knowing this, he began spraying laquer and there was an explosion. He was knocked down by the blast but was able to make it to the door before he collapsed. His wife was in the yard, and summoned help for him. The house was almost completely destroyed.

Jarrett was burned over 40% of his body, with third degree burns on his arms and legs. He wasn't burned about his face. Skin grafting was done, and he returned to his home about July 18. It is estimated that it will be a year before he can go back to work, and he won't be able to spend any time in the sunshine.

He has three children, who are five, three and eight months old.

Until recently, he hasn't been able to



What Is August Election About?

During the last session of the Legislature, a school finance bill passed which radically alters the way school property taxes are collected and distributed. The bill created 188 county education districts (CEDs) composed of the school districts in each county. Those county education districts will levy a property tax which will be distributed equally among school districts within the county education district. The election to be held August 10 will enable taxpayers in the county education districts to avail themselves of certain exemptions on their homesteads as well as open up the possibility of taxing certain tangible personal property.

What is on the August 10 ballot?

There will be two elections held that day—a statewide constitutional amendment election and a school district election.

The state election involves two constitutional amendments: (1) Proposition 1 to allow certain property tax homestead exemptions and taxation of certain tangible personal property by the county education district; and (2) Proposition 2 which allows the Texas Higher Education Coordinating Board to issue up to \$300 million in general obligation bonds to fund student loans.

The school districts will conduct a local option election on behalf of the county education district concerning issues addressed by Proposition 1. The school ballot will be in three parts: (1) whether to adopt a homestead exemption of 20% of the market value; (2) whether to adopt an additional exemption of \$10,000 for the elderly and disabled; and (3) whether to tax non-income producing tangible personal property.

What happens if Proposition 1 fails?

If this constitutional amendment fails statewide, the school district election whereby the voters authorize the exemptions will be disregarded. However, the governing body of the CED might adopt these exemptions under existing provisions of the Constitution.

Does each school district have to

approve the three ballot propositions for them to pass?

The results for each question will be added together for the county education district as a whole. If the question fails in one district but passed the CED as a whole, it is still adopted by the CED.

Is a vote against Proposition 1 a vote against taxing tangible personal property by the CED?

Yes, but it is also a vote against voter-authorization for the CED to use homestead exemptions and elderly and disabled exemptions. As stated previously, the CED governing body might adopt these provisions following procedures set up under current law.

What items would be taxed as tangible personal property?

Perhaps tangible personal property can best be described by what it is not: it is not real property; it is not household goods, which are exempt from taxation by the Texas Constitution; it is not intangible property, such as stocks or bonds; and it is not income-producing property. The most obvious targets are cars, boats, airplanes and RVs.

Where do I vote?

Ballots will be cast on election day (Saturday, August 10) in the Pioneer Room at First State Bank in Silvertown. A joint election is being held by Briscoe County and the Silvertown Independent

School District, and the two ballots will be voted at the same location.

Absentee voting will continue until August 6, in the office of County and District Clerk Bess McWilliams.

PUBLIC HEARING CITY OF SILVERTON TEXAS COMMUNITY DEVELOPMENT PROGRAM

The City of Silvertown will hold a second public hearing at 8:00 p.m. on August 6, 1991, at the Silvertown City Hall in regard to the submission of an application to the Texas Department of Commerce for a Texas Community Development Program (TCDP) grant. Topics to be discussed will include the proposed joint application between the City of Silvertown and the City of Quitaque for funds to develop a solid waste transfer station which would serve both communities. The City encourages citizens to participate in the development of this TCDP application and to make their views known at this public hearing. Citizens unable to attend this meeting may submit their views to Jerry Patton, City Manager, at City Hall. Handicapped individuals wishing to attend this meeting should contact City Hall to arrange for assistance.

Commission Advocates New Technologies in Treatment Of Soil Contamination

The Texas Water Commission is encouraging the use of alternative methods in the treatment of soil contaminated by hydrocarbons, a type of contamination often resulting from leaking petroleum storage tanks. The traditional method used consists of excavating the contaminated soil and disposing of it at a municipal landfill.

"Due to the large volumes of soil involved and the relatively low contaminant levels in the soil in many instances of leaking petroleum storage tanks, options aside from excavation and landfill disposal may be more economically and environmentally preferable," said Allen Beinke, Executive Director of the Texas Water Commission.

Though disposal at a municipal landfill is a legal and viable disposal alternative for soil contaminated with hydrocarbons, other methods of soil treatment may be utilized for excavated

soil or even soil remaining in the ground at the contamination site. By using an alternate treatment method, owners and operators of leaking petroleum storage tanks may benefit from more reasonable treatment costs and from possible reduced liability associated with landfill disposal. Additionally, in most cases, tank owners and operators who use alternative treatment methods are eligible for reimbursement from the state's petroleum storage tank reimbursement fund.

The Texas Water Commission has developed guidance for the use of some alternative technologies and is currently developing policies governing the disposal options for petroleum storage tank wastes. "Lone Star State" Coming To Plates

The eyes of Texas may think they're seeing things beginning next spring, but deep in the hearts of Texans, they'll know it's true.

That will be "The Lone Star State" written across the bottom of Texas license plates on passenger cars.

"Texans have made their pride plain, to the point of making it the object of legislation," said Arnold Oliver, engineer-director of the State Department of Highways and Public Transportation. "We obviously have a lot to be proud of, and our newest license plate, with its flag and 'The Lone Star State' couldn't trumpet that any more loudly."

The State Highway and Public Transportation Commission approved the new design in its July meeting. The new tags will begin appearing when all the current plates are issued, probably by early spring, said Lawrence Smith of the Division of Motor Vehicles.

Two years ago, the slogan surfaced as an alternative to using the proposed label "The Friendship State", rejected by the commission after Texans said they didn't like the idea. ("Friendship" is the state's official motto.) The commission opted not to mess with Texas plates except to add the Texas flag on the upper left.

This spring, the Texas Legislature passed a resolution suggesting the department consider adding "The Lone Star State" to the redesigned plates.

"Though the resolution conveyed a suggestion, we agreed it was time to put Texas' unofficial but best-loved label on the plates," Oliver said.

Texas Vets Special Financing Available Through August 31

Texas veterans have until August 31, 1991 to submit bids on approximately 800 tracts of forfeited state land being offered with special low-interest three percent financing. Non-veterans purchasing a tract will pay four percent.

Located in 120 counties, these tracts are part of the Tex-Trax II program which gives Texas real estate agents the exclusive right to market certain forfeited properties.

"The board will consider all offers that meet or exceed minimum bids set for each tract on a 'first-come, first-served' basis," said David Gloier, Deputy Commissioner for the Texas Veterans Land Board.

Tracts range in size from five to 30 acres. The board will offer full financing on each property. No down payment is required and the board will offer 30-year fixed-rate financing on each tract. The buyer will be responsible for the current year's taxes only.

"The terms of this sale place owning land well within the reach of most Texans," Gloier said. "For example, the monthly payment on a \$19,000 tract financed at three percent on a 30-year note with no down payment would be \$83.00. That's a financing package that's hard to best."

Gloier emphasized that all offers to the Texas Veterans Land Board must be made through local real estate professionals.

Under the terms of the sale, agents receive up to a five percent commission on each sale paid by the buyer to the closing agent.

Commission Announces 90-Day "Amnesty" For Tank Registration

The Texas Water Commission has announced that, beginning immediately, owners of underground and aboveground storage tanks who have not yet registered their tanks with the state agency may do so without penalty for late registration until October 15, 1991.

"Many individuals or small business owners who own and operate tanks, or who have unused tanks on their property, have not registered the tanks with the TWC because of lack of knowledge regarding registration requirements or a fear of penalties for late registration," said TWC Executive Director Allen Beinke. "Because our main goal is for every tank to be properly registered in order to protect the environment, we are granting this short 'grace period' for owners to voluntarily comply with the law."

Owners of underground storage tanks that contain petroleum and other hazardous substances have been required since 1987 to register those tanks with the Texas Water Commission. Tanks not currently in use, but not properly closed out according to TWC standards, also must be registered. In addition, aboveground storage tanks that contain motor fuel-type petroleum products have been required to register with the Commission since 1990.

Only owners of registered petroleum storage tanks are eligible for clean-up reimbursement from the state's petroleum storage tank remediation fund in the event their tanks leak and result in environmental contamination.

After the tank registration "amnesty"

period ends on October 15, 1991, owners with unregistered tanks are subject to fines of up to \$10,000 per day. The amnesty policy does not apply to persons who have unregistered tanks that are discovered independently by the Texas Water Commission.

Registration requirements do not apply to certain tanks exempted by law or excluded by TWC rules, including small farm and residential tanks of less than 1100 gallons, heating oil tanks, hydraulic lifts, hazardous waste tanks, wastewater treatment tanks, small aboveground storage tanks of less than 1100 gallons, and certain other exempted or excluded tanks.

The PLEXAR I user is then free to place or accept another call. CTD is not intended to be used to avoid toll charges. Therefore, CTD will not be available to PLEXAR I customers subscribing to optional Extended Metropolitan Service or Extended Area Calling Service.

If the company's application is approved, the monthly rate for CTD will be \$4.00 for each PLEXAR I station line. Prior to the June 19, 1991, interim rate approval, Southwestern Bell was billing customers who receive the service \$1.50 for each station line equipped with this feature. In addition, under Southwestern Bell's proposed tariff, every line within the PLEXAR I system must be equipped with this feature. The nonrecurring charge for the additional lines which must be equipped with CTD will be waived for existing CTD customers. The tariffed monthly rate will apply to all existing and future CTD customers.

The Bivins-sponsored amendment to Senate Bill 3 eliminates all internal auditors employed by state agencies.

Agencies employ 304 internal auditors, who review respective agencies' operations and report to the executive directors. Bivins says a conflict of interest exists when auditors are supervised by agency heads.

"The purpose of an auditor is to ferret out waste and mismanagement. When abuse is identified, executive directors of state agencies often have little incentive to correct it," Bivins says. Internal auditors are a nice luxury in prosperous times, but the state can't afford them today," he says.

"Agency heads should be streamlining their operations without internal auditors. If they aren't, they're just not doing their jobs," he says. "If we find that internal auditing is an absolute necessity, then we can take half the money from the savings and allocate it to the State Auditor's office to form a crackerjack internal-auditing unit."

Eliminating the internal-auditing jobs would save about \$12.7 million a year, Bivins says, noting the figure includes salary and benefits for the 304 employees. The figure does not include related expenses, such as for office supplies.

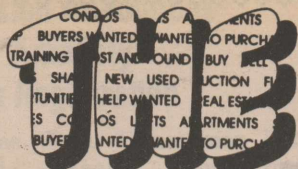
