TEXAS HIGHWAYS IS A PRIVILEGE, NOT A RIGHT

The highways of Texas are the property of its citizens. They constitute a system of nearly 200,000 miles of read of which 20,000 miles are designated as State highways and the remainder are county roads. All types of road are represented in this system, less than 5% have so-called "permanent" surface.

The total cost of these highways is unknown but it amounts to many hundred million dollars. From 1917 to 1980, inclusive, counties and road districts of the State issued \$243,592,884 in bonds for the construction and improvement of roads and bridges. In the two-year period ending August 81, 1930, the State Highway Commission sxpended \$89,082,825, of which \$22,488,426 was for maintenance of the State highways.

In view of these tremendous costs the preservation of our highways from rapid wear and destruction is a matter of very vital interest to their owners, vis., the public. It is especially important that they be made to outlast the life of the bonds, which run from 20 to 30 years.


The use of the public highways for commercial purposes is not a right but a privilege which may be withheld or granted subject to such restric-tions, regulations and charges as the Legislature may see fit to impose. tions, regulations and charges as the Legislature may see fit to impose. Such regulations are intended to promote enfety, preserve the highways and safeguard the interests of the public.

Texas Railroads, which pay the entire cost of construction, and mainte-nance of their own readheds and, in addition, make substantial contribu-tions to the cost of Texas highways, are thereasily regulated with respect to their services, rate, methods and practices. There is no good reason why commercial means of the highways, built and maintained at the expanse of the public, should not likewise be regulated to such entout as the public interest requires and pay such charges as will represent proper componen-tion for the privileges granted them.



WAR DEET CANCELLATION

The question whether Europe's war debts to the United States shall be cancelled will be one of the leading issues of the approaching campaign.

All Americans know where Governor Boosevelt and Speaker Garner stand on this vital question.

Obviously the European governments are organizing a drive, the purpose of which is the cancellation of these debts, and they and their fiscal agents can afford to put a lot of money into this campaign to insure the election of an administration which will be inclined to relieve Europe of this eleven billion dollars of debt and place the burden on the American people in increased taxes.


COMING HOME TO ROOST

The Imperial Economic Conference which is now being held at Ottawa will consider a plan said to have been effected by the steel interests of Great Britain which plan will bar from Canada all steel manufactured in the United States.

By the terms of the proposed agreement Canada will purchase in British steel markets all materials which she herself is not in position to manufacture, and Canadians will not develop new lines of steel manufacture to compete in the home markets with British steel.




