Council Hears Program on Plans For Local 911 Emergency Plan

Silverton's City Council met in regular session February 10, and heard Panhandle Regional Planning Commission representative Daniel Odneal present information on the 911 regional emergency network. Silverton and Briscoe County are scheduled to go on the 911 system by March 15, 1992. Briscoe County emergency calls will be routed to the Tulia Police Department because a 24-hour dispatcher is needed to handle the program. Silverton emergencies also can be handled in the same way as they are presently being handled.

Present at the meeting, in addition to the PRPC representative, were Mayor Wayne Nance; Councilmen John Bowman, Jim Estes, James Griffin, Wayne Henderson, Flute Hutsell; and Secretary Jerry Patton. None were absent.

Minutes were read and approved, and bills were approved for payment. The

Council discussed holidays that the City will observe in 1992 and motion carried to include Monday, February 17 (Presidents' Day), Monday, May 25 (Memorial Day), Monday, September 7 (Labor Day), Wednesday, November 11 (Veterans' Day), Thursday and Friday, November 26-27 (Thanksgiving), Thursday and Friday, December 24-25 (Christmas), and Friday, January 1, 1993 (New Year's Day).

The Secretary presented information on the City's 1991 TCD Grant application. The joint Silverton-Quitauque application was scored in seventh place. The joint grant application request for \$234,300.00 will receive partial funding of \$123,630.00.

Mayor Nance called a special meeting for February 18, at 7:00 p.m., to discuss the project. The Secretary was instructed to invite the City Council from Quitauque to attend the meeting.

The Secretary reported that the City's General Election will be held May 2, 1992. The terms of office will expire for Councilmen Estes, Henderson and Hutsell.

The bids for furnishing diesel and unleaded fuel for City operations were presented. Two bids were received. Both bids were current invoice prices plus a margin. They were Garvin Oil Company, invoice plus 3%, and Silverton Oil Company, invoice plus 6%. Motion was made by Henderson, seconded by Hutsell to accept the Garvin Oil Company bid. Motion carried. Councilman Estes abstained from voting. The bid contract is for a one-year period.

The January tax collection report was presented for review. The report showed a 77.8% collection rate.

A resolution for the continuation of a contract for the assessment and collection of property taxes between the City and Briscoe County Appraisal District was presented. Motion was made by Hutsell, seconded by Estes to pass and adopt Resolution 2-92 A. Motion carried.

A resolution to continue taxing personal property in Silverton was presented for review. Motion was made by Griffin, seconded by Estes to pass and adopt Resolution 2-92 B. Motion carried.

The Secretary reported that the used DPS car that the City has been trying to purchase has been reassigned in the DPS. A different vehicle, Unit D8-392, a 1988 Dodge with 78,427 miles, is available for \$3,350.00. Motion was made by Bowman, seconded by Griffin to authorize the City Secretary to purchase Unit D8-392. Motion carried.

The Secretary presented information on a computer from Quest Data System. The computer question was discussed and tabled.

Mayor Nance appointed Secretary Patton to represent the City as a member of the Red River Basin Water Quality Committee.

The Council discussed leasing the City airport for the coming year.

A letter from the Panhandle Conference of Mayors requesting the National Park Service's assistance in doing the necessary groundwork for development of a major historical attraction in the Panhandle was presented for review.

The Council voted to endorse the project and instructed the Secretary to write a letter expressing the City's support.

Council reviewed Chapter III of the Handbook for Mayors and Council Members before adjournment.

IN CASE OF AN EMERGENCY, WILL WE BE ABLE TO FIND YOU?

In preparing to establish 9-1-1 service in your area, the Panhandle Regional 9-1-1 Network, in conjunction with local emergency service providers, is asking all residents and business operators to complete and return this form.

The information you provide will aid emergency service personnel in locating your residence or business operation and cut precious seconds or minutes off their response time. The information will be very beneficial in finding rural locations since many homes are generally not numbered and many rural roads are unnamed. The information should be periodically updated by the resident and/or business operator when changes occur.

The information will remain strictly confidential. It will only be used when responding to a 9-1-1 emergency call.

The following should be considered before completing and returning the form :

1. If you have a telephone located elsewhere than just your business or residence, note this in the COMMENTS section. If it is a different number and within the vicinity of your residence, list that number also.

Include the children’s number if different from your own.

2. When giving directions from the nearest city, rural residents should give the highway number and begin routing directions from the city limits marker on that highway. If bad weather frequently causes the normal route to be impassable, include an alternate route.
3. In the COMMENTS section, list any circumstances or situations that would be helpful in responding to an emergency, such as health problems, guard dogs, locked gate, flammable material, etc..
4. If you wish, include nearest relative or friend to contact in an emergency situation, including name, address and telephone number in the COMMENTS section.

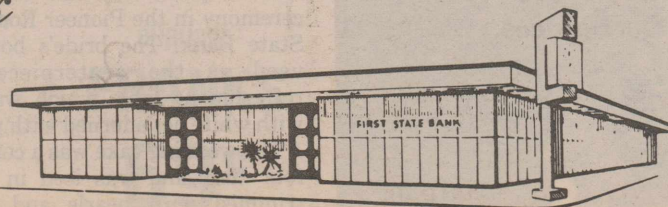

Are You An Environmentally Alert Consumer?

It's no secret that many areas across the country are facing a solid waste crisis because of an over-abundance of trash and not enough places to put it. Remember the floating barge of trash on the East Coast that no one would accept. We are not quite to that point yet; however, we all need to do our part. There are several solutions to the dilemma that we can all implement into our every day lifestyles.

The first is **source reduction**. This is any practice that reduces the amount of waste and may include making things last longer, reusing products or reducing packaging. This is the preferred option to the problem since it focuses on preventing the problem from occurring rather than trying to fix it afterward. Source reduction also saves natural resources (such as trees and oil) that are used to manufacture the products. It can be as simple as using a sponge, rather than a paper towel or resigning products so that less packaging is needed. For example, think about the packaging involved with deodorant. The product itself is usually in some sort of a plastic case. The case is then packaged in a cardboard box. The box may, in turn, be packaged in plastic wrap. The boxes themselves are packaged in larger boxes when shipped to the retailer. Is all of this really necessary? One company has included in its advertisements that its product is not repackaged numerous times. We should be aware of what we are buying. We are the ones who end up

paying for all of the packaging as well as disposing of the packaging.

Another step is to **reuse containers and products**. Can you use that plastic butter dish for something else, or the glass container that the applesauce comes in? If you can't, then you should think about recycling it. Many items now are coded with a symbol or code that tells recyclers what it is so that they will know how to recycle the product. Our only problem is finding places that will recycle the items. There are several recycling places in the area; however, you must take your items to them. There are still items, though, that many of these places do not have the capability to recycle.

One day, everything will be recyclable and we will all do our part in the process. Until that day comes, we must all do what we can to help alleviate needless waste today.

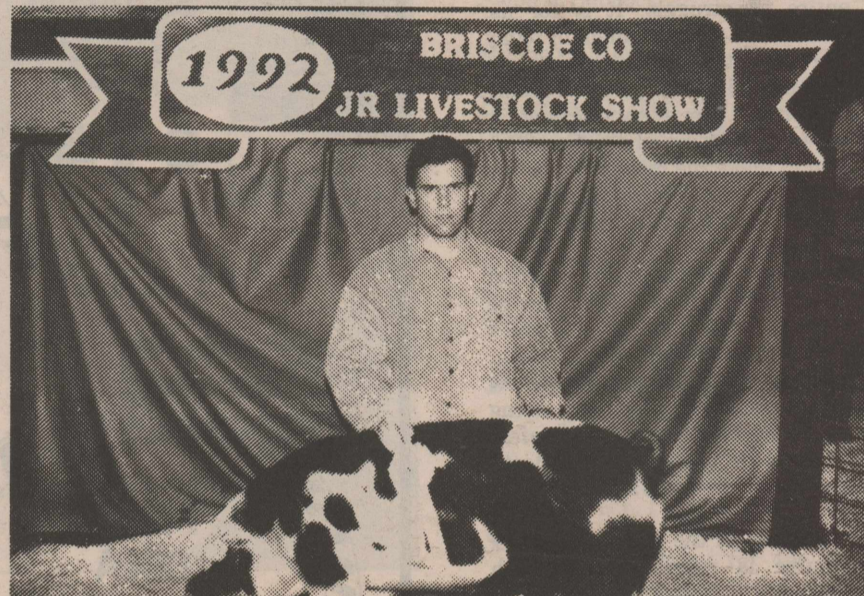

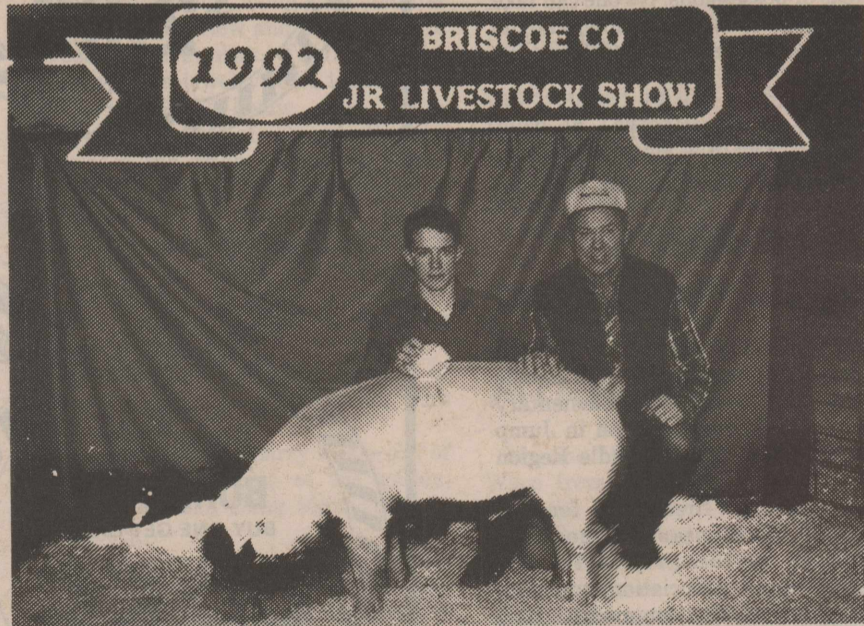

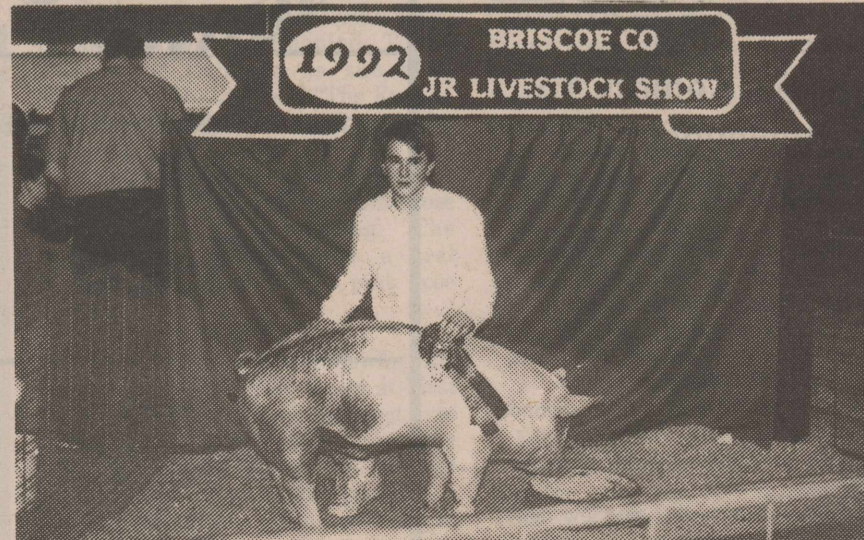

OUR NATION'S LEADERS WERE ALWAYS LED BY GOD'S GUIDANCE

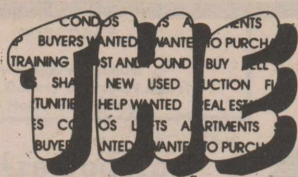

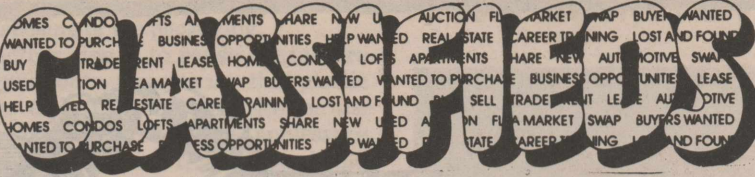
