### Hutsell Named Fireman of Year

Flute Hutsell received the Fireman of the Year award at the annual banquet of the Silverton Volunteer Fire Department Saturday night. The presentation was made by Jerry Patton, who said, in part:

"Flute joined the department April 1966, right after the Silverton Clay Plant burned to the ground. His main reason for joining the fire department was to show everyone how to put out fires and save lives and property damage here in Silverton.

"After four years of intense training, Flute finally became the top dog, Fire Chief, in 1970 and served for 13 years as Chief

"Under Chief Hutsell's terms of office he was instrumental in upgrading the department, training, equipment and membership enrollment. In 1966 when Flute joined the department, we had a 1928 fire truck and a 1948 fire truck and they were very undependable. We now have six pieces of fire fighting equipment, bunker coats, boots and hats for 25 firemen, plus air packs and other equipment.

"Flute quit the fire department in 1984 for personal reasons and the fire department burned three or four houses, Jerry Miller's being one of them, and Flute couldn't stand it so he rejoined in 1986 and worked his way back to the Top Dog again in 1988 and served as Chief through 1991.

"Under his leadership we have managed to burn a lumber yard, two churches, his own home, his shop and yard fence twice in the same day, and a few other houses and cotton gins. "Flute has received the Bonehead Award for 'screwing up' more than any other firemen in the department!

"Flute received his 20-year service certificate in January 1989. He has served the fire department a total of 22 years, has been our Chief for 17 years, was Fireman of the Year in 1975 has sold more fire department raffle tickets and spent more money than anyone else in the department, and for all this dedicated service we now bestow on Fireman F. E. Hutsell the 1991 Fireman of the Year award and a \$2.99 belt buckle," Patton concluded.

Doug Bradford was recipient of the Bonehead Award for losing the pump for the Hurst tool at a range fire last year. Fortunately, the landowner found it and returned it to the department.

The meal consisted of steak and all the trimmings, and a band from Plainview provided entertainment.

County producers who suffered crop losses in 1990 or 1991, due to natural disaster, should check with the ASCS office for eligibility requirements.

To be eligible, you must have had a loss greater than 35 percent on crops with insurance, or greater than 40 percent on crops without insurance. All crops are eligible—participating and non-participating, program crops and non-program crops—except crops on ACR and CU for Pay, and minor oilseeds for payment.

State and local officials even are taking the polls to the people in a new form of balloting called "mobile voting."

"It will put voting right in the middle of people's lives. They can do their shopping and cast a vote, or cast a vote and do their shopping—whatever their priorities are," Hannah said.

Since Texas enacted its "no-excuses, in-person absentee voting" law in 1987, lawmakers have taken several steps to boost voter turnout.

The Legislature renamed the absentee system "early voting". Other changes allow temporary polling places to be set up at malls and other gathering places.

Voting is underway in Silverton at the office of County & District Clerk Bess McWilliams in the Briscoe County courthouse.

#### IN CASE OF AN EMERGENCY, WILL WE BE ABLE TO FIND YOU?

In preparing to establish 9-1-1 service in your area, the Panhandle Regional 9-1-1 Network, in conjunction with local emergency service providers, is asking all residents and business operators to complete and return this form.

The information you provide will aid emergency service personnel in locating your residence or business operation and cut precious seconds or minutes off their response time. The information will be very beneficial in finding rural locations since many homes are generally not numbered and many rural roads are unnamed. The information should be periodically updated by the resident and/or business operator when changes

The information will remain strictly confidential. It will only be used when responding to a 9-1-1 emergency call.

The following should be considered before completing and returning the form:

1. If you have a telephone located elsewhere than just your business or residence, note this in the COMMENTS section. If it is a different number and within the vacinity of your residence, list that number also.

Include the children's number if different from your own.

- 2. When giving directions from the nearest city, rural residents should give the highway number and begin routing directions from the city limits marker on that highway. If bad weather frequently causes the normal route to be impassable, include an alternate route.
- 3, In the COMMENTS section, list any circumstances or situations that would be helpful in responding to an emergency, such as health problems, guard dogs, locked gate, flammable material, etc..
- 4. If you wish, include nearest relative or friend to contact in an emergency situation, including name, address and telephone number in the COMMENTS section.


