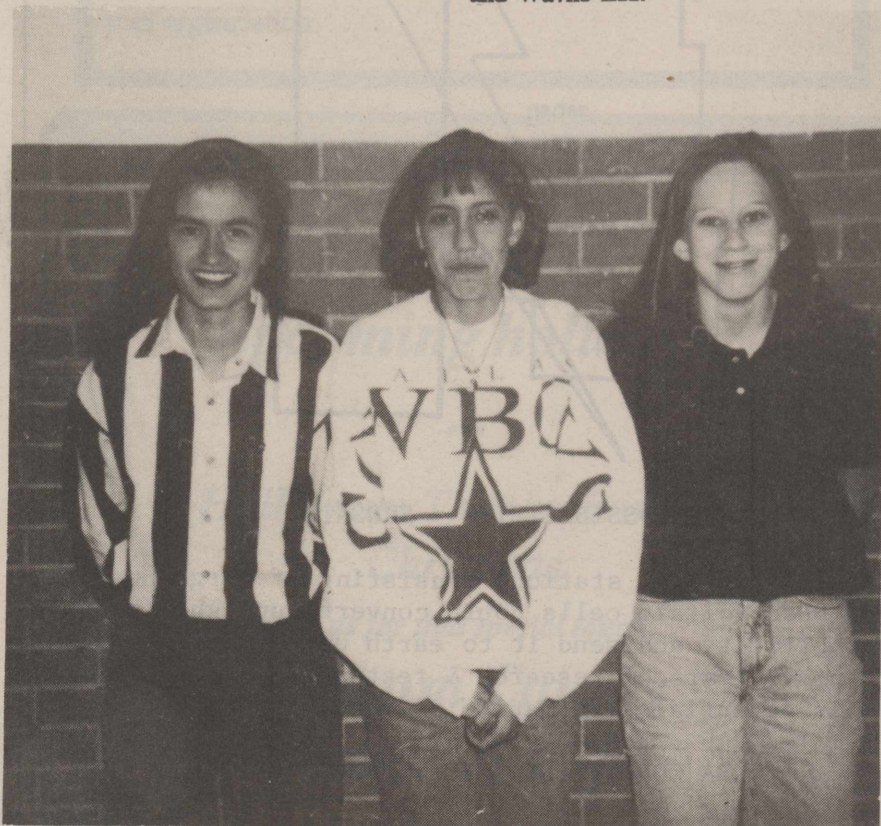

Yoakum SWCD to elect directors for Zones 1 & 2

The Yoakum Soil and Water Conservation District will hold an election for the Zones 1 and 2 Directors at 8 a.m. on Oct. 6, 1994 at the Plains Community Center.

Zone 1 covers the Southeast quarter of the county, excluding a square, six miles by six miles on the Northeast corner. The present director is David Turnbough who has announced that he is retiring.

Zone 2 covers the Southwest quarter of the county, excluding a square, six miles by six miles on the Northeast corner. The present director is Larry Morrow. Larry has indicated he will continue to serve, if nominated and elected. Candidate nominations will be made from the floor, at election time.

In order to serve as a director, a person must first meet the criteria of an eligible voter, as defined below. Additionally, the person must own land within the numbered subdivision for which the election is being held and must be actively engaged in the business of farming or animal husbandry.

Eligible voters for this election are individuals who hold title for farmland or ranchland lying within Yoakum County, which is the area covered by the District, are a resident of the county, and are 18 years of age or older. Title is considered to be owned by both husband and wife in this community property state. If a family farm corporation owns farmland or ranchland in the District then the corporation is entitled to one vote. The corporation shall designate one corporate officer to vote for the corporation. The designated officer must be 18 years of age or older and be a resident of the county.

Mr. Mike Holt, a farmer in the Spearman, Texas area will be our guest speaker. Holt is our area director on the five member board of the Association of Texas Soil and Water Conservation Districts. The title of his talk is "The Future of American Agricultural".

Mr. Bill Fryrear, Research Leader at the Big Spring, Texas USDA Agriculture Research Service (ARS) Cen-

ter, or a member of his staff, will also be at the meeting to give a background and status report on the two Yoakum County wind erosion test sites installed Feb. 8, 1994. These test sites are being jointly conducted by the Agricultural Research Service Center and the Yoakum Soil and Water Conservation District, with support from local and Area SCS offices. The District furnishes a person to collect the data, SCS furnishes a pickup and the ARS provides the needed test equipment. Sponsors are needed by the District to help with the approximately \$1500 annual data collection cost.

All persons interested in conservation activities in the District, State and nation are invited to attend. Refreshments will be provided.

Services held in Lovington for residents' young grandson

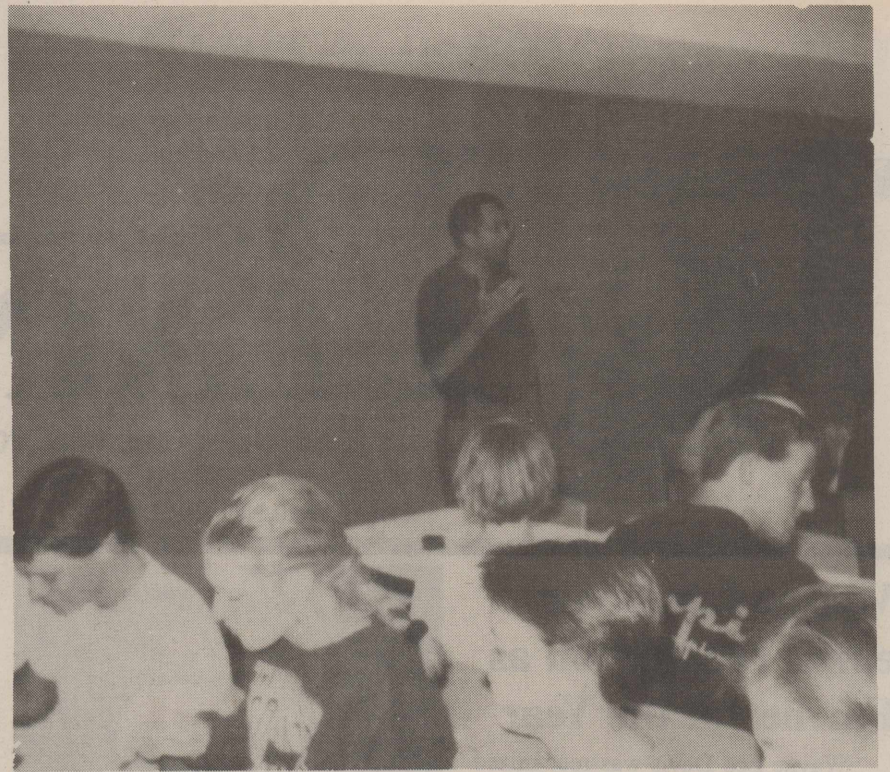

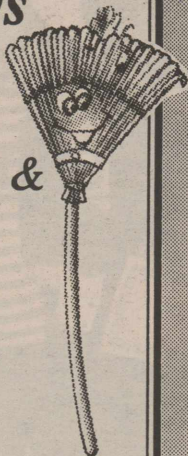

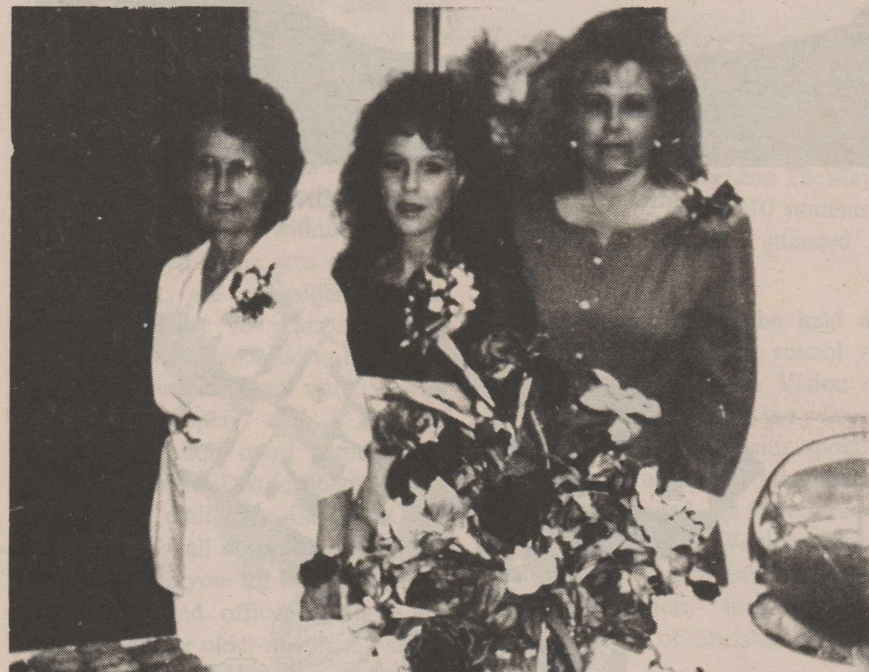

Dirt Gardeners plan projects

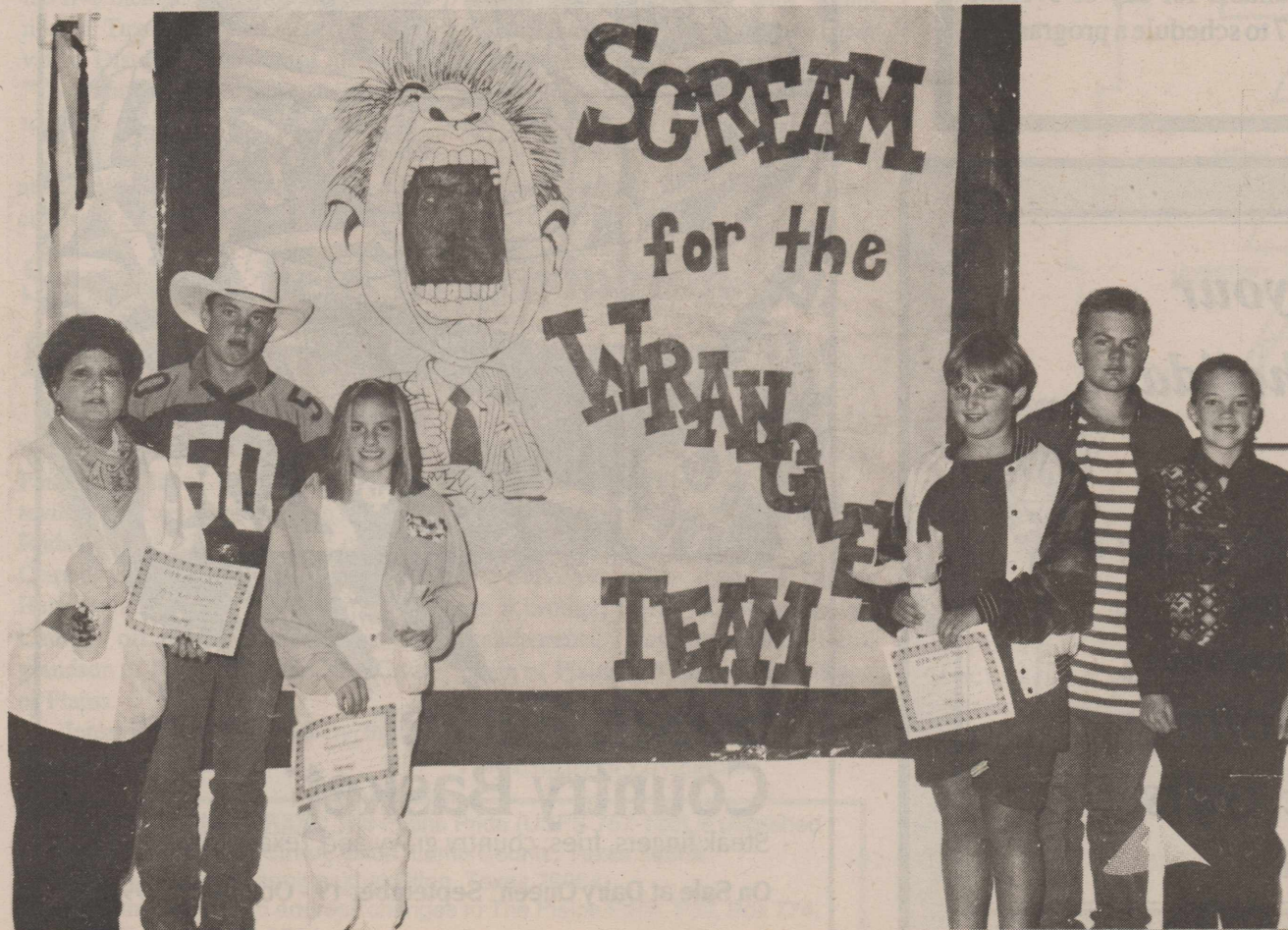
Plains Dirt Gardeners met Sept. 19 in the clubroom.

Plans and suggestions for the upcoming club year were discussed. Velma Dearing was appointed to be in charge of planting around the Booster Club sign.

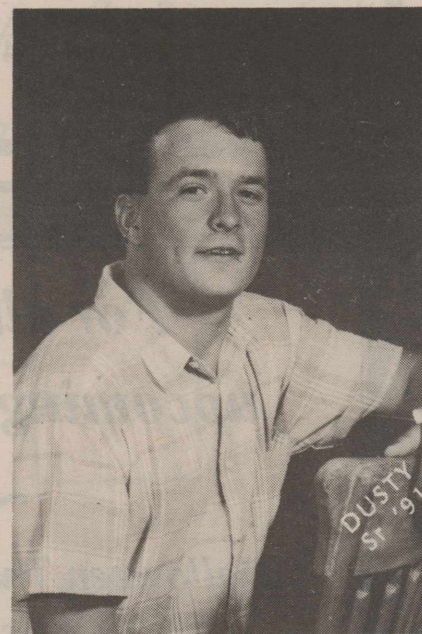

Members of the Class of 1984 of Plains High School gathered for a ten-year reunion this summer. They toured the school and met for a dinner in the community center with their families.

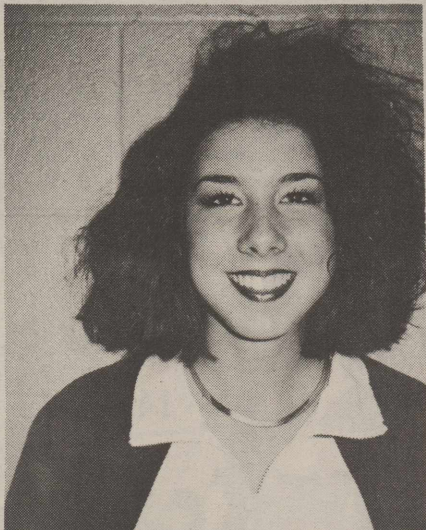

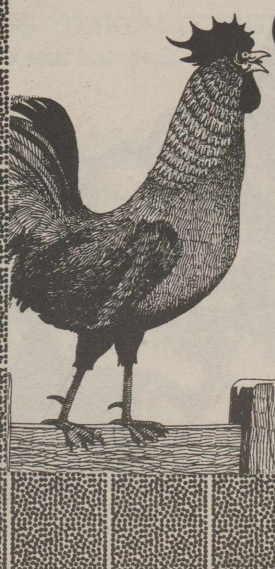

TFB 'Friends of Ag' endorse George W. Bush for Texas governor

Texas Farm Bureau Friends of Agriculture (AGFUND) has tapped Republican gubernatorial candidate George W. Bush to head up its slate of endorsements in statewide races in the upcoming general election.

U.S. Senator Kay Bailey Hutchison (R-Dallas) also gained the backing of AGFUND, the political action committee of the state's largest farm organization, in her re-election bid.

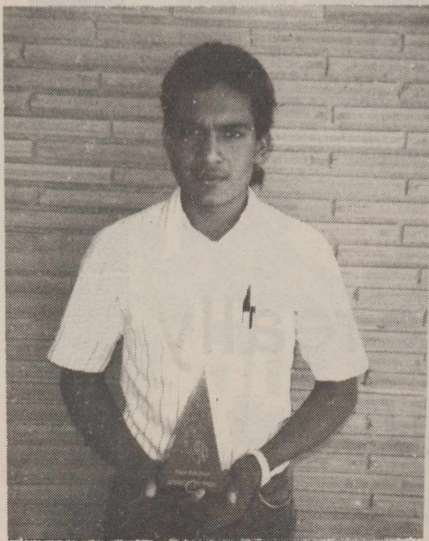
Other AGFUND endorsements for statewide offices include: Bob Bullock, Democrat, Lt. Governor; Dan Morales, Democrat, Attorney General; John Sharp, Democrat, State Comptroller; Marta Greytok, Republican, General Land Commissioner; Rick Perry, Republican, Ag Commissioner; Mary Scott Nabers, Democrat, Railroad Commissioner, Place 2; Raul A. Gonzalez, Democrat, Supreme Court, Place 1; Nathan L. Hecht, Republican, Supreme Court, Place 2; Priscilla Owen, Republican, Supreme Court, Place 3; and Charles F. Campbell, Democrat, Criminal Appeals, Place 1.

"The philosophies and records of these candidates most closely parallel the policies of our organization," said TFB President Bob Stallman, who also serves as AGFUND chairman. "Our members feel these candidates have the qualifications and experience to serve not only agriculture but all of Texas very effectively."

A businessman with a background in oil and gas, Bush is a General Partner of the Texas Rangers baseball organization.

Hutchison, an attorney, served as state representative and state treasurer prior to being elected to serve out an unexpired term in the U.S. Senate two years ago.

Bullock, the current Lt. Governor, owns a ranch in Llano County. Prior to election to that post, he served as State Comptroller, Secretary of State and as a state representative.



HECTOR GALLEGOS, son of Manuel and Lupe Gallegos was named Plains High School Student of the Week for Sept. 19-23. Nominated by Robert Canon and elected by the High School faculty, Hector is a junior. "Hector is always ready and willing to help his fellow students whenever necessary," says his instructor. "He is continually striving for excellence in everything he undertakes."

Prior to becoming the 48th Attorney General of the State of Texas in 1991, Morales was an assistant prosecutor in Bexar County and served three terms in the Texas House of Representatives.

Sharp is the incumbent in the State Comptroller's race, with almost 15 years of public service as a state representative, state senator and railroad commissioner.

General Land Office challenger Greytok has served in various capacities involving land management, including chairman of the Public Utility Commission of Texas for six years, chairman of the Harris County Central Appraisal District and as a mayor.

Perry, an AGFUND-backed candidate in 1990, has served mainstream agriculture well during his first term. A farmer and rancher, Perry was a state representative during the five years preceding his election to a statewide office.

Nabers was appointed to the Texas Railroad Commission in 1993. A native of Cross Plains, she has worked to minimize bureaucracy and to be accessible to the public in her role as Railroad Commissioner.

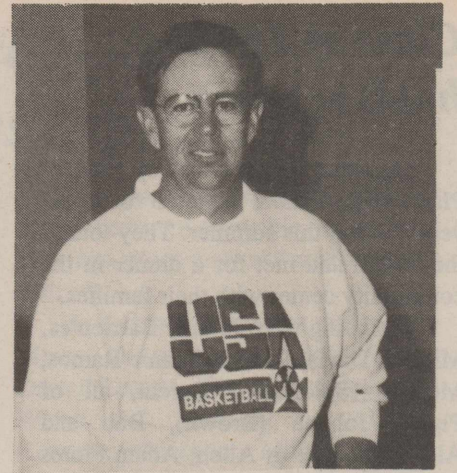
Gonzalez was first appointed to the Texas Supreme Court by Gov. Mark White in 1984. He was elected to complete that term in 1986 and to a six-year-term in 1988.

As head of the Rules Committee, Justice Hecht seeks re-election to continue his work toward making the Texas legal system faster and more cost efficient.

With more than 16 years in state and federal courts across Texas and the United States, Owen is reform-minded, advocating limitations on contributions from individuals and lawyers in campaigns for seats on the Texas Supreme Court.

After working for more than a decade in the area of criminal prosecution, Judge Campbell was first elected to the Texas Court of Criminal Appeals in 1982 and re-elected for a second term in 1988.

AGFUND is a legal entity separate from the Texas Farm Bureau and may endorse and contribute financially to political candidates. AGFUND is funded only by voluntary contributions of Texas Farm Bureau members.

Group applauds Dan Morales' actions

"Take Back Texas, Inc.", and Austin, Texas based Grass Roots organization of concerned Texans for Private Property Rights, applauds Texas Attorney General Dan Morales' action of Aug. 24, 1994 at which time Morales placed Secretary of the Interior Bruce Babbitt on formal legal notice of Texas' intention to sue the United States government if the U.S. Fish and Wildlife Service proceeds with its announced plans to designate 33 Texas Counties as "critical habitat" for the golden-checked warbler.

We now call on Attorney General Morales to formally notify Secretary Babbitt that Texas will institute similar legal action against the U.S. Government if U.S. F&WL Service proceeds with designating any further "habitat"

or "critical habitat" for the swift fox, Houston toad, red-cockaded woodpecker, jaguar, or any other so-called "endangered" species, whether plant, animal, bird, or bug, which the U.S. Fish & Wildlife Service has under consideration for possible illegal imposition on Texas.

TWDB approves \$\$\$ in Ag loans for five conservation districts

The Texas Water Development Board recently approved loans totalling \$6.6 million to five underground water conservation districts.

The loans approved by the Board today include \$4.0 million to High Plains Underground Water Conservation District No. 1 in Lubbock; \$1,000,000 to South Plains Underground Water Conservation District in Brownfield; \$600,000 to Evergreen Underground Water Conservation District in Jourdanon; \$500,000 to Panhandle Ground Water Conservation District No. 3 in White Deer; and \$500,000 to Sandy Land Underground Water Conservation District in Plains.

The low interest rate offered by the Board results from securing \$1.2 million in U.S. Department of Energy Oil Overcharge Funds provided through a grant from the state's General Services Commission. These funds will be used to buy down the interest rate on a seven million dollar block of Agricultural Water Conservation bonds to be sold by the Board in October.

The districts will use the bond process to make low-interest loans to area farmers and ranchers to purchase and install more efficient water conservation equipment.

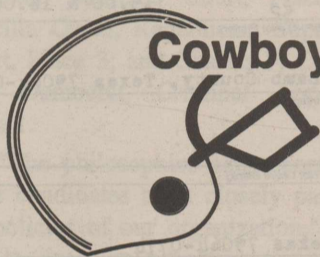
SEVENTH GRADE

David Bitolas scored again in the second half on a 27-yard run to bring the final score to 28-0.

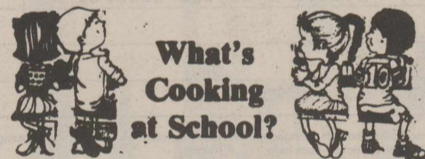
Bernal went six for 11 for 72 yards. The Cowboys combined for a total of 232 rushing yards with Stephen Bitolas carrying for 122 of those yards.

SPC student gets invitation to sing on Grand Ole Opry

Melissa Marshall doesn't have a country music hit to her credit. Or a contract with a major country music recording label. Or her name in lights. Yet.

But the 19-year-old South Plains College commercial music student from Sullivan, Ohio does have an invitation to perform Oct. 8 on the Grand Ole Opry.

That's rare for an untried young performer. "That's never happened, going from college to the Opry. I feel very honored that a college student would be selected to perform on the show," said Marshall, who will sing two Suzy Boggus yodeling numbers for the performance. "They usually have people with a major hit record or someone with a unique standing in the country music business," said the daughter of Jane and Glenn Marshall.

Marshall's chance came when she met Hal Durham, Grand Ole Opry president, during his recent lecture at SPC where the young woman is majoring in commercial music, sound technology and performing arts. "I suggested she send me a tape, and I would be glad to listen to it," said Durham.

Marshall subsequently sent him audio and videocassette tapes of her performances while on tour this summer with Country Caravan, an SPC country music traveling show.

Durham liked her style. "We have our own basic group of entertainers that we hire for the Opry, but I liked Melissa's enthusiasm and the fact that she can sell a song to an audience. I think she'll do a very professional job on the Opry stage."

John Hartin, chairman of SPC's Creative Arts Department, commented, "It's a very unusual thing to go from the college classroom to the stage of the Grand Ole Opry. I'm very excited that this sort of opportunity exists for people who are studying in our programs."

For her Opry appearance, Marshall will perform "I Want To Be A Cowboy's Sweetheart" and "Night Rider's Lament". The show begins at 6 p.m. (CST) on WSM Radio.

But the possibility for instant fame doesn't seem to bother her. "I've been bouncing around practicing, but I'm not nervous," she said.

She has been preparing for this break for a long time.

A child of the 80s, Marshall grew up listening to her mother's collection of 60s artists like The Beach Boys and The Platters. By the time she was eight, she had joined a country music band and as a teenager won the junior princess and princess titles for the Country Music Association in Ohio.

She enrolled at SPC to continue her music training. She has polished her vocals and learned to play the guitar from SPC faculty who are masters at their crafts. She has performed with a local television ensemble and learned the intricacies of engineering a demo in SPC's topnotch recording facilities.

"I'm a studio rat; I like doing that," she admits.

All this hard work is toward a longtime goal. "I would like to be CMA Female Vocalist or Entertainer of the Year," she explained. "But it's not about the shiny lights and the glimmer. It's about me. I know where I am headed, and that's important. If you don't believe in yourself, nobody else will."

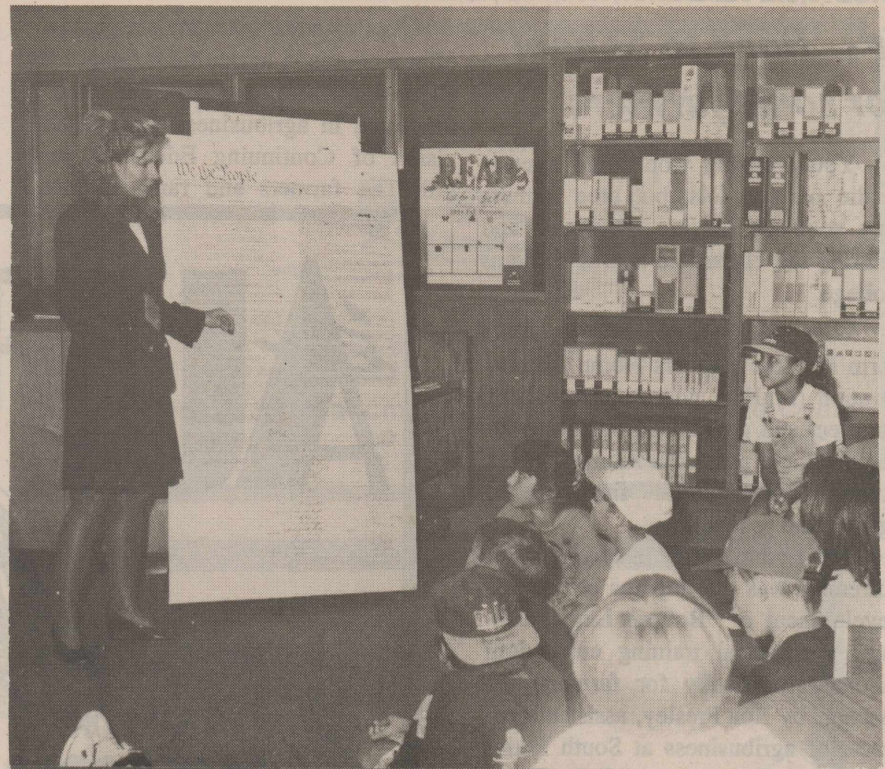

Plains Junior High students celebrate 'Constitution Week'

Plains Junior High School in Plains celebrated the 207th anniversary of the U.S. Constitution during a ceremonial Constitution signing with a representative from U.S. Senator Phil Gramm's office on Tuesday, Sept. 20 at Plains Junior High School.

Jennifer Crabtree, regional director of Gramm's office in Lubbock, led the signing ceremony and delivered remarks on the significance of Constitution Week.

"The United States Constitution has served as the foundation on which generations of freedom-loving people have built their hopes and dreams. It has furnished ordinary people, like you and me, an abundance of individual liberty and opportunity thus enabling us to accomplish ordinary feats," Gramm said in a letter read by Crabtree.

"It should never be forgotten that the effectiveness of American democracy has always depended upon an informed and involved citizenry. Proper steward-

ship of responsibilities which accompany American citizenship is essential if we are to preserve democracy and secure America's future," Gramm said.

"No matter how many people are in the majority or how many people think they know better, the basic fundamental right of every American to live free is the true genius of the U.S. Constitution," the Senator added.

The U.S. Constitution guarantees the freedom and rights of all people living in the United States. It secures the freedom of religion and speech, as well as other listed rights. The Constitution has three main principles, which are: inherent rights, government by the people and separation of powers.

Constitution Week, sponsored by the National Constitution Center, is celebrated Sept. 17-23. A replica of the Constitution, signed by the people of Plains during the ceremony, will be displayed at the National Constitution Center in Philadelphia for the next 12 months.

It's 'Back to School' for some farmers

You probably won't find tractors in the parking lots, but area farmers may soon be leaving the fields and entering the classroom at South Plains College.

With the passage of the 1990 Farm Bill, the Farmers Home Administration (FmHA) now requires all of its direct and guaranteed borrowers to complete and pass educational courses involving agricultural finance and agricultural production.

The continuing education requirement was the impetus behind the development of "Bottom Line Farming", a financial training curriculum tailored specifically for farmers and ranchers by Ron Presley, assistant professor of agribusiness at South Plains College, in conjunction with the Texas A&M Extension Service and Texas Rural Communities.

Texas Rural Communities, a non-profit organization based in Austin which was chartered to develop programs that aid rural communities, hired Presley in 1991 as a consultant to develop a curriculum which would meet the requirements specified by the FmHA to teach farmers advanced financial techniques.

In addition, an agreement recently was reached permitting Presley to run a pilot program designed to test the curriculum at South Plains College and four other community colleges in the state.

"I'm thrilled to get to be a part of this exciting new challenge and opportunity," said Presley, who was assisted in coordinating plans and course scheduling by Jim Jenkins, associate professor of agriculture, and Dave Cleavinger, instructor of agriculture.

"South Plains College is really getting to be the leader in this project. By working in the development of the curriculum, I have improved my abilities to teach agricultural finance, and as SPC offers this course in our community, we can be proud of the fact that we're serving area farmers and ranchers."

South Plains College will be the institution that serves as the central communication point within the network of other Texas institutions that offer the "Bottom Line Financing" financial training curriculum. Presley also will be charged with managing communications between the FmHA and the other participating community colleges. Financial support will be provided by Texas Rural Communities.

The course consists of 36 classroom hours that can be designed to fit the schedule of the farmers and ranchers. The curriculum begins with goal setting and priority management, and continues to cover interpretation and use of financial statements, strategic planning, operational planning and other practical aspects of farm financial management.

Presley estimates that 5,000 to 8,000 participants will be involved in the course across the state during the next three years, including some 500 participants at South Plains College.

Presley adds that there are plans to offer a course in agricultural finance to all area farmers, ranchers and others interested in agribusiness through Division of Continuing Education this fall. The farmers and ranchers have

two years to complete the course in order to comply with FmHA regulations.

"South Plains College can claim the distinction of being the community college that took the lead in working to organize this effort," Presley says.

"South Plains College had the goal-based foresight to work with other institutions and agencies to develop a partnership to better serve our community."

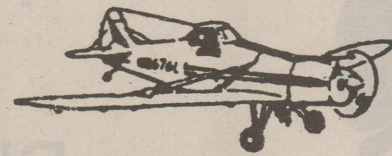
