Sporadic rains do little to assist tired West Texas firefighters over weekend

Sporadic rains that moved through Texas over the Fourth of July weekend did little to assist regional firefighters with fire starts, as a number of new wildfires started in both Potter and Motley counties, as well as the Big Bend country of the Trans Pecos area.

"Rains helped us just enough over the Fourth of July holiday," indicated Incident Commander Ron Davis with the Texas Forest Service's Wildfire Mobilization Staging Area in Abilene, "to keep fires caused by fireworks to almost nothing."

Two new wildfires caused by lightning started in Potter and Motley counties on Sunday. The Potter County wildfire is estimated at 1,500 acres. The Motley County wildfire is estimated at 1,000 acres, and is threatening some structures.

The majority of firefighters located at the Texas Forest Service's Wildfire Mobilization Staging Area (TFS WMSA) in Abilene were dispatched to both fires Sunday evening. These forces consisted of 100 firefighters from 17 states. Two more wildfire strike teams have been ordered to compliment the current firefighting force. Wildfire firefighters in Texas currently have over 160 pieces of firefighting equipment and over 45 aircraft and helicopters to assist them.

Other wildfires caused by lightening strikes in the Trans Pecos area started on Sunday, but no acreage determination has been provided to date. Several volunteer fire departments (VFD's) are working those fires.

Since May 1, 426 Texas wildfires have burned over 260,000 acres.

Since May 1, 4,426 wildfires have burned over 260,000 acres, and Texas Forest Service officials indicated that most of Texas west of I-35 is still under an Extreme Fire Danger Alert. The TFS is requesting that no outside burning be attempted until adequate rainfall has been received, which is not expected until the middle of August or later.

"What we worry about is people thinking because we have a little rain, it is going to be alright to do some outdoor burning," stated Information Officer Lou Sloat with the Texas Forest Service's Wildfire Prevention Team in Abilene. "But people need to realize that it is going to take a steady rain over a several day period to help relieve the fire danger situa-

Some 162 Texas Counties have issued burn bans, and Texas has staged some 869 wildland firefighters from 27 states strategically around the state to move on any wildfires that start.

Conditions are not expected to improve and are expected to get worse over the next ten day period, with temperatures in the triple digits throughout the western half of the state.

Texas Forest Officials are asking everyone to take these simple precautions:

• Dispose of all smoking material properly.

• Don't drive your vehicle off the road into tall dry grass. • Dispose of all barbecue mate-

rials properly.

· Don't attempt to do any outdoor burning.

• Don't use power tools or welding machines in areas around dry

With everyone's help, Texas Forest Service officials feel they can keep the number of wildfire starts at a minimum. If you see a wildfire, please call 9-1-1 imme-

DRESS AND GROOMING


The District's dress code is established to teach grooming and hygiene, prevent disruption, and minimize safety hazards. Students and parents may determine a student's personal dress and grooming standards, provided that they comply with District guidelines.

Dress and grooming practices that create safety hazards or disruption and therefore are prohibited include the following

- 1. Pictures, emblems or writing on clothing or elsewhere that are lewd, offensive, vulgar or obscene, that advertises or depicts tobacco products, alcoholic beverages, drugs or any substance prohibited under school policy or that suggests devil worship/occult activities, either explicitly or by innuendo. This would include skeletons, skulls or demonic representations that are commonly used by many hard-rock or types of bands
- 2. Shirts that expose the midriff when the student's arms are raised. Tank-tops and jerseys may be worn over tshirts, if otherwise appropriate
- 3. "Baggy" or oversized trousers and trousers worn down around the hips. (sagging trousers are expressly forbidden)
- Skirts and dresses not extending to at least the fingertips when arms and fingers are extended to the sides.
- 5. Shorts or skorts, except during PE
- 6. Clothing that is considered revealing, excessively tight, clothing with slits, splits, tears or holes, or deemed inappropriate by the building principal.
- 7. Hats, caps, head-dress, etc., shall not be worn in school buildings or at any indoor school-sponsored functions. Caps worn to outdoor functions must be worn with the bill forward.
- 8. Chains, functional or ornamental, shall not be worn as a part of clothing.
- 9. Ornaments in, on, or around the ears or nose of male students or nose ornaments on female students.

10. Facial hair.

- 11. Male students hair that extends past the bottom of the collar on a normal dress shirt or the middle of the ear or impairs vision
- Male student's hair must be neatly groomed. The length and bulk of the hair will be such that it does not present a ragged, unkempt or extreme appearence. The hair should present a tapered appearence when combed and not fall past the middle of the ear or eyebrow or past the collar on a normal dress shirt.
- Male students will not wear "tails" or ponytails of any form.
- *** There will be no designs shaved in the hair or multiple lengths of hair above the ears.
 - "Chili bowl", "chopped" or "cropped" cuts do not conform to the above policy.




