Ila K. Gross awarded CCS credentials

The American Health Information Management Association (AHIMA), the association for the nation's 38,000 medical record and health information management (HIM) professionals, recently awarded Knox City resident Ila K. Gross, Certified Coding Specialist (CCS) credentials.

CCS certification signifies that Ms. Gross passed a difficult exam designed to measure her health care coding skills. Healthcare coding is the process by which diagnoses and treatments are converted into numerical volues, whicha re used to determine the amount of payment for healthcare services. Healthcare coding also is the under pinning of medical research, outcomes measurement, and methods of determinint the cost effectiveness of patient care.

"CCS certification is the ultimate symbol of competency in the area of healthcare coding," AHIMA president Claire R. Dixon-Lee, PhD, RRA, said. "Anyone who has passed the certification exam has proved his or her coding expertise beyond the shadow of a doubt."

A total of 1188 individuals took the CCS examination in 1998. The test was administered on September 18, 1998. The names of the 812 CCS recipients will appear in an upcoming issue of the Journal of AHIMA, the national publication for healthcare coders and other HIM professionals.

State Plan 2000 public hearing set January 29 in Throckmorton

The Area Agencies on Aging of West Central Texas and North Texas in collaboration with the Texas Department on Aging (TDoA) will hold a public hearing on the current and future needs of older Texans. The hearing will take place at 1:00 p.m., Friday, January 29, at the Community Center in Throckmorton.

Area Agencies on aging (AAAs) hold these meetings to collect public comment on area plans for services they intend to fund. Required services include information and referral, benefits counseling and nursing home ombudsman. The AAAs must describe how they intend to reach older people with the greatest social and economic need.

The Department on Aging reviews and approves the area plans of Texas' 28 AAAs and distributes federal and state funds to the local level.

The 28 plans are then folded into a state plan which is submitted for approval to the Governor and the federal Administration on aging.

The federal Older Americans Act (the federal law under which TDoA and the Area agencies operate) requires both the state and area offices on aging to solicit the public's views about needs and concerns of older people.

The best known programs funded by the Department on Aging and the area offices are probably the nutrition programs. However, depending upon local needs in each area, many other services are available: case management, transportation, homemaker, personal care, residential repair, information and assistance, adult day care, care giver education and more.

In the current round of hear-

ings, TDoA wants to take public input a step farther than usual. "There are more than two million people in Texas over the age of 60 right now", Christy Fair, TDoA's Director of Policy and Planning, said. "That number will increase by 30 percent within ten years, and by 2030 there will be almost eight million older Texans. When you think of that, you can understand how crucial it is for us to hear from the public about more than the needs of Texans who are older right now."

"We absolutely need to also hear from family care givers and Baby Boomers who themselves will be older in just a few years. We want Texas citizens everywhere to comment about how what we're doing right now will affect older Texans tomorrow."

In the public hearing scheduled for this region, the hosts are asking local people to not only speak up about current and future aging concerns, but also how funding decisions are made, how services provided now are doing and what gaps in services need to be filled.

Serving on the hearing panel and receiving public comment will be representatives from the Texas Board on Aging, the Texas Department on Aging, the Area Agencies on Aging and a member from each AAA's local citizens advisory council.

Jane brought a most enjoyable informative and easy to understand, program entitled "Diet -Lowering Our Fat". She had displays and diagrams showing the amount of fat in different foods. For example: test tube type containers showing amount of fat in whole milk and amount of fat in lowfat milk. Believe me - seeing is believing.

Her display showed five (5) factors that contributed to high cholesterol which were: diet, exercise or lack of it, one's weight, smoking and heredity (or family genes).

Members were also shown tube type things representing four or five arteries and showing degrees of blockage, from clear to slight to complete blockage. Also a display showing a replica of a gob of fat equivalent to a pound of fat again - seeing is believing.

Foods that are high in calories as well as cost is many snack foods.

She stressed that babies 0-2 years of age need fat in their diet. For one thing, it helps in developing the brain. After age of two, children's diets should be monitored. For example, lowfat milk, fresh fruit and vegetables to mention a few. Jane stressed to read labels carefully in store!!

Jury finds Clyde man guilty of two felony offenses

A six-man, six-woman Knox County District Court Jury last Tuesday found Jerry Edward Dugan, 32, of Clyde, Texas, guilty of two felony offenses occurring in the same criminal episode, according to District attorney Bill Neal.

The jury found Dugan was guilty of Felony Driving While Intoxicated as well as Felony Theft, both offenses occurring on November 29, 1997, in Knox City.

District Judge David Hajek presided over the trial and after the jury found the defendant guilty of both offenses, Judge Hajek sentenced the defendant to a 10-year prison sentence for the felony DWI case to run concurrently with a two-year prison sentence in the felony theft case.

The evidence presented by the State indicated that the defendant and a lady companion arrived in Knox City around 10:30 p.m. on November 29, 1997 after riding around all afternoon drinking beer and tequila. Both lived in Clyde, Texas, at the time. After arriving in Knox City, the evidence showed Dugan and his companion parked their car at the Dairy Queen parking lot and then stole a truck and trailer belonging to Samuel Lee Hunter of Munday, which had been parked there overnight by his driver, Junior Montes. After the defendant drove the

truck a few blocks down Main Street, he rear-ended a pickup driver by Dwayne Chaney of Knox City. Chaney had stopped for the stoplight at the intersection of Main and Central. After attempting to flee the scene of the collision, the defendant was run down and stopped by Brandon Lewis, then of Knox City, who had witnessed the collision from the Allsup's parking lot.

Officer Harry Steen of the Knox City Police Department arrived on the scene and investigated the incident and subsequently took Dugan to the Knox County Hospital where a blood test was obtained, which indicated he was intoxicated at the time.

A search of Dugan's record revealed he had been previously convicted of DWI on numerous occasion.

In his defense of the theft charge, the defendant Dugan took the stand and denied taking Hunter's truck and trailer "with intent to steal" it. He testified that

he thought he was in Munday, Texas (not Knox City) at the time and that he thought the truck was one his cousin was driving, and that he took the truck to play a joke on his cousin.

Dugan had been scheduled to be tried in the District Court last September and a jury panel had been summoned for that purpose. However, when the case was called, Dugan failed to appear and had jumped his bond. District Attorney Neal called for forfeiture of hid bond and had a warrant for his arrest issued. Dugan was captured in Abilene on December 30, 1998 when an Abilene Police Officer stopped him for yet another DWI charge.

Dugan is presently under another knox County indictment charging him with the felony offense of failure to appear for his September trial.







THIS INTERESTING DISCOVERY was made recently at the construction site for the new Duckwall's Hometown Variety Store. While tearing out an old wall, contractor Sid Richardson found the above postcard, preserved for the past 55 years. Mailed from Dallas, Texas, on April 25, 1944, the card was addressed to Malouf Dry Goods Co. here in Knox City. One of the earlier tenants of the former Perry's Building, Malouf Dry Goods received the card to confirm an inventory order from The Model Tailors in Dallas. With interior walls removed, there is evidence that the building that will house the new Duckwalls Hometown Variety Store has been completely remodeled at least three different times since it was constructed. There is even evidence that the building once had a second floor, with windows and doors that have since been bricked up and plastered over. The current progress on remodeling for Duckwalls is progressing well, with the new front glass and doors being installed this week, as well as the completion of the new building expansion to the rear that will allow a much larger showroom floor. The sidewalk project in front has also been finished in the last week, as the old sidewalk was removed and a new sidewalk completed. More photographs next week.

The commission would appreciate receiving copies of old family obituaries and family histories. Obituaries of anyone who has lived in Knox County are sought, even if the person died elsewhere.


Board members are currently working to prepare for the museum dinner which will be held Sunday, February 6, at Benjamin. Tickets will be available in advance from board members or at the door.

• As will be advertised in the classified section of an upcoming issue of The Knox County News, EDC will be opening the process for accepting bids on completing other projects, with two of the bid notices for concrete work in the downtown area.

One bid will be for taking out a section of sidewalk and the construction of a concrete ramp that will allow on street access to the lot known as 'Merchants Park' in the downtown business district. (See photo, above right) Once a driveway is available, EDC hopes that employees of downtown businesses will utilize the lot for daily parking. This will free up critical parking spaces for customers of downtown businesses. Some store owners and employees already park behind their businesses, and a lot has been made ready to allow employees of the new Duckwalls Hometown Variety Store to park off street.

The other bid will be for concrete work is to remove and replace the old sidewalk on the north side of the former White's Auto Store on the northwest corner of the business district downtown. The current sidewalk is broken in many places, and in need of removal.

• EDC also has talks ongoing with a couple who are interested in opening an auto parts store in Knox City. Those talks are going well and a positive announcement with more details could be made within the next month or so.

• At its meeting last week, the 4A board of EDC made a decision to use a bidding process for all projects in the future. Current state law guidelines require EDC to use a bidding process only for projects in excess of \$25,000, but the local board wants to insure that all local firms have an opportunity to bid on future projects - even if the projects are under the state's \$25,000 guideline.


• EDC also extends a thank you to downtown merchants for their patience during the inconvenience with construction activities at the Duckwall's project, and to Doris Crownover at the Chamber of Commerce office who was without phone service for a week, and to Sterling Lewis, who faced an inconvenience when the street in front of Lewis Paint and Body Shop was blocked off for almost two weeks with phone cable repair.




