Businesses in the following counties are eligible to apply: Crosby, Dickens, Foard, Garza, Haskell, Howard, Kent, King, Knox, Lubbock, Sterling and Tay-

Applications and further information can be obtained by calling the SBA toll-free at 1-800-366-6303 or TDD 817-267-4688 for the hearing impaired.

These loans are intended to assist businesses in offsetting working capital losses which they suffered as a result of the severe weather reducing the crop income of the area farmers and ranchers. Small businesses claiming to have been physically injured by the weather are not eligible.

Red Cross Bloodmobile to visit here September 5

This summer, with its normal high temperatures, has slowed blood donations to a trickle, Red Cross representatives said.

The heat may cause many potential donors to have concerns about the donation process. It will not harm a donor as long as certain common sense precautions are taken, such as, increasing fluid intake 24 to 48 hours prior to donating, eating a good meal, and continue to replace fluids for 1 to 2 days following a donation. These are good precautions to use to avoid heat stress altogether.

"The American Red Cross is

issuing a plea to first-time and repeat donors to take the time to give blood in order to ensure that there is enough blood available for the people who need it," Kathy Rios, Red Cross blood drive coordinator, said. "The blood we receive will help people who depend on Red Cross every day for lifesaving transfusions."

The need for blood by patients being treated for accidents, routine surgeries and serious diseases, such as cancer, heart disease, and hemophilia, is ongoing.

Thousands of people rely on the generosity of blood donors daily.

To donate blood, one must be healthy, at least 17 years old, and weigh 110 pounds or more.

Setting for Knox County memorial underway, site prep has begun for long-awaited project

The setting for Knox County's War Memorial is underway thanks to the Commissioners Court and Texas Highway Department, who have been cleaning, grading the site and bringing in filler soil, encouraged by Judge David Perdue.

By early September, Engineer Dennis Duke, head of Truscott Brine Lake, U.S. Army Corps of Engineers of the Red River Brine Water project in northwest Knox County with county and city help will begin the foundation work for the monument.

Hopefully, those who have pictures and war memorabilia will mail or bring these items to the Knox County Historical Commission office in the courthouse ASAP to prepare for the dedication exhibit.

Tax deductible contributions for the monument mailed to the same address will complete the county effort to honor Knox County veterans, all who gave their youth, many who gave their health and some who gave their lives for our country.

One of these was young Marine Lt. Henry Jones whose four years of service without leave took him in action to Guadalcanal, Okinawa and China during his stint as a Marine in WWII.

As told by Jace Yates in a high school history and English assignment, 18 year old Henry Jones was attending Abilene Christian University when the news came that Pearl Harbor had been bombed.

He remembers that the news came as such a blow to the students that the very next day every male on campus went to the recruiter's office and tried to en-

A year later, with the required parental consent, young Henry volunteered for service in the United States Marine Corps. After the Navy V12 program at the University of Texas at Arlington and boot camp at Paris Island, NC, newly commissioned Marine Lt. Henry Jones was sent to California where he was given command over a 600-man replacement draft to be sent to Guadalcanal.

The next four years horror and black humor marked every day as the young Lt. led his Marine Corpsmen of the 22 Regiment of the Marine Corps from battle to battle . . .

... humor as a self directed old soldier (age 30) jumped over the side of the amphibious Amtrack landing craft soaking himself instead of exiting at the rear, furious at the Lt.'s "lack of direction";

... horror at some kid recruits "cracking up" and having to be removed as the regiment sat on the Amtraks awaiting the landing as if they were awaiting their own deaths;

supplied patrol was forced to circle base airport five days without supplies as enemy pursuit played out its operation over the base;

... horror as his platoon witnessed a kamikaze pilot flying below radar straight into an Allied ship which exploded and sank to the bottom of the ocean in ten minutes:

... devastation at witnessing "friendly fire fatality" when his patrol witnessed two Corsairs attempting to take out a Zero, one

Corsair above and one below, the zero escaped as the Corsair above caught the shot from the one below:

. . . disbelief after American ships, a few minutes after bombarding an island, mistakenly shot down an Allied observation plane;

... dismay at the loss of civilian life on Okinawa, as natives scavenged for food under cover of night even though Americans daily dropped leaflets advising the natives to stay under cover at night because of the difficulty of discerning friend from enemy;

namazement as young Jones; platoon experienced 100% casualties in Okinawa with not one fatality. Thirty five days after landing on Okinawa, the young Lt. was hit by sniper fire in a daylight attempt to lead his platoon across a rice paddy in an estuary on the northern peninsula of the island. Another Marine division and two Army divisions had crossed earlier under cover of darkness. Too late, he realized bad judgment and bad luck, not waiting for night cover;

assignment was not negative. The people and culture fascinated him, and he enjoyed the interaction with them... To come to America one young Chinese tried to stow away in his luggage;

charged in 1946 at Corpus Christi Air Force Base as a reserve, returning to active duty to train recruits at Paris Island, NC, until his release from the marines in 1959;

... gratefulness to the home front for supplying the troops with the best equipment enabling the Allies to win the war.
