

## Be There! KCHS Greyhounds prepare for season opener Friday night at home against Rotan's Yellowhammers

Under the direction of Head Coach Lynn Lierly, the 2000 edition of the Knox City Greyhound Football Team is set to begin the season with their first game at home on Friday evening as they host the Yellowhammers from Rotan in non-district action at Greyhound Stadium.

With a lot of returning experience, the 'Hounds look better than they have in several years. Nine returning seniors play key roles on both offense and defense, but the team can also count on a host of talented underclassmen backing up just about every playing position.

Lineman Aaron Sanchez, defensive back Omard Walton, linebacker Nefro Gonzales and end Jay Sandusky are seniors leading the defense.

On the offense, three running backs that gained valuable experience last year will be back to mark their turf again. Gemile Roberson fought for 651 yards on 143 carries last year, while Omard Walton gained 383 yards on 63 carries and Nefro Gonzales tallied up another 309 yards on 65 attempts.

Other seniors returning this year are defensive back Jeffrey Hernandez, center Matthew (Biscuit) Lowe, wide receiver Erik Rocha, lineman Salvador Silva and linebacker Justin Vasquez.

Juniors include offensive linemen Casey Carver, defensive back Will Grimsley, lineman Felipe Sanchez, tight end Shawn Speck, center - defensive end Russell Bishop, running back Justin Casillas, wide receiver Eric Green and offensive lineman Garry Manley.

Sophomores on the roster in addition to Gemile Roberson include offensive back Dominique Collier, Sedrick Roberson at quarterback, Scooter Thompson at linebacker, Caleb Carver, Sean Duncan, and Nathan Lierly on the offensive line, Logan Morrow at wide receiver and Landon Weirershausen at tight end.

Freshman players include quarterback Carlos Ruiz and lineman Brandon Espinosa.

#### Bloodmobile to visit here Tuesday from 3-7

The American Red Cross is urging residents of Knox City to donate at the upcoming blood drive on Tuesday, September 5, from 3:00 to 7:00 p.m. at the Knox City Community Center.

This summer, with its normal high temperatures, has slowed blood donations to a trickle, Red Cross representatives said.

The heat may cause many potential donors to have concerns about the donation process. It will not harm a donor as long as certain common sense precautions are taken, such as, increasing fluid intake 24 to 48 hours prior to donating, eating a good meal, and continue to replace fluids for 1 to 2 days following a donation.

The need for blood by patients being treated for accidents, routine surgeries and serious diseases, such as cancer, heart disease, and hemophilia, is ongoing.

To donate blood, one must be healthy, at least 17 years old, and weigh 110 pounds or more.



## Valor Telecom to begin offering local phone service September 1

Company will own and operate 325,000 local access lines

IRVING - September 1, 2000, Valor Telecom, the newest local phone service provider in Texas, will assume operational control of over 325,000 local phone lines in areas of Texas currently served by Verizon, formerly GTE.

"Valor Telecom is proud to serve Texas," Anne K. Bingham, chairman and chief executive officer of Valor Telecom. "With our corporate headquarters located in Irving, and one of our customer service centers located in Texarkana, we look forward to bringing a strong and lasting business presence to all the communities we will serve."

On September 1, all customer records and pending orders will transfer to Valor Telecom. In the first 15 days of the transfer, temporary systems will be used while transferred records and service orders are loaded into new automated systems and re-tested. Current phone service will not be affected by the transition.

To handle new service orders and the backlog of pending order, Valor Telecom has hired additional personnel; installed new

systems and worked closely with government and regulatory officials and community leaders to prepare for the transfer of lines.

During September and October, Valor Telecom may receive a high volume of calls and customers may experience delays in placing new orders. However, any delays will be temporary during this transition period.

With respect to customer billing, phone rates will not change, but the Valor Telecom phone bill has been reformatted. Therefore, some of the charges and fees may appear in a different section.

Furthermore, the transfer of lines to Valor Telecom will not affect customers' current long distance and Internet services.

Customers who have selected Verizon as their long distance and/ or Internet service provider will begin receiving a separate bill for those services.

Valor Telecom officials said that the company will soon offer long-distance service so that customers can have the convenience of receiving one bill for local and long distance services.

#### Monument construction plans are on schedule for memorial

Plans for the Knox County Veterans Memorial are on schedule. Many of the 2250 plus Knox County veterans to be honored in the memorial on November 11, have been and are serving in this cause.

Kenneth Baker of Munday remembers his tour of duty as a young First Lt. in 1954-55, 14 months in Korea after the war. He states, "Known as 'The Land of the Morning Calm', Korea had gone through very little calm for several years." A brief history explains.

At the end of WWII, after Japanese occupation of Korea from 1910 to the end of WWII, the Allies agreed that Soviet forces would accept the surrender of Japanese troops in Korea north of the 38th parallel, while the American troops would accept the Japanese surrender south of that line.

Soviets refused to cooperate with the UN plans to hold general elections in the two Koreas for reunification, and as result, a Communist state was permanently established under the Soviets in the north and a pro-Western state in the south.

On June 5, 1950, the North Koreans, at the prompting of the Soviets unleased a carefully planned attack southward across the 38th parallel. This brilliant landing far north of the main battle front succeeded in cutting the North Korean forces' lines. By December 31, North Korea faltered under Allied

In 1954, Young Lt. Baker remembered the port of Inchon near Seoul and its great tidal variations, 33 ft. difference in tide level. "A ship coming in at high tide would be left sitting in the mud at low tide," MacArthur had made a daring gamble and won.

In '54-'55, young Baker saw Korea still anything but "the Land of the Morning Calm".

"There was almost total destruction, no economy, very little electricity, no phones, just a waste land where 3,000,000 of its people had lost their lives since 1950.

The Korean people who worked for the army were paid in their currency, the whan. Most earned a boot box full of paper money of very little value for two weeks work. It would be interesting to go back and see the changers over the past 50 years."

Many positive changes have moved the Koreans into the 21st Century as United Nations forces have sought globally to limit con-

LAUREL, Montana - Every parents knows about the terrible twos. You know, the time many children become their mom and dad's worst nightmare.

But in Edward Acree's case, you could say he's his parents' worst nightmare - on wheels.

Acree, a two-year-old rollerskater from Great Falls, was the youngest competitor in the 2000 Big Sky State Games. He participated in both the limbo and singles races Saturday at the Starlite Roller Rink here.

Although it may seem odd that young "Eddie" would make the trek from Great Falls to Laurel, it turns out he's been groomed for skating competitions his "whole" life

"Roller-skating has been in our family for generations," said Eddie's mother, Tara, who also competed in the Big Sky Games this weekend. "When your family owns a rink, you walk and then put on the skates."

Tara's father, Allan Hauer, owns Wheels West at 300 23rd Ave. N.E. in Great Falls, and before it opened in 1981, Allan ran Hauer's Roll-O-Rena in Great Falls. For more than 30 years, the clan has been associated with roller skating in the Electric City, but unlike many State Games participants, this marked the Acrees' first time at the annual event.

If it were possible for the family to make the games a tradition, they probably would. But come August, that will be nearly impossible.






