Greyhounds wound Wildcats 20-2, Munday's Moguls are next

Knox City and Munday are undefeated in district action, Knox County's showdown is Friday night at 7:30 here in Knox City



PLAYING THE BEST DEFENSE KNOX CITY HAS SEEN IN YEARS, the Greyhounds have proven to be an awesome foe to every offense they have faced so far this season. Allowing an average of only one score per game, the 'Hound defensive unit is honored by Head Coach Lynn Lierly this week as the 'Player Of The Week' honors for defense has been awarded to the entire KCHS defensive unit. In the above photo taken last Friday night at Crowell, Senior defensive lineman Jay Sandusky (75) is shown as he hits a Wildcat runner hard enough to cause a fumble, with the football flying out in the direction of Sophomore linebacker Scooter Thompson (41) as he takes on Crowell's lead blocker for the play. While the photos of last week's game appear to be a little fuzzy, that is actually the result of trying to take photographs through a heavy fog that moved in and blanketed the field during the game.

The Knox City Greyhounds put another resounding win in the victory column last Friday night as they toppled the Wildcats at Crowell, 20-2. Undefeated in district play, Knox City will host the Munday Moguls this Friday night at Greyhound Stadium.

Playing on a cool, damp and foggy night last Friday in Crowell, the Greyhound defense proved once again that it is fully capable of dominating opponents. Allowing the Wildcats only 2 points early in the game that came on a runback of a fumbled kick attempt, the Greyhounds kept Crowell out of the end zone for the rest of the game.

Interceptions were the name of the game as Crowell tried to pass the ball repeatedly throughout the game. Greyhounds on the receiving end of intercepted passes were Senior Nefro Gonzales, Senior Jeffery Hernandez, Junior Will Grimsley and Sophomore Scooter. Thompson.

He married Jo Tipton in 1995 and she preceded him in death in June



island of Iwo Jima.

"He never covered up the killing, but he also didn't glorify it," recalled Korzenewski after returning home last week. "It was instructional to hear that there are tough and brutal things in life and that good men sometimes have to do tough and brutal things to survive."

Some historians suggest Wells' fearless example inspired John Wayne's hardened Marine in the film, "Sands of Iwo Jima" (1949). Earlier this year, James Bradley's best-selling book, Flags of Our Fathers, argued that on Iwo Jima "no one surpassed the courage of Lt. Keith Wells."

"I even read Keith's own book, Give Me Fifty Marines Not Afraid to Die, while I was over there, said Korzenewski, 46, who first began Scouting activities under Wells in the late 1960s. "I'm embarrassed to say I'd put off getting the book.

"But Erik and I began talking about it while we were in Bosnia and Keith sent us copies. I was hoping to derive a few lessons from it, such as leading form the front, being in the action with your men."

That's one of Wells' first principles for a fighting leader.

Involved in Scouting since 1953, Wells, 78, has never made any secret of his passion for instilling strong values in boys - and ensuring they have the skills to survive outdoors.

"I believe young boys should travel through the country on foot, backpacking, and if you can start them early, all the better," the strapping oilman told me. "Scouting has always appealed to me because there are so many things about it that are natural to the development of young people."

That includes appreciating the simple episodes of gentle humor that come along, such as the time Wells led a group of boys, including Wyse, on a 1987 camping trip to St. Croix - only for a long island chicken to adopt Wells as a "mother hen." It followed the former Marine everywhere.

Although Wells drove home lessons of what men must do in times of crisis, he also set an example to follow for his former charges on the homefront - so much so Wyse admitted he was thinking of moving his financial planning practice out of Dallas and back to Abilene.

"Hopefully that can give as much to the community over my life as you have," Wyse wrote Wells from Bosnia. "I don't know if I ever expressed to you that you are one of the few mentors I look up to and want to emulate in life.

"Thank you for helping me grow into the man I am and hope to be in the future."

For veteran Scoutmaster Keith Wells, I'd say it's a case of "Mission accomplished," pure and simple.


