





(Washington) Agriculture Secretary Ann M. Veneman announced the awarding of an \$8,751,950 loan package that will improve telecommunication services in 15 Texas counties.

Funds are provided from the USDA Rural Telephone Bank Program. Veterans News

The public got its first look today at the gated entrance, the sweeping lawns, the wide assembly area and the dignified columbarium that will soon be the state's first Texas State Veterans Cemetery. Five architectural renderings were unveiled today at the future site of the first Texas State Veterans Cemetery on State Highway 195 near Killeen.

Jerry Patterson, Commissioner of the Texas General Land Office, unveiled the renderings and was joined by U.S. Rep. Chet Edwards, Killeen Mayor Maureen Jouett, State Rep. Dianne White Delisi and Fort Hood Garrison Commander Col. William Parry. Other local elected officials attended, as well as many area residents.

"Central Texans know and respect the sacrifice made by those who serve their nation," said Patterson, who is chairman of the Texas Veterans Land Board. "They worked hard to make this final resting place a reality. I hope they are pleased with what they saw today - I know I am."

The renderings depict the entrance to the cemetery, the administration and maintenance complex, the columbarium, the assembly area and an overall site plan. Work on the cemetery will begin late this year, and will be completed by late 2004.

"Central Texas has a large veterans population and many Fort Hood soldiers make it their permanent home after leaving the service," Patterson said. "That's a good reason for putting the first Texas State Veterans

Cemetery here. It will be an honored place of rest for those who served their nation."


Patterson also announced the facility will be called the Central Texas State Veterans Cemetery. The U.S.

Department of Veterans Affairs, which is paying all construction and design costs for the project, prefers that State Veterans Cemeteries be named after regions.

Luke Dorminey, 7, from Killeen, led attendees in the Pledge of Allegiance. Luke's father, CW0-3 Keith Dorrniney, of the Texas National Guard, was called to active duty and has been in Kuwait since March





Texas Farm Service Agency announces managed CRP haying, grazing authorization

Cutting hay and grazing livestock on land enrolled in the U.S. Department of Agriculture's Conservation Reserve Program, in the absence of a weather-related emergency, is now an option for producers due to changes brought about by the 2002 Farm Bill.

Michael McDonald, County Executive Director for the Knox County Farm Service Agency, announced that managed haying and grazing would be allowed on CRP lands began July 2.

The starting date is tied to the end of the primary nesting and brood rearing season in the state. The ending date will be October 25, 2003.

To take advantage of the new haying and grazing options, producers must modify existing conservation plans for the CRP acreage to included managed haying and grazing practices.

The plans must be developed

in conjunction with USDA's Natural Resources Conservation Service or one of its technical service providers.

Producers must also agree to certain terms and conditions, including signing an agreement to re-establish, at the producer's own cost, any cover destroyed or dam-

aged as a result of haying or grazing and to remove all hay within 10 days of being notified that the managed haying and grazing season has ended.

Prior to the 2002 Farm Bill, commercial use of CRP land was generally prohibited except for weather-related emergencies.




