Nichols is currently in his second year as head coach at Abilene High School. His career coaching record is 315-135 and he has had ten teams win 20 or more games with the Lady Eagles just completing a 21-8 mark.

Coach Nichols coached the KC girls' team during the 1973-74 school term. During this time, the Houndettes advanced to the state tournament.

In his 15 years, Sam's teams have advanced to the state playoffs nine times, winning the 1980 State Championship at Slaton High School.

A 1968 graduate of Abilene High School, Sam earned his Bachelor of Science degree from McMurry College in 1972, and his Master of Education from Abilene Christian University in

Sam and his wife of 19 years, Judy, have five children, ages 14 through

In addition to his coaching, he is the weekend weather anchor for KTXS-TV in Abilene and is also a color commentator for local radio sporting events.

Sam speaks in several states at banquets, in schools, churches and civic groups. In 1985, Sam was awarded the prestigious honorary Life Membership Award from the Texas State PTA for distinguished service given to youth and children.

Sam has just been selected by Athletes in Action to be the head coach of an Interdemoninational Christian Women's Basketball team that will compete on a four-week tour of Africa this summer.

In addition to playing outstanding Club and National teams from different Africian countries, the coaches and players will be sharing the message of Jesus Christ with basketball players, fans, coaches, and officials through personal evangelism, basketball clinics, and church speaking engagements.

The area north of Knox City received the most hail damage. One home west of O'Brien reportedly lost its roof.






Next Week's Paper **Dedicated To Seniors**



Straight Talk

In recent months there has been a lot of media attention given towards the banning of certain types of rifles and pistols, basically because these certain types of weapons were used in one crime or another where people lost their lives. After each one of these types of crimes, anti-gun forces and far left politicians always seem to see who can scream the loudest and get the most attention by demanding that our legal system outlaw even more than what was demanded the time before.

In the midst of all the clamoring, pro-gun forces are just as loud when expressing their point of view that the United States Constitution gave citizens the right to carry arms and that outlawing certain types of rifles and pistols is not legal and goes against the wishes of the founding fathers of this great country. I agree with this point of view and put strong belief in the saying that guns don't kill people, people kill people.

In examining news reports about crimes involving certain types of rifles and pistols, I have paid close attention to the other things that might have influenced the person who committed the crime. One very common factor in most of the crimes was that the person

or persons committing the offense fancied themselves as a sort of 'Rambo' character. Most went further to have one other item in common, that being the type of clothes they were wearing at the time of the crime. Keeping in theme with the 'Rambo' image, most were wearing some sort of camouflage clothing.

Camouflage clothing was designed by genuine military forces as an aid towards concealment in combat. Instead of outlawing guns, why not outlaw camouflage clothing and take a giant step towards doing away with the 'Rambo' mentality that so many weirdos seem to feed on. But even this suggestion is sure to draw fire from hunters and other non-criminal types who like to wear the clothing. As a part of each sentence, every judge could outlaw clothes to those who are convicted of a crime. After all, the figures show that most crimes are committed by repeat offenders. Following my plan, repeat offenders would be easily spotted and ordinary citizens would sure know who to stay away from! Once again the criminal would have no place to hid guns, knives, or drugs. It sure would be a lot more effective that branding a scarlet 'S' like they did many years ago!

So that's my plan. Let's pass new laws that outlaw clothes to criminals who commit crimes. And while we're at it, let's put our politicans in there, too. If a politican commits a crime when in office, the same sentence should apply. Rallying 'Round The Bank

Rochester's Home State Bank Featured In Banking Publication

(Editor's Note: The following is an excerpt from National Bankers Association out of Sauk Centre, Minnesota, concerning The Home State Bank in Rochester. We are using the article in its entirety.)

"We knew that if we lost the bank, we'd lose the town." To George Mullino, chairman of the Home State Bank in Rochester, Texas, that statement captured the hopelessness of business people and residents alike in this small West Texas town just two years ago.

Two years later, Home State is enjoying a 25 percent return on earnings and a 1.5 percent return on assets.

The bank did close in 1986-but only for a very short time while local businessmen scurried to recapitalize the institution and win FDIC approval to reopen under a new charter.

For much of the 80-year existence of the bank and its predecessors, First State Bank and The Home State Bank, suffered under absentee ownership. Today, the bank puts a great deal of emphasis on its motto: "Home Owned by Home Folks."

Early in 1986, George Mullino and others in town realized that Rochester's sole deposit institution was in trouble. Loans were being made outside of the area-and for personal reasons. He and other businessmen organized to keep the bank open and to give it local ownership.

Their fears were realized. The bank was about to be closed after an embezzlement, and the FDIC asked Mullino to bid on the soon-to-be-closed bank. His family, after all, had been instrumental in saving the bank on prior occasions.

Nine investors were marshalled and some frantic plans were thrown together in an attempt to keep the doors open. There was too little time to beat the FDIC's closing schedule, but organizers did accomplish a near miracle in reaction time. Once the group had formed Rochester Financial Corp (in only three days' time), all of the paperwork for the new charter was completed with like speed.

The principals gave much of the credit for the feat to a helpful state banking department.

The bank's youthful president, Bill (W.H., Jr.) Parks was recruited to run the \$7.8 million bank that had its share of problem loans. He, himself, had been the victim of a bank closing nearby that had been caused by the past president's misappropriation of bank funds. But he's from a banking family and he couldn't resist the challenge.

Investors, at first, weren't sure there was enough of Home State left to save. Still, they shared George Mullino's concern that Rochester needed the bank in the worst way-and a few of them joined Mullino in a trip to Dallas to work on the FDIC bid.

Each investor put up \$20,000 for stock and the balance of the needed money was borrowed. Capitalization was achieved, the holding company formed and the local bid was accepted. Home State opened in the summer of 1986 with local ownership and management. It was a profitable venture in its very first year.

The town of 600 depends, almost exclusively on agri-business and farming. Its directors represent agribusiness. Locally grown products include cotton, peanuts, grain, sorghum and vegetables. Like so many West Texas communities, Rochester had its birth on a railroad line in 1906. Trains brought coal in to fuel the local

First State Bank opened in 1907 and closed 25 years later-insolvent. George Mullino's grandfather helped sell shares to reopen the bank as The Home State Bank a year later (1933). George's father was active in bank management in the 1970s when local investors pulled out of the bank Seems that an absentee investor purchased a significant block of stock earlier and, although he did not own a controlling share of the bank, he precipitated actions that were damaging to the institution.

Mullino, as reported earlier, credits the state banking department for helping guide local investors to the successful launch of the charter application. One particular step was to prove important. The state sent a conservator to assess the bank's condition. The chartering group was able to hire the person to investigate the loan portfolio and recommend actions to take on specific loans.

But it took some selling to get the bank department's attention, President Parks recalls. The regulator first had to be convinced that adequate local support was behind the chartering.

Financing was handled expeditiously by the Plains National Bank in Lubbock-another action critical to the reopening.

The return of the bank to local ownership has been a rallying point for the whole community. "The support has been gratifying," says Parks.

"The return of both depositors and shareholders has helped the bank return to profitability. Then, too, we're holding the line on costs. Our overhead expenses are low. We operate the bank with five full-time and one part-time employees."

Like most community banks serving agriculture, Home State is searching for borrowers. The bank is about 45 percent loaned up. Half of that portfolio is invested in ag loans; the balance split evenly between commercial loans and real estate.

"Now we've been able to turn our attention more to what the community needs and less on what the bank needs," Parks continues.

"And things are looking up. Bill Penman, a director of Home State Bank, has spearheaded efforts to renovate the downtown area. He recently remodeled two buildings to house his propane business. We have a new post office and a museum will soon be established. Many of the local stores are being remodeled. But what we are really enthusiastic about is a new employer, Lone Star Peanut Company. The firm employs 30."

Both Parks and Mullino agree that the No. 1 goal is industrial development. And they agree that if they concentrate on natural resources in the area, more growth is probable. The peanut dryer, for example, is supported by 6500 acres of peanuts.

"Rally 'round the bank, boys," has been the call in this small but proud Texas town for the last two years. The bank responds with concern for the residents and annual "thank you" dinners that attract hundreds of people. Central to this town's prosperity is its bank
