Before Hayes passed away in December, he used numerous units of blood.

Comments On Recent Changes In Social Security

President Clinton signed the Social Security Independence and Program Improvements Act on August 15, 1994, establishing Social Security as an independent agency. In addition to separating Social Security from the Department of Health and Human Services, the Act also contains several provisions which will have an important effect of certain groups of people. They include the following

- Effective January 1, 1995, election workers and officials may not be required to pay Social Security or Medicare taxes on wages of less than \$1,000 a year. Currently earnings of \$100 and over (but as low as \$50 in some states) are subject to taxes if the states have a coverage agreement with SSA. The new law allows states to modify their agreements with SSA to adopt the \$1,000 limit for years 1995 and after. If a state does not act to adopt the \$1,000 limit, the current \$50 or \$100 limit remains. If a state never acted to cover the earnings or election workers under the agreement, the current limit of \$100 for excluding earnings will increase to \$1,000 effective January 1, 1995.

- - Ministers who were U.S. citizens and residents of Canada and who did not pay Social Security self-employment tax for taxable years 1979-1984 because they paid taxes to the Canadian Social Security system will be exempt from paying back taxes and penalties to the Internal Revenue Service (IRS) for those years. Individuals who qualify for this exemption must file a certificate with the IRS within 180 days after IRS issues the regulation implementing the provision.

-- Wages paid to aliens who hold "Q" visas issued by the Immigration and Naturalization Service do not have to pay Social Security tax on their earnings. These visas are issued to aliens who visit the U.S. for a period of less than 15 months as participants in cultural exchange programs.

-- Federal employees who normally contribute to Social Security in their regular jobs and who are temporarily transferred to work in an international organization will continue to pay Social Security. Under current law, they are exempt from these contributions if working overseas, or treated as selfemployed individuals if working in the United States.

- - Unauthorized disclosures of information contained in Social Security files and fraudulent attempts to obtain personal information under the Social Security Act is now a felony punishable by a fine not to exceed \$10,000 or imprisonment not to exceed five years, or both. Under current law, violations are a misdemeanor carrying a \$1,000 fine and one year imprisonment, or both.

- - The extension time that can be granted for filing an annual earnings report to Social Security has been extended from three to four months. Annual earnings reports must be filed by people under 70 who receive Social Security benefits, work, and earn over a certain amount. The reports are usually die by April 15 of each year, but extensions of time for filing can be granted if there is a valid reason for delay. For taxable years ending on or after December 31, 1994, the extension of time for valid reasons is increased from three to four months.

- - People who receive both Social Security and Supplemental Security Income (SSI) and are getting Medicaid because they get SSI will not lose their Medicaid coverage when an annual Social Security cost of living increase causes their SSi to stop. Medicaid will continue even for SSI recipients who were not getting any SSI payments because of participation in an SSI work incentive program. Medicaid should continue so long as the person would still be eligible for SSI payments or participation in the work incentive without the cost of living increases.

- - The formula used to calculate benefits for workers who are eligible to receive Social Security based on work in the U.S. and work in certain foreign countries will be the same as the regular one used to calculate the benefits of beneficiaries who do not have foreign work. Previously, a person whose benefit was based on U.S. and foreign work had his/her benefit figured using a less generous formula than the one that is normally used. Beginning with benefits payable after December, 1994, benefits based on U.S. and certain foreign work will be figured on the regular, more generous formula.
