

State Representative David Counts Of Knox City Receives Two Valuable Re-election Endorsements

During the first few days of this week, two releases mailed to The Knox County News announced the endorsement of Knox City's own David Counts in his bid for re-election to the Texas House as Representative for District 70.







All lambs to be shown at the Knox County Junior Livestock Show and any major show in the spring of 1997, Fort Worth, San Antonio, Houston, San Angelo, must be state validated in October

All lambs must be validated on the same day at one location. This year, the validation will be at the Brazos Valley Young Farmers Building in Munday on Wednesday, October 23, beginning at 4:30

There is some paperwork to be completed at the time of validation. This form requires the signature of the exhibitor(s). Because of this, it would be great if all exhibitors can attend if only long enough to sign the paperwork.

For those families showing goats at the 1997 Knox County Junior Livestock Show, please bring your goats to this validation. Goats for the county show will be validated during the lamb validation.

This goat validation will only require an ear tag and very little paperwork. It should not take very long to complete this process.

The validation committee will remain on location until 7:00 p.m. or until all animals present are validated. If there are any questions call the extension office at 817-454-2651 or call the local ag science instructor.






