

Amendments Go to Voters, But Finance Bill, Issues Remain On The Ballot

Although the campaign is underway to pass the school finance equalization amendment, one major question remains: How is it going to affect my school district? But to answer that question, lawmakers have to tackle what may be the biggest bugaboo left in this legislative session other than the state budget—drafting a school finance bill.

Thus far, state leaders have been

reluctant to jump in and get to work on writing enabling legislation to carry out the proposed constitutional amendment that will be put to a statewide vote on May 1. That doesn't mean that there aren't school finance plans on the table. At least six to eight plans are on the drafting board and have been for quite some time, including SB 313 by the School Finance Working Group sponsored by Senator Bill Haley. Other plans range from legalizing county education districts (SB 7 by Ratliff) to a combination of county and statewide recapture (HB 639 by Johnson) to mandatory consolidation of school districts (HB 769 by Hochberg, et al).

Nevertheless, some optimistic observers attribute lawmakers' hesitancy to get on with the plan as simply (1) an effort to slow down and carefully think out what should and should not be in the enabling legislation, (2) a period to review all the options available, (3) waiting to see how much new money public schools will receive before they tackle the plan, or (4) waiting to see if the amendment passes.

Other, less optimistic observers, see the lull as an attempt by state leaders to (1) stall, because they know that any school finance plan presented before May 1 will look bad because of the small amount of state funding expected to be added to the system, thus giving rise to increased property taxes and potentially killing the amendment at the polls, or (2) confusion.

No doubt all four scenarios are at work, but the scenario that is being played out the most in Austin appears



Mr. Grantham died Monday evening at Methodist Hospital in Plainview after having suffered an apparent heart attack at his home here. He was transported by the ambulance service to the hospital.

He was born in Tulia on December 5, 1924, and lived in the Red Hill community in eastern Swisher County in his early manhood. to be one the papers are less apt to mention-behind the scenes negotiations. To get certain groups to work for passage of the constitutional amendment (or at least, to get them to agree not to stand in its way), Capitol sources say deals are being cut as to what will and will not be included in the enabling bill or passed in some other legislation that comes down the pike. Among the issues rumored to be in "negotiations" are five of particular concern to the Texas Association of School Boards:

(1) Extreme accountability and school district performance language that threatens local control of school

districts and school board authority. (2) Teacher salary increases that could siphon off scarce funds needed to handle student enrollment growth and to maintain existing programs.

(3) Automatic rollback election that would be triggered when a school district ups its tax rate by a certain percentage or dollar amount.

(4) Voucher, tuition tax credit, or scholarship programs that use public funds to send students to other public and private schools of their choice.

(5) Level of funding for public education, specifically, negotiations on

how much new money to put into public education and how much of it should go to the program or salary increases.

Texas Association of School Boards believes that passage of the equalization amendment is an important step toward finally solving Texas' school finance equity crisis, but other steps remain. The most important of these are (1) adoption of enabling legislation in line with the School Finance Working Group's plan before May 1, and (2) adequate state funding for public education. At the same time, TASB remains concerned about possible provisions that may be added to the enabling legislation (such as those mentioned). The Association urges board members and administrators to continue to communicate with their lawmakers about these issues and the needs of Texas public schools.



Attends Training For Ombudsman Volunteers


Lois Nance was in Amarillo Friday to attend quarterly training for ombudsman volunteers.




