A DEMOCRATIC FARMER

Proposes a Substitute for the Gibbs Banking Bill.

Capt. G. B. Brown a well-to-do farmer of Crystal Falls, Stephens county, is in the city visiting relatives and yesterday came to the News office to see the editor. He reads the News and had carefully considered the banking bill proposed and discussed at Lancaster last week by Hon. Barnett Gibbs. He has ideas of his own and came to tell the News about them. He found a willing ear and a welcome and this is what he said:

"While I think Gov. Gibbs' bank bill an improvement on the present law I would like to offer an amendment to some clauses and strike out or change others. I would offer amendment as follows:

"Section 1. There shall be established and chartered state and branch state banks of circulation under the provisions of the national bank act, so far as applicable and subject to the provisions here in provided, a well as those in said act contained and not in conflict herewith.

"Sec. 2. The states making application to the comptroller of the currency for legal tenders shall execute and pledge to the secretary of the treasury and his successors in office for the amount of legal tenders to be received their state bonds and other good assets held by them, together with the faith of the state, and shall receive legal tenders to the amount of the face value of their bonds and other assets, the state paying 1 per cent per annum to the government for the money thus furnished.

"Sec. 3. Said bank notes issued by the comptroller shall be legal tender for all debts and dues, public and private, and all taxes except import duties, and shall be redeemable in coin at the option of the general government.

"Sec. 4. Provided, that all kinds of money, gold and silver included, put in circulation at any one time shall not exceed \$50 per capita of the entire population, based on the last preceding United States census; provided, that congress increase or decrease the amount in circulation as the public welfare shall demand.

"Sec. 5. When any one state shall have received its pro rata of this per capita increase in the circulating medium from the present basis it shall receive no more until two years thereafter, when it may receive its pro rata of the remainder not absorbed by other states.

"Sec. 6. Those banks of circulation shall be the banks of government deposits, each state receiving its pro rata of those deposits. It is further provided that those banks may loan money on farm products or on such other security as they may deem proper at a uniform rate of interest not to exceed 4 per cent per annum, and it is further provided that the net profit accruing to the states from those banks shall be applied to the free school fund.

"It will be seen that the Gibbs

bill, amendment and changed as above, cuts out all chances for banking except by the states. It also solves the question of what to do with our school fund by finding a secure investment for it, at the same time doubling the available school money.

"My reason for proposing that the state governments loan the money is that the people are determined to get rid of the middle man as far as possible in the distribution of the government currency.

"The News suggests that the Gibbs bill wipes out the national banks. Why not? They are a greater burden on the country than the robber tariff, which, according to Mr. Mills, takes from the people \$600,000,000 per annum."

Discussing political matters in general and democratic policies in particular, Mr. Brown said:

"Gibbs struck the keystone when he said the democratic party must get out of the grooves. The times have changed and party policies must change with them. If old leaders refuse to be progressive and try to stay in the lead by thrashing over old straw, new leaders will take their places. The people are tired of being brought up to the rack every election and fed on the dry fodder of old war issues. Wade Hampton of South Carolina is a good man and a democrat and a patriot but he refused to fall in line with progressive ideas and is warning his seat. Irby is a democrat no better in this respect than Hampton, but he is a progressive man he was always ready to meet the new conditions in which the country has fallen. Infall in Kansas is a good republican and one of the brainiest men on the continent, but he stuck to issues indored the demands of the people for new measures to fit new conditions and he is now growing potatoes for a living. These two instances should be warning to politicians.

If Kansas and South Carolina can lay aside war issues, what may we expect from more progressive and tolerant states, like Texas?"

"No I am not an alliance man, though I do not oppose the alliance as to principles. I am not a sub-treasury man. I am a democrat and have never voted anything but the democratic ticket, but I recognize the fact that the country needs more money and if the democratic party fails to provide it some other party will."

"Suppose the next democratic national convention should fail to advocate measures for a largely increased circulation and should propose a platform satisfactory on that point and not objectionable otherwise. What would you do?"

"I would go with the new party, and thousands of democrats in Texas would do the same."—Dallas News.

a special message to the legislature last winter he called their attention to that duty. All that was said in favor of reapportionment then may be repeated with equal force and pertinence now.

The injustice of the present representation is as obnoxious now as it was then, when the governor considered it grave enough to deserve his official notice and action. His zeal in behalf of equal representation was commendable then. The legislature adjourned without carrying out the reform that he suggested, their dereliction of duty, the people do not release the governor from his responsibilities. The law puts in his hands the power and means to give the legislature another chance to do the work they slighted then by calling them together in special session to do this specific work.

The governor's course is plainly marked out. He should call the legislature together to redistrict the state and no doubt he will in time for the election of 1892 in order that the legislature and the congressional delegation as closed next fall should fairly represent the people of the state as they are distributed now and not as they were in 1880. It is not the governor's fault that this work was not done at the regular session of legislature. His warning went unheeded. Ft. Worth Gazette.

Wrong initials dent count.

Austin, Tex., May 25.—Attorney General Culbertson on a question from the secretary submitted to the senate a list of names as appointees to the office of notary public and the senate has confirmed the same and the secretary of the state instead of sending down to the governor a true list of names so confirmed certifies an incorrect list as to initials of persons actually appointed and confirmed that such mistakes would not operate to deprive a person of the office to which he has been legally appointed. The secretary of the state would not be bound by the incorrect list but would have recourse to the senate journals. The case of S. W. Porter appointed notary public and confirmed as such but reported in the list as T. W. Porter is instanced S. W. Porter being held entitled to his commission.

THE JACKSBORO KILLING.

Full Particulars of the Sad Affair of Saturday.

WEATHERFORD, TEX June 1.—Deputy Sheriff Joe Paul has just returned from Jacksboro and reports the particulars of the killing at that place late Saturday evening. He says Byron Cope was in town all day and was drinking. He was armed with a six-shooter, and said he would not be arrested, and that he would die with his boots on. Late in the evening he ran his horse out of town and was followed by the sheriff and his deputy, who were absent from town until late, for the purpose of disarming him. When they were a short distance out of town they lost Cope's track, and the officers separated, and the sheriff went only a short distance when he came right face to face with Cope, who had his pistol cocked, pointing it at Sheriff Haskins. The sheriff pleaded with Cope to surrender and go back with him. Instead of doing that he deliberately fired at the officer, the shot passing through his clothing, Mr. Haskins drew his pistol, and he and Cope fired at the same time, the ball from the sheriff's passing through Cope's heart, and Cope shooting the sheriff through the navel. When the shots were fired both fell to the ground, and the

sheriff seeing Cope with his pistol still grasped in his hand, fired at him, the ball entering his brain. Mr. Paul says when the report of the killing reached Jacksboro, every body was wild with excitement, as the officer was held in the highest esteem, and Cope was considered a dangerous character. Mr. Paul was one of the first men to reach the wounded officer.

At last reports Sheriff Haskins was not dead, though there's but little hope for him.

THE SUPERIOR COURTS.

Floyd City the County Seat of Floyd County.

J. B. Erwing et al, vs. A. B. Duncan et al; appeal from Floyd.

This suit was by appellants to restrain the commissioners court of Floyd county from expending public funds in the erection of county buildings at Floyd City and to compel the county judge to order an election for a county seat. The suit was dismissed on demurrer. It was alleged that on May 28, 1890, a pretended election was held for the organization of the county which had been attached to Crosby county; that the commissioners court of the latter county canvassed the vote and declared Floyd City to be the county seat; that this election was void for the following reasons: 1. There was no order by the commissioners court fixing the day of election. 2. The election was not held on a day of general election. 3. Because the county judge did not canvass and declare the result. 4. Because Floyd City is more than five miles from the center and did not receive a two-thirds vote. 5. Because it did not receive a majority of the legal votes cast.

The recent act passed March 5, 1891, and which took immediate effect, cured the alleged defect of not receiving a two-thirds vote. There is a manifest error in the certificate of the secretary of the senate attached to the bill. The certificate shows that the bill "passed the senate by two-thirds vote—yeas 24, nays 24." The senate journal shows that the bill was passed by more than two-thirds vote. This latter is the best evidence of the actual vote (1 Whar. Ev. 290; 94 U. S. 260).

The act does not aid the election in any other particular. The allegation in the petition must be construed to mean that no order fixing the time for the election was ever entered upon the minutes. If the order was in fact made the failure to enter it upon the minutes would not render the election void (Brown vs. Reese, 69 Tex. 586; S. C. 67 Tex. 318). Whether the county judge or the court should have ordered the election we need not inquire. That the election in such cases need not be on a day of election was decided in State vs. Cook (78 Tex. 406).

It was the duty of the county Judge to canvass the votes and declare the result, and it appears that the commissioners court did so in this case. The presumption may be that the result was never declared; but it is averred that the city received 31 votes and Della Plains 27 votes, as shown by the returns, and it is not averred that such was not the vote actually cast. In a judicial inquiry the legal votes actually cast will determine the result. If the city received a majority the fact that the county judge failed to do his duty is no ground for vacating the election.

It is averred that "at and just previous to the election" the owners of land upon which Floyd City is situated conveyed to sundry voters lots in the town for the purpose of influencing their votes, though no promise was exacted. This court is inclined to the opinion that the votes of all persons who received lots by donation after the election had been ordered and before their votes were cast and who were thereby induced to vote for Floyd City should be rejected. But the allegation in reference to this is that the persons who were so influenced are unknown because their deeds had never been recorded, but there were more in number than the alleged majority. This allegation was had on general demurrer. The defendants are the county judge and commissioners and they are not presumed to know any more about the facts than the plaintiffs know. Affirmed. Opinion by Gaines, J.
