## Moguls Victorious Over Cubs, Munday Defeats Olney, 41-6

The Munday Moguls extended their winning streak by defeating the Olney Cubs, 41-6, Friday night. The Moguls were slowed down only by fumbles and penalties.

Munday took the opening kickoff and drove down field to Olney's 28, picking up three first downs, before fumbling the ball.

The Cubs, unable to gain any momentum against a stubborn defense, punted to the 30 yard-line. Five plays later, Dockins scored on a one-yard run with 4:36 left in the period.

The first half belonged to Munday, as the Moguls controlled the clock.

Munday had 42 offensive plays to Olney's seventeen. The Moguls also had seven penalties for 65 yards, while the Cubs had none. Each team lost the pigskin once by a fumble.

Bobby Dockins scored his second TD on a 13-yard run, the first play of the second period. Terry Collier ran the extra point for a 14-0 lead.

Ronnie Whitfield scored his first touchdown of the year on an 18-yard pass play from Dockins with 7:52 left in the second quarter. Dockins kicked the PAT for a 21-0 lead.

Olney fumbled the kickoff at the 28, with Dockins recovering. The Moguls were not able to take advantage, however, as the Cubs stopped Munday on their 15-yard line.

The Cubs were forced to punt and the Moguls got the ball on the 44-yard line. Nine plays and three penalties later, the half ended with Munday on the Cubs' five-yard line.

Olney opened the second half play by picking up their first 1st down of the night, only to have a pass intercepted by Terry Collier on Munday's 23-yard line.

Munday fumbled, with Olney recovering the ball. But, Olney failed to make the first down, as they moved only five yards in the next four plays. Terry Collier then scored his only TD of the night on a 70-yard run. Dockins kick was wide, leaving the score at 27-0.

The Moguls fifth touchdown was on a 27-yard pass from Dockins to Perry Collier. Dockins kicked the PAT.

Coach Edwards then sent in his reserves, who played on even terms with the Cubs. Jerry Valencia intercepted an Olney pass at the 44. With Mike Bunton at quarterback and Valencia and Kent Latham running, it took only five plays for the second team to score. Bunton passed to Jay Kingston for 18 yards, Latham ran for 16, and Valencia carried three times, scoring on a two-yard run. Dockins kicked the PAT, to make the score 41-0.

The Cubs only score came on a 63-yard drive, when Cody Slater passed to Bo Hutchinson, with 3:29 left on the clock. The PAT kick was wide. The game ended in a 41-6 Mogul victory.

### COACHES COMMENTS

We played well during the first quarter last Friday night against Olney, but I thought we got a little bit careless in the second half. I think the boys had a mental let-down after being so up for the last two games against Electra and Holliday.

We played well defensively. Our first defense controlled the game at all times. Defensively, our front seven played an outstanding game. Our second team played great pass defense, picking off two Olney passes.

We need to improve our blocking fundamentals and be able to adjust whenever people throw a lot of looks at us.

Knox City this week will be a fired up football team and we must play our best to win.

In junior high football action last Thursday night at Scruggs field, the seventh grade team won their game against Olney, 28-6. The eighth grade lost, 32-0, and the JV won by a score of 14-6.

These teams face Knox City here this Thursday night (tonight) at 5:30 p.m.

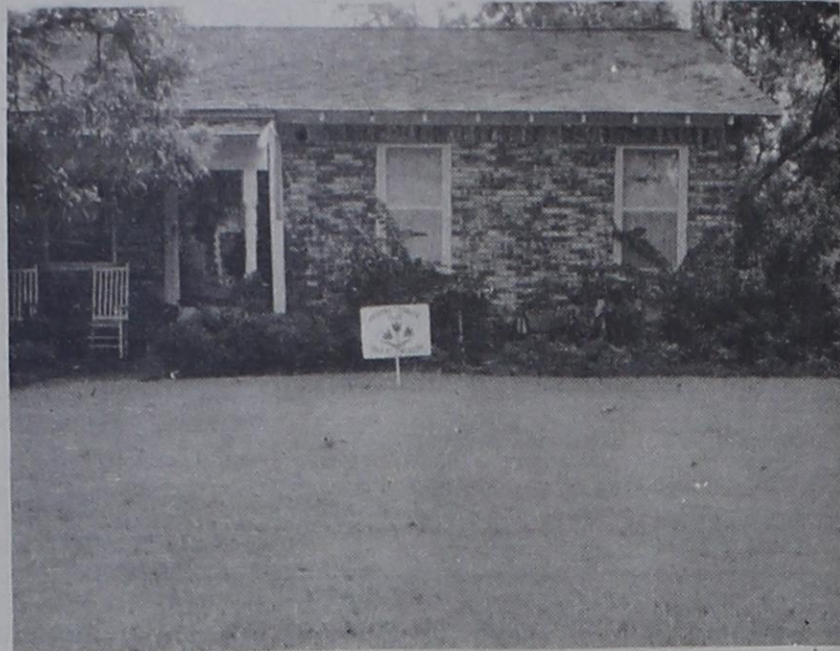

**The Fishing Doc**

**Millers Creek Reservoir**

Level: full  
Temperature (at surface): 75°F  
Condition: Clear in main lake, murky in creeks

**Black Bass:** Good to 7 lbs. Hitting new motorized lures best on surface and large live bass minnows. Best colors are red, ice and green.

**Striper:** Fair to 5 lbs. Taking trolling lures and small perch near dam areas.

**White Bass:** Good especially in creeks to 2 1/3 lbs. Watch for schooling fish. Be careful not to harm small schooling fry.

**Crappie:** Excellent in creek to 2 lbs. Many reported caught on jigs and minnows near surface.

**Catfish:** Excellent to 5 lbs. One pole limit reported caught in two hours. Taking large live minnows, shad and Tan Bait. A few being caught on blood. Trotliners report mainly smaller fish averaging 5 lbs. each.

**Carp & Buffalo:** Excellent to 13 lbs. in creeks. Best on Tan Bait, live minnows and cut bait.

**Fishing Tip**

**Q:** What are the new motorized lures and do they work?

**A:** Right now I know of only one company making this type of top water lure. Its principle is the same as Rat L Traps and other noise makers, to cause vibration in the water similar to live bait. Powerpak lures of Dallas have added a motor similar to some children's toys. When pulled, the motor causes the tail to move rapidly back and forth. I took a chartreuse and red combination lure out a few days ago and fished a creek. Half the time (about one hour) I fished the motorized lure and caught seven bass. The largest was four pounds. Another hour I used a Jitterbug (also a top water lure) of the same colors. It produced only two fish. This was not a scientific test but I was impressed with the action. Instructions on how to use the various powerpak lures are on the back of the carton along with a unique way to clean the motor by covering the hooks with bits of plastic worm and throwing it in the washing machine.

**Ecology Group Endorses Counts For Re-election**

TLCV is a non-profit, non-partisan citizen group. It has been endorsing and contributing to Texas candidates for state office since 1974.

But for the foolishness of many, they'd all have to pay.

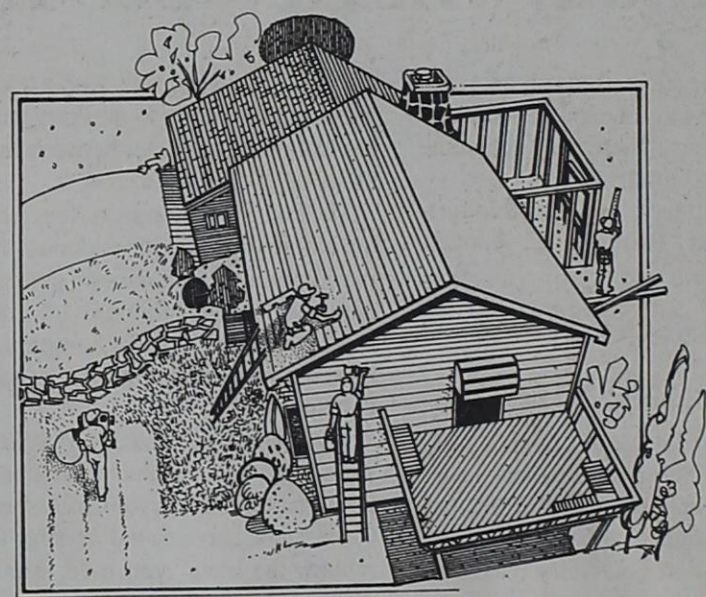

## At Your Service

Q: What do some religious people mean by "born again"? Where did that phrase come from?

A: A similar phrase was used by Jesus in John 3:3-5: "... unless one is born anew, he cannot see the kingdom of God...". This statement was made to a religious Jew, Nicodemus, who came to Jesus at night to learn about God. Jesus told Nicodemus that the man-made doctrines of the Jews concerning God's Kingdom was invalid. To become a member of that Kingdom, he had to be born anew. The original Greek word we translate "anew" is *anōthen* which means both "anew" and "from above." Jesus told us that unless we are spiritually reborn we cannot enter God's Kingdom (the church) and be saved.

Nicodemus misunderstood Jesus' statement thinking that it meant another physical birth (verse 4). Jesus then clarified his teaching: "... unless you are born of water and the Spirit, you cannot enter the kingdom of God." Some have tried to interpret this verse as meaning both physical and spiritual birth, however Jesus just used one preposition with both water and spirit indicating one act, not two. This one act is the rebirth which occurs at baptism. Immersion in water following repentance brings that special gift which is the Holy Spirit within you (Acts 2:38).

Therefore when Christians say, "you must be born again," they are quoting the Bible's description of the

conversion of people to God's kingdom. Some other passages concerning this rebirth are: Romans 6:1-5; Acts 22:16; 1 Peter 3:21.

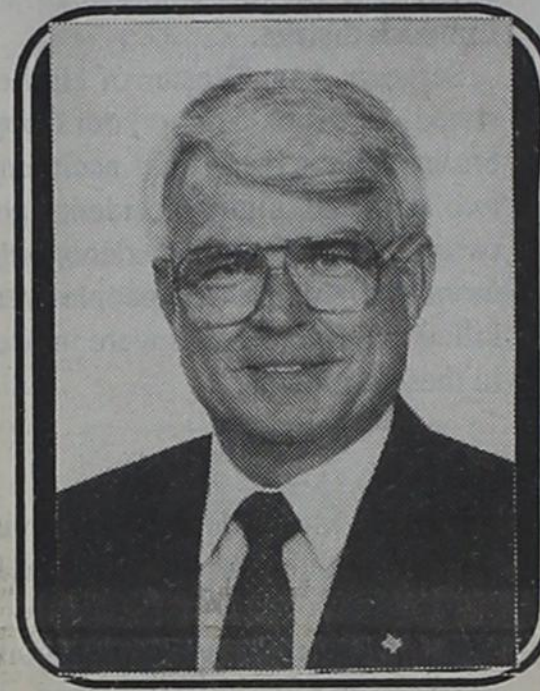

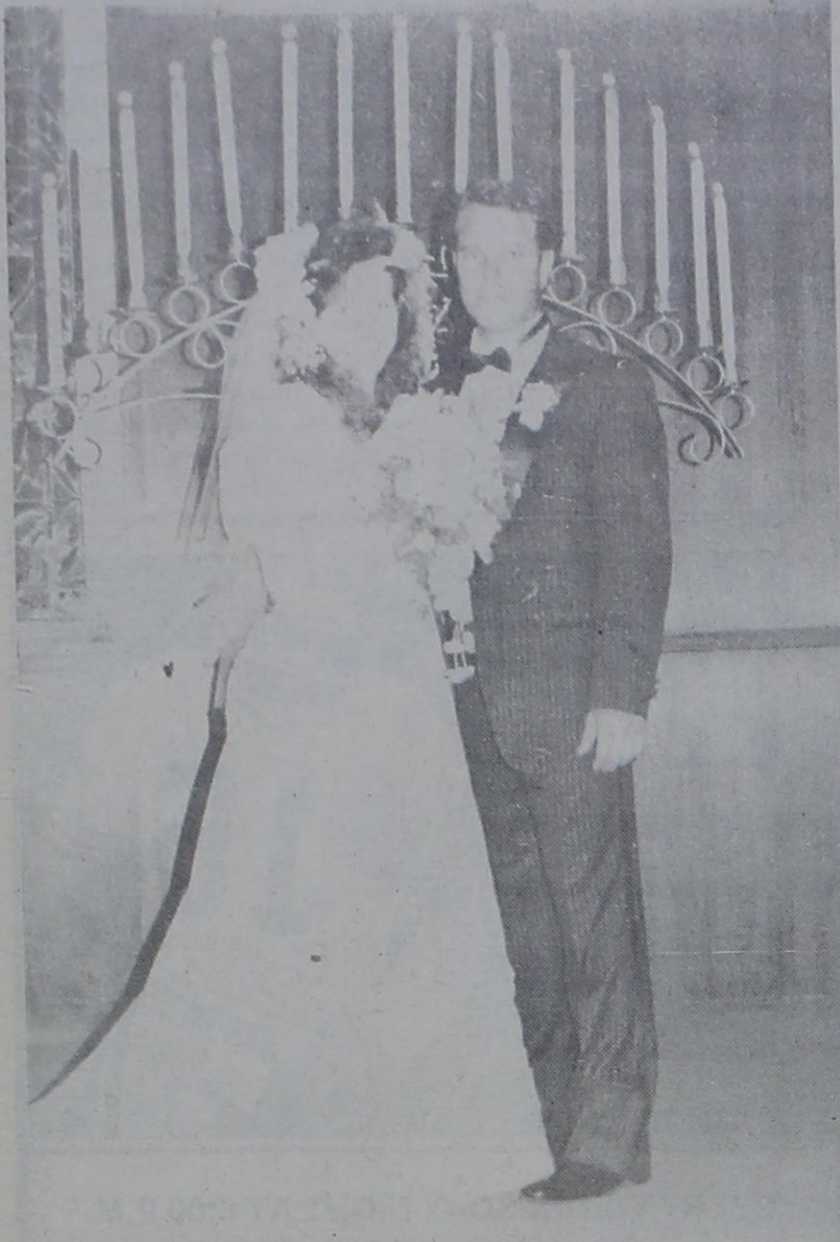

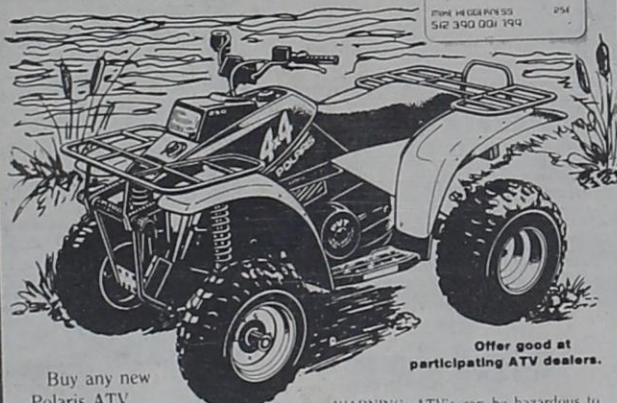

**UNANSWERED PRAYER**  
 All of us have had the experience of praying as hard as we can, only to feel that our pleas have been swallowed up by silence. When our prayers are unanswered, we may feel like giving up on divine providence.

On the other hand, we may want to take God off the hook by blaming ourselves instead: "I am unworthy," "I am being punished for my sins," "I should have prayed longer" or "I don't have enough faith."

No matter how hard we pray, we cannot manipulate a response from God. We can, however, learn to open ourselves to receive and accept God's answer by:

**Examining our image of God.** The Bible is a resource where we can find God portrayed as a walking companion, anxious parent, passionate debater and co-sufferer.

**Imagining what it would be like if all our prayers were answered.** In our prayers we may be seeking the image of fulfillment rather than the substance. Even though we pray sincerely, there may yet be too much of ourselves in our prayer.

**Remembering God's providence previously in our lives.** God is present to us in curious ways, and we often don't know he was there except by the evidence afterward.

**Being angry, but not staying angry.** Prophets and saints have fought with God, and so can we. To allow ourselves to express such passion is to take God seriously, to enter the intimacy God invites us to and to acknowledge God's providential power. But once we have expressed and processed our anger, the time comes to let go of our anger.

**Knowing that we are in very good company.** Although our anguish makes us feel alone, we are in a blessed company of distinguished persons who have known the deafening silence of God: Job, Jesus and Saint Francis of Assisi. Throughout human history, most people who have cried out to God have, at one time or another, experienced the mystery of ambiguity that calls for the reflection of faith.

**Continuing to pray.** Prayer is for the "pray-er." It cannot change God,

but it can change us. The purest prayer is the one who seeks to make his will conform to God's will, to make his thinking, God's thinking.

God does answer our prayers, though the response may be wrapped in mystery. But, whether appearing as a startling miracle or a chilling silence, it is destined to accomplish God's ultimate purpose: The removal of all needs through a perfect union of love.

#### Iron - Who Needs It?

Everyone needs iron, especially growing children and adolescents, menstruating women and pregnant women who have the greatest need. Iron is required for growth of new body tissue and increasing blood volume. Iron is also needed to replace blood cells lost through menstruation.

Iron is an essential mineral which plays a role in a variety of body functions. Its primary role is to carry oxygen and carbon dioxide within the red blood cells from one body tissue to another. Iron is also necessary for the production of energy and to support the immune system.

To help your body absorb more from the foods you eat:

\* Include HEME IRON sources. There are two types of iron foods - heme iron and nonheme iron. Meat, poultry and fish contain heme iron which is much more easily absorbed by the body than nonheme iron, found mainly in plant food.

\* Remember that Meat Factor. Meat, poultry and fish also contain a special quality called the Meat Factor which helps the body absorb more nonheme iron. For example, if you eat meat and vegetables together, you absorb more iron from the vegetables or breads/cereals than if you eat them alone.

\* Include Vitamin C Sources. Foods containing Vitamin C such as fruits
