# **Important Elections On Tap For Saturday** KNOX CITY

Texas voters will go to the polls on Saturday, April 5, to elect city, school and other district governments, and absentee response has been varied throughout the state. In Knox County, not many registered voters have bothered to cast their ballots absentee, and it is hoped that more will take the time to vote on Saturday.

A lack of candidates is certainly one reason for disinterest in the election. Some area elections just have enough people on the ballot to fill the vacancies, and in Goree, two write-in candidates will be elected. But there are plenty of choices in other elections, and voters are urged to invest just a few minutes Saturday in choosing those who will make many important decisions for our city, school and hospital district.

Here is a wrap-up of the candidates for office throughout the county:

MUNDAY

Mayor Doris Dickerson is running unopposed this year. Names on the ballot for City Council are incumbent Richard Albus and Gene Brown. Von Marr, the second incumbent, did not file for re-election.



# **6-Year-Old Boy Is Subject Of Search** In Nearby County

# **Ushers In Tornado Season**

Spring is officially here, as of March 21, and with the warm weather also comes the threat of storms. Courier readers are advised to pay close attention to weatherwatching and safety tips presented often during this season by the National Weather Service.

Radio and television broadcasts are often the first warning persons in our rural area have when threatening weather is approaching. Following these bulletins is important, although broadcasts from Abilene or Wichita Falls stations sometimes warn of danger after it has already passed.

Know the difference in a watch and a warning. A tornado or severe thunderstorm watch means that there is a likelihood of storms in a certain area because atmospheric conditions are providing the necessary elements. A warning indicates the existence of a storm within a defined area.

Local law enforcement authorities, firemen and other weather spotters are always on the watch during stormy weather. They are in close contact with the National Weather Service offices and are in a position to warn citizens when severe weather is imminent.

But one piece of good advice is to not wait until the last minute to decide you are in danger from the weather. If news broadcasts are telling of storms in or approaching this area, move to a safe spot. An important role is not to be caught in an automobile during a storm. If you must travel to go to a cellar or

Storm shelters or other enclosed places are the safest places to be during a tornado or hail storm. In a home, persons should seek shelter toward the interior of the building, preferably in an inner closet, bathroom or hallway which has no windows. The smaller the space and the more walls enclosing it, the better.

Since electricity can't always be depended on during a storm, a flashlight, extra batteries and a battery-operated radio are handy items to take into any sort of shelter. Other aids are candles, matches and bottled water.

In times past, opening windows to equalize pressure was recommended during a storm. This practice is not being advised any longer, as persons may lose valuable time opening

windows that will be shattered anyway if a tornado comes close enough.

Anyone being caught in the open when a tornado strikes should get in a ditch or a nearby building. Mobile homes are not sufficient protection during a tornado, as air can get up under them just as it can a vehicle. Lie flat on your stomach on the ground if there is no shelter, protecting your head with your arms and hands.

Although most people fear tornadoes, straight winds from a severe thunderstorm can do nearly as much damage. In our area, tornados generally move from southwest to northeast. Weather service statistics show that major tornados hit an area on the average of every ten years, but any well built thunderstorm can spawn a tornado if the conditions are right.



#### SEEDS VULNERABLE IN COLD SOIL

Crops often have a hard time becoming established due to cold soils and severe seedling disease. Understanding what is happening may help farmers and gardeners deal effectively with the problem.

First, seedling disease is more severe when soils are cold, even though this is not the basic cause. When plants are placed at a disadvantage and soil-borne disease organisms are favored, an ideal condition exists for the seedling disease complex.

Seeds function differently in cold soils than they do in warm soils. In cold soils germination is slow and seedlings emerge slowly, making them vulnerable to soil organisms over a longer period of time. During that time micro-organisms may produce seed decay, or pre or post emergency damping off. A skippy stand may result.

Seed quality is a most important consideration. High quality seeds have a better chance of producing a healthy seedling in a cold soil. Weak seeds may lose nutrients from their cell walls, thus attracting soil pathogens that feed on the nutrients. Generally, a cold test is used to tell which seed lots are of high quality.

The average soil temperature last week at a four inch depth was 40.5 degrees. The temperature was read at 7 a.m. in a loamy fine sand soil type.

Spring crops and minimum soil temperatures recommended for planting are: corn, 50 degrees; sor-, ghum, 55 degrees; cotton, 68 degrees; onions, cabbage and potatoes, 45 to 50 degrees; and tomatoes, melons, beans and peppers, 65 degrees. Other climatic factors, such as possible late freezes, should be considered with soil temperature whether you are planting a crop or a home garden.


\*Modeling agencies/beauty pageants. - Chances of making it big through itinerant "scouts" are extremely slim and the process can be very costly.




Triple arches of candles, candle trees, spirals and pyramids entwined with greenery and adorned with large mauve bows and white doves formed the setting for the ceremony.


