

# **Councilmen Approve Pair Of Ordinances**

MUNDAY, TEXAS 76371

The City Council of the City of Munday, Texas met in regular session April 7, at the Munday City Hall.

Members present were Mayor Doris Dickerson and Aldermen Jessie Andrade, Garon Tidwell, Jessie Tucker, Gene Brown and Richard Albus.

Mayor Dickerson called the meeting to order and requested minutes of the March 10, 1987 meeting be read. Tidwell moved minutes be approved as written. Tucker seconded; all in favor.

The council reviewed information on cities' right to collect tax on tele-communications services. After discussion, Gene Brown moved the ordinance recommended by our attorneys and approved as to form by the City Attorney be passed, said ordinance captioned as follows:

An ordinance relating to taxation of telecommunications service: Repealing the application of the exemption provided for in Section 4B(a) of Article 1066C V.A.T.C.S.; providing for notification to the Comptroller of the State of Texas; providing that no such tax provided for hereunder shall serve as an offset to or to reduce any amount payable by any provider of telecommunications service pursuant to any franchise, street use ordinance, charter provision, statute or any other imposition of the City of Munday; making this ordinance cumulative; providing a severability clause; and providing for an effective date. Jessie Andrade seconded the motion. Motion carried with Gene

Brown, Jessie Andrade, Garon Tidwell, Jessie Tucker and Richard Albus voting for passage. Full text will be filed in City Ordinance files under telecommunications; also a registered or certified copy is to be mailed to the Attorney General's office.


Next discussed was an amendment to existing orders passed in regard to collection of past due accounts for water, sewer or garbage bills. Key personnel are now being required, in some instances, to go to nomes or businesses to collect bills. After discussion Tidwell moved that a resolution be passed that in instances where City personnel must go to homes or businesses to collect bills for water, sewer or garbage due the City of Munday, if said bill is paid to the City employee, an additional \$5 is required to be added for such extra service. If water is actually cut off and not paid, the present \$7.50 charge applies instead.

# State's Economic Woes Reflected In Sales Tax Rebates

Sales tax rebates in Knox County are still showing a decrease, with the latest figures arriving early this week. Overall, the county has received more than 20 percent less in the first four months of 1987 than in the same time period last year.

Munday's April check was for \$1,704.71, compared to \$2,291.51 last April. The city's four-month total of \$12,385.39 is down 17.37 percent from 1986. Goree received a check for \$589.85, which brings their 1987 total to \$1,876.21, a whopping 34.13 percent less than in the same time frame last year.

Knox City banked a check for \$3,479.72 and has totaled \$20,993.36 for the year. That amount reflects a 21.45 decrease. Benjamin has only received \$573.90 this year, down 13.77 percent from last year's \$665.51 to this point.

In Haskell County, O'Brien and Weinert have escaped the oil-related loss in tax revenues. The City of O'Brien has doubled its tax check, from \$256.37 last year to \$513.09 so far in 1987. Weinert's total of \$1,335.46 is 38.14 percent larger than the rebates received in April, 1986.

But other cities and communities in this area are operating under smaller sales tax rebates, following the state-wide trend. Comptroller Bob Bullock said 1987 payments were down an average of 6 percent from last April. April checks represent tax collected on sales made in February and reported to Bullock's office by March 20. Cut-off notices prior to either above action still prevail as now required. Andrade seconded the mot.on. All members voted for.

emergency action situations, this being the second and final reading of said ordinance. Said ordinance is captioned in part as follows:

Every officer, agent or employee of the City, while responding to emergency situations, is hereby authorized to act in such a manner as to most effectively deal with the emergency. This provision shall prevail over every other ordinance of the City and, to the extent to which the City has the authority to so authorize, over any other law establishing a standard of care in conflict with this section. Neither the City nor the employee shall be liable for any failure to use ordinary care in such emergency.

This ordinance is recommended for passage by the Texas Municipal League and by Bobby D. Burnett, City Attorney. Garon Tidwell moved this ordinance be passed, full text copy to be filed in City ordinance files under emergency action. Jessie Tucker seconded the motion. Voting for were Garon Tidwell, Jessie Tucker, Jessie Andrade, Gene Brown and Richard Albus.

Mayor Dickerson next briefed the council on City Hall and fire station parking lot progress, street paving progress and drainage needed at the intersection northeast of the water tower. The drainage problem needs attention this summer, if possible. One little-used culvert needs removal before the other work would be effective, he said.

The council next reviewed the March 19 appointment (under a new ordinance) of John Phillips as City Judge. Albus moved the appointment of John Phillips as City Judge by Mayor Doris Dickerson be approved by the City Council. Brown seconded. Voting for were Albus, Brown, Tucker, Tidwell and Andrade.

# Munday Farmer To Serve On PCA Nominating Committee

A Munday man was elected to serve on the 1988 nominating committee for the Rolling Plains Production Credit Association at its annual meetings April 3 and 4 in Childress and Stamford.

Directors W.J. Boykin of Childress and B.H. DeBusk of Anson were re-elected to three-year terms at the stockholders meeting. Other board members are Garon Tidwell of Munday, W.H. Williams of Spur and Dan Henard Jr. of Wellington.

The nominating committee report was presented by chairman Walter Heller of Lueders. Elected to serve on the 1988 committee were Kyle Josselet of Munday, J.R. 'Pete' Jones of Tell, Dean Turner of Matador, Don Cobb of Stamford and Gary Bridge of Afton.

In the board report, Boykin advised the gathering that the Rolling Plains PCA had joined with 21 other Texas PCAs in a lawsuit against the Farm Credit Administration to prevent the FCA from assessing the surplus of the Texas district associations. A permanent injunction granted in March enables

### **County Residents Sentenced By Judge**

Two Munday residents were sentenced in district court proceedings on April 8 in Benjamin. Donnie Hise, formerly of Haskell, pled guilty to charges of driving while intoxicated and was assessed a 30-day sentence in the Knox County Jail. In addition to the jail term, he received a \$100 fine plus court costs in the amount of \$240. County attorney Bobby D. Burnett represented the prosecution. Rolling Plains PCA to avoid funding the assessment of \$591,000, and the association will be spared the inconvenience of having to transfer a portion of its substantial surplus account to weaker districts.

The Texas PCA district is the strongest in the nation, and Rolling Plains PCA is one of the most financially sound branches in Texas with capital accounts of \$13,297,913 and a capital to total assets ration in excess of 25 percent.

During the past five years, Rolling Plains PCA has loaned in excess of \$528,000,000 to farmers and ranchers, according to president John S. Rike III, who gave the management report. Losses have been a nominal \$1,500,000 of the volume loaned. Rike said the book value of members' stock continues to increase based on the profits of the association. Purchased at \$5 per share, the book value of one share of B stock has increased from \$11.49 to \$11.90 since December, indicating a healthy and viable organization.

Rolling Plains PCA maintains offices in Childress, Matador, Munday, Spur and Stamford.

Meeting adjourned following a motion by Tidwell and second by Andrade.

# **April Designated National Month For Cancer Control**

The Texas Department of Health (TDH) has joined other agencies and associations nationwide in observing National Cancer Control Month in April.

President Ronald Reagan proclaimed the observance to draw public attention toward a better understanding of cancer, its prevention and treatment.

In Texas, TDH and the American Cancer Society are assisting local public awareness programs, emphasizing the dangers and detection of breast cancer in women, cancer attributed to tobacco use, cancer screening among older adults, and other programs.

One recent statewide public information campaign, conducted primarily through local television stations and newspapers, attracted some 108,000 responses from persons concerned about breast cancer. Part of the campaign was low-cost examinations and mammograms conducted in some metropolitan areas. In addition, TDH's Adult Health Program has begun a pilot project to teach cancer preventive

nutrition for black adults in East Texas (Wood County).

At the heart of TDH's programs to prevent cancer is its cancer registry, which compiles records from Texas hospitals of the many factors involved in cancer incidence. Analysis of registry data since 1976 has begun to show characteristics of the more than 100 types of cancer suffered by Texans. Such information includes demographics, age, ethnic origin, previous illnesses, types of treatment and other pertinent facts that may indicate why some people are more at risk than others. An example of the registry's finding is that Hispanics appear to have a higher incidence of stomach, liver. and gallbladder cancer than do Anglos. Such facts help researchers in their quest for specific causes of the diseases.





#### **LEAF RUST AGAIN THREATENS WHEAT**

Leaf rust has been reported heavy in some wheat near Gilliland by E.D. Welch and Lloyd Don Welch. Leaf rust could reduce yields sharply, so farmers need to stay abreast of the situation.

After a heavy infestation of leaf rust in last year's wheat crop, the fungus-caused disease successfully "over-summered" and then infected the new wheat crop last fall. With mild weather and good mois-I would like to thank everyone for the ture conditions, the disease could be devastating.

While certain fungicides are effective against leaf rust, controlling the disease is a costly practice. That's why control is only practical when a farmer has a high yield potential and leaf rust is the major

this is because of the high boll weevil populations expected to emerge this year. Emory Boring, Extension entomologist, points out that peak boll weevil emergence generally occurs the last week of May or first week of June. Research has shown that overwintered boll weevils typically live from 10 to 22 days after they emerge. Selecting May 25 as the planting date will delay production of first one-third grown squares. Squares less than one-third grown are not large enough for developing boll weevils to survive. Only surviving female boll weevils are able to deposit their eggs in first one-third grown squares. Early planting will provide early egg laying sites. This can result in the production of an additional weevil generation and large weevil populations during the 1987 cotton production season. \*\*\*\*

#### **REDUCE BACKSTRAIN ON THE JOB**

If your job requires standing or sitting for long periods, learn to do it properly to reduce backstrain. Keep your stomach pulled in, your back straight and your head up. #### **USE DOLLAR BILL TEST ON REFRIGERATOR**

One possible cause for a refrigerator-freezer that won't maintain its temperature is a stiff, cracked and damaged door gasket which allows air seepage. Check for a good gasket fit with a dollar bill. Hold a dollar bill between the door and cabinet and shut the door so that some of the bill is outside. Pull the dollar bill out slowly. There should be some resistance. If there isn't, the gasket is allowing air to escape and should be repaired or adjusted.



### Local Man's Sister **Is Buried In Olney**


