## Time nears for city, hospital board and school board elections

The May 4 date for general elections is getting closer and it's time to start thinking about for whom you wish to vote.

In the city elections for Munday there are five candidates for aldermen. Winters Mathews and Danny Owens are running for re-election to the positions they have maintained for two years on the City Council. Also seeking election to the City Council are Robert "Bob" Bowen, Steve Morren, and Jay White.

Winters Mathews has been a resident of the Munday area all her life. She has been active in all types of elections and has been involved in school, city and county government. She was appointed to the City Council in January 1991 to fill the seat of her late husband and has been elected to two terms since then. She reports that she enjoys working with the city employees and says that Munday has a lot to be thankful for.

Danny Owens is the District Supervisor for the Texas Boll Weevil Eradication Foundation and, prior to this assignment, was a farmer whose main crops were cotton, milo and wheat. Mr. Owens has served for two years on the City Council and is seeking re-election to render civic service to the city. He has been involved in many church and civic organizations.

Robert Bowen, known to most by "Bob", has lived in Munday for twelve years. He is married to Kathleen Bowen, a life-time resident of the area. They have two children, Phillip, a graduate of Munday High School who currently attends Tarleton State University, and Robin, a senior at Munday High School. Robert is concerned about our city's needs, i.e. cleanliness of streets and repair or demolition of abandoned buildings and paving of streets being at the foreground of this concern. Robert is in charge of the Alternative Education Program in Weinert.

Jay White has lived in Munday

for a little over one year and is the manager of Moore Agricultural Products. He states that Munday has many features that most small towns do not possess and he hopes to help keep our small community a quality one. He is concerned about quality of life issues for our citizen's children and wants to help keep Munday a wonderful place to live and grow up.

Mr. Steve Morren is also running for an alderman position but was not available at press time. The Munday Courier will gladly publish a statement from him at a later date.

Mr. Gary Tidwell, Mayor Pro-Tem is running unopposed for Mayor. He was appointed as Mayor Pro-Tem after the resignation of former Mayor, Richard Albus.

There are four candidates for School Board. These include Jeremy Wilson, Mark Reed, Gary Wilde, and Maynard "Sonny" Moore.

Jeremy Wilson has lived in Munday for 20 years and has two children, Rileigh and Taylor. Rileigh is in the third grade. Mr. Wilson thinks that parents should be apart of the school system to help see that things are run as well as possible for the sake of the children. He would appreciate your vote.

Mark Reed has been a resident of this area all his life. He is a farmer, is married and has one child. Mr. Reed states that he is proud of the tradition of giving 100% at the Munday schools - whether it's in sports, academics, or band - and he wants to see it continue.

Maynard "Sonny" Moore manages Farmer's Grain Co-op and is owner of Munday Cotton Company. He has served on the School Board for the past twelve years and says that he feels a commitment to the children and the district. He is most proud of the fact that when he began serving on the School Board that the tax rate was \$1.30 and it is still that today. Many improvements have been made over the past

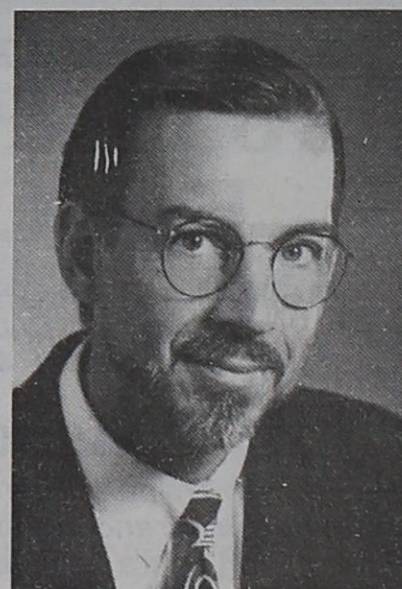

# Rollover Convincer to be featured at Parenting Fair

Have you seen a large maroon and white pickup cab and trailer driving around the state? The Texas Agricultural Extension Service in cooperation with the Texas Department of Transportation, through the Passenger Safety Education Project, has acquired a rollover convincer. The objective is to convince people to buckle up. The rollover convincer simulates

what could happen to a passenger if they are involved in a rollover crash and not wearing their safety belt.

The rollover convincer is designed to target audiences of all ages, but most specifically pickup drivers and passengers. According to survey results conducted in 25 rural Texas counties for 1994, only 36 percent of pickup occupants

were wearing their safety belts, compared with over 50 percent for passenger-vehicle occupants.

Some drivers and passengers may feel "invincible" in a pickup. They may believe that they have a better change of survival if they are thrown clear. The facts are almost 34 percent of vehicle occupants killed in Texas crashes during 1993 were in light trucks. The chance of severe injury or death increases 25 percent if a person is thrown out of the vehicle.

Demonstrating the convincer is just one step to making Texans aware of the risks that they take by not wearing a safety belt.

The Rollover Convincer will be demonstrated at various times during the Knox County Parenting Fair, April 23. The fair will be held from 4:30 p.m. - 6:30 p.m. at the Munday Elementary School Gym in Munday, Texas.

Edward Young said, "Who would wish to be valued must make himself scarce." Think about that phrase for a moment and ponder what Young was really trying to say. It seems that we now live in a country where this is no longer true. While in our family life, it may be so that we value those we seldom get the chance to see, in the world in which we live, that of the television set, we get a different picture.

In sports especially, we value and publicize those people who stand out, often not for good. Take for example what happened last week with a player from the Los Angeles Lakers who after being ejected from a game in the second half proceeded to challenge the referee, pushing him onto a table. No one really knew who this half-rate player was until this incident, and now he is a national star. The \$200,000 fine will mean little in lieu of all the free publicity the media is granting him. Is this the way we punish people for doing wrong in society? By shining the media spotlight on them? Would it not be more fitting to suspend him for the rest of the year?

And what about Mike Tyson? He is again being accused of sexual impropriety. We would rather overlook this social dunce, and simple revel in statistics like his ability to knock people out in the first round. But the truth remains that he, as well as Michael Irvin and Dennis Rodman just to name two, have grown bigger than the games they play. Professional sports is quickly abandoning the sport itself and settling for individual stars who have no team concept. It is sad that there are too many Dennis Rodmans and too few Reggie Whites.

I really have no idea how to tie this into Christian living other than

to say this -- Life is not always about being a star. Jesus himself, though admittedly very famous in his time, denied his own appeal and sacrificed himself on a cross for us. And while it may be true that he died for "each and every one of us," it is also true that Jesus prayed in John 17 that we may "all be one." Christianity is about playing as a team; about being a part of corporate worship. It is unfortunate that over 2000 years we have moved from the body of Christ to a group of individuals; to a society that has convinced many to believe that you don't really need church, that you can worship God on your own. The kingdom of God is not made of celebrities who have to have things their way, but by those people who can truly say, "Your will be done."

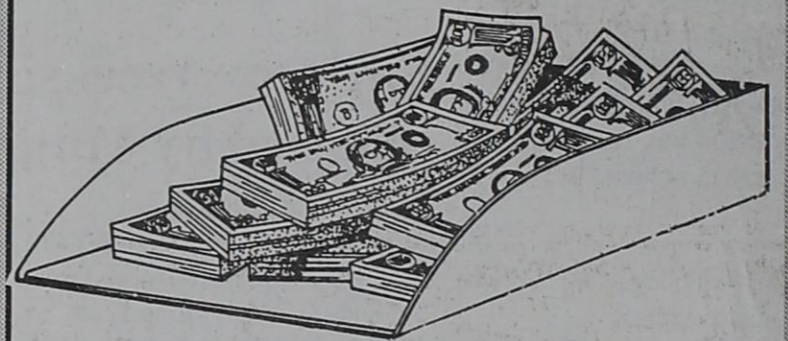

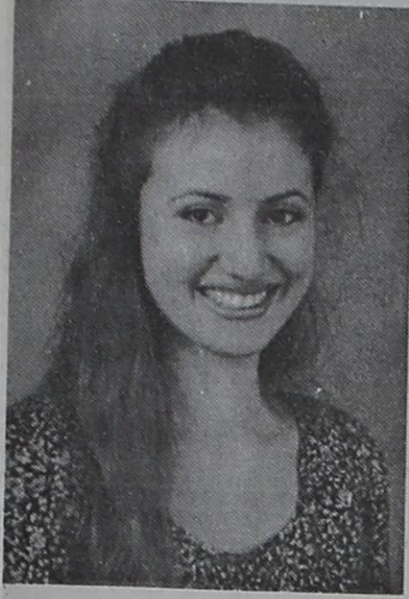

**HOW CAN ONE PERSON HELP PREVENT CHILD ABUSE?**

1. CHANGE YOURSELF...Ask yourself how you are doing as a parent. Vow to learn one new thing about being a parent by reading or talking to other parents. Respect your family members. Use a courteous tone of voice with them. Learn to apologize to your children when you are wrong. Make time to play together. Praise children and teens for being good, for doing the little things that are so easy to take for granted. Tell your children "I love you" more often. Violence teaches violence. Forget about hitting your kids.

2. Change your community...Reach out to neighbors or relatives with children. Offer to baby-sit to give them a much needed break. Don't wait for someone else to do it...take action! Arrange for a speaker on child abuse to come to PTA or adult Sunday school class. Volunteer time in a child crisis shelter, parenting support program, drug abuse prevention/treatment program, or shelter for the homeless.

3. Change the World...Write a letter to your elected representatives and let them know it is your choice that they act to support parent education and child abuse prevention. Register to vote and use your vote to reflect your concern about children.

### Area men receive sentences for illegal drug possession

Four area men received penitentiary sentences out of the 50th Judicial District Court during the past week and Grand Jury sessions were held in Knox, Cottle and King Counties, according to District Attorney Bill Neal.

Jerry Carl Eaton, 38, of Knox City plead guilty in the Knox County District Court on April 3, to the sale of methamphetamine to an undercover narcotic officer pursuant to a plea bargain agreement with the State to accept a 10-year prison sentence. In addition, under the plea bargain agreement, Eaton agreed to forfeit to the State his home in Knox City. Eaton was released on a \$75,000 bond pending formal sentencing.

The conviction resulted from a coordinated drug undercover effort between the North Texas Drug Task Force, the Knox and Baylor County Sheriffs' Departments and the District Attorney's Office.

The defendant, Jerry Carl Eaton, was represented by Alex Scharff of San Antonio.

On the same date, in the Knox County District Court, Gary Dixon, 24 of Goree and Chris Hardemon, 19, of Goree, plead guilty to the State's allegations contained in a Motion to Revoke their probation and were each sentenced to two years in the penitentiary by District Judge David Hajek. Both Dixon and Hardemon had been previously placed on probation for

Sale of a "Simulated" Drug on September 6, 1995. The State, through District Attorney Bill Neal, alleged both men had violated their probation in several respects, including, burglarizing automobiles in Goree on February 11, 1996, and the defendants plead true to these allegations prior to sentencing.

Meanwhile, in the Baylor County District Court, Jason Brunkow, 20, of Seymour, received a 10-year penitentiary sentence when he plead true to the State's allegations that he had violated his probation. However, District Judge David Hajek made it subject to the prison's "Boot Camp" Program whereby Brunkow will be sent to the prison's "Boot Camp" facility for 90 days. If he completes it successfully, he'll be brought back before the District Judge to determine if he shall serve the rest of his 10-year sentence or be placed on probation for the remainder of the sentence subject to supervision by the probation department.

Brunkow originally plead guilty on May 6, 1994 to Burglary of a Building. He plead true to violating his probation by possessing marijuana, failing to report, leaving the county without permission, failing to pay his fees and other violations. Brunkow was represented by Carl Quisenberry of Seymour.

Daniel Shelton Fontenot, 21, of Seymour plead guilty in the Baylor County District Court to an indictment charging him with possession of cocaine, and was given an eight-year probated sentence and fined \$2,500 by Judge Hajek.

Also in the Baylor County District Court, Augustin Lara, 27, of Seymour, appeared with his attorney, Kris Fouts, of Stamford and was formally sentenced to 60 years in the penitentiary, plus assessed a \$2,000 fine. Sentence was a result of a jury trial in the Baylor County

District Court held on March 26 and 27 wherein the jury found Lara guilty of selling cocaine to an undercover informant.

In addition to the above, Grand Jury sessions were held in Cottle, King and Knox Counties, all in the 50th Judicial District Court last week.

The Knox County Grand Jury on April 3, returned 6 indictments against nine individuals, including one cattle theft indictment against Jerry Carl Eaton, 38, of Knox City; Payton Ellis Tankersley, 38, of Knox City; and Kevin Wayne

White, 26, of Knox City, according to District Attorney Bill Neal.

In addition, Larry Holder, 53, of Knox City and Donald R. Glen, 55, of Denison, Texas, were jointly indicted for Unauthorized Brucellosis Vaccination. Others indicted by the Knox County Grand Jury include: Thomas Valencia, 51, of Munday, Aggravated Assault of a Peace Officer; Raymond Guerra, 28, of Munday, Resisting Arrest; Vernon Smith, Jr., 67, of Burkburnett, Felony Theft; and David Guadalupe Garcia, 48, of Goree, felony DWI.

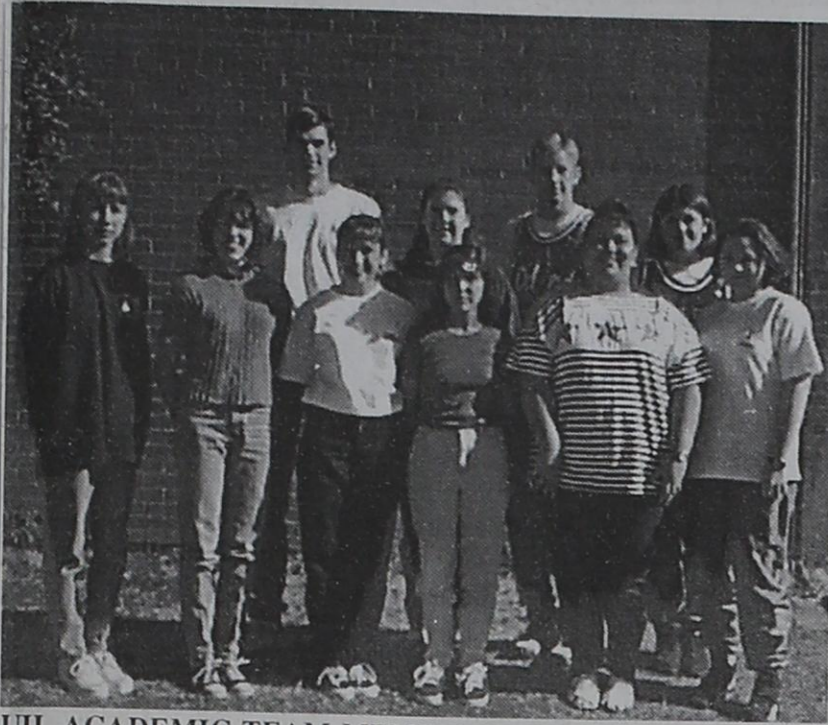

## Perry says Texas beef supply safe

Underscoring the safety of the U.S. food supply, Agriculture Commissioner Rick Perry says that Bovine Spongiform Encephalopathy has never been a problem in the United States and that stringent steps are in place to prevent BSE from entering the country.

"BSE affects the central nervous system of cattle, causing the animals to lose all muscle coordination," Perry said. "Unfortunately, it's being called 'mad cow disease' because the way cattle act and stagger around. In reality, it's a very sad situation to see."

There have been no cases of BSE found in the United States, and in 1989 a total ban was imposed on cattle imports from countries with BSE. The U.S. Department of Agriculture Food Safety Inspection Service says that no beef has been imported from the United Kingdom since 1985.

There is no scientific evidence that BSE is present in meat or milk, or that BSE can be transmitted through physical contact or the consumption of beef or of dairy products.

## Special edition license plates still available in Knox County

Texas motorists still have the opportunity to show off their pride for the Lone Star State with the new and colorful license plate commemorating Texas' 150th anniversary of statehood.

The plates became available December 29, 1995 and will remain available until supplies are exhausted. These special edition passenger plates temporarily will replace the standard "Lone Star State" design.

A shooting star logo and the words, "150 Years of Statehood" are featured on the license plates. They will be available to motorists who purchase a new car and to those who require a replacement due to loss, damage or because their current plates are more than 5 years old at the time of registration renewal. Replacements may be purchased at the local county tax assessor-collector's office for a \$5.30 fee.

"The Texas Department of Transportation is proud to have these plates manufactured for such a significant period in our state's history," said David Laney, commissioner of transportation. "We haven't issued commemorative license plates since 1986, when Texas celebrated the sesquicentennial of being the Republic of Texas."

Texas license plates are manufactured by the Texas Department of Criminal Justice in Huntsville. TxDOT's Vehicle Titles and Registration Division, which oversees the license plate program, registers 14 million vehicles and issues 4 million titles annually.

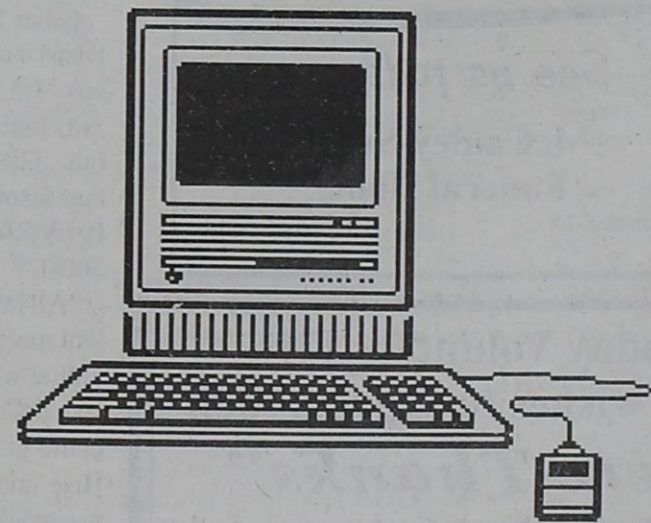

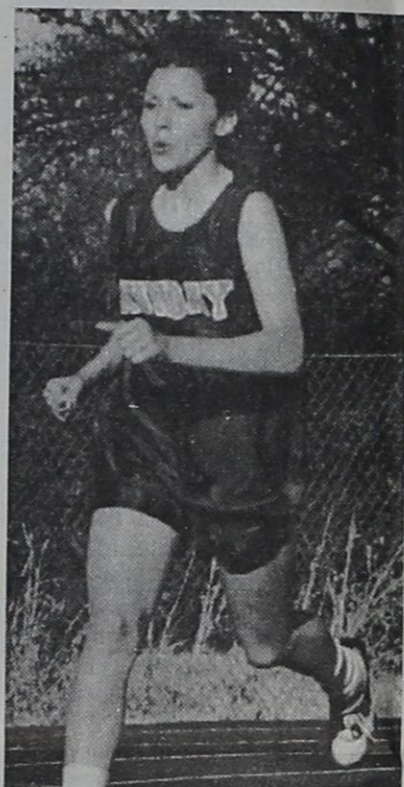
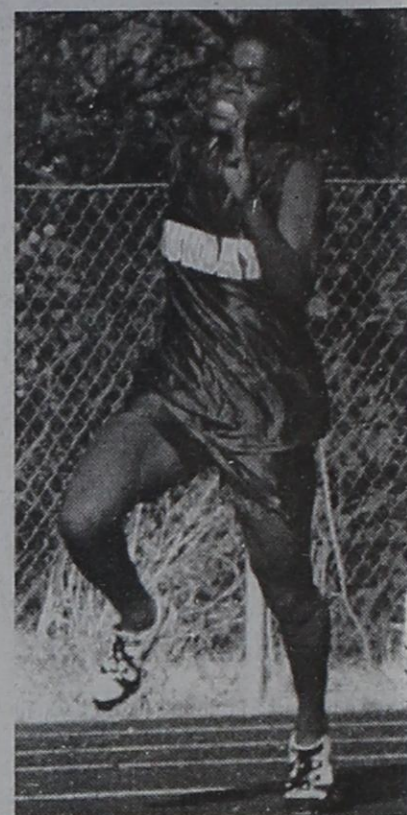
