

## Deposits Growing At Bank

The statement of condition issued by the First National Bank of Munday for the month of June, 1991, shows an approximate \$3 million increase in deposits above what was recorded in June, 1990. Current deposits are \$30,070,104, as compared to \$27,340,000 at the same time last year. The exact amount of the increase is \$2,730,103.

Loan statistics for the Munday bank show that the 1991 loan total is \$11,827,409. That's an increase of \$782,409 over last year's \$11,045,000 total. Assets also showed an upward trend, rising from \$30,915,000 last year to \$38,865,645 this year.

## Little League Ends Season

The Munday Little League ended their 1991 season last Wednesday night in Seymour at the District Little League competition.

Munday was defeated by Seymour in Monday night baseball action. Seymour then lost to Knox City on Tuesday night. On Wednesday, Munday and Seymour faced off again, with Seymour coming out the winner once more. As it was a double-elimination tournament, this ended the season for the Munday All-Stars.

Seymour went on to defeat Knox City on Thursday night, with the two teams scheduled to play again on Friday. The winner of that game will advance to the area playoffs in Olney.

## Local Sales Tax Rebates Show Sharp Increase

State Comptroller John Sharp recently sent checks totaling \$98 million to 1,065 Texas cities and counties in sales tax rebates.

"Local sales tax rebates -- from Beaumont to El Paso -- continue to run ahead of this time last year, an indication that the Texas economy is expanding at a steady rate," Sharp said.

Knox County was no exception to the rule, as they showed an 18.88% increase over this payment period last year and a 6.15% increase over 1990 payments to date.

Munday also showed an increase, as did all communities in Knox County. Munday received \$4,248.55 for this period, compared to \$3,006.92 for the same period last year. That

shows an increase of 41.29%. On the year to date totals, Munday reported a 3.60% increase with rebates of over \$30 thousand.

Knox City showed a 9.19% increase for this payment period and a 7.37% increase for the year to date. Goree had a 6.82% year to date increase, with a 27.60% period increase. While Benjamin had no rebates for the period, they still show a 5.33% year to date increase.

July's checks include taxes collected on May sales and reported in June by businesses filing monthly sales tax returns with the state. The state retains its share and returns to cities, counties and other taxing entities their local portion of the sales tax.

## Council Approves Development Corporation's Formal Resolution

(Following are the minutes of the regular session of the Munday City Council for the month of July.)

The City Council of the City of Munday met July 9, 1991, in regular session at Munday City Hall at 7:00 p.m. All members were present.

Mayor Albus called the meeting to order. Minutes of the June 11th regular meeting were read. Motion by Oustad to approve minutes as read. Seconded by Matthews. All in favor.

Mayor Albus declared that the first Public Hearing for the 1991 Texas Department of Commerce grant application was in progress. This hearing will remain open until the end of this meeting and comments will be accepted from the public.

Representatives from W.T.U. met with the Council concerning the Franchise agreement. After discussion, a motion was made by Andrade to table this item pending further investigation. Seconded by Tidwell. Motion carried.

Charles Baker met with the Council representing the Development Corporation. Mr. Baker presented the Council with the Articles of Incorporation and a Resolution to be sent to the State. Motion by Booe to accept the Articles of Incorporation and to approve the Resolution. Seconded by Oustad. All for. (Full text in City files.)

The 1990 Audit and Auditor's report were reviewed by the Council. No action needed.

Applications for Police Officer and Ambulance Coordinator were examined. No action was taken at this time.

The Medical Director for the Ambulance Service was discussed. The Council had decided to change Medical Directors at a previous meeting. The consensus of the Council was that this decision will stand.

Discussion of the Board of Directors of the Munday Housing Authority were next on the agenda. No action was taken on this issue.

All employees were discussed. A motion was made by Andrade to grant a raise to one part-time employee. Seconded by Booe. Motion carried.

Seal Coat bids were reviewed by the Council. Two bids were received for this project. Coltharp Construction Company of Seymour bid \$23,124.39 and Lipham Construction Company of Aspermont bid \$20,231.60. Booe made the motion to award the bid to Lipham Construction Company. Seconded by Matthews. All in favor.

Garbage rates were discussed. The Council instructed the City Administrator to contact the Mayor and City Council of Goree to request a meeting to further discuss the present rate which they are charged.

Mayor Albus called for any comments on the Public Hearing. However, no public was in attendance for this hearing. The hearing was then

closed.

Motion by Booe to pay bills as follows: Airport, \$59.18; Ambulance, \$753.75; Swimming Pool, \$50.03 and Operating, \$23,899.10. Seconded by Matthews. All for.

Oustad made a motion to adjourn. Seconded by Tidwell. Motion carried.

The meeting adjourned.

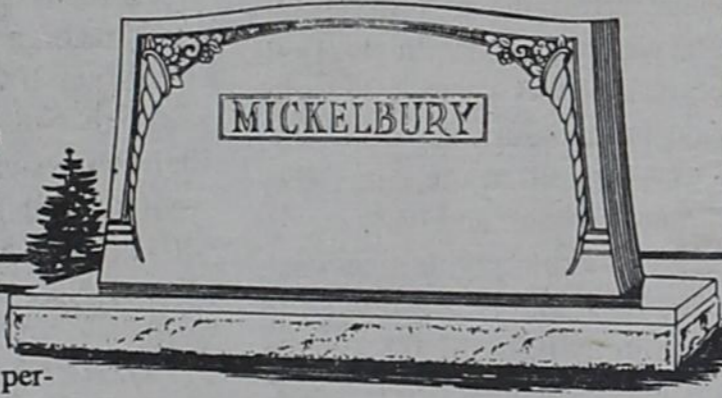

**Are You A Safe Canner?**

Eating home-canned foods should be a healthy, safe experience. If you follow the rules, it can be.

Safe canning involves a series of safety tips and checks. After all, food preservation is a science. Science is serious, but by not following the rules, you may be placing yourself, your family and your guests at serious risk.

As scientific knowledge about food safety continues to evolve, recommendations for home canning change; we know more today than ever before. Unfortunately, we have learned that some long-time canners are skeptical of new canning procedures. Why? Because they've been doing things their way since grandmother's time without a hitch!

The old methods could have been dangerous even generations ago, but no one made the connection between illness and food. We don't know the rate of illness in the early 1900's. Back then, they didn't have the diagnostic methods that we have now. People died and it could well have been from food poisoning.

Foods have changed, too. Growing conditions along with pesticide and herbicide usage affect the chemical balance in the produce. Science and the development of new types of corn and other vegetables and new varieties of fruits such as apples have been developed since grandmother's day and may make her recipes not as suitable as they once were. The chemical composition of the new varieties are different enough from the original varieties that old canning recipes simply don't always do the job safely.

How does this impact home canning? Well, one major recommendation is that all low acid foods must be processed in a pressure canner to eliminate the risk of botulism, a po-

tentially fatal bacterial toxin that can also cause muscular paralysis, vision problems and difficulty in breathing.

The lower the amount of acid a food contains, the higher its pH value. Low acid foods -- meats, seafood, poultry, dairy products and all vegetables except acidified tomatoes -- have pH values higher than 4.6. Acidity prevents the growth of botulism.

The spores of the botulism bacteria are very hard to destroy in boiling water; temperatures must be higher than 212° F. attainable only with pressure canners operated at 10 to 15 pounds pressure. At these temperatures, the time needed to destroy bacteria in low acid canned foods ranges from 20 minutes to one hour and 40 minutes. The exact time depends upon the type of food being canned, the way you've packed it into jars, and the jar size.

What this all boils down to is that home canning today requires recipes developed today. You must follow current processing methods because they have been scientifically developed for safety.

If you need any more convincing, consider this serious story: a faithful canner for 40 years was hospitalized near death after tasting a batch of her home-canned vegetables, the vegetables she had processed the same way for 40 years without incident. What happened? She had been incorrectly canning her vegetables for 40 years in a boiling water canner; it was mere luck that she had not poisoned hundreds of people with her previously home canned food.

IT CAN happen to you, especially if you say, "I've been doing it this way all my life, and I've never had a problem!" So, be a safe canner and follow current DA approved recommendations available through the County Extension Office.

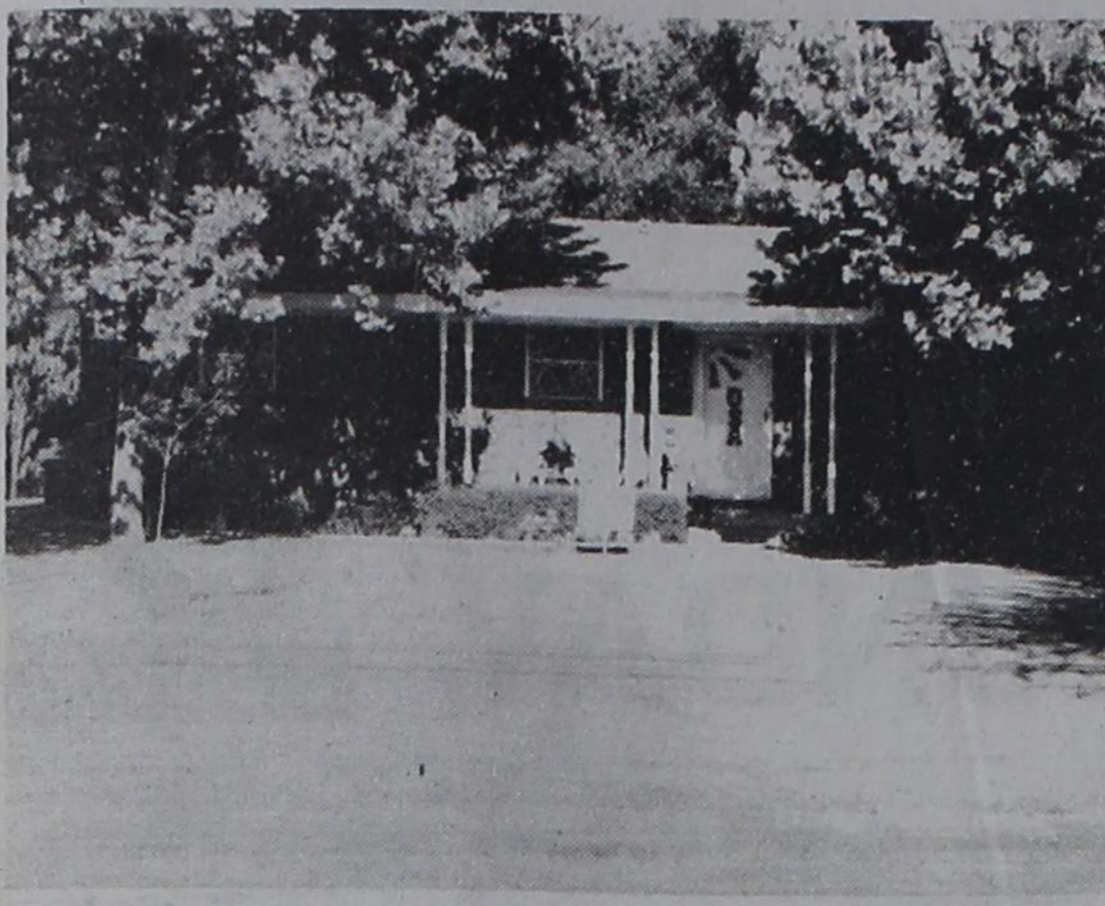

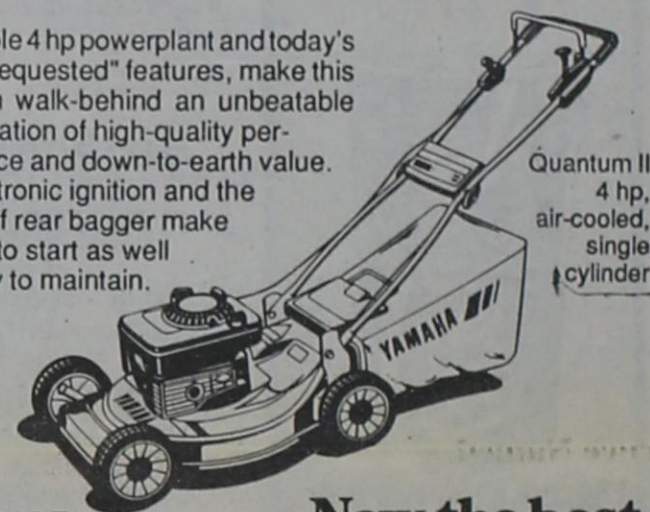

## Farm and Ranch Report

By Donnie Peters



### FALL GARDENING TIME IS HERE

Many gardens are now being harvested of vegetables and as the older plants are declining in yields, now might be a good time to expend the plants to your compost pile and begin your fall garden.

Oscar Mangis and I were talking about dates to begin planting fall gardens. I provided him with a fall planting guide from a gardening magazine. This guide is shown below.

#### FALL PLANTING GUIDE

(Items are listed in order of the name of the vegetable; seed per 25 feet; yield per 25 feet; and planting date.)

Beans, snap; 1/8 lb.; 5-7 lbs. (shelled); August 1. Beans, lima; 1/8

lb.; 5-7 lbs. (shelled); July 25. Beets; 1/4 oz.; 15-25; September 1. Carrots; 1/8 oz.; 150 carrots; Aug. 15. Chard, Swiss; 1/2 oz.; 12-20 lbs.; Aug. 15. Collards; 1/16 oz.; 25-37 lbs.; Aug. 15. Corn, sweet; 1-1 1/2 oz.; 25-50 ears; Aug. 10. Cucumber; 1/8 oz.; 35-40 cukes; Aug. 1.

Lettuce (leaf); 1/16 oz.; 12-25 lbs.; Sept. 15. Mustard; 1/16 oz.; 10-25 lbs.; Oct. 1. Peas, southern (black-eyed); 1/2 lb.; 25 lbs. (shelled); July 1. Potato; 1 1/2 to 2 1/2 lbs.; 38 lbs.; August 1.

Pumpkin; 1/8 oz.; 3-7 pumpkins; July 1. Radish; 1/4 oz.; 200-300; October 1. Spinach; 1/4 oz.; 12-25 lbs.; Sept. 1. Squash, summer; 1/4 oz.; 17-25 lbs.; Aug. 15. Squash, winter; 1/8 oz.; 25 lbs.; July 1. Tomato; 7-9 plants; 50-90 lbs.; June 15. Turnip; 1.8 oz.; 350; October 15.

Dates for planting are based upon average first frost thus it may still be possible to produce vegetables if the first frost is later than usual. The average first frost date for this area is November 15.

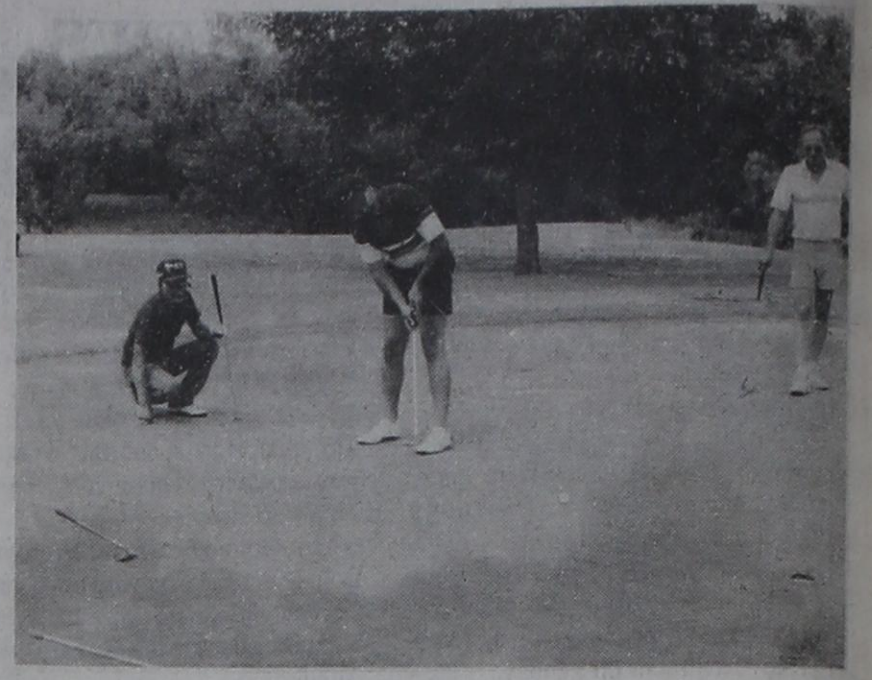

### DPS Reports Fewer Traffic Fatalities Than Expected

Fewer persons were killed in traffic accidents in Texas during the July Fourth holiday period than any time since at least 1970, according to preliminary figures released by the Texas Department of Public Safety.

"While we regret that we had seven fatalities in Texas during the 30-hour July Fourth holiday period, we were pleased to see that we fell short of our estimated that 12 persons would die on Texas' streets and highways during the holiday," said DPS Assistant Director Lt. Col. James Wilson.

The previous lowest July Fourth traffic death count was in 1973, when nine persons died during the 30-hour holiday period. Four others later died of injuries, pushing the final total to 13 deaths that year.

"Of the seven deaths reported this July Fourth," Wilson said, "three were in motorcycle accidents, two in auto-pedestrian accidents and two in vehicle accidents. In both the vehicle accidents, the victim had not been wearing a safety belt. The count might have been even lower if they had been buckled up."

All available Highway Patrol Troopers were on the roadways during the holiday period, which Wilson said may have been discouraged drunken driving and speeding, the two leading causes of traffic deaths.

"Texas motorists also deserve our thanks for helping make it a safer July Fourth," Wilson said.







## At Your Service

Q: I have a serious problem and no one else to turn to. My boyfriend has asked me to marry him. We're both over twenty and level-headed. The problem is with his mother. She never has a nice word for me and I'm sure that she thinks I'm not good enough for her son. What do you suggest?

A: The Bible gives a clear picture of how we are to treat others. Do everything you can to live peacefully with your future mother-in-law (see Romans 12:18). In fact, Romans 12:9-21 offers some good advice in dealing with her. Truly love this woman and show her honor (verses 9-10). Be patient in the tribulation she causes and be constant in your prayers for her and the situation (verse 12). Bless her as she persecutes you; be happy when she is happy and sad when she is sad; do not be conceited (verses 14-16). If she wrongs you, do not wrong her back. Instead, be good to her (verses 17-21).

Your future husband needs to understand his role prior to your marriage. He is to never take his mother's side against you. It will be his responsibility to protect and support you. This is wrapped up in the biblical principle of marriage: "For this reason a man shall leave his father and mother and be joined to his wife..." (Mark 10:7). This should come out in pre-marriage counseling, which I recommend for all couples considering marriage. If your

fiance is unwilling to support you in this way, then you should seriously consider postponing the wedding until the two of you can work out this problem. In my opinion, in-law troubles only intensify after marriage.

From the point of view of your fiance's mother, remember that she will be giving up her son to another woman. This is hard for some mothers to take because of the special relationship that mothers have for their sons. She probably would treat any prospective daughter-in-law the same way. Therefore, I doubt that she has singled you out as "not being good enough for her son"... because, for many mothers, no woman is good enough.

Your challenge is to learn to love your mother-in-law in the same way Ruth did in the Old Testament (read the book of Ruth). If your future husband is willing to support you, the odds are good that you will win his mother over with kindness. If not, and you follow these principles, then you are blameless.
