"It is good for a man that he bear the yoke in his youth." Thus did the Spirit of God move Jere-miah to write in his almost forgotten lament over the fall and captivity of Jerusalem. In similar vein, some 400 years before, the wisest of men (1 Kings, 3:12) summed up the scope of human experience with worlds which grate harshly on the suave twenieth century ear: "Sorrow is beter than laughter: for by the sadness of the countenance the heart is made better. The heart of the wise is in the house of mourning; but the heart of fools is in the house of mirth" (Eccles 7:3, 4). 


