Year's Program Is Announced by Farm Agency

An increase in appropriations for farm operating credit for the fiscal year that began July 1, was announced today by L. J. Capple-man, state director of the Farm-ers Home Administration, through Julian L. Wight Julian J. Wright, county super

The amount for operating loans Texas is \$6,940,000.00, a 20 per cent increase over last year's funds. "We expect to provide hese loans to 2500 more fam-lies this year than last," Mr Cappleman said.

The agency is also authorized to insure farm real estate loans made by private lenders. For direct farm ownership loans in the state it has \$100,000.00, which the same as last year.

Direct or insured farm purchase oans are available to qualified farmers, tenants, sharecroppers, and veterans who can find soundvalue farms, and who can't get the credit they need anywhere else. "Loans are made or insured only on farms that will pay out in terms of their long-range earn-ing capacity," Mr. Wright, coun-ty supervisor, said, "rather than at today's relatively high farm prices. In this way the DDT fog penetrate dark corners in the home. If the house is left com-pletely open the fog spray will pass through and may miss some dark spots where mosquitoes and flies are accustomed to gather.
