## More New Homes Featured This Week

For the third week, the News is printing short descriptions of new and re-modeled homes in Foard County. This week, the new homes of Mr. and Mrs. Jack Seale and Mr. and Mrs. Jim Cook are featured.

**Seale Home**  
Mr. and Mrs. Seale's new brick home is located on North Main Street. It contains 1,900 square feet of living space and has five rooms—two bedrooms, a living room, a dining room, kitchen, two bathrooms and a service porch.

The den and kitchen are paneled with sakar wood with a fruit wood finish. Louver shutters are in the den, dining room, kitchen, and louvered folding doors are used between the living room and den. Louvered swinging doors open from the hall into the kitchen.

The kitchen, matching vinyl floor and the cabinet oven and burners are built in. A new type kitchen faucet has only one lever controls both hot and cold water.

Corner windows in the bedrooms permit better furniture arrangement. Storage presents no problem in the Seale home, as the house has twenty conveniently located closets.

Light and toast colors are used in the interior decoration. Carreling is used throughout the house, except for the kitchen and the home has central heating and cooling.

Mr. and Mrs. Seale plan to add patio and car-purt in the future.

**Cook Home**  
Mr. and Mrs. Jim Cook, who own the brick home on North A Street, have built a new red brick home at 513 North Main.

The Cook home contains 1,400 square feet of floor space and has three bedrooms, living room, kitchen, two bedrooms, plus two bathrooms and a large double garage.

In the east wall of the spacious den is a built-in glass-door cabinet with drawer space for linens. Their kitchen is a combination steel and wood unit. Three windows over the cabinet unit provide plenty of light for the kitchen work area.

The home—which has central heating and cooling—is finished with four colors of red brick, which is set off by white mortar.

The front lawn at the Cook home is watered with an under-sprinkler system. Concrete steps go completely around the house, in addition to a concrete walk along the clothes line; plus concrete walk leading to the garage.

**Davis Re-Modeling**  
Mr. and Mrs. Byron Davis have had a re-modeling job at their residence at 509 E. Marietta. A partition between the living room and dining room has been removed, making a large combination living and dining area. Part of this area was made into a large closet, which opens from the hall. A mock place was also added in the living room, as was wall-to-wall carpeting.

A garage was added on the east side of the house for easy access to the car during inclement weather.

## Foard Countians Buy \$29,308 in Bonds During February

"Savings Bonds sales in Foard County totaled \$29,308 during February. Sales for the first two months of 1959 amounted to \$34,494 which was 28.5 per cent of the county's 1959 goal of \$121,000," George Self, chairman of Foard County's Savings Bonds Committee has announced.

The total sales in Texas during January and February of this year were \$31,100,328 which represented 17 per cent of the state's 1959 goal of \$182.5 million.

The importance of the Savings Bonds program to our nation's economic and military well-being was emphasized over and over again by the speakers. # PROGRAM BUILDING COMMITTEE MEETS

The Foard County Program Building Committee met last Thursday afternoon in the Down Town Bible Class room. Twenty-five members and visitors were present at which time the group evaluated their past work and made plans for the future program.

W. A. Dunn, chairman, presided, and committee reports were given on work done so far in 1959. The group discussed ways of completing the 1959 program of work.

Committee reports, as announced by the Foard County Agents, Mrs. Mary D. Brown and Joe Burkett, were given as follows:

**Community Improvement**  
Mrs. Virgil Johnson, chairman  
Problems selected by sub-committee to be worked on in 1959: 1. More farm and home identification. 2. Community recreation. 3. Upkeep of cemeteries.

What has been accomplished to date by committee: 1. Junior leaders are working on plan to get more farms and homes in county with identification. 2. Five 4-H parties which included all children of 4-H age in county. 3. Three Home Demonstration Clubs keep up cemeteries in county.

**Farm and Home Development**  
J. F. Matthews, chairman

Problems: 1. Johnson grass control. 2. Temporary and seasonal pastures. 3. Orchards. 4. Identification and control of beneficial and harmful insects. 5. Home improvement.

Accomplished: 1. One Johnson grass control demonstration using talapan. 2. Three families are using seasonal and temporary pastures. 3. One family has planted and is maintaining an orchard. 4. Agents helped two families with insect identification and control. 5. Worked with two farm and home development families on home improvement.

**4-H Clubs**  
Mrs. Grover Moore, chairman

Objectives: 1. Give girls more opportunity to display their work. 2. Work towards a 4-H building. 3. Encourage at least 30 per cent of all boys and girls to start and keep 4H records. 4. Train and use more recreation leaders. 5. To educate more people to the goals, programs, and value of 4H club work. 6. Use more adult and junior leaders and give them more responsibility. 7. Have more sponsorship of all 4H activities.

Accomplishments: 1. Since the Down Town Bible Class room was moved, we were unable to enlarge the girls' part of the 4H and FFA Project Show. However, we did have 61 girls who entered a total of 83 projects. We have 119 girls enrolled, so this is 50 per cent participation.

2. 4H Program Building Committee members met and examined building that F. Laine Farm Equipment moved to town. This was considered to be too high. 3. All Junior Leaders 4H Club members have been asked to start a 4-H record and help 1 other younger member on a 4H record. 4. So far we have held 5 parties where Junior Leaders planned and conducted the games, etc. Also Foard County leaders led recreation at district Council meeting.

5. During National 4H Club week, 4H members set up 12 posters and 13 merchants used 4H mats in papers. 4H Clubs also subscribed to National 4H Club news for each club president and club leader.

6. Adult and junior leaders are being used for all 4H activities. 7. We still need more sponsors for 4H Girls Bake Show and sponsors for the Bedroom Improvement contest this summer. However, more people than ever before turned out for the food sale this year and we cleared \$151.42. 8. So far, agents and 4H members have written over 35 news articles on 4H work.

**Health and Safety**  
R. H. McCoy, chairman

Objectives: 1. To have more people safety conscious. 2. Reduce the number of accidents. 3. Control rodents. 4. Put up posters and exhibits in observance of National Farm Safety Week. 5. Check 10 per cent of farm home water supplies to see if it is safe for human consumption.

Accomplished: 1. Agents and Junior Leaders have given 15 demonstrations on safety. 4H Junior Leaders also have a safety demonstration planned for 4H con-

tests. 2. Seven meetings were conducted on rodent control for 157 people. Agents wrote 3 news articles. 3. We plan to observe National Farm Safety Week in July. 4. Junior Leaders plan to check farm water supplies in April. 5. Agent showed 1 film on cancer to 1 civic club.

**Foods and Nutrition**

Objectives: 1. Have well balanced meals which do not take much time or advance preparation. 2. Provide help to all women in newest and fastest methods of food preservation. 3. Help women to realize they can save time and money by planning well balanced menus in advance. 4. Help more girls and adults to realize the importance of milk in the diet and encourage more people to use dried milk. 5. Encourage all girls to eat breakfast. 6. Help 4H girls to improve their after school snacks. 7. Have better foods demonstrations.

Accomplished: 1. Agent trained leaders who gave demonstrations on well balanced, easy to prepare oven meals to 7 clubs. 2. Other demonstrations and workshops are scheduled for later in year.

**Clothing**

Objectives: 1. Train women how to alter and fit commercial patterns. 2. Teach new ideas in basic construction. 3. Give consumer information on buying ready made clothes to general public. 4. Give help to younger members in carrying out clothing demonstrations. 5. Give help on wardrobe planning.

Objectives: 1. Agent held two workshops on basic construction. 30 women attended. 2. 4H Clubs are carrying clothing program. 3. Other work is scheduled for later in year.

**Home Demonstration Committee**

Objectives: 1. Each club get 2 young members. 2. Have well trained club officers and committee chairmen. 3. All club leaders should give better demonstrations. 4. To educate people to the goals, programs and value of HD Club work.

## STATE CAPITAL Highlights AND Sidelights by Vern Sanford

Austin, Tex.—"After seeing the appropriation bill—and with all the sentiment there is in favor of a teacher pay raise—I don't see how we can pay for it all without passing one of those big tax bills."

Speaking in private conversation was a legislator. He is one of an estimated 80 to 90 House members who told voters flatly last summer they wouldn't vote for a general sales tax.

But the "big tax bills" to which he refers are the Strickland-Roberts bill, Blanchard bill, Oliver bill, etc. All of these are, as someone said, "mighty like a sales tax," in that they would be collected on the basis of the sales of large numbers of items.

His predicament is shared by many Texas lawmakers this year. It is: how to finance the things the people of Texas want without voting a tax the people don't want.

**BIGGEST EVER**—House Appropriations Committee is recommending a 1960-61 spending bill that is the granddaddy of 'em all. Altogether, spending from all sources, including federal grants, would total \$2,401,276,388. It is \$240,000,000 higher than the 1959-60 budget.

Even so, it is \$7,500,000 less than recommended by Gov. Price Daniel. Committee's bill calls for general revenue spending of \$322,461,196; the governor's for \$322,462,992.

Financing the committee's recommendations will require about \$157,000,000 in new tax money for the general fund. This results from adding together (1) the expected \$65,000,000 deficit from 1958-59, (2) the \$42,000,000 increase in spending for the coming biennium over this one and (3) an expected \$300,000,000 gap between expected revenue and present spending levels.

**News From the Congress**

Congress will be in its annual Easter recess during this week. When it reconvenes, there will be much more legislative activity because of the fact that many of the committees reported bills just before the recess.

The Berlin crisis has brought into focus the controversy over the size of the military forces. It is speculated that General Maxwell Taylor, Chief of Staff of the Army, is retiring largely on account of his views on the strength of the Army. The difference of opinion can be brought into focus by noting the differences in proposals of the Administration and some of the top military men. The Army, for instance, now has 891,000 men which number is due to be reduced to around 870,000 by the middle of

the year with reserve forces to be 630,000. The Army spokesmen say that they need 925,000 with reserves of 700,000. The Army also wants money for an anti-missile missile, extra money to modernize its weapons, and for a minimum of fifteen divisions. This controversy is, of course, yet to be resolved, and all of the evidence is not in, but it would seem that with the Berlin crisis being what it is, this is no time to scale down our forces. Historically, one of the most costly mistakes we have made has been to reduce our armed services during times of relative peace and then have to rebuild them in a crash program when a crisis occurs. It is hoped that we will not make this mistake again.

Workmen engaged in re-working the east front of the Capitol have been excavating looking for the building's original cornerstone. Recently they unearthed a pile of bones that caused great excitement; however, a careful examination of these remains proved them to be only what was left of

**Forgot Something? Revenue Service Asks Quarter Million Texans**

Forgot anything? That is the question Internal Revenue Service is asking of a quarter of a million North Texans. These 250,000 taxpayers are due a refund on their 1958 taxes but have not filed their tax return. The Internal Revenue Service is anxious to start processing these refund returns.

Incidentally, there are 350,000 other North Texans who have not filed their tax return. These taxpayers owe money, Internal Revenue says, and now is a much better time to file than on April 16 when a penalty is due.

The tax folks sum up their advice to the 600,000 who haven't filed their 1958 tax returns with the following: "File Now."

**Responsibilities on Local Citizens Is Key to Success of American Schools**

Charles B. Shuman, president of the American Farm Bureau Federation writes: "The success of our public school system is largely due to the responsibility placed upon local citizens and the school boards they elect. Any plan which further reduces their authority and responsibility will inevitably result in weakening our schools. Yes, there are many needed improvements in our educational system. We need a broadened base of support to relieve tax inequities. We need to return to a merit system for teacher advancement so that salaries will become more adequate, for the best qualified instructors. We need to place greater emphasis on fundamentals and be less concerned with educational 'frills.' These needs will be met more certainly by local people than by a vast federal bureaucracy."

**Early Diagnosis Is Vital Treatment of Cancer**

More than 800,000 Americans have been cured of cancer since the American Cancer Society began its program in 1913. Another 900,000 who have gone through treatment are in a five-year observation period at the end of which they will be judged as cured if their symptoms do not reappear. Where the cure rate was 10 cancer cases in 1913, it is now one in three. Early diagnosis is vital.

"Fertilizers and Their Use" Is Title of New Agricultural Bulletin

"Fertilizers and Their Use" is the title of a bulletin released by the Texas Agricultural Extension Service. William F. Bennett, extension soil chemist and author of the bulletin, points out that plants are much like human beings. They need air to breathe, water to drink and nutrients to help them grow and reproduce. If any one of these is not available, the plants wither and die.

Why should we be concerned about diseases in animals? What relationship does animal disease hold to humans? Often people wonder what veterinary medicine has to do with public health. The answer is, it has much to do with it.

What about brucellosis? This is the number one problem in some countries. It can cause dire economic consequences because of its effects on goats, hogs and cattle. In humans it is called undulant fever.

At the same meeting mentioned above, it was brought out that so-called shipping fever, a bane to cattle buyers and shippers, has its parallel in the illnesses suffered by students going off to school for the first time or recruits entering the army or navy.

The probable cause for such illnesses is the exposure to new infectious agents the individual has not been exposed to previously. Therefore, he has not built up an immunity and falls prey to the strange infection.

It is known that many diseases of animals have their counterparts in humans. Ringworm, rapidly spread among children, is shared by animals. It is not unusual for Fido to pick up the ringworm parasite during his wanderings.

Little Johnny or Suzie romps and plays with Fido and the next thing we know, they have contracted the unsightly and embarrassing disease. These minor illnesses we can live with. We can cope with most of them. But a constant vigil by public health authorities is necessary.

"Seward's Ice Box" Stocked with More Goodies Than Snowballs and Polar Bears

Alaska, once ridiculed as "Seward's Ice Box," has turned out to be stocked with more goodies than snowballs and polar bears. When Secretary of State William Seward bought Alaska from Russia for \$7,200,000 in 1867, many American taxpayers and senators denounced it as an icy wasteland. But the new state has paid back its cost hundreds of times in the value of its resources.

The 1959 Annual Supplement of The World Book Encyclopedia says Alaska's annual production now amounts to approximately 160 million dollars—more than 21 times the purchase price of the territory.

The waters off Alaska's shores are the world's richest in salmon and halibut. Forests cover 375,000 square miles—an area twice as large as the four Scandinavian countries. Oil was discovered in commercial quantities in 1957.

Only two per cent of Alaska's 586,400 square miles has been surveyed. But 31 of the 33 strategic minerals needed by the U. S. already have been found there.

With Clinton Davidson

The new military draft law passed recently by Congress makes an additional 5,000,000 young men subject to induction into the armed forces within the next four years.

That is the number which Selective Service estimates will become 18½ years of age, and thus subject to the draft, between next July 1 and mid-1963, the next date on which the draft law is due to expire.

We asked Selective Service who and how many it expects to call for military duty and how they will be chosen. Here are some of their answers.

Draft calls so far this year are running at around 8,000 a month. Barring world-wide disarmament or a big shooting war, neither of which is expected, that rate will probably continue. The rate is at about 100,000 a year.

Only about one out of every twelve young men who become of draft age actually will be called. Selective Services' figures indicate. How, we asked, will those to be called be selected.

Only those in excellent physical condition and above average mentally will be chosen. The tests on both physical and mental conditions will be more strict than in the past, we are told.

In the past only about 2 out of every 10 called have been rejected, but, Selective Service says the rejection rate will be about 3 out of every 10 under the new law.

The President, it was explained, has broad powers to change the number as well as the physical

and mental standards of those to be called. Selective Service officials, however, know of no plans for changes.

The law fixes the age for draft at between 18½ and 25 years, but for those who have been deferred the law makes them subject to draft up to the age of 35. As a matter of practice, most of the draft calls are for the 22 and 23 year olds.

Deferments. The law does not provide for deferments to permit the youths to continue through high school and college, but Selective Service officials say that unless there is a national emergency the present practice on deferments will be continued.

The present practice, which could, however, be changed by a presidential order, is to defer fathers and expectant fathers, providing they keep their draft board informed of their status.

The law also provides another way to avoid active duty in the military forces. A young man can sign up with one of the military reserve units, including the National Guard, for six months active duty training.

After that he must attend weekly drills and a two weeks annual training period. This would continue for several years, in most cases until he reaches the age of 35 and thus become exempt from the draft.
