

SUPREME COURT UPHOLDS FARM BUREAU CONTRACT

Rules That It is Not Unilateral But Is Mutual and Is Constitutional

The Supreme Court of Texas, by fusing to grant a writ of error on Docember 14 by the Galveston Court tract as used by the Cotton Associa tion and the other commodity mar keting associations of the Texas Farm Bureau Federation.

The Supreme Court's decision goe much farther than to sustain the lower court's opinion that the contract is mutual. The Supreme C in effect, has decided that the Operative Marketing Law is constitutional; also that the Farm Bureau cooperative marketing associations are that co-operative merchandizing as carried on by the Farm Bureau Associations is strictly in line with

the public policy of the State. The history of the hay case may be reviewed briefly as follows: The Texas Hay Association, a Farm Bureau co-operative marketing organition, brought action in the District Court of Brazoria county against one of its members who was alleged to have sold his hay outside the association. The Association won it case The member than appealed to the Galveston Court of Civil Appeals on the grounds that the contract is unilateral. The higher court decided in favor of the association. Then the member carried the case to the Supreme Court, asking it to grant a 1500, writ of error in the decision of the 1200, appellate court. The Supreme Court refused to grant this writ of error. 800. This action means that the highest 600 court in Texas has sustained the Gal-\$1800 veston Court of Civil Appeals. 

License Fees Raised

The new licen a le hicles passed by the Texas Legislature will become effective January 1, 1924, and will be somewhat heavier than heretofore. They are based principally on the weight of the cars rather than on the horsepower of the motors. There will be an annual feel of 171/2 cents per horsepower, that is on passenger motor vehicles, and a minimum charge of \$4.00. But on a vehicle of 2,000 pounds or less there will be a fee of 40 cents per 100. from' 2,000 to 3,500, 50 cents per 100; 3,500 to 4,500 pounds 60 cents per 100, and all above 4,500 will pay 75 cents per 100 pounds.

The fees on trucks runs from 3. cents up to \$4.00 per 100. There ar no trucks in this country that would have to pay the maximum. The average will likely be 30 or 40 cents, with the same charge of 171/2 cents per horsepower as in the case of the pasenger vihicles

According to the State Highway Department's explanation of the dis position to be made of these funds, the 17½ cents is to be kept in the county depository and placed to the credit of the road and bridge fund of the county, and therefore is to be used by the commissioners as such at their discretion. The balance of the fees are to be sent to the State Highway Department at Austin. The State Highway Department is authorized to take over and maintain the veries highways designated as "State highways" in the several counties, and this fee as above designated is to be thus applied. Counties are free from the burden of maintaining "State highways" and can apply the 171/2 cents on any of the county roads. THE FOARD COUNTY NEWS

Asks to Transfer \$3,000,000 at Once

Austin, Texas, March 17 .- It was the demand of Prof. S. M. N. Marrs, State Superintendent of Public Instruction, to immediately transfer the \$3,000,000 supplemental appropriation to the available school fund caused the question to be raised as to the priority of claims on the general revenue fund and which now is being considered by Assistant Attor ney General L. C. Sutton, at the in stance of the State Treasurer.

Before making such a large trans fer at a time when the general fund s on its way to return to a deficiency basis, the State Treasurer wanted le gal advice. He wanted to be sure of his official acts when a huge sum of money was involved.

Up until this time, only \$4 per apita has been paid out of the \$10 er capita apportionment of last August and Professor Marrs was anxious that the \$3,000,000 be sent out immediately, which would mean \$3 per capita more in paying the salaries of the school teachers.

"Some of the schools have already losed and more are destined to close next month." said Professor Marrs, unless we can get these funds to hem in order that the teachers can transferred at once and become availfor instant distribution. It and that is what I am endeavoring to do now."

California Eggs 34c While Texas For Are 20c

Is there any reason California should be selling now at 4 cents while Texas eggs are bringing not more than 20 cents, and on the local market not over 15 cents? There is a cause for this difference in the price of eggs, and here it is, as is pointed out by J. H. Barber, general manager of the Pacific Egg Producers, who addressed the poultry men and women at Dallas on March 7, according to the Farm Bureau News. Mr. Barber stated that the success of the egg production on the Pacific coast was due to several things, among them being that eggs must be fresh, they must be infertile, they must be graded according to color, size, weight and cleanliness they must be carefully packed, must be shipped in large quantities and




