Francis Era Wolford

Francis Era Wolford died Monday March 27, at the age of 19 years, 8 months and 4 days. The funeral services were held at the Christian Church Tuesday afternoon at 4 o'clock conducted by Rev. S. J. Holmes of Vernon, after which she was laid to rest in the Crowell Cemetery.

She was taken down with typhoid fever about six months ago in the city of Dallas but after some time was strong enough to be moved to Crowell in hopes that the change would be for the better and her former health restored. But not so, the fever settled on her lungs and she gradually grew worse until death claimed her.

Miss Frankie, as she was generally called, was a good christian girl and bore her long suffering with much patience. She leaves a mother, two sisters and three brothers, and other relatives and many friends to mourn her death.

The bereaved ones have the deepest sympathy of the people of Crowell.

Investigation of Orient

Austin, Texas, March 25.—The report of W. E. Fitzgerald, auditor of the Railroad Commission, which was filed today after Mr. Fitzgerald had visited Sweetwater, the headquarters of the Kansas City, Mexico and Orient Railroad Company in Texas,

shows a condition prevailing which will be investigated by the commission and possibly result in a suit for forfeiture of charter, or at least a demand that the company comply with the law requiring that railroads operating in Texas shall maintain general offices in the State and direct the operation of the property by officials who shall actually reside in Texas.

Auditor Fitzgerald has attached to his report numerous copies of letters, orders and other documents on file at Sweetwater, which indicate conclusively, according to Railroad Commissioner Williams that the principal affairs of the road are really directed by executive officials whose headquarters are at Kansas City, Mo.

According to Commissioner Williams, the only serious discovery made by Auditor Fitzgerald is that which he says shows about \$800,000 of stock unpaid, heretofore represented as paid up.

The report has not as yet been given consideration by the commission as a whole, but doubtless will be taken up during the ensuing week.

District Court Changed

Permit me to say through your paper that a bill was passed by the legislature changing the dates of holding District court in your county, but which bill had not received the Governor's approval when the legislature adjourned, and has not yet so far as I have learned, but it being a local bill will be approved, undoubtedly, and having passed with the emergency clause and the necessary two-thirds in each House, will become a law as soon as it receives the Governor's approval.

The dates remain the same in Wilbarger and Hardeman as they have heretofore been, but in the other counties are fixed by the new law as follows:

In the county of Foard on the eighth Mondays after the first Mondays in February and September. (April 3, and Oct. 30, 1911.)

In the county of Collingsworth on the tenth Mondays after the first Mondays in February and September. (17th of April and 13th of November, 1911.)

In the county of Childress on the twelfth Mondays after the first Mondays in February and September. (1st day of May and 27th day of November, 1911.)

In the county of Hall on the seventeenth Mondays after the first Mondays in February and September. (5th day of June, 1911, and 1st day of January, 1912.)

The length of terms in each county is the same as under the present law. One week intervenes between the end of Childress terms and the beginning of Hall terms so as to accommodate Christmas week, but there is no court anywhere that week.

I shall notify all papers when the bill has been approved.

Progress on Orient

San Angelo, Tex., March 25.—Roach & Stansell of this city have been awarded the contract for grading twenty miles of the Kansas City, Mexico and Orient Railroad right of way between Mertzon and Fort Stocton on the main line. The grade is completed fifty miles west of Mertzon and twenty-five miles north of Fort Stocton, leaving a gap of fifty-six miles to be put in shape for the track. Material for the continuation of the line west of Mertzon, to which track has just been laid, is en route. The Orient expects to reach Fort Stocton within twelve months. Grading is now in progress between Eldorado and Sonora on the Del Rio or southern extension of the Orient. The grade to Eldorado, forty-five miles south of here, is finished and track laying on this extension of the line begins soon.



In San Antonio labor union is an issue in the city election. Candidates have to pledge themselves to support the unions and favor the union label in order to get the vote of the union men.

A Harvard professor has figured out that a man of 155 pounds weight can live on 10 cents a day. Still people go right on eating three times that amount and pay no attention to this professor's figures.

If you are in favor of state-wide prohibition you should line up for the fight. The antis are doing everything in their power to defeat the movement and it is very necessary that the pros be active in this campaign.

There is not much difference between the man who does not farm and who at the same time tells how it ought to be done and the man who knows nothing of the printer's trade and tells how the paper ought to be run.

It is no exaggeration to say that the wheat crop in Foard county is more promising than

it has been in many years. No more beautiful spectacle can be found than a three-hundred acre wheat field, like scores that surround our little city.

Farming is becoming a science in Texas. It is being conducted on a business basis for the purpose of making money, not purely for scratching from the soil a bare existence. As a result the percentage of agricultural failures are becoming less and the proportion of success is taking rank with other lines of industry.

Paducah has had another big fire, this time costing the city about \$30,000. If our neighboring town happens to such luck many more times she may decide after a while that it is cheaper to put up a system of water works at any cost. Paducah has already lost enough in big fires to have put down two or three deep wells.

The Federal Bureau of Statistics has announced its report on the average wages paid farm hands in the various states. The average price paid farm laborers is \$18 per month with board and \$24.50 per month without board. This shows an increase of \$5 per month during the past ten years and indicates that the farm laborer is getting a share of the increased price of farm products.

The cry of "Back to the Soil" has not been in vain. Its echo reverberates against sky scrapers; it startles the banker, the merchant, the clerk and the laborer; it is permeating the very core of our municipal life, inviting the buffeted and careworn to the bosom of nature. Rural possibilities have awakened in our citizenship new hope and inspiration and the farm is taking back some of its very best and that too, after they have been

refined and finished in business experience.

A bill has been introduced in the Illinois Legislature which provides for a prize of \$100 for every baby born in the state; \$200 for twins and \$300 for triplets. The State of Illinois pays a heavy tribute in population to Texas through immigration every year and the method employed by the statesman of the Sucker state in offsetting the work of the foreign immigration agent, by encouraging the work of the stork is to be commended. If this bill passes, Illinois will be the first state in the Union to put a premium on baby raising, the practically every state in the Union offers prizes for every other line of industry.


