Your guide to proposed amendments

Texas voters in November's general election are going to have 16 decisions to make on proposed amendments to the state's antiquated constitution

On pages 10, 14 and 15 of today's Dispatch. readers may read the public notices on each of the constitutional amendments. They will appear in The Dispatch for each weekly issue for the next four weeks, as required by law, to acquaint voters with the amendments.

Of the 16, several are important.

Certain to be one of the most "interesting" as far as the pros and cons are concerned is the No. 1 amondment.

It provides that all land owned by natural rsons and designated for agricultural use shall be assessed for all tax purposes on the consideration of only those factors relative to such agricultural use

In other words, it would do away with present state law requirement that all land be valued for taxation purposes upon more or less its fair market value.

Farm land these days across the county sells. for far more than it is worth on the basis of what it can earn via crops or livestock. That is because there is a shrinking amount of such land in the United States. Expansion of cities and the development of highways each year cut thousands of more acres from the farm and ranch land total. So it has become a commodity valued on the market at a price of more than it can earn.

Farmers have argued that their tax valuations should be based upon the earning capacity of their land. Actually, tax engineers do take this into consideration along with market value, the only true measure of worth in the eyes of the law.

Farmers are going to vote heavily come November for Amendment No. 1. It will mean lower valuations generally for them if the amendment passes. The unanswered political question in: Will city voters, now in the majority in Texan, vote so strongly against it as to defeat it.

Another amendment of certain interest here -as in all county seats-is Amendment No. 5 which would authorize the legislature to provide for a system of retirement, disability and death benefits for county officials and employes and others.

Veteran employes of hundreds of Texas courthouses fervently hope the voters will like this one. They, like most workers on the national scene, are "security conscious." They want to look forward to an orderly retirement financially when the day does come

Another one which has some organized support-this time from the "law arm"-is the No. 6 providing for payment of assistance to survivors. of law enforcement officers, custodial personnel of the Texas Department of Correction and fullpaid firemen. The families of our law officers today have no protection when a criminal shoots down their breadwinner. Certainly this one has merit.

Certainly, amendment No. 14 should win hands down in November. It would allow members of the armed forces to vote in Texas upon satisfying the residence requirements applicable to Texans in general. This has been a wrong which has needed "righting" for a long, long time. It is ridiculous to think that a young Texan of voting ge can't vote for the candidate of his choice in Texas simply because he is in Viet Nam risking his life in the service of his country.

We would hazard a guess that Amendment No. 7 on the upcoming November ballot already has been outdated by the U.S. Supreme Court. But maybe it is needed to get Texas "up with the times." It would repeal the constitutional provisions requiring a poll tax as a prerequisite to voting and requiring the legislature to provide for annual registration of all voters.

In the weeks ahead, responsible state groups will circulate to newspapers the pro and con argaments for all of these amendments. They will assist voters in evaluating them and helping them make up their minds about them

As space and time permits, The Dispatch will use such stories in its news columns, at least for all the important amendments.

But we would urge our readers to take the opportunity during the next four weeks to stop and read these public notices on the 16 amendments. They are published in every county in Texas at considerable expense for your information. Along with the rights of people to vote goes the obligation of being responsible-and that means being informed -JC

You never mistake the meaning of a Church spire.


