# Indigent Assistance Policy Adopted by Garza County Commissioners

Indigent care assistance was on the agenda as Garza County Commissioners' Court met in regular session Monday, September 25.

The court reviewed and adopted a manual of services, drafted by Kay E. Mares of Lubbock and based on similar guidelines used by Terry County, for indigent assistance through the Garza County General Assistance Program eventually reimburse these funds (G.C.G.A.P.)

The manual outlines the county's policy on emergency aid and lists the general eligibility requirements for assistance with rent, utilities and food for residents of the county who are unable to support themselves.

Applications for assistance will be presented to the secretary of the County Judge and the applicant will be informed at that time, in writing, of the date, time and place of a hearing on the application.

In conjunction with the Garza County General Assistance Program, an Appeal Committee was appointed with the following members: Preston Poole, chairman, Judge E.A. Howard, Jr., John Valdez, Lewis Earl and Lonnie

Eight bids ranging from \$500 monthly to \$13,400 yearly for courthouse janitorial service were opened Monday morning and, after a discussion of the bids received and services offered, the commissioners agreed that County Judge E.A. # **Emergency Medical Service Provides** County Residents Top Quality Help

medical services respond to more than a million calls for help, in crises ranging from multiple-casualty incidents to the more common cases of cardiac arrest, motor vehicle accident, near drowning or fractured leg.

Specially trained emergency medical services personnel are able to respond at a moment's notice. Their skills routinely make the difference between life and death.

The Post EMS Association was founded in 1978 for the purpose of providing top quality emergency assistance to the people of Garza

Over the past 11 years, the Post Emergency Medical Service has grown and present staff members include Janie Ammons, Ronny Burtch, Jackie Gonzales, Pam Hair, Lynn Herridge, Marie Odom, LaVena Palmer, Betty Posey, Jane Redman, John Redman, Debbie Reiter, Eva Troxtell, Becky Warren and Melody Yarbro.

These Emergency Medical Technicians spend a minimum of 120 hours in class, learning how to assess and stabilize a patient's condition before transporting him to an emergency room. Also, each must complete 20 hours of clinical observation and three emergency ambulance runs before being certified as an EMT. Paramedics perform invasive emergency medical procedures such as cardiac defibrillation, airway intubation and intravenous drug administration. They must complete a minimum of an additional 400 hours of training beyond the EMT requirements.

More than 40,000 people in Texas are certified by the Texas Department of Health as Emergency Care Attendants, EMTs and Paramedics. Twelve hundred groups around the state now provide pre-hospital emergency medical care in their communities.

"EMS has come a long way since we started out," said Gene Weatherall, chief of TDH's Bureau of Emergency Management. "The old ambulance law of 1943 required EMS workers to have only an eight hour Red Cross certificate, a first aid kit and a backboard. But since the '70s, people throughout the state have volunteered for training and certification at much higher


complishments as a model program, not only for the state, but nationally.

# City Council Approves New Budget, Tax Rate

In a public hearing at 12 noon, Monday, September 25, Post City Council members approved the 1989-1990 budget and an effective tax rate of .3189 per \$100 valuation, an increase of three percent after adjustment for decreased valuation.

A summary of the 1989-1990 City of Post budget lists General Fund: revenue, \$924,631 and expense, \$941,819, a net of -\$17.188; Water and Sewer: revenue, \$325,501 and expense, \$308,313, a net of \$17.188. Total revenue, \$1,250,132 and total expense, \$1,250,132.




