

# Cotton Unlimited unveils new industrial plant in Post

"We are going to wrap the world in West Texas cotton," Joe B. Pate, Jr., warehouseman and cotton farmer, said Friday at the grand opening of the new Cotton Unlimited, Inc., manufacturing plant in Post, Texas.

Working with Paul Muncrief, a Post inventor, Pate and other investors have spent the past few months retrofitting a former textile mill to manufacture an insulation product made principally from cotton fibers. Research and development of the product and organization of the start-up company have been in progress for more than four years.

The aims of the project are to capture a share of the United States' \$20 billion-a-year insulation market and to create a new market for Texas cotton.

The insulation product, manufactured on a combination of conventional textile equipment and a new type of bonding oven developed by Muncrief, will have similar insulation properties to fiberglass but will require far less energy to manufacture.

Unlike fiberglass, Cotton Unlimited's insulation, made from a blend of 80 percent cotton fibers and 20 percent polyester, will not require that installers wear respirators or protective clothing. This will help to reduce costs to contractors who use the cotton insulation instead of fiberglass.

Cotton Unlimited's basic product, a non-woven textile blanket of insulating material, will be fire retarded and can be adapted for use as insulation in homes, commercial structures, automobiles, airplanes and appliances.

"Cotton is a natural, renewable resource material and is better for the environment. We hope this new product will make us an industry leader in the effort to protect the environment," Pate said.

The Cotton Unlimited manufacturing plant is housed in a former textile mill that closed several years ago. The equipment is laid out according to the latest modular manufacturing techniques, with a single production line that can be expanded to as many as six production lines or "modules," as product demand increases.

"Our plant can consume 12,000 bales of cotton a year with the present line of equipment. If we gain a significant share of the insulation market, we could consume as much as 500,000 bales a year by the turn of the century," said W.D. Martin, company spokesman.

The West Texas start-up firm received technical and marketing

assistance from a variety of public and private sources, including Eastman Kodak of Kingsport, Tennessee, the manufacturer of the polyester that is blended with the cotton fibers to produce the insulation product.

The Texas Tech University Textile Research Center assisted the project with product development research, and the Texas Department of

## Auditors declare healthy financial status for Post ISD

Post ISD taxpayers can be assured that the school district is on sound financial standing, following a detailed report by independent auditors Robison, Green and Company of Lubbock at the regular board of trustees meeting Tuesday, October 9.

"I don't know of any school anywhere," auditor Ken Robison emphasized, "which allocates funding directly to the athletic department completely separate, so you know exactly what it costs to maintain the program."

"Other schools apparently would prefer not to know the exact costs for these programs," he added. "We like it, and we want to keep it that way," Post ISD trustee Gary Workman replied.

Robison, who spent more than an hour explaining the audit report, answered a number of questions from trustees as superintendent Bill Shiver reminded the board members of their fiscal responsibilities and the importance of understanding where the money is spent.

Robison pointed out that Shiver's management style is ideal for keeping track of expenses and controlling how funds are spent. "The checks and balances that we see in this system are more than adequate to catch problems before they get out of control," Robison added.

## City Council increases water, sewer deposit rates

Citing a continuing problem with collecting on vacated rental properties, Post city manager Bob Turner recommended at the October 8 city council meeting an increase in the water and sewer deposit for residential customers to \$50 to cover the estimated three months of the average delinquent accounts.

The council agreed to the change and is preparing a revision of the city ordinance to allow for rate adjustments as needed.

Turner reminded the council that Thursday, October 19 the West Texas district of the American Institute of Planning will hold its banquet here to award Post a special recognition for the Main Street landscaping project as the Best of the District.

An estimate of \$34,000 has been submitted to the Post Main Street committee for the expansion of the landscaping project to the two blocks of West Main Street from Broadway to the Courthouse. The project will be funded entirely through private contributions and "in-kind" city services.

The council discussed the various alternatives for workmen's compensation, which currently includes coverage for the Post Volunteer Fire Department. Turner was authorized to maintain the coverage with The Norman Agency and to establish a trust fund to assist in injuries beyond the current coverage.

Overnight parking of the flat bed truck for residential users will be limited to two consecutive evenings at any one address, following a discussion of occasional abuse of the service.

Turner informed the council that "rumblings from Washington" indicate that perhaps the city will be allowed to maintain a landfill, "but then, we won't know until the regulations are issued," he added.

The council and city manager agreed that repairs to the ball park lights would have to be made before the baseball season starts and Turner explained costs involved in the project.

Attending the meeting were Mayor Pro Tem Larry Mills, council members Jim Schooler, Dan Lamb, Larry Waldrup, Irene Fry, city manager Turner, city secretary Wanda Wilkerson and city attorney Harvey Morton.

## Sheriff's Department assists in returning child to custodial parent

Following an order from the 106th District Court, Garza County Sheriff's department officers removed a three year old child from control of her father, and returned the child to the custody of the mother, Cheryl Hill of Arkansas.

The order stemmed from Arkansas and New York courts naming the mother as custodian of the child.

The child was placed in the mother's care Friday, October 12.

"If you aren't careful, you can get three months behind in a hurry, and with many school districts, that could eat up all the reserves," the auditor continued.

He recommended that the current fund balance practice, which maintains a healthy reserve, be continued, especially considering the recent state Supreme Court ruling and the question about state funding in the future.

Alluding to his retirement, Shiver emphasized to the trustees the importance of understanding the financial program, "so that you know what questions to ask."

The board approved the audit report.

In other action trustees approved the payment of bills, renewal of certificates of deposit for \$1,772,458 at 6.66 percent for 31 days and \$1,240,696 at 6.59 percent for 31 days.

A budget change request was also approved, providing funding for Project Intercept, a program which earlier was terminated by Lubbock ISD for area schools, but now reinstated. Students with severe behavior problems are entered into the program, which Shiver told trustees has been a tremendous success.

Trustees took no action on a request from attorney Pat Walker to release a lien on property owned by John Henry Osby and Lillie Mae Price, pending proof that payment has been completed on the property.

Approval was given for a change in the report card format for the elementary school.

Dr. Jeff Young was named as ISD health officer.

Shiver presented a detailed survey of test results, which demonstrated to the board the continuing need to evaluate teaching methods. "We want to find out what motivates children and how to get them to enjoy learning and participate in class," Shiver added.

"We think the best way is for our teachers to be active in finding these solutions, and build on the strengths of our students," he said.

Board of trustee president Royce Hart opened up a discussion concerning the increasing costs of health insurance, suggesting that a cap of \$150 be placed on the monthly premium. No action was taken.

Attending the meeting were trustees Hart, Barbara Hardin, Gary Workman, Pru Basquez, Jerry Hays, Dan Hodges and Ronnie Gradine.

Before the regular meeting began, trustees held a special meeting to set the tax rate, as had been publicized earlier.

## GMH enters into affiliation with St Mary of the Plains Hospital

The board of directors of the Garza Memorial Hospital has entered into an affiliation with St Mary of the Plains Hospital, which will provide consultative services for all major departments of the hospital.

GMH will also benefit in the affiliation through the larger hospital purchasing group, to take advantage of volume purchasing power.

St Mary of the Plains will also assist with nursing education and access to a pool of temporary personnel and a number of other areas.

The affiliation has no effect on hospital management and all controls will continue with the Garza Memorial Hospital board of directors.

The agreement is for a two year period, but may be terminated by either party with a 180 day notice. The GMH board of directors entered into the affiliation September 11, 1990.

## Post earns top honors in state-wide award

Post Main Street manager Wanda Mitchell was notified Monday that the city will be awarded "Best Streetscape Project" for 1990 at the annual Texas Downtown Association meeting November 13 in San Antonio.

Competing with cities of all sizes throughout Texas, Post was chosen on the basis of photos and accompanying explanatory material submitted by Mitchell for the competition.

Previous winners have included Daingerfield and San Antonio for its river walk.

"This is a real honor for us," Mitchell said, "and it's just one more example of the recognition Post is getting across the state."

### Estrogen Patch May Not Cause Hyperplasia

Estrogen replacement therapy is often prescribed for women who have reached menopause (cessation of menstrual periods) or undergone surgical removal of the ovaries, the site of natural estrogen hormone production. Replacement estrogen may reduce the incidence of "hot flashes" a term used to describe an abrupt sensation of warmth, followed by sweating and chills. Estrogen also may help alleviate other potential health problems, such as thinning of bone and bladder-genital problems (burning, itching, and infection) which are experienced by many women following menopause.

One problem with estrogen therapy is *endometrial hyperplasia*, an abnormal increase in the number of cells lining the uterus. Some physicians prescribe progesterone, another hormone, to help prevent this condition.

Estrogen is available as an oral tablet, vaginal cream, or intramuscular injection. Estrogen transdermal patches which are applied to the skin have been available for a few years. Usually the patch is applied twice a week for three weeks, followed by one week in which the patch is not used. According to a recent report in the medical journal *Lancet*, estrogen administered in the form of a patch did not produce endometrial hyperplasia in a small group of women studied in Switzerland.

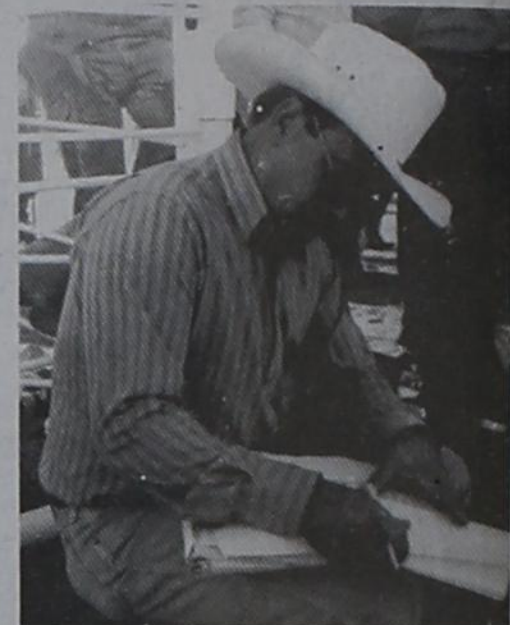

# 'Lopes stiffen in 4th quarter, still undefeated

The Post Antelopes went to New Deal last Friday night and found themselves in a "war zone", finally shutting down a determined Lion offense to take home a 33-27 district win. The 'Lopes remain undefeated.

Post fans weren't so confident of the undefeated status when New Deal opened up the game on the first kickoff, as Mario Garza roared through Post defenders down the middle of the field to the end zone. And the final outcome of the game wasn't decided until less than a minute in the contest with only six points separating the two teams on the scoreboard.

Three Post players were injured during the fracas. Junior Ray Gonzales was taken from the field on a stretcher and by ambulance to University Medical Center, where he was treated and released. He is recovering from sprained muscles in the neck and back. Also injured were quarterback Matt McCook and tailback Darrin Brown, both with sprained ankles.

**First Half Action**  
Following New Deal's touchdown, the Antelopes put on an offensive show of their own, as Jay Whitehead took the kickoff out to the Post 29 yard line.

McCook completed a pass to Brown to the 35, who hauled it in and ran to the 43 for a first down.

An offside penalty on New Deal set the ball at the 48 and Brown took the handoff to the Lions' 44 for another first down.

On second down McCook pitched the ball to Brown heading around the right side of the line, finally being hauled down at the 18. Gonzales got the call on first down, ramming to the nine and after an incomplete pass, McCook handed the ball to Brown who pounded his way to the six for another first down.

Brown got the call and banged over the right side for the touchdown. Gonzales' kick tied the score at 7-7 with 9:04 left in the first quarter.

The defense held on New Deal's next possession and the 'Lopes took over after a punt at the Lion 48 yard line.

A personal foul penalty on New Deal set the ball at the 32 yard line. Whitehead got the call, breaking his way to the eight yard line. New Deal was called for offside and the ball was moved to the four. After a two yard loss on a running play, McCook found Curtis all alone in the end zone for a touchdown pass and the 'Lopes led 13-7. Gonzales' extra point attempt kick was blocked.

A short kickoff set up New Deal at their own 35 yard line. On first down Tommy Herron got the ball and ripped through Post defenders to the Post 16 yard line. An

offside call on Post set the ball at the five. On second down quarterback Abel Ramirez completed a pass to Travis Hale in the end zone, and the extra point put New Deal on top 14-13.

After a sputtering offense, stymied by a holding penalty, the Antelopes were forced to punt from their own 36 yard line...the punt was partially blocked by New Deal, giving the Lions another shot at the end zone from the Post 49 yard line.

The second quarter opened up with New Deal on the move and in four plays the Lions led 21-13 as Herron bulled his way over the goal line from four yards out.

Starting at their own 28 yard line following a kick return by B.J. Funk, the 'Lopes managed to penetrate to the New Deal 25 yard line with Brown and Gonzales getting the yardage. Two incomplete passes and a running play gained only two yards and on fourth down Gonzales got the 18, where the Lions took over on downs.

On that play Gonzales did not get up. Antelope fans looked on with concern as Gonzales was taken from the field by ambulance.

The Antelope defense dug in and forced the Lions to punt on fourth down.

Starting at the New Deal 40 yard line, the 'Lopes mounted a touchdown drive, getting a key fourth down conversion

from the 39 when McCook completed a pass to Whitehead at the 20, who advanced it to the 17.

Three plays later McCook again connected to Whitehead, who was wide open in the right corner of the end zone. The two point conversion pass attempt was intercepted and McCook stopped the play from going the other direction to maintain a slim 21-19 score.

A face mask penalty on the kickoff forced the 'Lopes to kick from deep in their own territory. A terrific kick by Shane Horton gave the 'Lopes breathing room as the Lions started their drive at their own 31.

Floyd Slay cut off the Lions, after they had collected two first downs, when he intercepted a Ramirez pass in the end zone. The 'Lopes took over on offense at their own 20 yard line.

McCook was sacked and injured on the first play, and Michael Radle came in to guide the offense.

After a short punt, New Deal tried to beat the clock with a pass, which was broken up and almost intercepted by Slay and Damon Curtis.

The Pride of Post marching band provided a brilliant halftime performance, as the players went to the locker room to figure out second half strategy, trailing 21-19.

**Second Half Action**

The 'Lope offense couldn't take advantage of the second half opening drive, and Horton punted on fourth down from the 50 yard line.

A strong defensive stand, aided by a clipping penalty on New Deal, forced the Lions to punt on fourth down from their own 15 yard line. Joe Garcia, Benji Vargas, Lance Bland, Chris Redman and David Dean were key defenders for the Antelopes in the series.

The offense took the ball at the New Deal 42 and behind the running of Slay, Whitehead and Brown, got six yards, setting up a fourth down at the New Deal 36. Radle handed the ball to Brown, who skirted around right end to the end zone, with a tremendous downfield block by Chad Kirkland. Two points were added to the scoreboard as Radle completed a pass to Whitehead and Post went out front 27-21 with 6:07 left in the third quarter.

Curtis and Brandon Bird led the defensive charge on New Deal's next possession, forcing a fourth down punting situation from the Lion 26. Whitehead gathered the ball in at the Post 38 and returned it to the 48. A New Deal offside set up first down at the Lion 47.

Brown clipped off a run to the 38 and a face mask penalty put the ball at the 23 for a first down. Two more running plays by

Brown put the 'Lopes at the 12. A holding call after two plays put the ball back to the 24. On third down from the 23, Radle rolled to his right and lofted the ball just over the defender's hands into the waiting arms of Danny Leach in the right corner of the end zone for the touchdown. The two point conversion attempt failed and the Antelopes led 33-21 with 1:05 left in the third quarter.

After holding the Lions, the offense tried to put the game away, but on third down from their own 34 yard line, Radle's pass to Leach was intercepted by Chris Villegas, who returned the ball to the Post 31 yard line.

New Deal went to work, with Herron driving down the field and aided by a fourth down pass completion to Hale at the 15 yard line for a first down. Three plays later Herron bulldozed his way into the end zone. The two point conversion failed and the 'Lopes held on to a slim 33-27 lead.

New Deal got another scoring opportunity on Post's next possession as Horton's punt was blocked and the Lions took over at the Post 40 yard line.

The 'Lope defense was determined to keep New Deal out of the end zone.

On first down Garcia stopped Herron after a six yard gain. Slay put Garza on the ground at the 29 and the Lions got a first

The Antelopes are working this week on figuring out how to get around Tahoka's stiff defense, which has held opponents, with the exception of Spur, to no more than 21 points.

The Bulldogs use a basic 5-2 defensive alignment, and "play good, solid defense, similar to Littlefield, you just have to go out and beat them, they make very few mistakes and have great technique," the coach said.

On offense the Bulldogs mix up the passing and running game approximately 50 percent, using talented receivers Daniel Garvin and Bryan Moore. Quarterback Trey Nance, a 165 pound senior, uses the running abilities of 150 pound junior Billy Wilborn and 175 pound senior Joey Stone.

The game starts at 7:30 p.m. at Antelope Stadium.

"It is really important for us to fill the stands," Osborne added, "I'd like for our fans to realize that we need their strong support as we take on these traditional rivals."

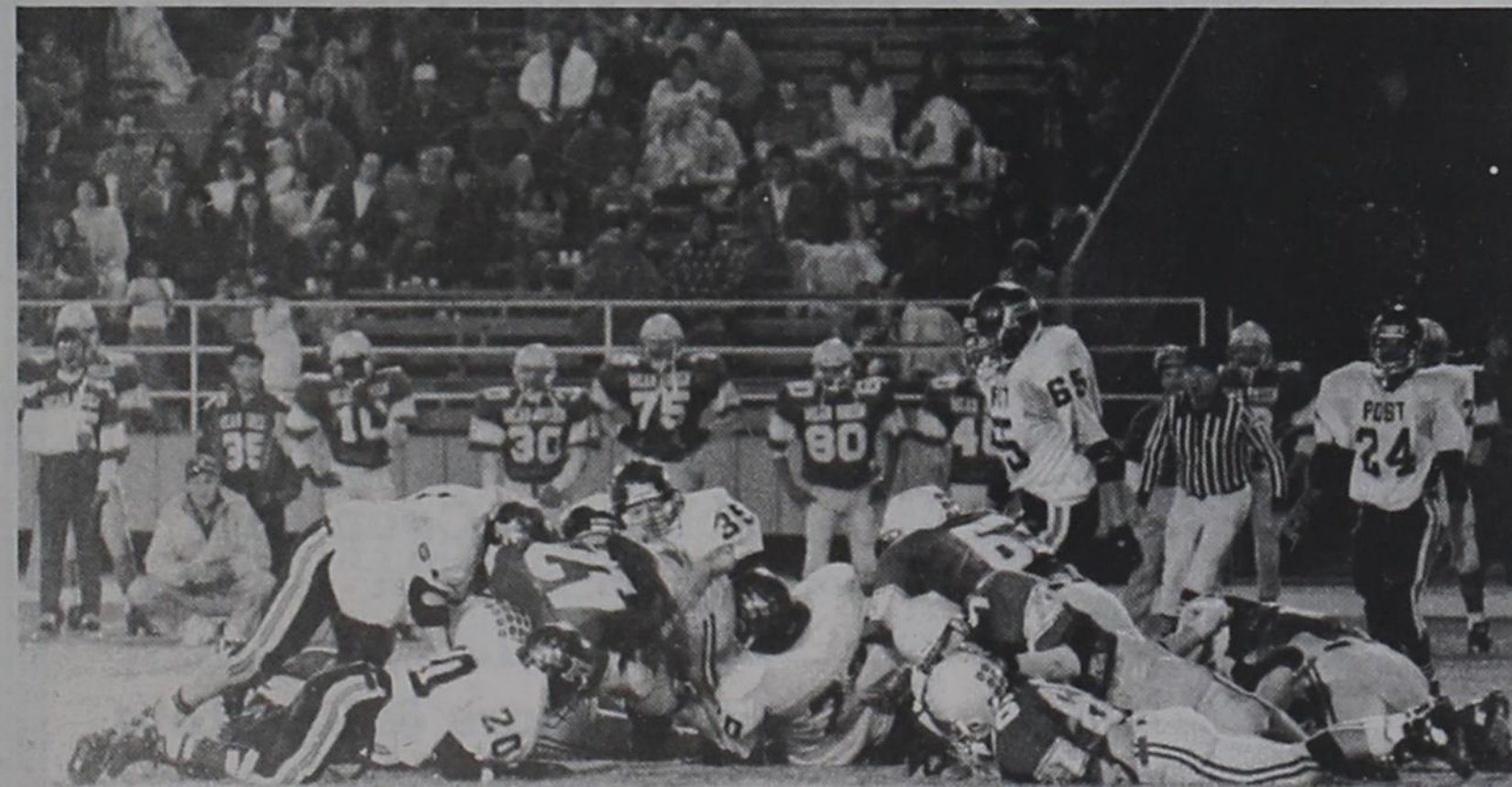

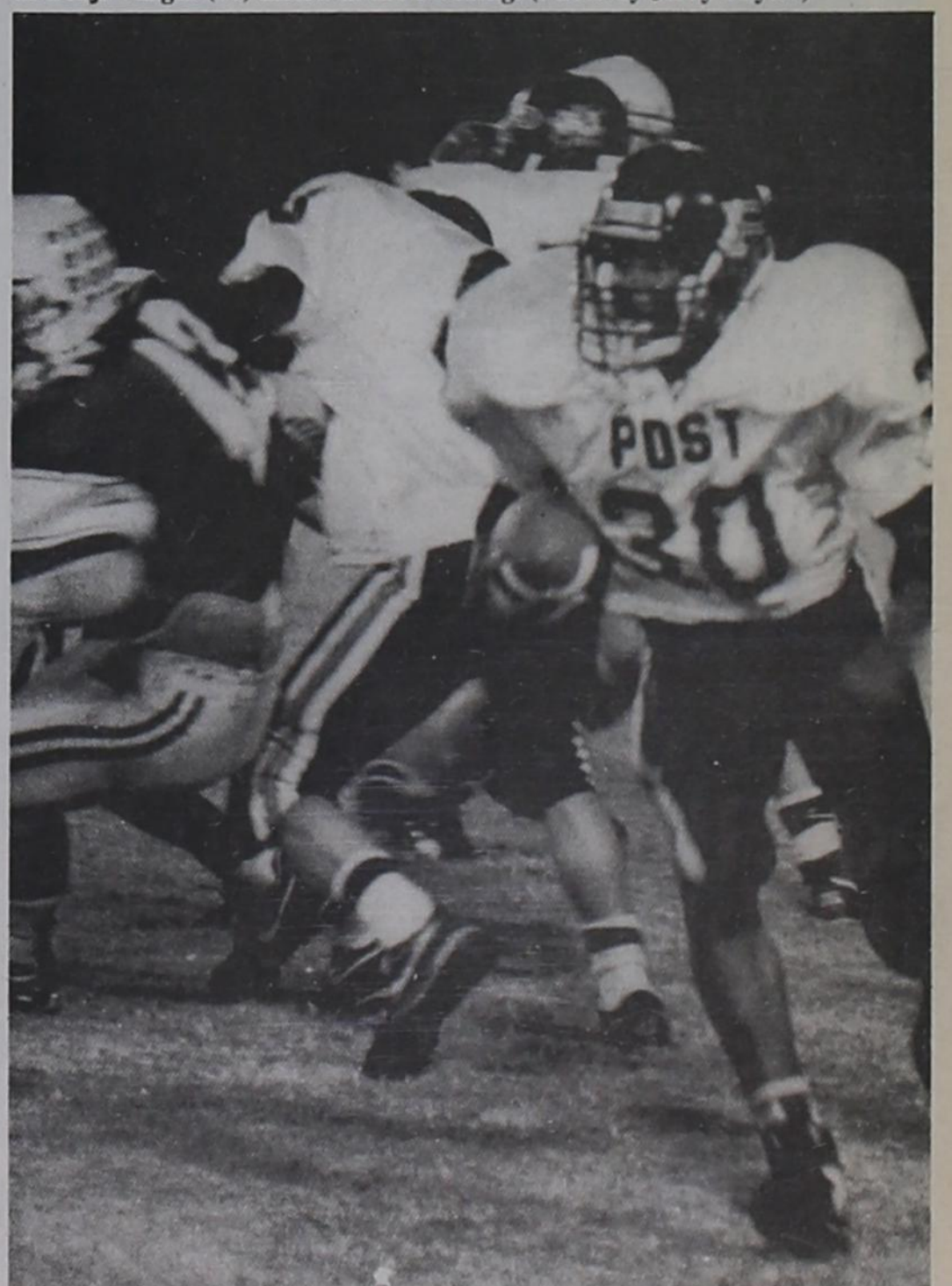

## Garza County SWCD selling trees in observance of Soil Conservation Week

The Garza County Soil and Water Conservation District is taking orders through February 23, 1991 for windbreak trees. Several types of evergreen trees, various types of hardwood trees and shrubs and four different wildlife packets are available for purchase. Price will vary, depending on type of tree, size and are sold in lots of 20, 25, 40 and 100.

Windbreaks properly located and containing the right tree type will provide wind and snow protection for farm homesteads as well as livestock. One source has shown reduced heating costs as great as 15 percent with homestead windbreaks in the High Plains and Rolling Plains. Living windbreaks, or greenbelts, also provide nesting places for small insect-eating birds as well as food and cover for numerous High Plains game birds. Windbreaks for shelter or wildlife habitat are permitted on Conservation Reserve Program (CRP) fields.

The Garza County SWCD is also selling drip irrigation systems

at a considerable savings. Drip irrigation is the slow, frequent application of very small amounts of water to the soil directly surrounding plant roots. Evaporation is greatly reduced and runoffs eliminated. Since water is applied directly to the plant roots, less water is needed. Drip irrigation can save up to 60 percent of the water required by other watering methods. With proper water scheduling, drip irrigation maintains a constant level of soil moisture, leading to healthier plants.

The Garza County SWCD wants to help make your windbreak planting a success. For assistance in designing your windbreak and drip irrigation system to meet your individual needs, contact the SWCD at the Soil Conservation Service at 210 W. Main in Post or call 495-2056.

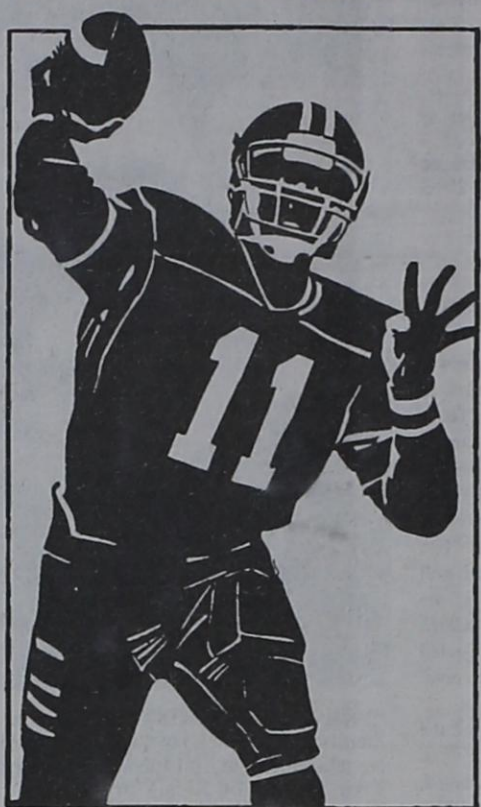
