



1,400 Schools Expected to Participate in League High School Basketball

Austin, Nov. 27.—Basket ball is already attracting many high schools in the State according to Roy Henderson, athletic director of the University of Texas Bureau of Public School interests. Approximately 1,400 schools are expected to participate in the National League high school basketball. Schools may enroll without penalty this sport until December 15, while a penalty is imposed from that date until the final deadline on January 15.

Regulations Governing Use of NRA Emblem

Regulations governing the use of the NRA emblem and insignia were issued today by the National Recovery Administration. The rules do not prevent the labeling of articles made under codes, but do prevent the use of emblems and insignia containing the letters "NRA" or the "Blue Eagle" phrase as a part of trade mark or trade name. A government patent was issued some time ago safeguarding the Blue Eagle insignia against exploitation.

Blank Forms For Filing Complaints In Proper Form Distributed

With a view to expediting action on complaints of violation of specific codes of fair competition for industry and trade groups as well as the blanket code, the National Recovery Administration has distributed to postmasters throughout the country printed forms of which such violations may be reported to local and district compliance boards, according to Ernest L. Tuttle, District Compliance Director.

This action was taken following the receipt of thousands of letters complaining of "chiselers" and code violations. Many of these letters give incomplete information necessitating a return to the complainant. The forms are intended for the convenience of citizens who feel warranted in reporting individuals or firms which they believe to be violating specific provisions of codes of fair competition. Discouraging "spite" complaints, space is provided on the printed forms for one or more witnesses familiar with the facts. The printed forms call for the name of the individual or firm against whom the complaint is made, known technically as the respondent. The complainant is next requested to state the business in which the respondent is engaged. The principal product handled and the principal service rendered. Space is also provided for other details reflecting indicating violation of some definite provision of the code to which the respondent is subject.

When properly filled out these forms will give a complete and quick picture of the nature of the complaint. With the forms in the hands of postmasters and available to all citizens, the facts concerning reported violations may be sent to Mr. Tuttle's office in the Chamber of Commerce building, thus insuring prompt action. This arrangement possesses a double advantage. The citizen filing a complaint will be notified more quickly than if a letter were written to Washington headquarters and returned to Mr. Tuttle's office. "We have received very few complaints," Mr. Tuttle said today, "and with the complaints filed directly with district or local boards in proper form, it will be possible for the local officials to get to the root of the matter at once and take such action as may be warranted by the facts developed in the investigation."

Rivals for ten years, this is the second game in fifteen that the Eagles have won with only one scoreless tie.

"Beware of the Common Cold" Says Dr. J. W. Brown

Austin, Texas, Nov. 27.—"Beware of the common cold," Dr. John W. Brown, State Health officer, in a statement issued here today, cautioned the people of the State of Texas. "This is the season of the year when colds are most prevalent, and their consequences more far reaching. The organism causing the disease is not known, but every individual is acquainted with its effects."

Not a little of the susceptibility to catching colds can be overcome by a gradual acclimating to lowering temperatures and inclement outdoor weather. This hardening should begin now, and consist of regular exercise—walking is good—to be continued throughout the winter, in weather of every kind. Some things to avoid are wet stockings, drying on one's feet; over-heavy clothing—over-heated rooms.

There are two broad principles to observe in the treatment and prevention of colds. The first says: "Let the patient keep to himself, and keep his oral and nasal discharges to himself." This includes indiscriminate spitting, kissing, and other forms of contact.

The second principle requires doing away with coddling and overprotection of the body against the elements.

"The cold is a common disease," Dr. Brown said. "But every cold is important enough to justify careful attention and treatment for its immediate cure. Death-dealing pneumonia and tuberculosis may begin with colds that did not receive care and attention.

"Over-indulgence of dehydrating stimulants, such as alcohol, tobacco, tea, and coffee do much to lower the resistance to colds."

EXAMINATIONS FOR CONSERVATIONISTS (FORESTRY) ALL GRADES

The United States Civil Service Commission will accept applications until December 12 for positions of conservationists (forestry) of various grades, to fill vacancies under the Forest Service, Department of Agriculture. These new positions have been created by the emergency work approved by the Public Works Board as a part of the National Recovery Act program, and the appointments may be only for the duration of such work.

A separate list of eligibles in each grade will be established for each of the following options: Erosion control, Silviculture, range management, forest or range ecology, forest economics, forest administration, forest survey, forest recreation, and forest land acquisition.

The salaries range from \$2,600 a year to \$6,400 a year, less a deduc-

tion of not to exceed 15 per cent as a measure of economy and a retirement deduction of 3 1/2 per cent. Full information may be obtained from Cleve H. Austin, Secretary of the United States Civil Service Board of Examiners, at the post office at Lamesa.

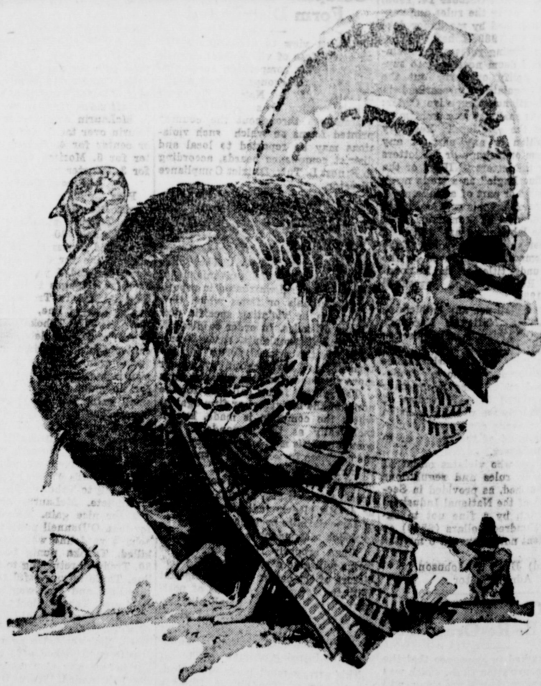

"AND SO IT CAME TO PASS"

Now the Tahokaites dwelt upon a
plain toward the north, and they cal-
led themselves a war-like generation.
Annually, as was their wont, they
made war upon their neighbors north
about, even the O'Donnellites, and
