Farmers Union speaks

A proposal made by Farmers Union three weeks ago to provide an equitable solution of the meat price stabilization tangle is now under study by officials who are guiding the proposed extension of the Defense Mobilization Act.

In a statement supporting the use of price controls to stabilize the economy, the Farmers Union declared the meat price rollback as inequitable. Farmers Union said that it would be confiscatory or work a great hardship on many beef raisers, and particularly those who had bought or contracted for feeders at high prices. We proposed that production payments be used to adjust hardship cases . . . and that the cost be charged to poor administration of the Mobilization Act authorities.

Methodists Planning Evangelistic Mission

Plans for the Texas Methodist Evangelistic Mission, Oct. 27 to Nov. 4 in the Dallas-Fort Worth area will be advanced at First Methodist church, Dallas, June 27 in a meeting of North Texas conference preachers and laymen.

J. V. Folsom of Dallas, lay leader, is inviting every local church lay leader to attend the meeting.

Bishop William C. Martin will preside. Dr. Dawson C. Bryan, minister of First church, Houston, formerly with the board of evangelism, will explain the plans to be used.

Dr. Kenneth Copeland, pastor at Travis park, San Antonio, will be the inspirational speaker at the luncheon.

Dr. Robert E. Goodrich Jr., First church, Dallas, is chairman of the Conference board of evangelism. Dr. H. C. Henderson of Waples Memorial church, Denison, is the secretary of evangelism.

Young Pianist to Give Recital Friday Night, Vocalist to Assist

Miss Barbara Butts will be presented in a pianoforte recital by her teacher Mrs. W. G. Steele, Friday evening, June 22, at 8:15 in the Methodist church.

She will be assisted by Miss Lou Ann Duke, mezzo-soprano, pupil of Max Kreutz.

Both Miss Butts, daughter of Mr. and Mrs. R. J. Butts, and Miss Duke, daughter of Mr. and Mrs. Carroll Duke, are outstanding musicians. They are members of the Junior Musicians' club in Wichita Falls. Lou Ann was accompanied by Barbara when she appeared on the spring concert at the Woman's Forum when the club entertained for the Senior Musicians club and friends.

Miss Butts has studied piano for eight years with Mrs. Steele. In 1950 she won second division honors in the regional interscholastic meet at Denton, playing Mozart's "Sonata in F Major No. 4." This year she placed in first division, playing Schubert's composition "Impromptu A Flat." Her playing embodies brilliant technique, a masterful touch and splendid interpretation. She is also an able accompanist. She is pianist of the intermediate department of the Baptist Sunday School.

Barbara will play an ambitious and difficult program Friday evening. Her first group of numbers is from the works of Bach and Haydn. Bach inventions whether two, three or four points are always considered difficult because the statement of the theme and its imitations must always appear foremost. While the counterpoint section is generally more subdued the themes are to be clearly delineated.

The Haydn sonata in three movements is typical of that composer in brightness and happiness with a short slow movement before the last light, brilliant movement.

The second group by the pianist are from the romantic period and begin with Schubert's Impromptu. All selections embody the characteristics of that period in brilliance and changing mood.

The two Gershwin preludes that close her program emphasize classic jazz at its height.

Miss Duke has studied voice with Max Kreutz for three years. She has received favorable comment from critics in Wichita Falls and Denton. In the 1951 regional interscholastic meet at Denton she earned first division first rating with her interpretation of "When I Have Sung My Song."

Mrs. Ralph Stone was severely burned last Saturday when she started to light the kitchen stove to prepare dinner. Some accumulated gas flashed out and burned Mrs. Stone's face and left hand.

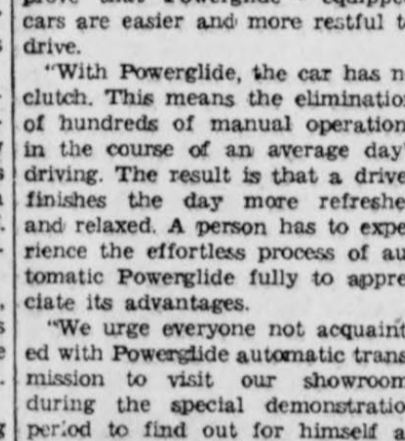

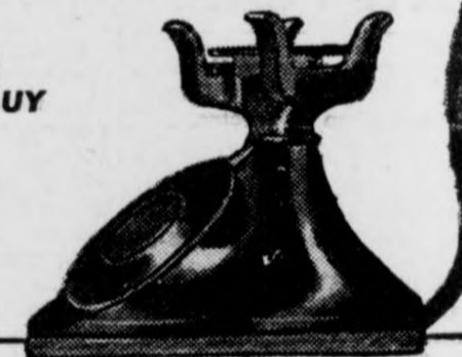

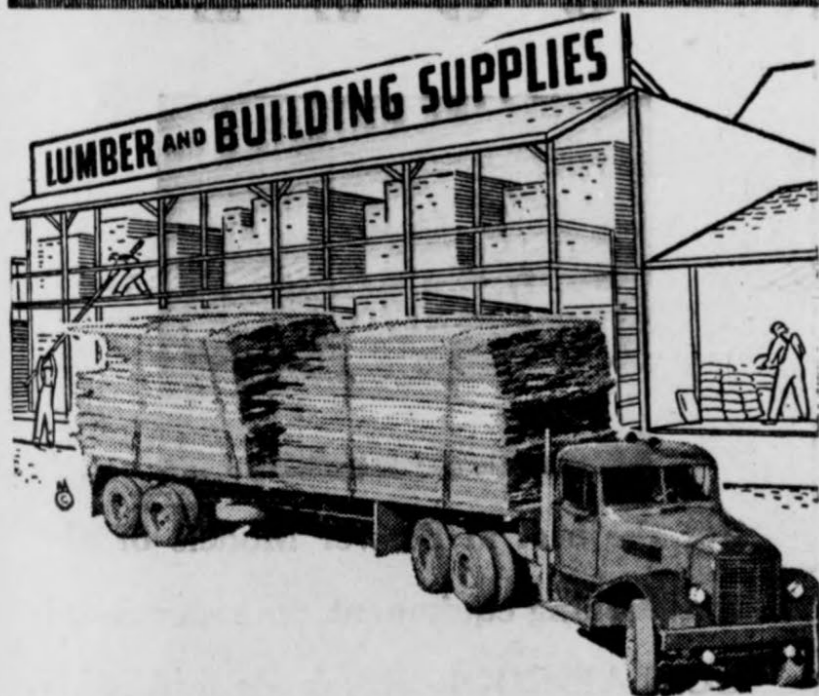

A cluster of candles burned in tall candelabra immediately in front of the church baptistry, while seven-branched candelabra held tapers to shed light on either side of the choir loft. The nuptial space on the rostrum was centered with a fan-shaped arrangement of white gladioli and bluish white peonies with center petals of palest pink. Candles were used to mark outer extremities of the platform.

An effective supplement of green-

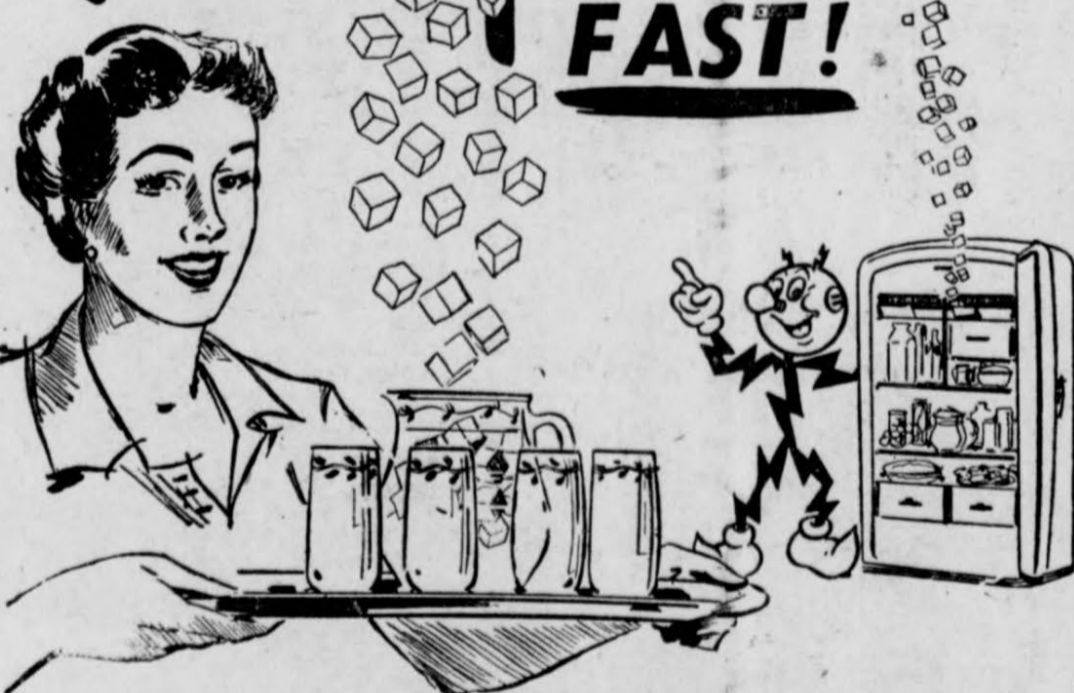

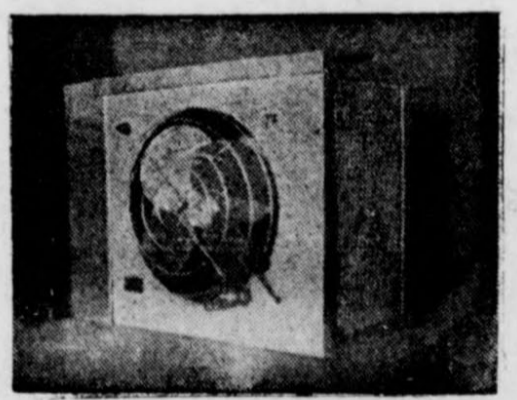
