# Championship title on line for Hawks

In their final game of the regular season, the Hawks will be playing mostly for pride when they host the Bridgeport Bulls at 7:30 p.m. Friday in Hawk Stadium.

Iowa Park clinched a berth in the playoffs by defeating Jacksboro last week, to remain undefeated in Dist. 6-AAA play.

Irregardless of the outcome tomorrow, both here and at Decatur, the Hawks will represent the conference as the first-place team.

The pride they'll be playing for is their first outright district football championship since 1970. The Hawks shared the title in 1985 with Vernon and Springtown, and by luck of the draw, represented the district as the winning team in the playoffs. Last year the Hawks were runners up to Breckenridge, advancing all the way to the quarterfinals of the state playoffs.

Should the Bulls upset the Hawks Friday, Iowa Park would share the 6-AAA crown with the winner of the Breckenridge-Decatur game. But the Mean Green would still represent the district as the first-place team by virtue of their win over the Buckaroos and Eagles.

But before the Hawks start looking toward Dist. 5-AAA, where Abilene Wylie and Ballinger are the leaders, they've first got to meet a team that has the potential of pulling off an upset, despite their 5-4 record.

The Bulls have an offense that can match up with any in the conference, but their defense is rated as "suspect." *They're led by fullback Cason Rangel. a 202-pound* senior who has been a starter all four years with the Bulls, and quarterback Jeff Franklin, a 190-pounder who is the team's second-leading rusher.

Bridgeport has plenty of size, with a line that is anchored by the league's biggest player, 274-pound Scotty Hale. Others on that line which have helped the backs average some 270 yards rushing this season are Bart King, 217, Donnie Kleam, 180, Steve Sweatman, 200, and Ronnie Kleam, 182. primarily because of seven turnovers: four fumbles and three interceptions. They still gained 233 yards rushing and 63 passing in the losing effort.

Bridgeport opened 6-AAA competition with a 24-13 win over Jacksboro, with Franklin carrying 19 times for 110 yards and completing four passes for another 91.

Despite Franklin's 130 yards and 76 more from Rangel, Bridgeport lost 31-7 to Decatur. The Bulls suffered three lost fumbles in that contest.

Rangel picked up 162 of Bridgeport's 332 yards in defeating Bowie 34-12.

Last week, Bridgeport jumped out to an 8-0 lead against Breckenridge and held an 8-6 margin at the half. But the Buckaroos scored three times in the third frame and went on to win 33-14.

Countering the Bridgeport rushing game will be the Mean Green defense, which has given up more than 172 yards only twice this season: 252 to Decatur and 257 to Vernon. For the season, Iowa Park's nine opponents have averaged only 137.5 yards on the ground.

Meanwhile, Iowa Park is averaging 281 yards rushing, with fullback Jim Cummings and tailback Joel Galloway averaging seven yards each time they are handed the ball. Cummings has carried 165 times so far and gained 1,160 yards. Galloway, with 86 tries, has 643.

And for those teams that want to stack up their defenses on the line to try and stop the Hawk ground attack, a new dimension has been added to the Mean Green offense. Passing.

Sophomore Jimmy Duggins, brought all the way up from the junior varsity as quarterback when senior Jeff Huff and junior Dan Fannin were injured, has completed 13 of 23 attempts for 171 yards in the last two games.

# Pair arrested on gun charge

Police arrested two persons Wednesday of last week on a charge of carrying a gun in their car, and now face an additional charge of credit card abuse.

After being alerted of concern about a credit card the couple had used to make a local purchase, police stopped Retta Coleman Johnson, 35, and Bradley Glen Young, 30, in the parking lot of King's Food at 5 p.m.

Officers found the weapon, a hand gun, in the car while investigating, and arrested them on that charge. However, after they had been taken to jail where they promptly made bond, it was learned the card they had used at three local stores was actually stolen. A warrant has been issued on the two on that charge now, but they have not been found.

Merchandise purchased with the stolen card was recovered, however, and returned to Parkway, Park Pharmacy and Louis Jewelry.

A charge of wreckless damage has been filed on Monte Castro, 17, as result of two doors on the west side of Iowa Park High School being demolished early Sunday morning.

After an investigation by police, it was determined the vehicle, a Toyota pickup, used in the incident was owned by John Rusk. Further investigation led to the charge that Castro was the driver at the time the \$1,400 in damages was inflicted.

# Housewife is charged 'tampering'

Iowa Park police Friday afternoon arrested a local housewife on an unusual charge of "tampering with a witness."

Suella Crim Jones, 45, is alleged to have made a financial offer to two teenage girls if they would go to a district judge and say they lied when they gave testimony against Kenneth Watts last year.

Watts, who was 58 and building trades instructor in Iowa Park schools when he was arrested April 21, 1986, was charged with indecency with a child, and is serving a 10-year probation.

The charges were made by girls 12 and 16 years of age.

Chief Alan Sheffield said the arrest was made after investigation by personnel both in his department and the office of Criminal District Attorney.

Mrs. Jones was arrested at 2 p.m. at her home at 604 W. Cornelia. After being booked on the felony charge at the police station, she was taken before Justice of the Peace Virgil Hill, who read her rights to her and then placed her under a \$10,000 bond. She was then taken to county jail, and released later that day after bond was posted.

Bridgeport opened the season with a 28-14 win over Olney. Rangel carried 22 times in that game and gained 109 of the Bulls' 234 rushing yards.

The club fell victim, 41-6, to state-ranked and undefeated Southlake Carroll. Franklin, in that game, was credited with 115 of Bridgeport's 186 rushing yards, and also completed three of 12 passing attempts for another 20 yards.

After defeating hapless Sanger 43-7, the Bulls outscored Aledo, a team that has already made the playoffs. Rangel ran wild that game, carrying 35 times for 227 yards.

The Bulls lost 24-7 to state-ranked Class AA Boyd,

Iowa Park this week was elevated to the number 10 ranking in the state by the Dallas Morning News, and the Harris Rating System has Iowa Park ranked sixth among the state's AAA teams. Harris has also figured Iowa Park to beat Bridgeport by 20 points (and Decatur, ranked 10th, by nine over Breckenridge).

Down in Dist. 5-AAA, Wylie, which defeated Ballinger, plays Clyde tomorrow night and Ballinger plays Brady. A win by both teams would make Wylie the champion and Ballinger the team Iowa Park would meet in the first game of the playoffs, which would be the third consecutive year for that to happen. However, should Ballinger win Friday and Wylie lose, Ballinger would be the winner and Wylie Iowa Park's opponent next week.

No site has yet been picked for next week's first round in the playoffs.

# Road ends at region for marching band

The Iowa Park High School "Mean Green Marching Machine" placed third in regional marching competition held Saturday in Wichita Falls.

The two bands selected to go to state competition this month are Southlake Carroll and Tulia, with Springtown as alternate. Springtown and Tulia tied for second place in the contest.

The three judges placed Iowa Park second, third and fifth with their votes, for a total score of 10. The two second place bands only bested the "Mean Green" by one point.

Iowa Park was ranked second in the state last year.

Although neither the band

members nor directors Greg Miller and Ed Hefti are pleased with the final decision, they are taking it in stride. "The bottom line is, we didn't do it as far as the judges were concerned," said Miller, head director.

Miller said the band had to march with three positions unfilled in Saturday's competition because of injuries. Other than that, he said most of the problems the judges cited were with marching precision.

During halftime Friday night, the Hawk band will only march the first half of its contest show, and as tradition will have it on the last home game of the season, senior members of the band will be introduced. and the trustees are to start at 7:30 p.m. Tuesday in the administration building.

A "show cause" hearing, the third and final hearing required under city ordinances, will be held to permit owner Joe Harry Bower of Uvalde an opportunity to show why his rent house at 325 E. Bank should not be demolished and a lien for costs placed against the property.

After hearing a number of violations listed against the structure, the council voted some two months ago to commence condemnation proceedings against the owner.

Two other hearings are on the meeting agenda. One concerns an application for a Community Development Block Grant and the other is to consider a petition to annex a tract of land into the city.

Aldermen will consider authorizing the city administrator to enter into a contract for improvements on the police department structure.

Two resolutions, one accepting water line improvement work in the south part of town and the other to accept and approve the 1987 tax roll, will be considered.

Also on the agenda, aldermen will consider street work for next year, revising the code enforcement officer position, authorizing the administrator to enter into a grass lease for land at Lake Iowa Park, a lease renewal for the used car lot land on West Highway, consider a community center master plan, and consider authorizing the administrator to buy a new copier.

School trustees will decide on a proposal to re-open Valley View school to house the fifth grade for the 1988-89 school year.

Board members voted some two months ago to have the property listed for sale, and that has not been as yet rescinded. Trustees toured the facilities last month, some for the first time.

A review of a special report on school facilities is also on the agenda, as are action to sell the old homemaking cottage and other intown lots; consideration of a promotion, retention and placement policy, and reports on curriculum goals and district drug committee.

# Local, state voters agree

Area voters Tuesday agreed with the rest of the state to have an elected state school board and to allow parimutuel betting at the race track during an election in which Texans voted on a record number of proposed constitutional amendments.

Referenda one on the ballot was defeated handily, allowing for an elected state school board, rather than one appointed. Referenda two was a closer contest, but voters gave the nod to allow for legalized pari-mutual wagering on a county-by-county local option basis.

Voter turnout, both state-wide and locally were better than anticipated, with a 29 percent turnout in the five area precincts.

In precinct 32, where there are 2,812 voters registered, 844 ballots


were cast for a 30 percent voter turnout. Precinct 33 saw a 22 percent turnout with 212 ballots cast of 926 voters registered in that precinct.

A 31 percent turnout was recorded at precinct 34 where 103 of 330 registered voters cast ballots.

Precinct 53 reported 124 ballots cast for a 36 percent voter turnout.





#### **Registration period** ending for men 26

Men who turn 26 during the remainder of 1987 will be reaching an important milestone, according to the Selective Service System.

Young men born in 1961 were required to register with Selective Service in July of 1980 when President Carter reinstituted the registration requirement. These men turn 26 in 1987.

Selective Service does not have the authority to accept a young man's registration after he has reached his 26th birthday.

Harold Doyle, Texas Selective Service state director, warned that, with few exceptions, a man who fails to register before turning 26 will permanently forfeit his eligibility for federal student financial aid, job training benefits and most federal employment.

Additionally, non-registrants face possible prosecution as felons.



#### **Neighborhood Watch program** being brought back to life

The Neighborhood Watch program is being revived in Iowa Park with the guidance of police officer John Cross and the enthusiastic action of residents.

The program was started a few years ago, but died a natural death without continued leadership of the police department.

The revival has been made possible by a federal grant which pays half Cross' salary, he explained Tuesday in a talk before the Iowa Park Lions Club.

The first of several neighborhoods to resume activity got underway with an Oct. 26 meeting, when Bert Caddell, 604 N. Wall, accepted the responsibility of serving as block captain.

Caddell, according to Cross, has already assisted his neighbors with a program to identify their property by distributing electric engravers loaned by the police department.

Information is also being compiled on each household, as to emergency telephone numbers, numbers of persons residing in the household, medical information of residents, and other data which will be kept on file at the department.

Cross said numerous other meetings are being scheduled in various parts of the city, with an aim toward organizing all residents.

"We can't patrol all parts of the city more than two or three times a

day," Cross explained, "so it is important neighbors keep a watchful eye for anything or anyone they're not familiar with.

He emphasized calls to the police department, asking that something be checked out is not at all a bother.

In fact, he said the department's goal is to have its calls increased 200 percent.

Cross is also working with children, primarily in elementary schools, on several different programs, ranging from bicycle safety to the "Just Say No" program.





# Cook of the Week

Born and raised in Louisiana, Cynthia (Mrs. Bennie) Brashear naturally has a treasury of Cajun recipes and she shares three of them with the Leader readers this week.

The Cajun foods are hot and spicy and call for a generous use of red and green peppers, onions, garlic and tomatoes.

In their search for edible plants, primitive people must have discovered many of those that supply us today with spices and condiments that are used for Cajun dishes. The primitive people probably learned to use the plants to make food more flavorful. In time, some of the plants became intentionally cultivated, and with the Romans, the spices came into their own in the art of cooking.

Garlic, one of the discoveries of the primitive people, has indeed had a long history and it has always been tied to the working man. It was mentioned in a Chinese book dating 2,000 years before Christ. It was known to have been used by the Babylonians around 3,000 B.C. In Greece it was a most important vegetable, and eaten as a vegetable in its own rights, not simply as seasoning for something else. It was an important food of the pyramid builders.

Garlic and its by-products, salt and powder, have risen in popularity in the United States since 1940.

Cynthia was graduated from Lake Charles, La. High School and attended McNeese State Univ. She and her husband, Bennie, lived in Spain while he was stationed there in the Air Force. He has been in the Air Force 15 years and is presently at Sheppard Air force Base in helicopter maintenance.

She has worked at a Payless Shoe Store and as a saving counselor for Independent American Savings. They moved to Iowa Park from Wichita Falls a year and a half ago. She is now helping her husband in his Quality Cycle business.

#### CHICKEN AND SAUSAGE **GUMBO**

Cut sausage in thin pieces, combine oil and flour to make a roux. Stir over low heat until brown. Add parsley, onions, shallots, bell pepper, garlic, sausage and 1 cup water. Bring to a boil. Reduce heat and simmer 3 minutes. Add remaining 9 cups water and bring to a boil. Add chicken, salt and cavenne pepper. bring to a boil. reduce heat, cover and simmer about 2 hours. Serve over rice. Makes 6 servings.

#### BISCUITS

Stir above ingredients well, add: 1 heaping Tbsp. margarine 1 1/2 cups milk

Beat well, then add self-rising flour until workable. Turn on floured board. Knead, roll out and cut. Bake at 425 degrees 45 minutes.

#### **CAJUN (DIRTY) RICE**

Giblets of 3 chickens 1 medium onion, chopped 2 stalks celery, chopped fine, including leaves 2 Tbsp. parsley 1 1/2 cup rice, cooked 3 Tbsp. fat 2 slices stale bread 1 clove garlic, minced, if desired 1/4 of large bell pepper, chopped fine 3 Tbsp. green onions Salt, pepper and poultry seasoning to taste

1 cup chicken broth

Grind the giblets together. Beat fat in saucepan and brown ground mixture Add celery, bell pepper, salt, pepper and poultry seasoning. When well browned, add about 1 cup chicken broth. Let cook until tenderit should have the consistency of hash. In the last 10 minutes of cooking, add the green onion and parsley. Cook rice the usual way and mix with giblet mixture while both are still hot. The best way to mix is to take a large bowl and and put some rice in it, add some giblet mixture and mix; add more rice and more giblet mixture. This should made the rice brown and will be moist.

HOLLIDAY - Holliday residents gained a new city mayor and council member Tuesday after voters there elected Grady Graves and Randy Getts to those positions, respectively.


Both candidates ran unopposed, with Graves receiving 227 votes and Getts, 218 votes,

The Tigers had shown they were a team that could stay on the field with anyone two weeks earlier, when they held Breckenridge to a 7-3 decision.

Iowa Park committed both its turnovers in the first half. One led to Jacksboro's only score and the other nailed the Hawks deep in their own territory.

On the first play following Jacksboro's second punt, quarterback Jimmy Duggins threw an interception that gave the Tigers possession on their own 49 yard line.

The hosts immediately launched their longest gain of the game, a 45-yard run that took the ball to the Hawk four yard line. Three plays later, with the ball still at the four, Jacksboro kicked a 12yard field goal that put the Tigers in the lead, 3-0.

Early in the second half, Jacksboro punted to Marc Cruz, who misjudged the ball's flight in the strong wind, and a Tiger covered it on Iowa Park's 38 yard line.

But three plays later, after having gained only one yard, the Tigers again punted and the ball went out of bounds on the Hawk five yard line and slightly more than three minutes remaining in the

Fullback Jim Cummings capped the drive with a six-yard plunge over right guard, followed by the first of four booming and successful extra point kicks by Toby Brown.

Cruz returned Jacksboro's first punt of the second half from his 17 to the Hawk 48, and Iowa Park made quick work of that drive by scoring in only five plays. A 39-yard pass from Duggins to Cummings was the key play to setting up Kenyon's nine yard gallop around left end to score.

Iowa Park also scored on its next possession. Key plays on the drive was another 23-yard pass to Cummings, who followed with a 15-yard run.


Joel Galloway appeared to have scored from the four, but the play was nullified by a 10-yard holding penalty. Undaunted, Galloway blasted his way over right guard on the next play, and Iowa Park led 21-3 with 47 seconds remaining in the third period.
